

More Details of Local Swimming Pool Proposal Heard By Commissioners

More details of the proposed swimming pool project for Sanderson were revealed at the called meeting of the Terrell County Commissioners Court Thursday morning of last week. The posted agenda called for consideration of the television system for Dryden, recreation project for Sanderson, and flood insurance for Terrell County. No other considerations were possible at the called meeting since they had not been on the agenda.

The commissioners voted to ask for bids on the installation of television re-broadcasting equipment to furnish reception for that part of Terrell County from Dryden north. The bid advertisement is in The Times this week. After hearing the proposal, W.W. Sudduth, commissioner of precinct 1, made the motion and the second was by Graham Childress, commissioner of precinct 4. The vote was unanimously favoring the seeking of bids.

Troy Druse, local insurance agent, presented a detailed report of the flood insurance proposal to the court. The court agreed to make application for approval by a federal agency that would make it possible for any Terrell County resident to purchase flood insurance. The county, if the application is accepted, en he responsible for enforcing the rules and laws of the federal agency concerning future construction in the county. The county would not participate in the payment or receipt of any premiums for the flood insurance, but merely enforce certain building codes required by the federal agency. It is hoped that future insurance premiums against flood damage will replace the current method of contributing disaster funds by the federal government to flood-ravaged areas. Druse pointed out that failure of the court to seek approval for local residents to purchase flood insurance would diminish considerably the possibility that Terrell County could expect federal funds in case of another flood, according to information that he had received.

In the consideration of the swimming pool project, County Judge Charles Stavley stated that he had contacted Mrs. Ed Robbins concerning the property containing the swimming pool built and put into use in 1935 by her father, John Clark. Judge Stavley reported that the property was available for \$30,000.00, 29% of which would be in the initial payment, and the balance payable over a five or sixyear period. He reported estimates of from \$8,000 to \$12,000 for the installation of a filter system, and \$5,000 to repair and make serviceable the existing tank. Other costs would be rest room facilities, a shower head, and foot bath, plus cost of maintenance of the facility. Judge Stavley stated that he felt sure that the salary of a life guard could be taken care of in a grant from the Permain **Basin Regional Planning** Commission in the summer youth job project, and that fees for users of the pool would help to offset other costs. He cited the fact that \$23,324 in revenue sharing funds had been committed to recreation, that there was a possibility of the Dryden television installation project would not use all of the \$10,000 allotted to that cause, and that any remainder

tively correct suggestion as to how the money should be spent that no one can question: We will go out on another limb and express that opinion: the money should be spent in a way that does the most good!

There are all kinds of opinions as to how tax money should be spent, some of which have been repeated in this column previously: for the benefit of tax payers mainly - that are the source of that money. We don't go along with that theory in any of its possible concepts, since this would deprive so many of so much. Since the reve-

nae sharing funds are the kick-back of income tax payers, this gives some people some good ammunition to argue where and how the monev should be spent according to the pay-benefit ratio. The only problem is trying to figure out who spent the most on income taxes.

Those who presume to believe in this theory of expenditures have very little to do. in our humble opinion, and would not be interested in hearing what anyone else thinks.

The commissioners are asking for some more information about the cost of the swimming pool project, like estimates on fencing, etc., all of which is well and good. But sometime soon, someone is going to have to say that bids is the best way to determine an ultimate cost. Estimates are only that! Bids give a concrete figure to look at, consider, and accept or reject.





EDITORIAL

What more appropriate time to seek out the nation's philosophical foundations than now, the eve of the 200th anniversary of the signing of the Declaration of Independence?

One hundred and ninety-nine years ago this fourth day of July. the Continental Congress adopted the resolution of independence without one dissenting vote. It meant that the 13 Colonies of America were united, free and independent. A new nation began its great experiment under law, a written constitution.

The successes achieved since July 4, 1776, can be traced directly to the strong foundation laid by the Founding Fathers and their collective expression of an extraordinary quality of thought, speech and action.

We have much to celebrate, but we must do more than that. Each generation has been called on to accept the challenge of a different crisis, and each generation has lived up to its responsibility. There must be a rededication to the past. an awareness of the present, and a plan for the future. We must share the same spirit and determination as those founders to solve the complex problems that lie ahead.





Future Safaris In Texas Can Promote Big Game

Exotic game herds in Texas have grown from a few odd animals kept as a curiosity to dozens of herds involving thousands of animals.

At a time when world population pressures and the demand for protein has resulted in thinning of many wild herds, Texas has begun a serious expansion of big game numbers.

Some of the big ranches of Texas, working with the Department of Wildlife and Fisheries Sciences of the Agricultural Experiment Station and some of the big zoos in the state, have imported and multiplied more than two dozen kinds of big game animals.

At present, the eight most important (together with their estimated numbers) are: axis deer, 6,450 on 69 ranches; 4,125 blackbuck antelope on 56 ranches; 1,300 aoudad sheep on 40 ranches; 10,000 mouflon sheep on 121 ranches; 10,000 European wild boar on over 100 ranches; 4,000 nilgai antelope on 7 ranches; 875 sika deer on 22 ranches; and 445 fallow deer on 43 ranches.

Dr. James Teer, head of the Department of Wildlife and Fisheries Sciences for the Experiment Station, is project leader of the Caesar Kleberg Research Program in Wildlife Ecology. This privatelyfunded program has assisted in the rapid expansion of this important new source of income to many Texas ranches. More and more ranchers are realizing that wildlife can be an income producer that rivals their domestic livestock. In many places in North America, wildlife resources on private lands are being recognized as an economic asset that needs to be encouraged. guarded and harvested. Present trends in many of the 50 states where there is little public land suggest that we are adopting the traditional European system of producing and harvesting game animals. This not only involves the big game species but smaller mammals, upland game birds and migratory birds. Commercialization of hunting takes many forms. but the basic point is that money is paid for hunting recreation. "The displeasure that many Americans feel toward commercialization of hunting and fishing is well known to sociologists and wildlife ecologists," Teer says. "Our society feels that hunting and fishing is an expression of their heritage and that to pay for something that has been their right takes the purity and pleasure from the sport.

"However, the ethics and morality of rewarding those who produce is also deeply ingrained into American culture. Therefore, it seems appropriate that those who own and manage the land should be rewarded for their protection and management of wildlife in whatever form it occurs.

"This need not imply that production of wildlife should be directed toward economic gain alone, but for those who do allocate resources of range forage and the like, some reward system is merited. "Such an allocation of

resources is a basic decision in any land use program, and wildlife production must compete economically with other uses of the land.

"One especially interesting development from the sale of season leases has been the development of family-oriented weekend and holiday recreation centers. Landowners are beginning to attract more of the recreation market by improving facilities and offering additional activities for all members of the family.

"Fishing in streams and stockpond, horseback riding, hiking, camping and photographing wildlife and nature are other facets of leasing programs that are becoming important.

"Income from all these sources is encouraging landowners to help increase both native game and the imported big game animals," Teer concluded.



State Comptroller

AUSIIN-Some people are getting on my back because I've set up a tax information office in the Comptroller's Department.

But that may turn out to be one of the best investments I've made.

A copy of the tax laws.

Now, the tax laws were written by tax lawyers to be read by other tax lawyers. And if you were starting up a business on a shoestring, and trying to comply with the law, you would probably not feel safe unless you hired a tax lawyer to explain to you what the Comptroller's Office had handed you.

I want to change that. That's why I hired newsmen. Journalists are trained to talk to lawyers and bureaucrats and technicians of all sorts and reduce what they say to simple English and put it in the newspaper for the people to read.

I have put those newsmen to work translating the tax laws into plain English. They are writing pamphlets that will make it clear to anybody what steps they need to take to meet state law in starting up a business, filing reports and making tax payments.

This will make your dealings with my office simpler. What's more: it will save some of your tax dollars.

Let me tell you why. This office spends a lot of man-hours having to correct simple errors in sales tax reports. This involves getting another report and sometimes makes a taxpayer delinquent, and that's a headache for everybody.






