(No. mam, the man in the upper portion is not pulling off his clotheshe's just removing one layer as the sun warms things up.)

In the second picture, the rig is approaching the location. Belonging to the Hunt Oil Co., moving of the huge machine without tearing it down is being done by Rumbaugh, a company experienced in oilfield skidding of rigs.

In the bottom scene, the rig has reached its destination and workmen are preparing to set it over the exact spot to be drilled. Pulled by three large catapillers, the rig was moved from its last location to the new site, a distance of approximately 11/2 miles, in about four hours.

Scheduled to drill to an undetermined depth, the well is located approximately one mile off the Crane highway and brings oil activity in this part of the county a little closer to Rankin.



Texas Military Men Can Vote Attorney General John Ben Shepperd in a recent opinion said that the Texans in military service are now qualified to vote if they meet other constitutional requirements. Until adoption of a constitutional amendment in last November, Texas barred citizens from voting while on active military duty (regulars).

The Attorney General's opinion is that the amendment is "self enacting" and became effective on November 19th, the date votes were officially canvassed.
