DOG VACCINATIONS OF DOGS TO BE AT FIRE STATION ON FRIDAY

April 12, will be "Needle Day" for dogs in Rankin.

Agent Dub Day, working with the City of Rankin, will be on hand all day at the fire station to "shoot" dogs and give them the vaccine. Charge for this

service will be \$1.50.

At the same time, all dog owners will be able to purchase their city dog tags. Price of the tags will be \$1.00.

For the past two months, an extensive drive has been made by city and county officials to rid the area of all stray dogs as well as any found running loose on the streets. This drive has resulted in a much lower dog population for Rankin in an effort to control rabies.

Officials were still undecided this week whether or not to extend the emergency which has required all dogs, whether tagged or not, to be confined to the premises of the dog owner.

PLATE SALES IN UPTON COUNTY

Sales of 1957 auto licenses for Upton County were reported at 3503 for the week, according to the tax assessor.

Reduction May Be Avoided

First Cutback In Mail Service Due Saturday

Unless new appropriations of money are forthcoming from the Congress, Postmaster General Arthur Summerfield has ordered a curtailment of postal service beginning Saturday, April 13. The Rankin post office will be included in the service cut-back.

Effective Saturday, the local office will not be open for business. Incoming mail will be put into boxes and outgoing mail dispatched. The sale of money orders to the public will be discontinued April 29

as will the acceptance of third-class mail with the exception of medicines, seriums, drugs and medical supplies. These are the only 3 curtailments of service that will affect Rankin although a number of others are to be taken by the Postal Department.

Postmaster General Summerfield has called for the service cuts because Congress has refused to grant his request for additional funds to operate the Postal Department as it now functions through the last fiscal quarter of the year which ends June 30, 1957. The appropriations committee of the Congress is still discussing the matter and definite decisions may be reached at any time.

MERCHANTS TO CONTINUE EFFORTS FOR BETTER CREDIT REGULATIONS IN RANKIN

In their second meeting, members of the Rankin Credit Bureau made plans last Monday night for a number of projects affecting credit ratings and credit buying in Rankin. One of the steps taken was the decision to run a series of advertisements pointing out the advantages of good credit ratings and prompt payment of accounts. "Credit buying is becoming more and more the principal means of

doing business throughout the country," pointed out Merle Brown, local head of the Credit Bureau. "This means that better credit regulations are needed by the merchants and good credit ratings are becoming more valuable to customers."

"It is not the aim of the Credit Bureau to injure the credit reputation of customers but rather to help them in establishing good ratings," she said.

It was also pointed out that it is of benefit to new people moving into Rankin to call the Credit Bureau and give them information concerning themselves.

Another point discussed by the group was the fact that progress has already been made by the organization toward better credit conditions in Rankin and that with the cooperation of all the merchants and business firms here, still further results may be expected.

Among the recent plans put into action by the group is the reporting of all delinquent accounts to the local bureau. Once an account is turned in, it is put on the files concerning the paying habits of the particular individual. This information is then made available to all local merchants as well as those throughout the state.

"It is for this reason that it is most important to credit buyers to keep their accounts in good order," Mrs. Brown said.

RANKIN POSTAL RECEIPTS GAIN

Postmaster Grace Roach released the figures for receipts at the local post office for the first quarter of 1957 this week. They indicate a definite increase in business for this post office.

In the first quarter of 1957, the Rankin office did a total business of \$4,726.54. This was an increase of \$1,014.92 over the \$3,711.62 for the first quarter of 1956.

Last month also showed a slight increase over March of last year with \$1,477.06 reported this year as compared with \$1,431.24 for March, 1956.

An indication of new people in Rankin is found in the fact that 10 new boxes have been rented in the first 5 days of April. Among the new crews in Rankin are Southern Geophysical and Ard Drilling. They have moved in since April 1.

A MESS

These days it is almost impossible to pick up a newspaper without seeing a headline concerning government taxes and spending. Lower taxes are talked on every side but none are lowered. Cuts are made in the big bellied budget and are later restored by some committee further down the line.

The post office department says its going broke and foreign aid planners say they must have more money—more money to give to chigger scratching Arabs who repay the good favor by killing those who try to help them as was the case a week or more ago.

The United States has poured

more money into foreign aid than a lot of nations have and still has failed to buy any friends abroad. What are we trying to do—what is the aim—when do we reach the goal. We hear that we're saving the foreign countries from Communism. Saving them from Communism—maybe—but for what? To become a nation like Egypt with a dictator like Nasty Nasser?

In what way is good old Nasty any different than a Mussolini or Hitler. We say we should have stopped them before they got started—yet—when the British and French tried to stop Nasty—we jumped down their throat. We say Nasty is doing a lot of good for Egypt. Mussolini and Hitler did a lot of good for their countries for a short time and in just the same way as Mr. Nasser is now doing in Egypt. They gave the Italians and Germans a strong sense of nationalism while at the same time making nothing more than their personal slaves of the people. So, likewise is camel driver Nasty Nasser.

Yet—we, the federal government, have forced everyone to keep their "cotton picking hands" off the little feller. And to keep him from crying—we'll most likely hand him a lolly pop in the form of several hundred million American dollars—all donated by the good citizens of America.

Yep, the federal government has some wonderful plans. They figure that the best way to do business is to take \$100 away from a taxpayer, ship it to Washington, cut it up into little pieces, send a piece back to the taxpayer, fling the rest of it to the four corners of the world and keep a string tied to every little bit of it. (Of course, in the meantime, they manage to spend another \$100 that they don't even have and have no way of getting.)

These foreign friends we try to buy are wonderful people. For the past 100 years, the United States

has been on "friendly terms" with the Phillipines. During that time, we have sent forces there to fight rebels, defend their land and feed them when disaster struck.

Yet, from personal experience during the last war, we know that you didn't wander around many places in the Phillipines without carrying a gun at a time when we were "liberating" them from the Japs. Three days after the war ended, we walked down the streets of Yocohama and Tokyo and later the country villages and received more respect and show of friendship than we ever did in Manila.

Put another \$100 in the pot, boys—we're going out and buy some more playmates.

When and where in the world will it ever stop? It will only stop when enough people in Rankin, in Upton County, in Texas and in the United States get mad enough to get up off their bowing position and raise sand with their men who go to Congress.

As long as a congressman does not hear grumbings from the people at home, he thinks he's doing

what they want him to do. He is perhaps the world's most sensitive person to pressure and once the pressure from the home folks hits—he jumps.

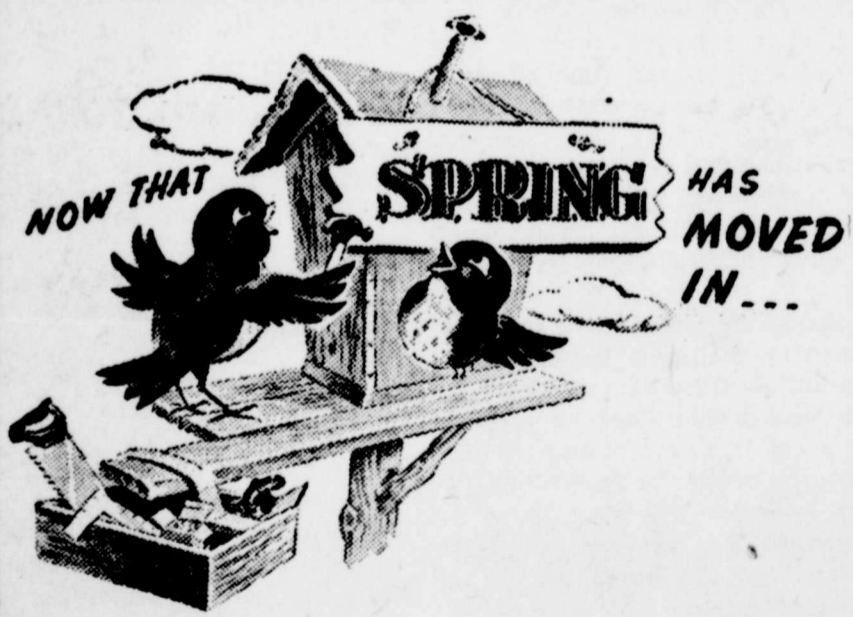

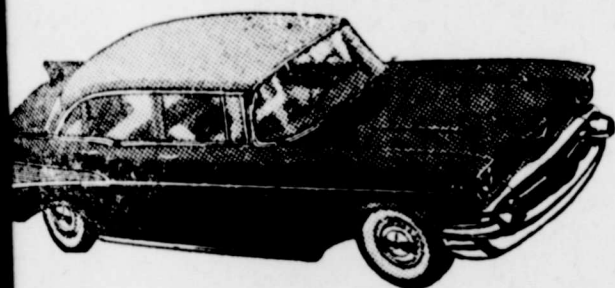

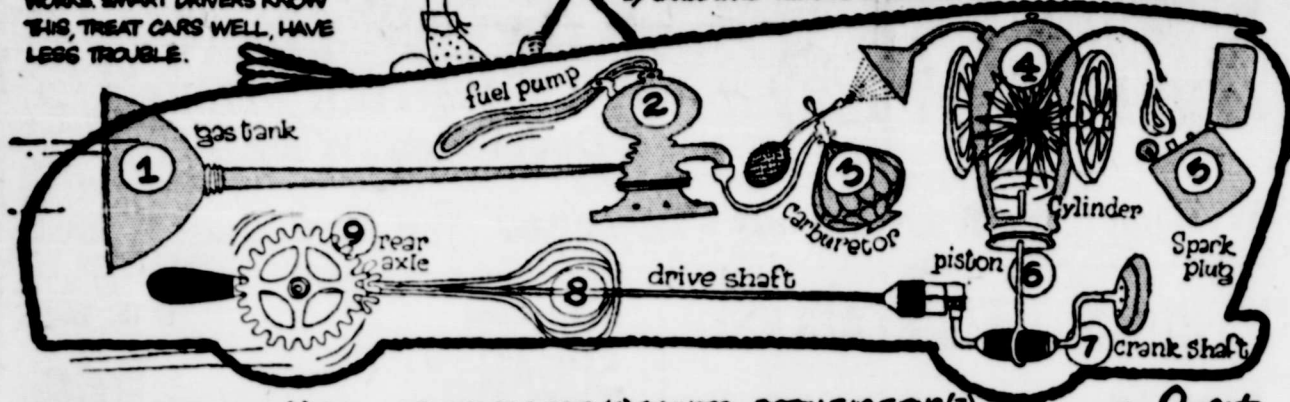

Soil Supervisors Will Meet Monday; To See New Plow

Supervisors of the Middle Concho Soil Conservation District will meet in Rankin Monday, April 15, in their regular monthly meeting. Meeting time has been set for 2:00 p.m. in the office of the local SCS officer in the Rankin Park Building.

At the meeting, discussion will be held on the forthcoming demonstration of a new-type rootplow suitable for work on much of the range land in this area. This plow, a smaller version of the large unit which was in service here last summer, is reported to be much more economical to operate than its big brother.

A full scale demonstration will be held in the near future with invitations going to the public to attend.

Results from last year's rootplowing have proved most satisfactory according to Sam Fitzhugh, local conservation officer, with indications of good grass returning to rangeland this summer which was used in the test plowings.

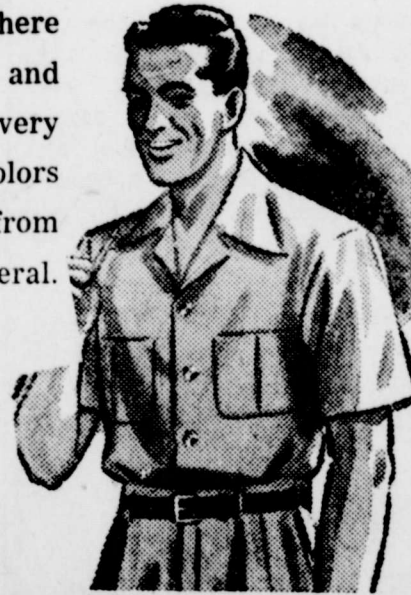

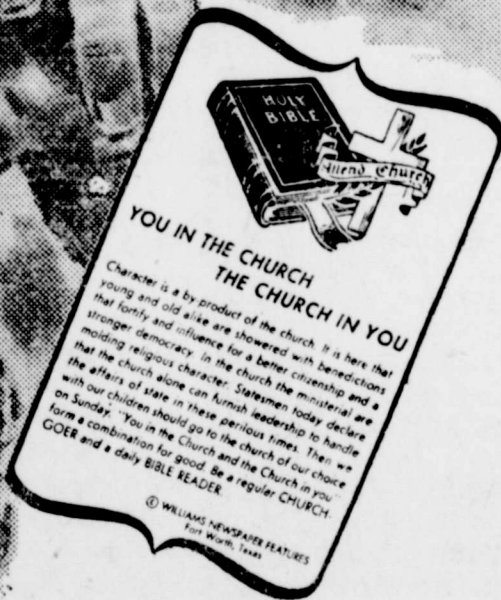


BIG LAKE WOMEN WILL HOLD GOLF TOURNEY SATURDAY


Tee-off time in the golf portion of the day has been set for 9:00 a.m. Entry fee is \$2.50. Names of golfers and bridge players must be in by April 10.

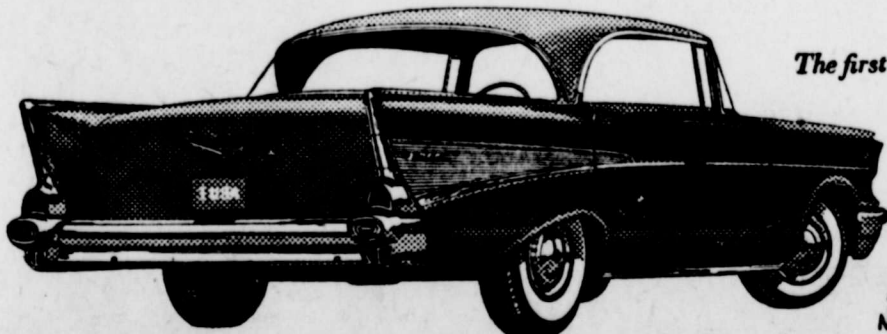
