# **RUTHERFORD GIVES VIEWS** WASHINGTON SITUATION

Visiting his 19 West Texas counties during the temporary recess of Congress, U. S. Representative J. T. Rutherford says he hopes the national legislative body will "put aside partisan politics during the remainder of this session".

"The times and events call for full attention to our problems by responsible men," Congressman Rutherford said.

Pointing out that the Russians have three times threatened to rain missiles on the U.S. or its overseas bases in recent weeks, Rutherford said that only "by dedicated and cooperative unity may those of us in Congress help to

fashion the fabric of peace". He said he feels the American people will "repudiate any candidate or party attempting to use the remainder of the session for political gain."

Congressman Rutherford will remain in West Tevas until he returns to Washington for the reconvening of the U.S. House of Representatives on August 15. He hopes to see as many West Texans as possible while here, to seek their advice and counsel on matters of interest to them.

Rutherford said he has tried to cast votes this year that would "strengthen our hand in any show-(Continued To Page 5)

## Capt. John Coffee Hays, Ranger

#### "As a mounted soldier the Ranger has no counterpart in any age or country!

TEXAS LAWMEN

The real Ranger — not the gun-fanning, hip-shooting tough guy of fiction — has been recorded in Texas history as a quiet, deliberate, gentle person who could gaze calmly into the eye of a murderer and with unhurried courage ride straight up to death. Such a man was John Coffee Hays. He was a frontier surveyor for the Republic of Texas at 21, a Captain of Kangers at 23, a famous Indian fighter with the Army and a Major at 25. The deleat of the Comanches at Enchanted Rock and Bandera Pass, the Plum Creek fight and the battle of Salado are a part of his record. During the war with Mexico, 1846-48, Hays commanded the 1st Reg. Texas Mounted Volunteers and distinguished himself at Monterrey and Mexico City. Mustered out, a 31-year-old veteran with the rank of Colonel, Jack Hays next served as a commissioner to settle the boundary dispute between Texas and the United States over the New Mexico Territory.

After that, it seems as if Texas became too quiet for this "quiet, deliberate, gentle person." During the Gold Rush days of '49, Col. Hays led a caravan to California to begin the second half of a kind of life that "has no counterpart in any age or country." The state honored his name with the creation of Hays County, in the Texas Hill Country.
