

# **Big Money Comes** From Animal Sales In Sheep Business

BY W. M. DAY, JR. County Agent-Upton County

Sheep growers get over twice as much money from the sale of animals as they do from wool.

Last year's cash receipts from marketing of sheep and lambs, including farm sales of lambs and mutton, were over \$336 million. In addition, sheep raisers consumed almost \$4 million worth of their own lambs and mutton, so that their gross income from the sheep enterprise totaled \$340 million. This was a little less than in 1958 but more than any other year before 1952

About two-thirds of the income from sheep during 1950-54 came from the sale of animals. Since then Government payments to encourage wool production have part of the \$32,777 million receivwool somewhat.
