Student Shot Requirements Mailed Out by Schools

were mailed out this past week by Rankin Schools explaining the new state law that requires immunizations for all students enrolled in schools and institutions of higher learning. This requirement must be met when school opens this fall, with few exceptions.

Certificates from a doctor or other valid medical records must be submitted to show compliance with the law.

Shots required are polio, diphtheria, two types of measles and smallpox, Kindergarten through grades Five must have had three palio and diphtheria doses since the age of four; one Rubeola and

Letters to students and parents one Rubella measels shot (or illness in the case of Rubeola) thru age 12-anytime. One small pox vaccination within the last 10 years is required.

> For Grades Six and above-including college- the polio requirement is three doses since age 4. For diphtheria, three shots are required within the last 10 years while the Rubeola measels is one vaccination anytime or one illness-thru 12 years of age. For Rubella, it is one vaccination. Neither type measels require attention for those 13 and older.

All grades Six and above must have had one smallpox vaccination within the last 10 years.



Frankly, I can't see how any investigation into the spending of tax money can be political-be it an investigation of the McCamey Hospital, the Rankin Hospital or what have you. I seriously doubt that the Grand Jury is out to get anyone's scalp; however, when tax money is spent, there are certain rules and regulations that must be followed and if these are not being followed, then, certainly, there should be some action taken to see that they are.

If it takes a Grand Jury investigation, then that investigation should be made and it would appear to me that any board or taxing body that is not in line with the legal requirements would want to get right. The only thing that amazes me about the entire matter is that it took so long for the investigation to come.

And it should serve as fair notice to one and all that if they spend tax money, they should do it legally and properly or be prepared to get hauled up before a Grand Jury and set straight. In the case of the McCamey Hospital, it may well be that they are already legal and proper, in which case they then might have a right to say it is all a political witch-hunt but I doubt that any public fund-spending body is 100
