Gone are the simple old days when one paid his poll tax on or before January 31, got his receipt and was ready to go to the polls at any time.

Since those by-gone days, numerous "improvements" in voter registration have been made, both by the State and Federal governments. These changes never seem to be completed, and as a result, each year see new regulations and requirements handed downsome not very clear and some still unanswered.


In the Grandfalls Tournament last week-end, the Girls A team pushed past McCamey B squad, 49-36 then lost 47-60 to Crane.
