A FELLOW name of Richard Starnes writes (in his syndicated column) a few comments about the coming April 15, which isn't as far away as most of us would like for it to be.

Hale Center Stops Sudan In Finale

The Sudan Hornets closed out a disappointing season with an 18-14 loss at Hale Center last Friday night, but the Gold and Black did turn in one of the season's best efforts in the finale.

Coach Henry Hall's charges struck like lightning on two long scoring plays in the first half, and a third thrust at the goal line in the last half was stymied about half an inch from the promised land.

Early in the game, QB Mike Smith tossed a perfect strike to HB Larry Morgan who caught the ball on the dead run shoulderhigh and outran all defenders on an 80-yard play. Mike Bellar kicked the point, and Sudan led

Christmas came early for Hale Centera few minutes later when Sudan fumbled on its own 17 and the Owls recovered, scoring two plays later as FB Leroy Taylor waltzed across from the 5. Frank Cantu and Kenzel May stopped an extra point running effort and Sudan led 7-6.

In the second quarter, Hale Center went into the lead, with HB Buddy Dukes going 5 yards at the end of a short 28-yard drive. May again led the charge that stopped a runuing effort and it was 12-7, Owls,

The lead was plenty brief, for on the ensuing kickoff, Smith bobbled the ball, finally picked it up at the 12, ran to the right sideline, where he appeared trapped around the 20 yard line. But he suddenly reversed himself completely and ran back toward the left sideline, where he broke free and ran all the way to score, The play covered 88 yards downfield and about 50 yards sideways. Bellar again split the uprights and it was 14-12 Sudan at halftime.

Hale Center took the second half kickoff and moved quickly to the Owl 46. Then the quarterback lofted a pass to HB J. D. Davis, who juggled it at the sideline, finally wrapped it in with one hand and sped straight down the corridor for \$4 yards and the winning touchdown, A run failed, and it was 18-14.

Late in the third, the combination of Smith to Morgan clicked again, with Morgan racing 48 yards with the aerial down to the Hale Center 6, FB Danny Masten made 1, then smashed to the 6-inch line. But Sudan failed to score in two more plays, one by Masten and one by Smith, although a few admittedly prejudiced observers thought Masten went over on the third down effort, Anyway, never again did Sudan have it so good, and that wrapped it up.

Masten was the Hornets' leading






