THE PLAGUE which killed so many persons during the Middle Ages again is spreading, according to reports from the World Health Organization.

Responsible for the deaths of one-fourth of Europe's population in the 14th century; the plague 's fatality rate had been reduced to 4,628 cases around 1950. But around 1960 a rise in the incidence of the dread disease was noted. Three persons died of the disease in the United States during 1966,



Living closer to Amherst than Sudan in the early days, the family traded in Amherst as there were no roads, just trails and the route to Sudan was so winding then that it added up to several more miles than the present route of 10 1/2 miles.

The Humphreys remember their first trip to Sudan and seeing the old General Store, the Hotel and the Railroad depot.

The two older children Arlis and Dorothy started school at Amherst, but after one year a group of farmers built roads and the two then rode busses and attended Sudan schools. The Humphreys resided in the Sudan school district and since the enrollment of these two in 1925 there has always been an Humphreys child enrolled at the school. This year the son of John is attending; and next year. a great-grandchild will move into line and attend the schools. He is the oldest son of John Allen Humphreys andwife, Sandra (Haragan) Humphreys.

The "Big House" built by Mr. and Mrs. Humphreys in 1925 was considered a "mansion" in those days having six rooms and the Humphreys still reside in the house, modernizing it from time to time. The two helped organize the Church of Christ in Amherst where the family attends church and plans are being made for a reception for the couple to be held in the church April 16 on the occasion of their fiftieth wedding anniversary.


