That in accordance with an order adopted by the City Council of said City. the said election shall be held at the following place in said city and the following named persons are hereby appointed officers for said election.
In Election Precinct No. 1 at the City Hall building in saidd city with Mr. Velson Welch, Presiding Judge; Mr. Ceorge M. Baker, Judge; Mrs. Cari Fairchild, Clerk and Mrs. R.B. Mckee, Clerk.
That said election shall be held in accordance with the election code of the state and only resident qualified voters of said city shall be eligible to vote at said election.
