Morton Carries 67 To 0, Lehman **Defeats Proposal**

The second proposal in two ears to consolidate the Morton and Lehman schools into one listrict was voted down in an election Saturday at Lehman.

Lehman voters cast 56 ballots against the proposition and 36 ote for the consolidation and thereby defeated the plan even though Morton voted 100 percent for it

The State law provides that the proposal must be carried in both districts before the consolidation can go into effect. It would have meant that school children of both Lehman and Morton would go to one school and the district would be called Morton Independent School District.

In the balloting at Morton Saturday, 68 votes were cast and 67 were for the consolidation. One ballot was multilated and had to be thrown out. Lehman also reported one mutilated vote.

The first Lehman-Morton con solidation proposal was voted on in 1946 after a petition had been presented to the county judge. In that election Morton carried the vote but Lehman voters defeated

Farmers Urged to Raise More Pigs By C. F. Brannan

Secretary of Agriculture Charles F. Brannan has again urged farmers to increase the fall pig crop by at least 10 percent. Holding back, rather than selling, bred sows and gilts now on hand offers the first and most rapid means of increasing the Nation's red meat supply, the Secretary pointed out.

Farmers can plan to expand the number of sows they keep for farrowing this fall with increased confidence, according to Secretary Brannan. This belief is based on (1) excellent prospects for 1948 feed crop production, (2) the probable strong demand for meats next year, and (3) assurance of continued price support.

Under recent legislation. Government price supports on hogs continue during 1949 at 90 per-cent of parity. This is the same level of support that has been in effect the past several years. Supports during the hog marketing year fluctuate seasonally, but the present annual support level is \$16.85 per 100 pounds, Chicago basis. The current 6-month pricesupport period extends through September

The well was bottomed at 4,. 960 feet in lime. It has a string of 51/2 casing cemented at 4,883 feet. The rotary rig has been moved off and a cable tool unit has been installed to use in test. ing. Cores between 4,883 and 4,-929 feet has shown signs of oil. Water has been encountered below that level.

It is expected that the bottom of the hole will be plugged back above the water level.

Typhus Fever Cases Total 182 Mr. and Mrs. Presley Tharp

For This Year

AUSTIN-Statistical informaion compiled by the State Health Department shows a total of 182 ase sof typhus fever so far this ear. During the week between July 17.24, seven new cases were reported, one-half the seven year edian of fourteen for the week of July 24

The disease reaches its peak in the month of August, Dr. Geo. W. Cox, State Health Officer, said.

Over a five year period from 1943 to 1947, typhus fever has been responsible for 273 deaths. The death rate has been reduced from sixty-three in 1943, to thirty in 1948

"Typhus fever as we know it in Texas is transmitted by the fleas of infected rats." Dr. Geo. W. Cox, State Health Officer, said. "It can be controlled by the simple expedient of consistently maintain. ng a program of rat poisoning. rat trapping, and rat proofing."
