Appraisal District meets

Shelia Faulkenberry told the board members present at the December 5 meeting of the Floyd County Central Appraisal District board "The lawyers from Amarillo who represent the district entities in tax collection matters have asked that the entities consider the seizure and sale of personal property on which the lawful taxes have not been paid as a means of collecting. The lawyers tell me there are now 306 delinquent tax suits filed and pending. 142 of these have made arrangements to pay their taxes, but the rest have made no attempt to pay the taxes or to work with us in getting them paid," said Faulkenberry. "The lawyers feel that the next available course of action on such long standing cases is to seize the personal property in question and hold a sheriff's sale in an attempt to collect the taxes due."

"The Appraisal District is responsible only for the collection of taxes. Suits for delinquent taxes and seizure or sale must be filed by the tax entity not being paid, such as the county tax office, the schools, or the hospital," added Faulkenberry.

Eddie Teeter stated the opinion, "We all have to live in this county, and we don't need to lose any businesses or any residents. I think we need to seriously consider this, but I am not ready to consider making any recommendations at this time."

Tom Duvall, chairman of the board said, "We need to have all the members of the board present before we discuss a matter like that."

"I have had some of our taxpayers tell me that they don't mind paying the

taxes as long as everyone does, but they resent paying when others do not pay and nothing is done about it," said Faulkenberry.

The board agreed to wait until Jack Lackey and Adrain Helms who were not present could be brought up to date on the situation before a decision was reached.

"The Floyd County Central Appraisal District is already realizing a savings of about \$20,000 in lease fees with the computer we have purchased. Now, because of the redistribution of the workload in connection with the use of our own in house computer, we will be able to reduce the staff of the district by one employee, effective January 1, 1985, for an additional savings of more than \$7,000," said chief appraiser Shelia Faulkenberry.

She reported that tax collections are 58% complete at this time. A year ago, collections were 62% complete.

The Appraisal District voted to purchase a new letter size filing cabinet for use in the office. Also approved was the payment of a \$300 membership fee in the Texas Association of Appraisal Districts. The board was reminded of the need for appointing a voting delegate to the TAAD Conference in February by Faulkenberry.

Eddie Teeter proposed the payment of Christmas bonus checks to the six district employees. "They have done a good job this year, and I think we should show our appreciation if we want them to continue to do a good job for us in the future," said Teeter. Payment of \$200.00 bonus per employee was approved on a motion made by Fred Zimmerman III.

Commissioners open elevator bids

Bids were opened for the elevator and renovation project at the Floyd County Courthouse on November 29. Nine companies submitted bids at the time of opening following the 4:00 p.m. deadline. The base bids covered the elevator and installation as well as the exterior ramps. The alternate bid covered the interior modifications necessary to bring the restrooms, water fountains, and doorways up to standard for use by handicapped individuals. All bidders complied with the bond requirement by providing a bond equal to 5% of their total bid.

Reynosa Construction of Amarillo bid \$116,129 on the elevator project and \$15,590 on the modifications for a total bid of \$131,719. Work completion time was listed as 180 calendar days.

Sam J. Smith Construction of Amarillo submitted a bid of \$142,564 on the elevator and \$20,466 on the modifications for a total bid of \$163,030, completion of work requiring 210 calendar days.

Wiley Hicks Jr. Incorporated of Amarillo bid \$115,175 on the elevator and \$22,155 on the modifications, making a total bid of \$137,330 with work to be completed in 210 days.

The Ritter Company of Amarillo bid \$122,990 on the elevator and \$19,990 on the modifications for a total bid of \$142,980 with 160 days for finishing the work.

Pharr and Company of Lubbock bid \$118,795 on the elevator and \$14,100 on the modifications. The bid totaled \$132,895 and work would be completed in 240 calendar days.

Perry Cates Construction Co. bid a total of \$152,000 for work to take 180

days. His bid on for the elevator was \$127,500 and for the modifications was \$24,500. Cates operates out of Amarillo.

Lubbock Development bid \$115,574 on the elevator and \$11,674 on the modifications. The work would take 240 days and the total bid by the firm was \$127,248.

All Texas Builders out of Lubbock submitted a bid of \$143,356 on the elevator project and \$12,382 on the modifications. The total bid was \$155,738 and the time to complete the project was submitted as 210 calendar days.

Wardrop and Associates of Lubbock submitted a \$109,876 bid on the elevator and \$19,000 on the modifications, making the total bid \$128,876 with a completion date of 240 days from the start of work.

The Floyd County Commissioners reserved the right to award the bids as a package or as separate projects. The bids will be awarded at the December 10 regular session of the court. The references and past work record of the firms submitting bids will be investigated prior to that meeting.

Several farm work contracts were submitted and approved by unanimous vote of the Commissioners at the November 29 meeting. Bundy H. Campbell requested that a stock tank be cleaned out 1 1/2 miles north of Floydada on the Plainview highway. Johnny Miller of Barwise requested the digging of a trash hole. Eddie Smith asked to have a basement covered over on the Pauline Sparkman land 10 miles south and 1 mile west of Floydada on the Ralls highway. Emma Seitz requested a clean up around improvements two miles



Neighborhood Watch urges caution

Deck the halls with boughs of holly, 'Tis the season to be jolly; Holiday cheer is on the way. Don't let a thief spoil your Christmas Day!

Kind of corny...but it does make a point! Historically, the Christmas season brings out the best of us, and, far too often, brings out the worst. Street crime, especially household and vehicular burglaries, rise considerably during the holidays. Floydada Neighborhood Watch would like to remind all citizens of a few, simple precautions to take in these next few weeks to help prevent property loss from such crimes.

1. During the holidays, there will be a lot of strangers (visitors) in the neighborhoods. Be aware who these strangers are and what business they have in

your neighborhood (who they are visiting, etc.).

2. Be wary of door-to-door salesmen and peddlers. Floydada has a solicitor ordinance. If approached, ask to see the salesman's credentials and approval from City Hall. If he cannot or will not show such identification, call the police immediately (furnishing description, license number, etc.). There are several reasons for this procedure among which are (1) it will confirm the legitimacy of the salesman's business and (2) it will help deter unscrupulous parties from checking out and "casing" neighborhoods for unattended houses.

3. When out shopping and leaving a car unattended, lock all packages in the trunk and LOCK THE CAR even if

you'll be away "for a minute." Don't leave parcels in the seat or back of the rear seat -- that only invites trouble.

4. Display Christmas tree, and the gifts that go with it, in a location that cannot be easily seen from an outside window. If a tree is displayed in a window, close the drapes and turn out the tree lights when leaving the house. Remember, a burglar needs only a few minutes to make the "hit." If he has to take time to search for the tree and its accompanying booty, moments wasted may help save your gifts and valuables.

5. ALWAYS lock and totally secure your house when leaving. THIS IS A MUST.

6. When entertaining (open house, house parties, etc.), most coats, wraps, furs, women's purses, etc. are usually placed on a bed in some away-from-activity bedroom. With a lot of people coming and going, it is simple for someone to enter the house, remove articles of value, and depart virtually unnoticed. Place guests' belongings in a secure room or closet.

6. Do not publicly discuss or publish in newspaper upcoming holiday trips, etc. One never knows who may overhear a conversation about the "ski trip to New Mexico" or the "trip to Oklahoma City to see the folks." Advance notice of an unattended house is music to the ears of a potential burglar or his accomplices.

There are many other tips regarding home security that should be applied year-round -- not just during the holidays. They include:

1. When on vacation, enlist the help of neighbors. Ask them to park their car in your driveway. Pick up any advertising bills or papers. Stop all mail and newspaper delivery. Mow the yard, etc.

Make the house appear "occupied and lived-in."

2. Fill out a home watch form, obtainable at the Sheriff's office. This form will furnish law enforcement officials the dates you will be away, whom to notify in case of fire or other emergency, who is authorized at the house during your absence (yard-boy, cleaning lady, etc.), and other information which will be helpful in the protection of the unattended house.

3. Never answer any questions about your home or family over the telephone.

This is especially important to younger members of the household and babysitters. Establish the caller's identity, say you're busy, and offer to call them back if they'll leave their number. Never let a stranger into your home to make a phone call -- do it for them while they wait outside.

4. Deadbolt locks should be installed on all outside entrances, and special locks should be placed on windows and sliding glass doors. Install a timer device that turns lights on and off at pre-set times.

5. Many insurance companies now offer reduced rates for homes that have installed an approved-type burglar alarm system. Your broker or agent can provide you with details.

6. Report any unusual occurrences in the neighborhood to the police immediately.

Remember, just a little common sense, a regular security routine, a few extra precautions, and an awareness of neighborhood activities will help keep your home and streets safer during the holidays and all year long.

Mexican Pumpkin Candy

from Mrs. B.A. Robertson
Select a round pumpkin that can be cut into uniform slices. Peel pumpkin and remove center. Cut into pieces. Soak overnight in enough water to cover pumpkin, using 1 tablespoon of quicklime for each quart of cold water. Stir well before pouring pumpkin into lime water. The next morning remove pumpkin from limewater. Wash three or four times in clear water. Cover pumpkin with warm water and slowly bring to boiling point. Boil for 5 minutes.

Wash twice in clear, cold water and allow to drain for about one hour. Pierce each piece in several places with fork so syrup can penetrate. Weigh the pumpkin taking equal weight in sugar. Place pumpkin in baking dish or pan that has never had fat in it. Cover with sugar and moisten with water. Cook over very low heat until pumpkin is crystallized (several hours) carefully moving pieces around so all cook evenly. When pieces are tender and crystallized, drain from syrup and dry on waxed paper.



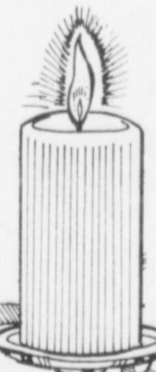

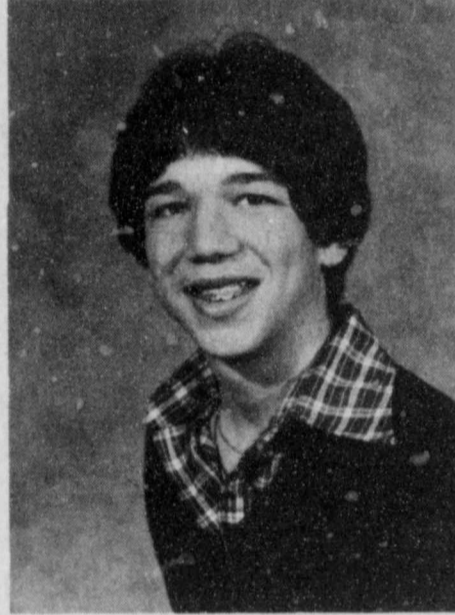

Green Thumbers attend oral history seminar

The Green Thumb Senior Employment Program which serves low income Texans, age 55 and older, is undertaking an oral history project in celebration of Texas' sesquicentennial anniversary. Sponsored by Texas Farmers Union and funded through the Department of Labor, Green Thumb is undertaking the project for several reasons according to program director, Diane Parrish.

"This will be Green Thumb's and Farmers Union's contribution to the Texas Sesquicentennial," said Parrish. "There is a substantial amount of local history - an entire past way of life - that is being lost forever to future generations because most people won't write down their past experiences. But they do love to sit down and reminisce. They're fabulous storytellers. If we can capture these stories on tape, we do a great service in preserving our history and heritage. But we're losing many of this generation each day. That's why we need to begin this preservation now," Parrish added. The project will also serve to provide work-training opportunities for Green Thumb enrollees who will serve as the interviewers.

Oral histories present a true picture of life because they are recorded just as they are spoken. They represent a slice of life in the teller's own voice, told in the teller's own words.

Local public libraries and county historical museums will serve as host agencies for the project. Upon comple-

tion, copies of the taped interviews will be housed in the respective libraries and museums and will be made available to local citizens, historical researchers, and anyone interested in the history of Texas.

Recently, Green Thumb enrollees and interested host agencies attended a training seminar in interviewing procedures conducted by Dr. James Conrad, Director of Oral History, East Texas State University. The seminar was developed to instruct those attending in the gathering and preparation of oral histories. Among the many points of instruction covered were suggestions for obtaining accurate accounts and questions that could be used to make a history more vivid when answered.

Conrad also told the gathered researchers, "An oral history need not necessarily be from an older person. The events of each day are history and need to be recorded."

Attending the seminar from Floydada was Green Thumb worker, Georgia Finley, museum hostess for the Floyd County Museum. Finley and Mary Adams, who also works at the Floyd County Historical Museum, hope to begin work on local histories after the holidays.

"I feel that this project is very worthwhile and should give us a lot of really interesting and little-known facts about life in Floyd County," said Finley.

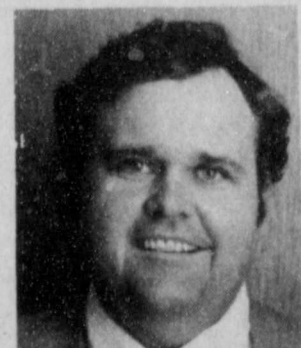
