# Justice Department OKs school vote plan

The "5-2" single-member voting plan for Floydada Independent School District, adopted Nov. 1 by the school board, has gained Justice Department approval. Superintendent Jerry Cannon said a Monday afternoon phone conversation informed school officials of the Justice Department decision.

The single-member system is being initiated this year and will be effective for the April 4 trustee election. In balloting that day, school board members from Precinct Three and one at-large position are to be named to three-year terms.

Under the "5-2" plan, five trustees will be chosen from single-member places or precincts and the remaining two trustees will be elected on an at-large basis.

Anyone in the Floydada school district may declare as a candidate for the at-large posts, and everyone within the district may vote.

## 108,811 county bales

Thirteen gins within the Floyd County boundaries have handled 108,811 bales of 1986 crop cotton, according to a survey conducted by the two county newspapers.

Totals from these same gins for the previous year were not available.

Area crop specialists believe that cotton in this county, particularly in northern sections, was among the best on the South Plains. For most of the South Plains, '86 production was well below normal.

Yields reportedly ranged up to and, in isolated cases, above two bales per acre in northwest sections of Floyd County. Despite devastating October rains, some producers in that area report producing their "best crop in several years."

Yields in certain other sections of the county were

reduced by hail, excessive moisture and an early freeze date.

According to information from the ASCS office, 143,726 acres were planted to cotton in this county.

However, production and ginnings will not parallel exactly because some cotton grown in adjacent areas of other counties was ginned in Floyd County and some crop produced in this county was processed elsewhere. Also, some planted acreage was "disastered" and not harvested.

Participating in the survey were: Brown Gin, Darty Gin, Floydada Cooperative Gins, Hendricks Barwise Gin, McCoy Gin, Scott Gin, Marble Bros. Gin, D&J Gin, Lockney Cooperatives, Lockney Gin, Sterley Gin, Crume Gin and Providence Gin.

## Roster complete for city election

## Three way race anticipated in District 4

With the passing of the final date for filing in the city election on February 18, the roster of candidates is now complete.

THREE WAY RACE ANTICIPATED
A three way race has developed in
District 4 with Nancy Willson being
opposed by Fred Thaxton and Wayne

Tipton. This one year term is the only

position for which more than one person filed.

Current council members are seeking election to positions under the new specifications set forth in the single member district voting system being implemented in Floydada for the first time this year.

Don Green is on the ballot for the

council position in District 1, a one year post. Ginger Warren is seeking election to the council position in District 2 for a two year term and Leroy Burns is running for a two year term in District 3.

Parnell Powell has filed to run for the mayoral post. He has served as mayor of the community since 1973 and is unopposed in this bid for another two year term.

## COSTS INCREASE

City officials point out that with the change to a single member election system and the separation of the city into four districts, expenses for the election will "nearly quadruple" due to having to maintain four polling places and four sets of election officials and supplies.

This added expense is the result of a minority lawsuit filed in December of 1985 to enable minority candidates in the city an equal opportunity to seek election to city offices and to allow minority voters the opportunity to elect a candidate of their choice to city post. These election expenses will be a factor in all future elections in addition to the

## Friday final CRP bid day

Landowners have two more days during the current signing period to submit bids to place acreage in the CRP (Conservation Reserve Program). Bids will be accepted through Friday, Feb. 27, at the ASCS office in Floydada.

Registration for this period opened Feb. 9. The federal program stipulates that land accepted for the CRP must be kept out of production for 10 years and prescribed conservation practices must be followed. This includes planting the land to grass or trees to prevent wind and water erosion, with costs shared by

If the bid is accepted, landowners will be paid that price annually over the 10-year period provided they follow the prescribed conservation plan.

A new "wrinkle" in the program this period is that a bonus is being offered on a one-time basis for corn land. Details may be secured at the ASCS office.

Lotspeich says the ASCS office is open both Tuesday and Thursday mornings — when the office is normally closed to handle paperwork — this week due to the CRP deadline.

# 'Crack' found in speeding vehicle

An apparent routine stop of a speeding vehicle Friday night resulted in the discovery of 112 grams or "about four ounces" of a controlled substance.

Two California men riding in the 1982 Buick remained in Floyd County Jail early this week on charges of "possession of a controlled substance." Justice of the

Peace Lowell Bilbrey set bond for each man at \$100,000.

DPS Trooper Dudley Speed of Motley County stopped the eastbound auto for excessive speed on Highway 70, about 16 miles east of Floydada. He became suspicious that more than speeding might be involved and searched the vehicle.

Under the back seat, officers found what was believed to have been cocaine or another controlled substance. It was individually wrapped and the blocks were in a single bag.

The Sheriff's Department and local DPS assisted with the investigation.

Results of the analysis were returned Monday, and the substance was identified as "crack," according to Deputy Sheriff Raymond Hamilton.

\$112,000 STREET VALUE

An officer with the Drug Enforcement Administration, an agency of the federal government, told Floyd County Sheriff's Department that "crack" is purchased by dealers for "about \$400 a gram," compared with about \$150 per gram for cocaine. He explained that, after processing, "crack" is sold as "hits" — with a street value of approximately \$10 per hit. Each "hit" measures 100 milograms and is

consumed by smoking in a cigarette or pipe.

The DEA agent from Lubbock said each gram contains 100 "hits." Using this barometer, the California men's "crack" had a street value of about \$112,000.

One of the newest forms of narcotics, "crack" is 95 to 98 percent pure. It is "much more potent than cocaine."

Local officers were told that a single "hit" of "crack" causes addiction. It is described as being "the most addictive drug known at this time."

Back to DeWitt County: The war (WW II) was over and every little community in the county thought it was going to grow like a weed. Oil had been discovered in the county, in massive quantities, and many people thought that was all it took. As one might expect, they began to fight among themselves over every potential new business that might be drawn by the oil. While they fought each other Victoria citizens rallied around and landed one supply house after another.

By the time folks in DeWitt County realized what was happening to them the future growth of Victoria and Victoria County was assured. Now Victoria is over 50,000. But the point of this column is to note that they finally did realize what was happening and what they were doing to themselves. To cut down on some of the bickering and concentrate their energies they formed a county-wide Chamber of Commerce and Agriculture, made up of business and agricultural leaders from all over the county and all the communities. Each town continued to have its own Chamber of Commerce, as they should have. But they finally realized that they could get more done by pulling together than pulling apart. After all, a job 10 miles away is better than no job at all.

The enterprise worked well. The DeWitt County Chamber of Commerce and Agricultural became the umbrella organization under which many beneficial activities took place, particularly an effort to provide some degree of economic growth and stability to communities within the county.

We don't know whether the organization is still active as it once was or even if it still exists. Any organization is made up of people, and as the people grow old and tired the organization grows old and tired, unless it is continually refreshed by new people with new thoughts, ideas and energy.

But we have the feeling that something like that ought to be explored here. This county has an abundance of talent and leadership potential. By reaching out all over the county and bringing the very best we have to offer into an organization dedicated to improving the economic life of all our people, we just may make a difference.

Too we might be able to use an organization like that to support those elected officials who give leadership to efforts aimed at improving the economic condition of our community.

Without belaboring the point we would note that we are not the only community experiencing some economic difficulties. Down in Beaumont the other day a big rally was held to try to put some spirit into a community that has been suffering mightily. Beaumont's unemployment rate has been up around 12 percent for quite some time, one of the highest in Texas. The Mayor presided over the affair and it featured big shots from big corporations, Con-



McCoy; Frank E. Murchison, attorney for plaintiff and intervenor; and S. Tom Morris, attorney for defendant.

Morris, who has an Amarillo law practice, replaced Plainview attorney David Teel as the defendant's attorney. Murchison is from Lubbock.

At the conclusion of a Nov. 3, 1986, injunctive hearing, Judge McCoy ordered the defendant to return all books previously removed to the courthouse. He issued an order that the county should match invoices with books and that Miller should make a strict accounting of all books he had previously removed from the courthouse.

Judge McCoy also ruled at that time that "any expenditure of public funds must remain with the public trust. All books paid for by the county must remain in the custody of the county."

Lackey's suit contended that "During Miller's term in office, Floyd County purchased certain law books and provided upkeep and supplementation thereof. These law books and publications were purchased at the request of Miller presumably for use in a county law library; however, these law books were housed in the Floyd County Courthouse in the judge's chambers under the executive control of then Judge Miller.'

Miller served six years as district attorney and 10 years as district judge prior to his Oct. 3, 1986, resignation to enter private law practice in Plainview.

He contended that he entered into an agreement with the county governing body in February or early March 1976 that he would provide the original law library and that the county would purchase supplements and additions after that time. He contended that the agreement should have been expressed in minutes of the commissioners court meeting at that time.

The county paid for maintenance and updating of law books from March 6, 1976, through September 1986.

Miller said during the hearing that "As a matter of course," the books revert to the owner and not the person (or entity) responsible for their upkeep. "I consider that I own the books and

took them with me when I left (office)," Miller stated at that hearing. Lackey, who served as county com-

missioner of Precinct Four until his recent resignation, filed the original suit. It was styled: "Jack Lackey, as an individual taxpayer and citizen of Floyd County, Texas, a county commissioner, Precinct Four, Floyd County, Texas, and as representative of the taxpavers Defendant GEORGE MILLER does and citizens of Floyd County, Texas, vs. hereby expressly relinquish unto

The order was signed by Judge George Miller, Plaintiff's original petition for declaration and determination of ownership, reimbursement of funds, and injunctive relief."

The county later joined Lackey in the suit as "intervenor."

#### RELEASE-SETTLEMENT AGREEMENT

In consideration of TEN DOL-LARS (\$10.00) and other good and valuable considerations paid by Defendant to FLOYD COUNTY, the receipt and sufficiency of which is hereby acknowledged, and in further consideration of Defendant's relinquishment of any right, title or claim which he has or might have to any and all law books and legal publications now in the possession of FLOYD COUNTY in the Floyd County Courthouse, including specifically the following:
