## Floydada has first reading of new zoning ordinance

Members of the Floydada City Council were presented with a rewritten zoning ordinance at their regular monthly session on July 15. A second reading will take place at the August session prior to passage of the new ordinance. The multipage document designates all zoning areas within the city limits of Floydada.

According to city secretary Jimmie Lou Stewart, the revised ordinance complies with all current court rulings. A map of the city with the various zoning areas depicted on it will now be available for city residents to view at City Hall. The zoning ordinance will also be available to the public for examination at that location.

### CENTER PARKING AUTHORIZED

Ordinance #739 was passed by unanimous vote of the council on a motion by Wayne Tipton with a second by Clar Schacht. This ordinance designates the areas in Floydada where parking in the center of the street will be allowed. These areas are to be marked and parking regulations will be strictly enforced according to the wishes of the council.

As previously designated, center parking will continue to be legal around the four sides of the courthouse square. Additional areas where center parking will be allowed include California Street between Second Street and Fourth Street and on Wall Street between Mississippi Street and Houston Street.

Vehicles parking in these areas may be no longer than 18 feet and must park at a 45 degree angle by entering front-first from the left. Exiting the parking space must be accomplished by backing from the space and driving in the direction the

vehicle is headed. Curb side parking will not be allowed in areas designated for center parking.

The newly approved ordinance is now effective following its adoption by the council on July 15.

### PUBLIC GRANT FUNDS DISCUSSED

Kay Howard of Gary R. Traylor and Associates met with the council during

the Monday evening session to explain the 1991 grant program to council members. The firm has worked with the city since 1979 to acquire grant funds for such projects as street paving and water line expansion. The firm receives no compensation for their efforts unless the project request is granted.

Howard told the group that \$1.4 million will be available to fund projects meeting national, state and regional cri-

teria. The money is provided from federal sources and administered by the State of Texas and South Plains Area Governments (SPAG). Awards are made on a two tier scoring system based on several items including matching funds the city is willing to commit to the project.

Among the points Howard stressed that will be considered are the project's

benefit for low to moderate income residents, emergency projects, severity of need and projects meeting basic human needs. Criteria for the regional screening committee were scheduled to be set on Wednesday, July 17.

Howard urged the city to proceed with the setting of required public hearings in order to be moving on schedule for submission of a program request this

year. The hearings will determine the project to be pursued in the application. The council authorized city manager Gary Brown to coordinate the hearings as soon as possible.

## Commissioners appoint redistricting committee

Meeting in special session on Friday, July 12, the Floyd County Commissioners Court appointed a seven person committee to assist the court in approving a plan for the redistricting of the county following the results of the 1990 Census. The first meeting of the committee was scheduled for Tuesday, July 16, at 7:00 p.m.

Appointed to the committee were Fidel Martinez, Jeff Johnson, Kelton Shaw, John Campbell, Jessie Garza, Alex Wall and Margaret Herrera. The task of this committee will be to formulate a plan or approve one of two plans the commissioners court has proposed. The committee will report to commissioners court as they proceed.

### BUDGET WORK SESSION

County Judge Bill Hardin and the four precinct commissioners met with other elected officials and department heads to work on the budget for the coming fiscal year. Present for the session were Sheriff Fred Cardinal, Treasurer Glenna Orman, Tax Assessor/Collector Penny Golightly, District Attorney Becky

McPherson, Librarian Sandra Crawford, County Clerk Margaret Collier, and Justices of the Peace Lowell Bilbrey and Dottie Stansell.

Each went over their previously submitted budget requests with the court. Most departments did not ask for major increases in their funds and most of the requests for increased funding were in the area of extra labor for parttime help. These increases were attributed to the increase in the minimum wage last April.

The proposed budget for the coming year will be based on a tax base reduced from last year's more than \$254 million to \$252,167,302.00 for this year. Officials anticipate a 7.9 percent increase in taxes in order to maintain the current level of services. The working total of the proposed budget as it stands at this time is \$1,608,414.93.

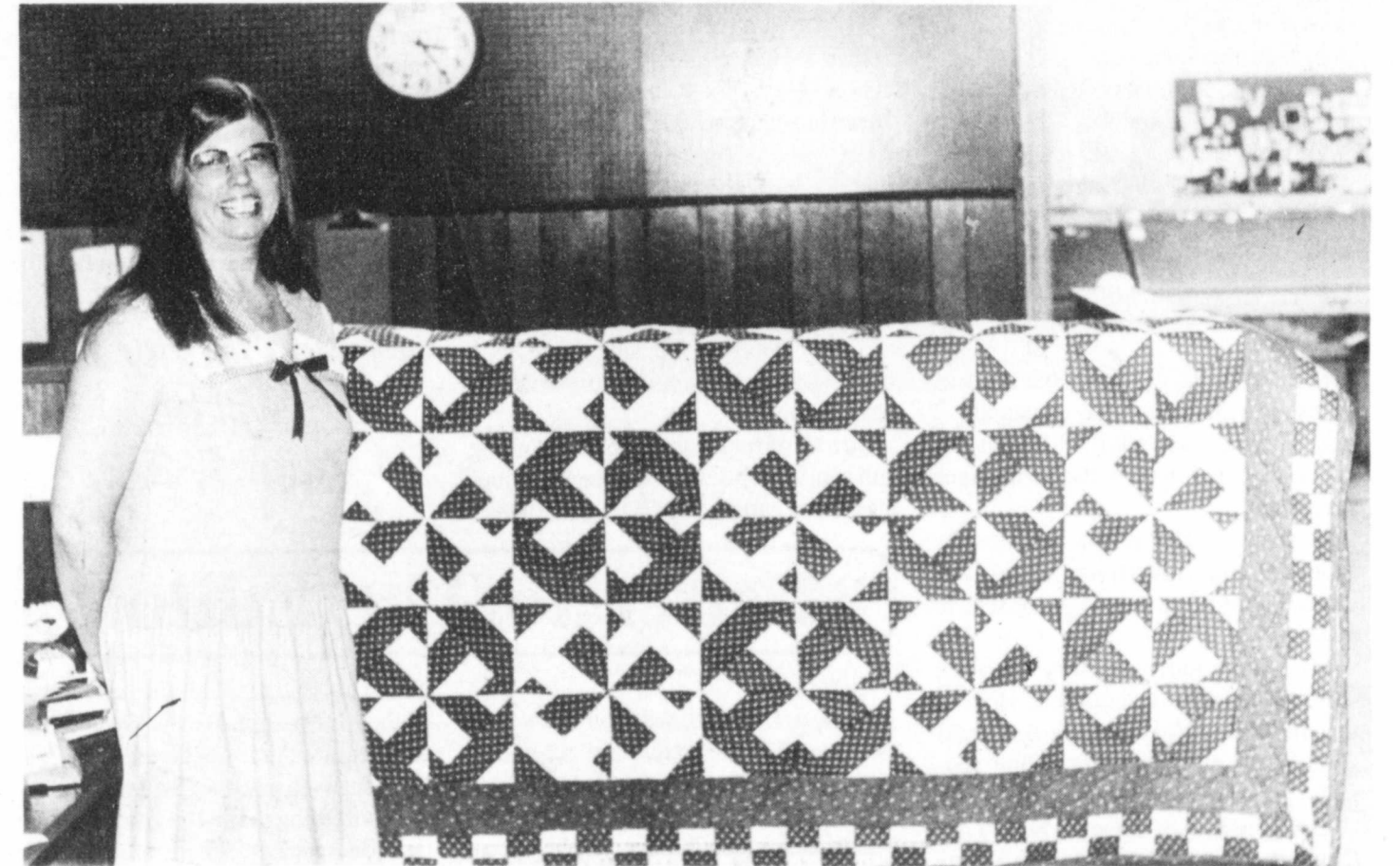
According to Judge Hardin, this proposed budget does include some salary increases. Elected officials will not be among those who will receive salary increases. Only regular fulltime county employees are being considered for a five percent salary increase.

Further budget considerations will be made at coming commissioners court session. Nothing discussed at the Friday meeting has been approved by vote at this time.

In the presence of the gathered officials, Judge Hardin asked that the court review its position on a motion made and approved by unanimous vote at the February 28 session of the court. The motion in question stated that no bill would be paid for any department which goes over the budgeted amount of the line item the purchase will be charged to unless permission to spend the money is obtained from commissioners court in advance.

Hardin said, "I feel that we need some direction from the commissioners on this matter." He then added, "Each office is provided with a monthly accounting so they know what funds they have available, yet over expenditures are continuing to appear in the monthly bills. We either need to enforce this policy or go to preapproved purchase orders."

### CARNIVAL

The E-B Fun Time Carnival will be located on the fairgrounds and will open at 4:00 p.m. Thursday, August 1. Carnival tickets are currently on sale at 2 for \$1.00. Tickets will be half price until

July 31. After the fair starts all rides will be \$1.00. Tickets can be purchased at the Lockney Cooperative, Kellison Spraying, the First National Bank in Lockney and the Floydada Branch of the First National Bank.

### PARADE

I was on vacation last week and was not responsible enough to leave a column here to use in last week's paper.

I had meant to thank Johnny Summers at the Floydada Pay-N-Save for another successful and fun filled 4th of July in his parking lot. I told him, while I was stuffing my face with free food, that I had worried about him having to compete with the parade in Lubbock on the 4th.

He said it didn't matter to him. All he wanted to do was thank the people in the community for their support. Thanks for your support too Johnny!

Also thanks to Lockney parents who organized the Lockney parade of patriotic youths on the 4th. I know it's silly, but when they all rode by in their red-white & blue bikes waving flags I got all choked up. I started to think about living in a small town and how I wouldn't have seen that anywhere else and it made me cry.

\*\*\*\*\*

Speaking of living in a small town—we spent our vacation in Austin. We loved the trip and visiting with my folks but we did notice some things that we don't notice around here.

We would hear police and ambulance sirens wailing all the time. The people who live there don't hear it anymore.

I remember moving here from Houston. The first week here I heard an ambulance going by my house late at night. The next day I was asked if I had heard the ambulance and did I know where it went. It took me a while to even remember that I heard it because I was so used to hearing them constantly. I also thought it was a little different that anybody cared where the ambulance was going.

It takes a while to get used to city living and small town living. I guess you can be happy anywhere—you just have to adapt.

My brother told me a story last week that made me think about this. He said that he had read a story in the paper about how everyone (including animals) get acclimated to a way of life.

The story told of a man in New York City that was walking along the streets when he heard the all too familiar "back-up" sound of the city garbage trucks. He stopped and started looking around to make sure he wasn't fixing to get run over. He couldn't find a truck but he kept hearing the loud beeping. Finally he discovered that the truck was nothing more than a mockingbird mimicking the sounds he was used to hearing.

I read in the newspaper today where the federal health officials were recommending doctors and dentists performing surgery or pulling teeth get AIDS tests and stop such procedures if they're infected. It didn't tell them they had to be tested for AIDS it just said that they should. (evidently some doctors and dentists don't know the risks already)

The story said that the recommendations could affect tens of thousands of dentists and surgeons nationwide. The guidelines urged infected doctors and dentists to refrain from invasive procedures involving blood exposure (such as abdominal, gynecological, heart surgeries, tooth extractions and root canals.)

The CDC wouldn't recommend mandatory AIDS testing for health-care workers, saying, "The current assess-

ment of the risk...does not support the diversion of resources that would be required to implement mandatory testing."

Now I may be simple-minded but it seems to me if they think that the recommendation alone could affect "tens of thousands of doctors and dentists" that kind of blows their theory that the current assessment of risk does not support the diversion of resources (whatever that means).

Now this is my own personal opinion of course—but I find it hard to believe that a responsible health care professional would object to being tested for AIDS, unless of course he knew he had it and didn't want to spoil his career.

So in my opinion if the doctor has AIDS and knows he has AIDS and continues to risk the lives of his patients—he needs to be in jail.

There are probably plenty of doctors who have been exposed to AIDS from their patients and don't know it. I also think a patient who knows he has AIDS and doesn't tell his doctor deserves to be in jail.

So why did the federal health official refuse to make it mandatory to test for AIDS? They refused because they were scared to—that's why. They didn't want to offend anyone who has a "lifestyle" that is conducive to AIDS exposure.

I also know that the only doctors and dentists that will follow up on the "recommendation" of the federal health officials will be those who we never had to worry about in the first place. The ones who have AIDS and know it, will never be tested.

So a lot of fuss was made over nothing and a lot of publicity was given to spineless and meaningless CDC guidelines.

By now I am sure that you know that the federal deficit reduction act was a sham. Congress promised to use the new tax revenue to reduce the federal deficit. The facts are they did exactly the opposite.

Congress enacted the second largest tax increase ever and rather than reduce the deficit, they increased spending by \$111 billion (and that doesn't include the cost of the Gulf War) and pushed the FY 1991 budget to an all time high of over \$320 billion.

It was simple for them to receive us because we wanted to believe that help was on the way finally. However they simply counted reductions in the future proposed costs of operations and said that was a spending cut. Even with their proposed cuts of \$500 billion, spending costs will skyrocket.

There are over 600 separate accounting systems in the federal government and none of them can be audited, even by our own government accounting office. We must force our representatives to push now for a single accounting system using generally accepted accounting procedures. This is the major problem facing us today and it cuts across all racial and economic lines.

The \$600 toilet seat which you probably assumed was not costing us less because of the publicity is now over \$1,000. It's simply on another airplane. The government is using our tax dollars to subsidize the city of Las Vegas by selling them electricity at one cent per kilowatt hour when we all know it costs us much more.

Congress is bankrupting America. One third of all the taxes we send to Washington buy no government services at all. They are used to pay the INTEREST on the national debt. That is

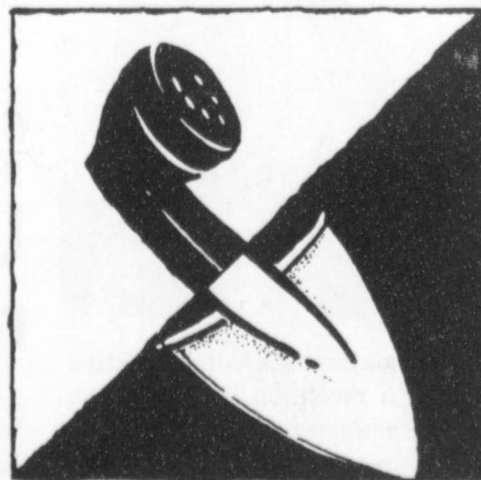

Tired of the same old summer routine? Long for something exciting? Want to get out in the country and experience an event unique to our area?

Well, roundup the kids, throw the lawn chairs and the old umbrella in the back of the pickup, and come out to the eighth annual Burleson Memorial Roping located between Flomot and

Whiteflat. On July 19, 20, and 21, outstanding equestrians will vie for a variety of prizes in five major events.

As in the past, the gate admission of \$1 will go to the scholarship fund of the Ranch and Feedlot Management program of Clarendon Junior College. Honored guests will be the three 1991 Scholarship recipients.

Chad Sheffield of Amarillo, who competed in bull riding as a member of the Tri-State High School Rodeo Assn., finished a four year stint with the U.S. Marines last year.

Robert Long of Hedley, active in FFA, basketball and baseball in high school, plans to continue his family's long standing interest in the agricultural field. Quail Reed of Las Vegas, New Mexico, who earned his State FFA degree and was named Star Chapter Farmer and Top Hand from Grady, N.M., high school, breaks colts, ropes and makes bits and spurs.

On Friday at 9 a.m., 11 categories, including a spot for youth, women and the non-pro, are slated for the cutting horse contest. As an added incentive Mr. and Mrs. D.M. Cogdell Jr. will be donating prize bits for the high money winner of the day.

The Caprock Cutting Association will lend a professional expertise to the judging and scoring of the cutting events. S.C. Burleson, sponsor and organizer, emphasizes that it is not necessary to be a member of the association to participate in the cutting contests.

As the evening cools down in the sandhills surrounding the arena, the crowd pleasing team penning events are scheduled around 6:00 p.m. Here the ranchhorse and cowboy have a chance to shine with skills picked up on round-ups and daily chores when they attempt to cut out three flop-eared bovines from Bundy Campbell's herd. The trick is then to pen them into a small pen in the middle of the arena without having a wreck and post the fastest time.

Youngsters will be rubbing sleep from their eyes as they load their horses on Saturday morning when the books open for the Youth Playday at 7:30 a.m. Three age divisions will share the fun and compete for prizes of halters, trophies and ribbons in the Flag, Stake, Barrel, and Potato Races. Amid the laughter and the tears, triumphs and spills, these kids put on a heart-warming show well worth the price of admission.

Under the cool shade of the hay barn, where the books open at 9 a.m., the Washer Pitch teams will challenge and cajole their adversaries in friendly competition. Sitting in their lawn chairs on the sidelines, the gallery of fans will cheer their favorites on to victory.

Around noon on Saturday, Team Roping will get underway with "One Over Fifty," followed by several other categories. As the infinite variety of header and heeler combinations plan their strategy, spectators will have a chance to enjoy the bar-b-q on the hill overlooking the arena, prepared by the "coosies" from the Lockney Lions Club.

Sunday morning at 9:00 a.m. ropers will pair up for the novice Team Roping

to do some heading and heeling on stock furnished by Carl Alford of Hereford, giving those less experienced ropers a chance to practice and compete in an arena setting.

The introduction of "Pasture Ropers" is scheduled at 1 p.m. with the Novice Pasture Ropers twirling their loops soon after. Hard on their heels will be the skilled Open Ropers. In this thrilling and sometimes "smashing" series, a steer is given a running head start into a wide open pasture before the barrier pops and the header gallops in pursuit. Following close behind is the persistent heeler, even when the critter heads for the watching crowd and their vehicles, parked at a "safe" distance on the ridge overlooking the unpredictable action.

So if you are tired of watching reruns of bad TV shows, drive a little and see a lot at the Burleson Memorial Roping, where something is always happening on the weekend of July 19-21.

The Burleson Arena is located in the caprock breaks of the North Peace River, between Flomot and Whiteflat, on Farm Road 2009. Large signs mark the turn-offs on Farm Road 97, two miles east of Flomot, or on State Highway 70, about two miles north of Whiteflat. Y'all Come!

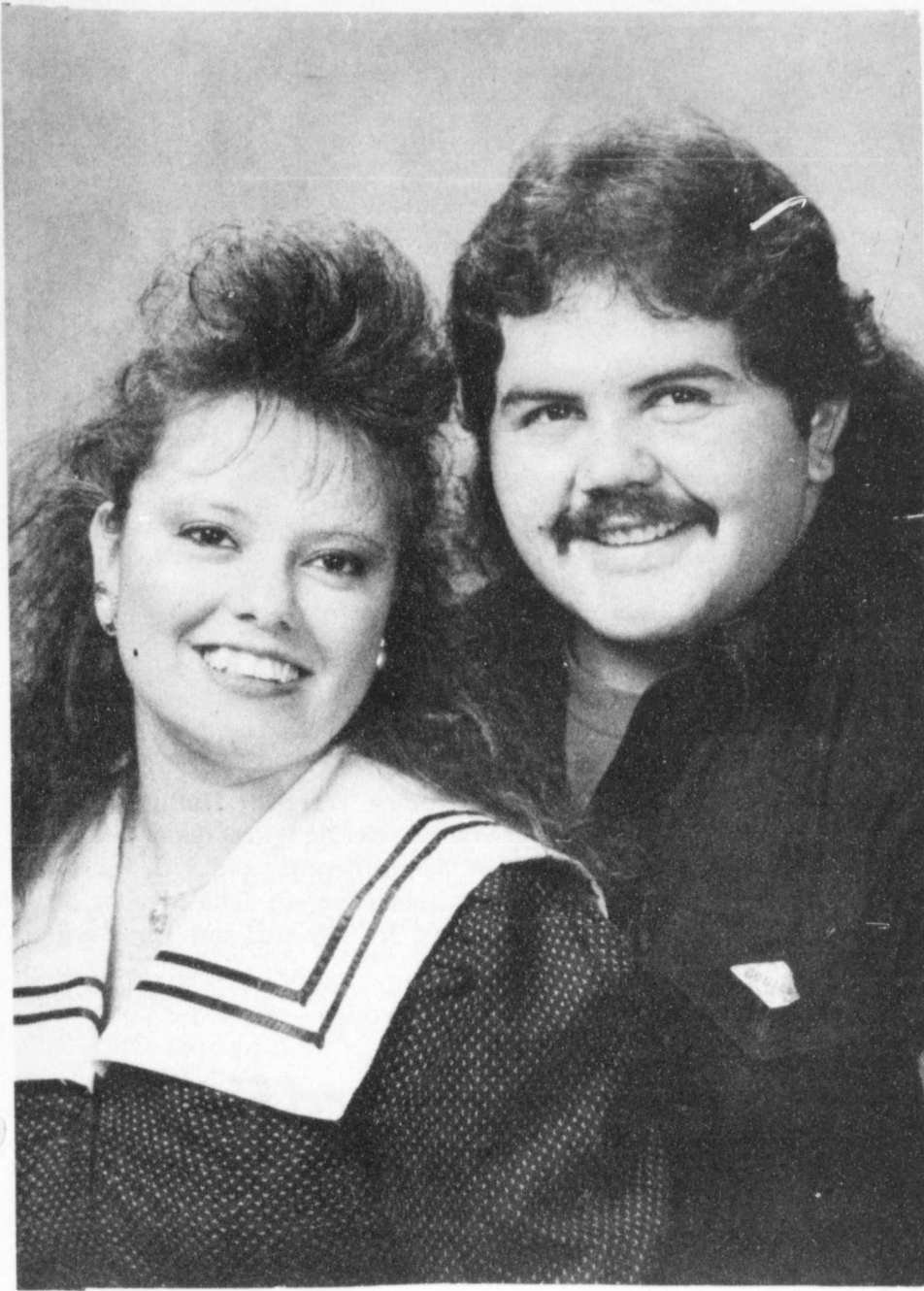

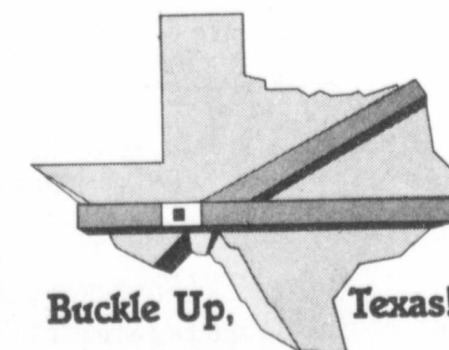

# 'Friends of the Caprock' continues to move forward

The common desire among nearly everyone in Floydada is that the town be re-staffed with medical doctors and that Caprock Hospital be reopened. It is also the desire and the primary purpose of the "Friends of the Caprock".

Friends of the Caprock are in the progress of organizing with their goal being to unite the community and help solve the current medical problem in Floydada.

Monday, July 15, 13 citizens met at the community room of Floydada's First National Bank. Another meeting, which will be open to the public is scheduled for Monday, August 5 at the Lighthouse Electric community room.

At the meeting, Friends of the Caprock agreed on two objectives to help the Caprock Hospital Board of Directors in reopening the hospital: (1) make improvements to medical facilities to enhance doctor recruitment; (2) to purchase equipment as requested by doctors.

To achieve these goals a local fund raising campaign will be kicked in September. The organization will attempt to raise \$250,000.00 to help the hospital and clinic. In order for the campaign to be successful, Friends of the Caprock feel it will be very important for almost everyone to be involved in one way or another.

Citizens who want to donate will be allowed to designate their donations to an area that they feel will be the most beneficial to the hospital. In much the same way that members of a church mark their tithing envelopes to go toward mission work, general fund, building fund etc., citizens who donate to the hospital fund can specify funds to: (1) clinic remodeling (2) X-ray machine (3) anesthesia machine and other monitoring equipment (4) equipment requested by doctors and (5) a general fund.

The biggest and immediate need for the hospital, once it reopens, is the purchase of an X-ray machine. This one piece of equipment will cost approximately \$125,000.00.

The request for these hospital needs have come from Hospital Administrator Terry Keltz and the hospital's board of directors. Friends of the Caprock are working closely with the hospital board

in order to accomplish these goals.

The officers of Friends of the Caprock committee are Laura Farris, chairperson; Bud Crump, vice-chairman; and Edd Henderson Jr., secretary.

The various committee chairmen are Nick Long, publicity; Trena Simpson, hospitality; Bill Harbin, civic clubs; Travis Jones, farm drive; Sheree Cannon, school drive; Judy Beedy, residential drive; Susan Green, area doctors. The person to chair the business district remains undetermined.

Other citizens who have been meeting with Friends of the Caprock and make up the remainder of the executive committee are: Clar Schacht, Fred Thayer, Adolpho Garcia, DeDe Covington, Bill Hardin, Betty Marquis, Gladys Jones, Mike and Barbara Coconouger.

Despite the two previous visits of prospective doctors, the hospital board has yet to extend an invitation to a doctor to join its staff and neither doctor has made a decision on coming to Floydada.

Two other doctors from Lubbock have visited Floydada to reopen the clinic for basic medical care, but no arrangements have been finalized on this possible plan either. At this time, Methodist Hospital has no other potential doctors lined up, but their search continues.

Friends of the Caprock would like to extend thanks to everyone who has assisted in the two previous "welcomings" to prospective doctors: the Women's Chamber of Commerce for decorations and food for the public receptions; Lighthouse Electric for providing its community room for receptions; Meth-

odist Hospital for providing financial support and bringing in the prospective doctors;

Ladies of Caprock Hospital who have fed the doctors while the hospital board met with the prospects; and Mayor Wayne Russell, Gary Brown and Bobby Welborn for assisting in private parties.

Even though an organized fund raising campaign has not kicked-off, numerous memorial contributions have already been made to the hospital fund through the Floydada Chamber of Commerce. Anyone wishing to donate can contact the chamber of commerce at P.O. Box 147, Floydada, Texas 79235.

While Friends of the Caprock continue to organize they are asking local civic organizations and groups to be prepared once the campaign begins and to consider fund raising drives to help meet the \$250,000.00 goal.

Ridley Gibson of Floydada Cable TV came before the council to advise the council of his firm's plan to increase local basic cable rates within the city limits from \$14.00 to \$14.75 per month as of August 1, 1991. Gibson told the council that rising costs of supplying cable service and the addition of the weather channel has necessitated the increase.

Gibson also told the council that the office in Floydada was once more a "full time operation". He stated that the office is now open from 8:00 a.m. until 5:00 p.m. and that a full time service technician is now on duty in Floydada to serve the needs of customers.

No council action was necessary at

this time.

### OTHER MATTERS

The council authorized the sale of three tax title lots located in Block 7 of the Honerhea Addition to Floydada to CapTrans, a community service organization out of Crosbyton. The company intends to erect a building to house the programs they maintain in Floydada. The firm offered \$500.00 for the three lots. Motion for the approval came from Eric Cornelius with a second by Amado Morales. The sale will be effective when all taxing entities have approved it.

Approval for advertising for the demolition of a structure at 615 E. Jackson Street was given by the council. Bids will be taken for the action and opened at the next regular council session. Motion for the action was made by Amado Morales and seconded by Eric Cornelius.

City secretary Jimmie Lou Stewart presented the annual report on the city employee retirement fund. This report details the employee and city participation in the plan and shows how the city can increase contributions from one to one matching of employee contributions to 1.5 or 2 to one matching.

Councilman Leroy Burns asked that exact dollar figures be presented at the next meeting before the council considered such a step. "We have to remember that the economy is not in the best of shape and that taxpayers are supporting this program," said Burns.

July 29 at 7:30 p.m. has been set for a budget workshop on the 1991-92 operating budget.

City manager Brown presented a brief report of on-going activities in the city beginning with the status of the landfill expansion permit. According to Brown, the city is still working on it and all studies have now been completed. Reports are now being written for resub-

mission to the Texas Department of Health is an attempt to get the project moving.

Brown also reported that the county is now digging a small pit in the only remaining location available on the present landfill site. This will provide space for a few months.

City workers are preparing to erect covered picnic tables at the High School Park. Barbeque grills are planned for installation near the tables in the future. Brown told the group that negotiations are still underway in seeking an agreement between the city and FUSD for the use of the baseball field at the High School Park for FHS baseball next fall.

A report received from Diversified Utility Consultants suggests that an appropriate rate increase for Energas would be approximately half of the rate increase requested by the gas company. A meeting to discuss the matter is slated for later this week according to the local office manager.

In a rate case suit against SPS, the city received a settlement check in the amount of \$64,000.00 but has now been informed that SPS has petitioned the court to reopen the case. SPS is contesting one point of the case and asking for the return of a portion of the settlement according to Brown.

The council approved the minutes of the previous meeting as presented and paid the monthly bills during the evening session.

Present for the session were Mayor Wayne Russell and council members Amado Morales, Clar Schacht, Leroy Burns, Wayne Tipton and Eric Cornelius. Councilman Ruben Barrientoz was not present. Also in attendance for the session were Gary Brown, Jimmie Lou Stewart, Karen Houchin, Sharon Quisenberry, Karen Lawson, Kay Howard, Ridley Gibson, Joe Stepp and the Hesperian-Beacon reporter.

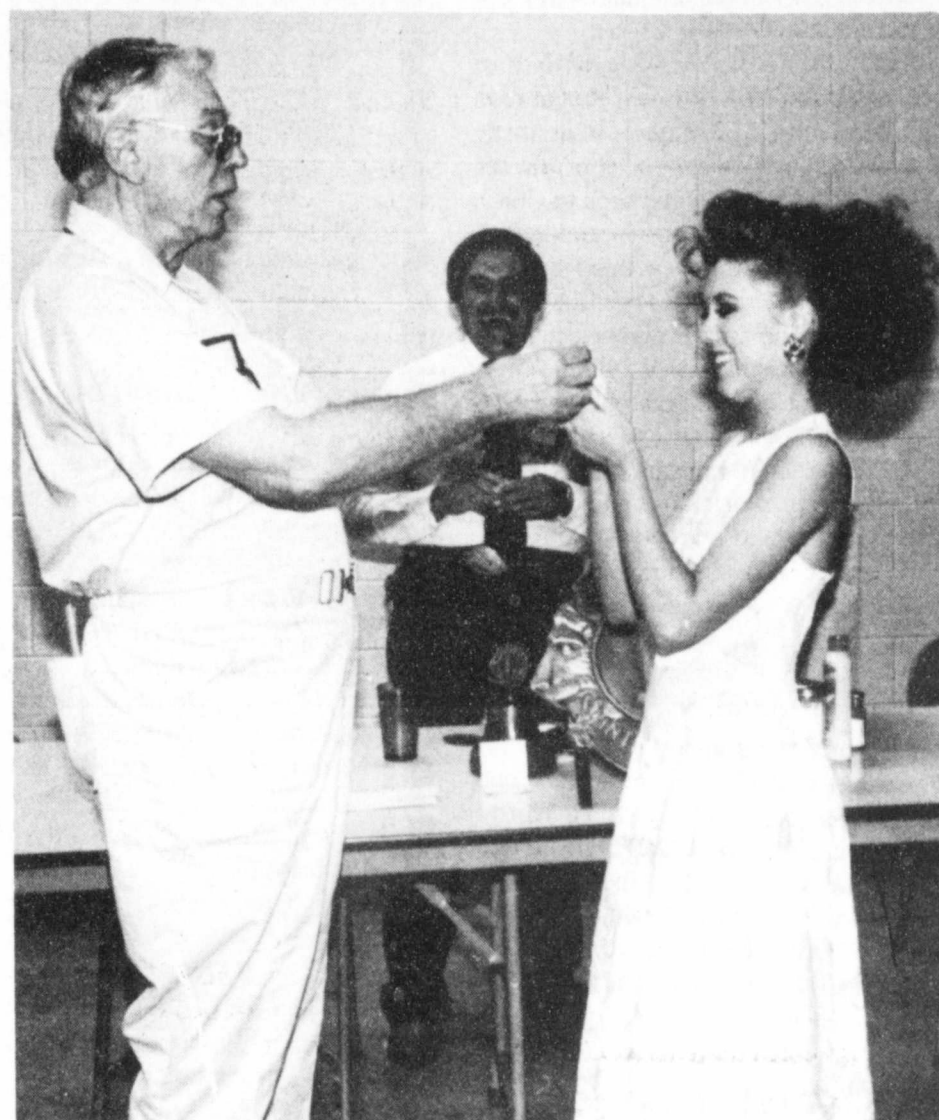

# USDA announces July 26 as cotton referendum date

U.S. Upland cotton producers will begin receiving ballots for the referendum to amend the funding process of the Cotton Research and Promotion Program. Producers should return their ballots to their local ASCS office no later than midnight, July 26, 1991.

If passed, the referendum will eliminate the refund provision in the current

funding process of the Cotton Research and Promotion Program and extend the cotton assessment to imports of raw cotton and cotton textiles.

Currently, the program is funded solely by U.S. Upland cotton producers through a voluntary per-bale assessment equal to one dollar plus six-tenths of one percent of the value of the bale.

Anyone engaged in the production of U.S. Upland cotton, except cash-rent landlords, may vote in the upcoming referendum. This means, owners, operators, partnerships, corporations, wives (in community property states) and ASCS payment entities. As in past cotton research and promotion referendums, domestic producers will receive a mail ballot and explanation from ASCS.

## Good management decisions maximize crop potential

According to figures compiled by Lubbock-based Plains Cotton Growers, Inc. (PCG) area growers will need to make good management decisions in order to maximize an already late 1991 crop's potential.

"The lateness of this year's crop will limit the ability of a producer to bring cotton out of any stressful situations that might develop during this year's short growing season," notes Donald Johnson, PCG Executive Vice President. "What it boils down to is that producers are going to have to make timely decisions this year and closely monitor the crop for any signs of stress that could further reduce their yield potential."

Overcoming dry conditions at the outset of the 1991 growing season has turned out to be only the first hurdle that this year's crop is going to face.

The majority of area cotton producers were able to establish a crop, albeit late in some areas, and getting that late crop to produce good yields is going to be the biggest challenge many producers will face this year.

The expected increase in the number of acres planted on the High Plains did materialize even though planting continued up until the very end of June in some areas.

Based on recently released figures from the United States Department of Agriculture (USDA) the Texas crop should come in with a greater number of harvested acres than in 1990. Whether or not more cotton is produced is going to depend on the crop receiving good weather for the remainder of the growing season and timely rains.

High Plains producers increased their cotton plantings to slightly over 3.62 million acres in 1991, 13 percent over 1990's 3.2 million planted acreage figure.

Using a breakdown provided by the Texas Agricultural Statistics Service (TASS) it was possible to estimate how much of the 6.5 million cotton acres attributed to Texas in USDA's 1991 preliminary planted acreage report were found on the High Plains.

The 3.62 million acre estimate was derived using the planted acreage totals for districts 1-N and 1-S, which include 21 out of the 25 counties around Lubbock.

Figuring in a 10-year historical abandonment average of about 15 percent leaves 3.07 million High Plains acres available for harvest in 1991. This would allow 1991 production to come close to 1990's 2.9 million bale total.

Applying the High Plains five-year yield average of 447.5 pounds per acre projects a 1991 crop somewhere between 2.8 and 2.9 million bales.

Taking into account the late planting, which occurred over much of the High Plains, yields are expected to be lower than 1990's 510-pound per acre average.

In the end however, it appears that while the High Plains did see an increase in its cotton acreage of about 400,000 acres in 1991, there will probably not be any notable production increase in 1991.

## Pyle named to soybean board

Louis W. Pyle of Floydada has been appointed by the secretary of Agriculture to a two-year term on the United Soybean Board, U.S. Sen. Phil Gramm

reports. The board was created by the 1990 Farm Bill with a mission of providing research and consumer information on soybeans and promoting the commodity nationwide.

Pyle was one of 63 soybean producers selected by Secretary of Agriculture Edward Madigan from nominees submitted by state boards. He will be the lone Texan on the panel.



## Cattle operators offered computer course

A variety of computer programs which will help cattle operators make management decisions will be explained during a two-day short course at the Texas A&M University System Computer Training and Education Center in Halfway.

The training, July 23-24, will be presented by the Texas Agricultural Extension Service. Extension agricultural economist and management specialists Stan Bevers of Vernon and Jose Pena of Uvalde will conduct the course.

The program will cover several software programs designed to help with cattle production records and decisions, Bevers said. These will include historical calf records, weaning weights, birth

weights, herd summaries and programs on 205 adjusted weight gains.

"We will also look at the Quicken program and how it can be used in cow-calf operations," Bevers said.

Participants will receive hands-on instruction in operating the programs. Training will be from 9 a.m. until 4 p.m. daily.

The \$100 registration fee includes training materials and a catered lunch each day. The computer training center is 14 miles west of Plainview on U.S. Hwy. 70. Lodging is available in Plainview.

Deadline for registration is July 17. Participants may sign up by telephoning Jane Green at the Texas A&M Agricul-

tural Research and Extension Center in Lubbock, telephone (806) 746-6101.

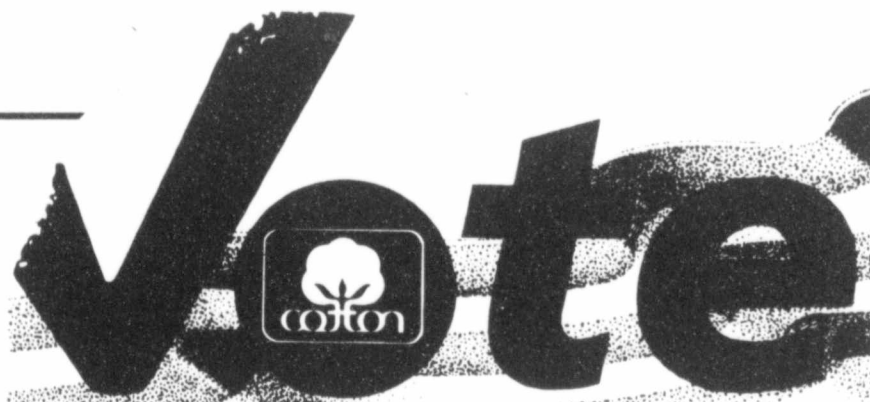

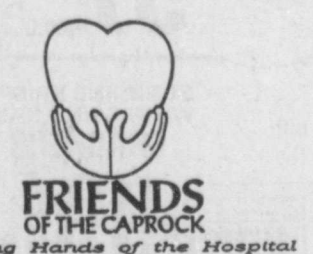
