

The Commissioners' Court of Floyd County met in special session June 26 to approve farm contracts, accept the resignation of J.P. Lowell Bilbrey and approve bids for a motor grader.

A motion was made by Howard Bishop to accept the higher bid of West Texas Equipment of \$65,564(with one trade-in) for the purchase of a motor grader for Pct. #4. Connie Bearden seconded the motion and it carried unanigrader with one trade in) \$52,584.00;

West Texas Equipment (motor grader with two trade-ins), \$61,796.00 less \$1,900.00 no chrome moldboard=\$59,896.00.

Webster Service and Supply closes doors

A Lockney tradition has closed its doors. Webster Service and Supply will no longer be a sure place to get free bubble gum for the kids or a good laugh from one of R.V.'s trunk full of practical

R.V. Webster and his wife Rita have decided to retire from the gas station that has been their life for so many years and spend some free time relaxing and visiting grandkids.

Webster's Gas Station had its beginnings in 1947 as part of the Jackson Tire Company, located at 101 S. Main. R.V.'s father, Kelly Webster, was partners with Dwight Jackson and Al Dunton. Originally this business sold gaso-

line and tires. Raised in Lockney, R.V. worked alongside his dad and learned the gasoline business. After serving in the merchant marines for three years in the South Pacific, R.V. returned to Lockney and joined his dad at Jackson Tire.

Rita Webster is also no stranger to "gas station work." Rita moved to Lockney from Brownfield in March 1947, with her parents Wayne ("Moon") and Viola Mullins.

"My dad had also had a service station," said Rita. "I swore I would never marry a man with a gas station," laughed Rita, "and look what I did."

After a "whirlwind courtship" R.V. and Rita married in July, 1947. "She chased me all over the place,"

said R.V. with a twinkle in his eye. "She lived in Sterley and when it would rain I couldn't get my car down the dirt roads to see her, so I would ride the rails from Lockney to Sterley to pick her up!" In 1948, R.V. and his father bought the

Sinclair Filling Station (located where Lockney Oil & Butane is now). They shared the location with Henry Hodel who operated a gas and oil distribution business. "We bought our oil and gas from him," said R.V. "Ham Gammage bought out Hodel at a later date, and continued that operation."

Approximately five years after the purchase of Sinclair, the Websters changed the name of the station to Webster's Service and Supply.

"That sure was a fun place," reminisced R.V. "We had a 'mongoose' in a box that we would talk up real big. We told everybody it was a deadly animal and you had to be very careful or it would bite you bad. People would come from all over to see it.

"We had the box rigged up so when someone would look into it we would

pull a gadget and it made a noise like the door opening and all you would see was this big fuzzy tail flash by.

"We sure got a lot of funny reactions. The snuff chewers would spit all over the place!"

Another favorite gag was rigging the car seats to shock people. "We would run a line from the battery under the driver's seat. When they got in and turned on the car they would get a little shock.

"One fella we pulled the trick on took the car home and played the gag on his wife. After she started the car she came back into their house and said that something was still wrong with the car. She said there was some kind of short in it and it kept shocking her when she sat down. The husband kept telling her that it hadn't done it to him and he didn't know what she was talking about!"

Another well known trait for the Websters has been the free handout of bubblegum to all the youngsters who stopped in with parents.

The fun loving atmosphere of the Websters became famous and it quickly became a favorite "hang-out" for high school students. "The kids would always sit in our parking lot," said R.V. "I can't tell you how many times I would get called in the middle of the night to come bail some kid out of trouble because they were too scared to call their parents. "I pulled many a car out of a

"We also had a lot of high school kids working with us. Elvin Lyons, the FFA teacher would help recruit kids to come work for us. They have a DECA program that does that now."

The Webster Service Station moved to its present location, at 609 S. Main, in 1977. "We have always been a full service station," said R.V. "We made farm deliveries and sold gas, oil, and diesel."

Not only have customers been loyal to the Webster Service Station, but so have R.V.'s employees. A familiar face to Webster's patrons has been Junior Martinez. "Junior's dad, Arsenio ("Chano") Martinez went to work for us in the mid fifties," said R.V. "Junior started in 1970 and has been working there ever since. Another employee, Andy Soliz, has worked for us for 15

"I've always had a motto when it comes to my employees. I never ask them to do any more than I haven't done, or I wouldn't do."

In the midst of all the hard work, Rita

and R.V. were blessed with the birth of their first child, Bobby, in 1948. Bobby is currently living in Wichita Falls and is a doctor of Reproductive Endocrinology. He has blessed his parents with three grandchildren.

In 1952 another child, Deborah, was born. She is currently living in Lubbock and works as a pharmacist at Stumbaugh

Even though the idea of visiting grandkids, working in their beautiful

yard and taking fishing vacations appeals to the Websters, giving up the service station has been a very difficult thing for them to do.

"It is hard to put into words, " said R.V. with tears in his eyes. "This town has never been anything but good to us. We have made more friends than you could imagine. It has made us a living and educated our children. It's not easy to give it up. Everything we've got we owe to this community."


## New disabled placards must be obtained by December 31

The new disabled placards will have to be obtained no later than Dec. 31,

"The old permanently disabled cards will no longer be valid after Dec. 31, 1992. Permanently disabled persons may exchange the old ones at the tax office," says Penny Golightly, Floyd County Tax Assessor-Collector.

"There will not be a charge to exchange the old ones. However, the new permanently disabled placard will expire after five years," she added. "The disabled person will have to bring their application back in to obtain another

The cost will be \$5.00 to renew the permanently disabled placard.







# Proposed rules for pesticide records

By Mike Mallett, CEA-Ag.

Following is information on the PROPOSED rules regarding pesticide and commercial applicators. Comments on these rules will be accepted until August 10, 1992.

USDA-AMS 7CFR Part 110 (CS-91-077) RIN No. 0581-AA39, Recordkeeping Requirements for Certified Applicators of Federally Restricted Use Pesticides

#### Major Recordkeeping Requirements

\* A certified applicator is any individual who is certified to use or supervise the use of any restricted use pesticide covered by that individual's certifica-

\* A commercial applicator is a certified applicator, whether or not the individual is a private applicator with respect to some uses, who uses or supervises the use of any restricted use pesticide for any purpose on any property other than as provided by the definition of private applicator.

\* A private applicator is a certified applicator who uses or supervises the use of any restricted use pesticide for purposes of producing any agricultural commodity on property owned or rented by the applicator or the employer of the applicator, or if applied without compensation, other than trading of personal services between producers of agricultural commodities on the property of another person.

\* Certified applicators of restricted use pesticides shall keep records of the brand or product name, the formulation, and the EPA registration number of the pesticide. They must also record the total amount and rate of application, address or location of the application, the size of area treated, target pest, crop or commodity on which it was used, date used, and name, address, and certification number of the certified applicator who applied the pesticide or supervised its application.

\* Certified applicators shall record the required information in a timely manner and retain those records for two years from date of application. They must maintain the records in such a manner as to be accessible by authorized

representatives of the Secretary of Agriculture or the state lead agency.

\* Certified applicators who are rerecord keeping requirements for private quired by state laws to keep records comparable to those required for commercial applicators are not subject to the previous two paragraphs, but must continue to maintain records in compliance

> \* Commercial applicators shall provide copies of records with this information within 30 days of application to those for whom they applied restricted use pesticides. Those persons receiving the commercial application service must then retain these copies for two years after the application.

> \* Certified applicators must make available the records to authorized representatives of the Secretary of Agriculture or the state lead agency upon either oral request and presentation of credentials or written request. These representatives can only review and copy the records, with the originals to be retained by the certified applicators. In copying these records, the federal or state agencies cannot release any information which would directly or indirectly reveal the identity of the producers of commodities to which restricted use pesticides have been applied.

> \* Licensed health care professionals are authorized to review restricted use pesticide records if they determine it is necessary to provide treatment to an individual who may have been exposed to the restricted use pesticide for which the record is maintained. Once licensed health care professionals gain access to these records, they may not release any of the records or information to anyone else except as necessary to provide medical treatment.

> \* Violators of these record keeping requirements are liable for civil penalties of not more than \$500 for the first offense, and not less than \$1,000 for each subsequent offense unless the violator made a good faith effort to comply.

Texas agricultural producers most impacted by these proposed rules are those certified applicators who are not currently subject to the requirements of the "Right to Know" laws and those who use commercial applicator services to apply restricted use pesticides. They will now need to keep the kinds of information indicated above for all restricted use pesticides they use. Those who currently comply with the "Right to Know" provisions will find very little, if any, impact. For commercial applicators in Texas, the major impact of these rules is the requirement of providing copies of application records to their clientele within 30 days of application.

According to the Texas Water Commission (TWC), it is estimated that about 18 million gallons of used motor oil is dumped on the ground or into storm sewers or discarded with household garbage within the state.

New regulations passed by the 72nd Texas Legislature took effect April 1, 1992, requiring that used motor oil must be taken to a waste oil collection center, such as a quick lube operation, service station or retailer, for disposal.

Anyone who continues to drain used oil upon the land surface can face fines of up to \$2,000 per violation.

"If an irrigator has 12 wells on his property and continues to drain the oil from these internal combustion engines onto the land surface, the potential fines for this violation could easily reach \$24,000. Most producers could not afford this expensive fine, so it is a good idea to carry the oil to a local reclamation center," said A. Wayne Wyatt, High Plains Underground Water Conservation District manager.

Many rural communities on the Texas High Plains do not have public waste oil collection centers. In this case, the Texas Water Commission recommends accumulating used oil until it is feasible to transport it to a recycling center.

"The used motor oil may be accumulated for a short period of time in plastic gallon jugs. If the farmer is going to be accumulating the waste oil for an extended period, then a more substantial container like a metal drum is recommended said D.E. Balusek of the TWC's Recycling and Waste Minimization Section.

The Texas Water Commission now registers all collectors, transporters, marketers and recyclers of used motor oil. These collectors must report annually on the amount of oil they receive from the public. They also must use registered transporters to remove collected oil. The transporters must maintain careful records of the source and destination of each used oil shipment.

### **Exemption** granted for use of Asana XL on grain sorghum

The U.S. Environmental Protection Agency has granted a Texas Department of Agriculture request that will allow farmers emergency use of the insecticide Asana XL on grain sorghum, Agriculture Commissioner Rick Perry said.

"We appreciate EPA's quick response on this matter," Perry said. "Without this method of control, our sorghum farmers were projected to lose as much as \$10 million this summer to the sorghum midge.

The sorghum midge is a type of fly that is primarily controlled by planting sorghum early and having it flower before midge populations can seriously threaten crops. This season's heavy rains caused sorghum crops to be

available to eligible farmers and ranchers in 18 Texas counties that were declared federal disaster areas due to freeze or excessive rain between Sept. 1 and Dec. 31, 1991, Texas Agriculture Commissioner Rick Perry said.

To be designated as a primary disaster area, the Farmers Home Administration determines if a sufficient number of

Each loan appication will be considered on its own merits, taking into account the extent of losses, security available, repayment ability and other requirements.
