## LISD approves new gym

LOCKNEY — The Lockney Independent School District board members met for their regular meeting on Thursday, August 13 and approved the construction of a new gymnasium.

Mike Lowe, engineer for Jim Hickman Engineering, met with the board members and presented them with a drawing of the proposed gym and answered questions concerning all aspects of the project.

The plans call for a recessed playing floor with a hard wood floor and permanent wooden bleachers on both the home and visitor sides. The lobby will hold the concession stand. The plans include dressing rooms for the students and offices for the coaches as well as a weight room and a therapy room.

They discussed the floor in the weight room and were told that either a harder

concrete (PSI) would be used and that a hardener would be added to the top. Lowe stated that there were several options that could be looked at to insure that the floor would not have to be replaced after a short time of use.

The board members discussed all the pros and cons and each agreed that the people who had talked to them about the building project were in favor of building the

"It is my understanding," stated Gary Mangold, "that we will not have to raise taxes for this project, that the money for this project has come from state funds that are designated for building projects and that if we do not use it for our benefit that it will most likely go for someone else's benefit."

After a lull in the discussion Mike Mathis made the motion to take bids on the construction of the gym and Gary

Mangold seconded the proposal. The vote was unanimous for the project.

Bids for the construction of the gym will be published and will be opened at the board meeting on October 15.

The board also called for bids to be let on a house and lots owned by the school district. The bids will be published and then will be opened at the October 15 meeting.

Phil Cotham, principal of Lockney Elementary gave a report of the LISD Academic Excellence Indicator system (a report of the Lockney Schools will be printed in the 8-27 issue of this newspaper). A full copy of the report is available in all the school libraries and in the superintendents office.

Bids were opened and the bid to supply the Lockney Schools with milk and milk products was accepted from Bell. They were the only bid received.

The lunchroom prices were set at ninety cents for lunch and fifty cents for breakfast for elementary students and lunch for secondary students is set at \$1.00. A breakdown of the National School Lunch Program was printed in the August 13 issue of the Hesperian-Beacon

Bids were opened for gas and diesel and the low bid made by Lockney Oil and Butane was accepted for the first semester. A bid was also received from Consumers Fuel.

A discussion was held on the phone system at the elementary school. Hallmark told the group that there are only two lines into the school. One is in the office and the other is in the kitchen of the cafeteria. There are no lines running to the north end of the building.

The board voted to have a phone installed in Mrs. Mitchell's office which would give them an extra line.

The board voted to hire Scott Cassler as boys basketball coach and Rodney Dowell as junior high coach. Deanna Brewer, Roxanne Henegan and Meli DeLeon were hired as aides.

A tour was made of the rooms in high school that have been renovated during the summer. The rooms are painted in bright cheery colors have been carpeted. After the tour Dickie Lambert commented, "This was money well spent."

Hallmark stated that the carpeting tends to make the rooms quiet and the atmosphere for studying calmer.

The group also toured the new computer room in junior high. The room is equipped with Macintosh computers.

The board voted to meet in special session on August 20 at 7:30 p.m. to adopt the budget for the 92-93 school year and on August 31 at 8:00 a.m. to adopt the tax rate for 1993. The 91-92 budget will also be amended on the 31st.

In regular business the board heard and approved the reading of the minutes, approved the payment of the current bills and reviewed the tax report and the investments.

## McIntosh hired by Floydada EMS as full-time paramedic

FLOYDADA -- Caprock Hospital and Floydada EMS are proud to announce the hiring of Paul McIntosh as a full-time, paid, paramedic.

A Floydada native, McIntosh has been voluntarily working with EMS in Floydada for 3 1/2 years, helping organize the program and overseeing medical emergencies.

"Paul is a great asset to Floydada," said Joy Assiter, a EMS board member and Hospital Board member. "He can give us better qualified care for our community. Paul is also recognized in the larger hospitals as an outstanding paramedic and is well received by medical personnel when he goes in with a patient."

"He is also a big comfort to other EMS personnel," said Jimmie Lou Stewart, EMS bookkeeper and office manager.

In a joint effort to bring qualified care to Floydada and keep it here, Caprock Hospital and the EMS board worked together to put McIntosh on the payroll. Caprock Hospital is contributing the money for McIntosh's salary and along with the city and county, the hospital subsidizes EMS with \$6,000 a year.

"Not only will Paul be bringing his expertise to health care," said Assiter, "but his personal vehicle is recognized as a 'FOX' vehicle, which gives the community two emergency vehicles without the expense."

"A 'FOX' vehicle," explained McIntosh, "can go ahead of an ambulance and carry some equipment. My four-wheel drive can go down roads that an ambulance can't."

McIntosh also brings at his own expense, a radio in which he can communicate with a doctor at the Texas Tech Health Science Center.

"The radio communication enables me to get on line medical direction," said McIntosh. "Because I am a Paramedic I am allowed to give medications to a certain extent, and after exchanging information with the doctor I am able to administer other types of medication."

"With a paramedic in the back of the ambulance we are a Mobile Intensive Care Unit. Without a paramedic we are a basic life support system. It makes a big difference," said McIntosh.

McIntosh qualified as an EMT-Paramedic on February 17, 1989, and currently has more than 160 hours of continuing education.

He has successfully completed courses in Management of Lightning Injuries, Recognizing & Identifying Hazardous Materials, Pre-hospital Trauma Life Support, as a Public Safety Telecommunicator, and Air Craft & Crash Rescue.

McIntosh qualifies as an Emergency Medical Service Program Instructor, Prehospital Trauma Life Support Instructor and as an Emergency Medical Service Examiner.

He has taught Prehospital Trauma Life Support at Texas Tech University Health Science and has also taught skills at the Health Science Center.

He holds the titles of Paramedic, EMT-I, EMT, and ECA Preceptor (which is on the job observation of students).

Besides serving as a Paramedic with Floydada EMS, McIntosh has been a Nurse Tech at Methodist Hospital in Plainview, a Paramedic with Hutchinson Air Ambulance Service of Plainview and a Paramedic at Caprock Girl Scout Camp in Crosbyton.

## FCED discusses budget, 1992 tax rate

A Floyd County Education District board meeting scheduled for 8:00 p.m. Monday, August 17, got underway at 8:10 p.m. with Lockney board member Dickie Lambert and Lockney Independent School District superintendent W. H. Hallmark absent. Those attending

included Floydada representatives Michael Hinsley and Charlene Brown, Lockney representative Jim Martin, Floydada Independent School District superintendent Jerry Cannon and administrative assistant Jimmie Collins, Joe Stepp and the Hesperian-Beacon reporter.

Despite pending litigation and court action, education funding in the State of Texas must still be calculated and collected according to the state mandated education district plan. Cannon stated that it is believed this may be the final year for this type of funding process. Court decisions and new legislation are expected to alter the funding formulas for future years.

Following the reading and approval of the minutes of the previous session, Collins presented a brief overview of the budget expenditures made by the FCED during the past year. He stated that the entity had taken in \$1,343,803.57 in local tax revenues which were disbursed to FUSD (\$828,395.23) and LISD (\$525,408.34) and had received \$5,000.00 from LISD and from FUSD for operating costs.

A breakdown of these costs included payment made to Floyd County for the cost of the state mandated August 10, 1991 election, payment to Goen & Goen Insurance for liability coverage for the board, payment to attorney Paul Lyles for representation in a series of lawsuits filed against all CED's and miscellaneous expenses of \$5,764.00. FCED accounts retain a balance of \$1,081.10 as

## FISD Board adopts 19.30 cent tax rate for 1992

FLOYDADA -- Meeting in an early morning called session, the Floydada Independent School District board voted unanimously to adopt the 1992-93 budget as presented by administrative assistant Jimmie Collins at the August 10 regular session of the board. (Details of the budget may be obtained by contacting the school administration office or by reviewing the story in the August 13 issue of the Hesperian-Beacon.) Motion for the action came from Michael Hinsley with a second by Steve Lloyd.

The second item on the 7:00 a.m. meeting held Wednesday, August 19

was the adoption of a tax rate for the 1992 tax year. The board elected to retain the same rate they had set in 1991, 19.30 cents per \$100 of valuation for ad valorem taxes. Motion for the action was made by Lloyd and seconded by John Campbell. The vote was unanimous.

Attending the called meeting held in the library of A. B. Duncan Elementary School just prior to the annual employees breakfast were board members Charlene Brown, Michael Hinsley, Trena Simpson, Steve Lloyd, John Campbell and Billy Villarreal, administrative assistant Jimmie Collins and the Hesperian-Beacon reporter. Board member Don Hardy was not present.

## Caprock Hospital District Board and administrator face taxpayers at hearing

FLOYDADA -- Caprock Hospital District board members Jim Word, Joy Assiter, Fred Thayer and Jerry Thompson joined hospital administrator Terry Keltz in listening to the concerns and opinions of CHD taxpayers as well as trying to provide answers to the questions posed by taxpayers attending a public hearing last Thursday. The special meeting was held at 7:00 p.m. in the District courtroom on the second floor of the Floyd County Courthouse in Floydada.

Approximately twenty people were present for the meeting in addition to the aforementioned board members and administrator.

Board president Fred Thayer opened the meeting by explaining that the district was seeking public approval of its proposal to maintain the 42 cent tax rate for one more year in order to continue to accumulate the funding necessary to reopen and operate the local hospital until cash flow could be established. He told those gathered that the board will be setting a tax rate at the regular session at 7:00 a.m. on Thursday, August 20, and wanted to hear the views of those concerned prior to that time.

"We feel that Floyd County and Floydada in particular needs medical services," stated Thayer. "If we are

going to have medical services in Floydada, if we are going to have a hospital, it is going to have to be supplemented by tax funds."

Thayer went on to explain that about 60 percent of the patients seen in Floydada are Medicare or Medicaid participants. "The problem with this," he added, "is that reimbursement for a small rural hospital like ours on these patient services is only about 60 percent of what a larger city hospital gets. The services we provide cost about the same amount and in some cases, more, but we get less to cover the cost from the government programs."

**TAXPAYER CONCERNS**

Questions from the people in attendance began with a wish to know just where the hospital finances stand at this time. Keltz was asked how much money the district now has on hand. He replied, "About \$400,000.00." He added that the district has no indebtedness at this time. "All past debts have been paid off and we are paying for our operation and renovations as the bills come in."

Keltz also told those present that with the anticipated tax revenues in the fall, the hospital would have about a million dollars with which to complete the repairs, purchase the necessary new equipment and carry the facility through

the first few months of operation until a cash flow can be established after reopening. This would allow the district to function without borrowing money and starting the debt cycle over again said Keltz.

Asked about the status of money owed to the district by people who had not paid their bills when the hospital closed, Keltz replied, "There is about \$900,000.00 in debt that dates back many years and is largely uncollectible. Collectible accounts receivable are now at less than \$26,000.00."

Keltz explained that about 15 percent of all care provided by a small rural hospital is uncollectible. "There are those people who know that treatment cannot be refused if they present themselves at an emergency facility for treatment," stated Keltz. "We are bound by law to see that they are treated, whether they pay or not."

"Beyond that expected loss, accounts for many years were not billed and collected in a timely manner. This allowed many to fall into an uncollectible state. Some of the people have died, many have moved and we have no knowledge of their whereabouts in order to attempt collections. The older the debt is, the harder it is to collect," added Keltz.

Some of those present seemed to harbor a bit confusion as to when ad

valorem taxes are set and collected. Aaron Carhel indicated that he thought the taxes being set this month were for next year and that taxes for this year had already been set. He and others present thought they were being asked to pay the 42 cent rate this fall and next before the

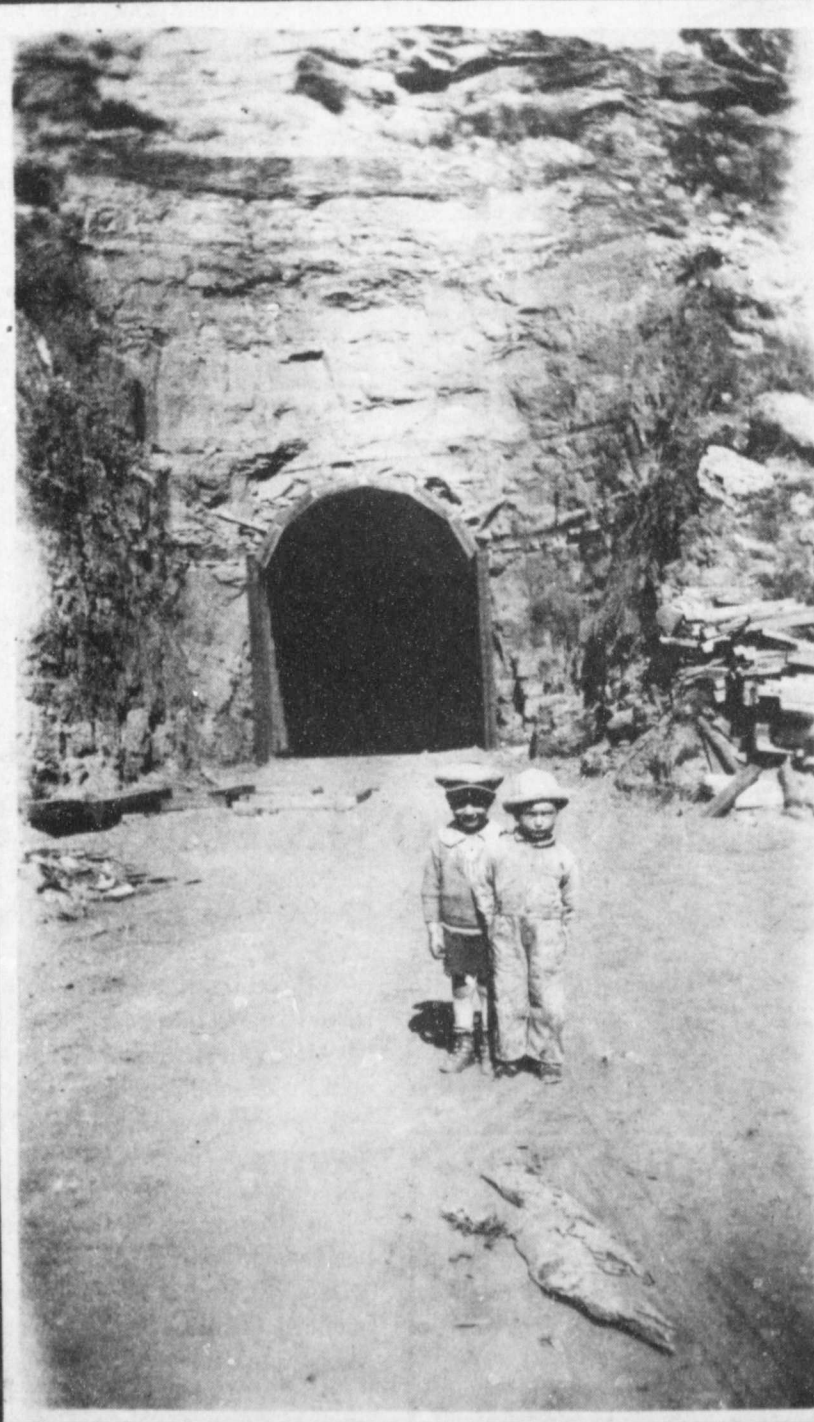
Just bits and pieces.

# City Council addresses budget, grants and annexation

**FLOYDADA** -- Budgets, annexation and grants were the topics of major interest at the Tuesday, August 18 session of the Floydada City Council regular session. The 7:30 p.m. meeting opened with a report from John Simpson of Mackenzie Municipal Water Authority concerning the entity's proposed budget for the coming year.

Floydada and other area cities share in the annual operating costs of the water authority which provides water to the local population. The monthly cost of this for Floydada during the 1991-92 budget year was \$22,878.00. According to Simpson, the monthly tab for the 1992-93 budget year will fall by \$1,334.00 to \$21,543.00. He also told the group that no tax increase was anticipated for 1992. The current rate of 27.49 cents per \$100 of valuation will also be the rate for 1992.

**ANNEXATION REQUESTED**  
 Residents of an area adjacent to the city limits on the South side of the Ralls Highway presented a petition and letters requesting that the area be annexed into the City of Floydada. The group already receives water, electric and trash disposal services from the city, paying a higher rate for the services than customers within the city limits. Annexation would obligate the city to provide sewer services to the area.

City manager Gary Brown told the council that installing the sewer service is estimated to cost \$56,348.00, but using city workers for most of the labor could cut that figure by one third. Balanced against the estimated tax revenue (approximately \$1,550.00 per year at the current rate) on the area, the city would not gain a significant amount on the transaction.

The residents of the area would pay the standard fee for sewer services, \$7.25 per month, but their cost for the services they already receive would decrease if they became a part of the city. Brown told the council that the city is obligated by law to install the sewer if the area is annexed and the work would have to be started within 36 months and completed before the end of 60 months.

A motion was made by councilman Wayne Tipton to table the matter until the next regular session while it is determined just how much the sewer installation would cost and how soon it could be

accomplished. Councilman Clar Schacht seconded the motion and the vote was unanimously in favor.

**GRANT PROJECT PARTICIPATION DISCUSSED**  
 The council was faced with deciding if they were in favor of pursuing grant funding from two different sources in the next few months. The annual application period for Texas Department of Commerce block grants is approaching and the city had to state whether they were interested in applying and what type of project they would seek funding for.

The council opted to apply and will be asking for funding to replace older existing two inch water lines serving about 20 blocks with a new six inch line. They also expressed their interest in trying to get part of the available funds to be distributed throughout the state for HOME PROJECT grants. These grants would enable the city to provide housing rehabilitation funds to home owners in lower income areas of Floydada.

Motion to pursue the acquisition of funds was made by councilman Ruben Barrientoz and seconded by councilman Amado Morales. The vote was unanimous in favor of the motion.

**1992-93 BUDGET DISCUSSED**  
 The council discussed provisions of the proposed annual budget during the evening session. Major differences seem to crop up in only two areas, a proposed across the board cost of living increase for all city employees of 5 percent and the proposed purchase of seven new vehicles, two cars for the police department and five pickups for various departments.

A workshop was scheduled for Thursday, August 27, at 7:30 p.m. to work out the final budget proposal. Motion for the workshop came from Tipton with a second by Barrientoz. The matter was tabled until the slated workshop meeting by unanimous vote of the council.

A public hearing was also scheduled for presenting the 1992-93 proposed operating budget to the public on September 15 during the regular monthly session of the council. Motion for the hearing was made by Schacht with a second by Barrientoz and approved by a favorable vote of the council.

**HOUSING AUTHORITY HEAD RESIGNS**

Don Green, head of the Floydada Housing Authority, submitted his resignation to the council, effective August 10. According to Mayor Wayne Russell, Green had stated that he would probably be leaving the city to find work and did not feel it would be proper to continue as a member of the local board. Russell also told the group that it would not be necessary to replace Green until the November session. This is the time housing authority board members are usually appointed for full terms.

Motion was made by councilman Amado Morales and seconded by Schacht to accept the resignation and leave the post vacant until November. Vote on the matter was unanimous.

**FUEL PURCHASES DISCUSSED**

City secretary Sharon Quisenberry asked the council to establish a guideline for her in dealing with local fuel vendors. According to Quisenberry, the city is entitled to an exemption from the federal excise tax on fuels. Federal regulations for obtaining the exemption states that the fuel seller must complete a rebate form which is submitted to the proper federal agency to get a refund on the taxes paid.

Quisenberry told the council that after recent purchases made from Brooks Oil Company, Ray Brooks informed the city that he would not be completing the forms any more. According to Quisenberry, this could mean a loss to the city of about \$50 to \$200 a month depending on the amount and kinds of fuel purchased. She also told the council that Friends Convenience Stores had indicated a wish to participate in selling fuel to the city.

Schacht made a motion that the city purchase fuel from any local vendor who is willing to complete the proper forms for the city. His motion specified that purchases be rotated among the vendors to allow each an equal chance at city business and that vendors who do not cooperate with the city in filing the necessary rebate forms be excluded. Barrientoz seconded the motion and the council passed it by unanimous vote.

**OTHER MATTERS**

The proposal from local accountant Edd Henderson, was approved for the financial audit of city records for the 1991-92 fiscal year ending September 30, 1992. Motion to use the local firm was made by Schacht and seconded by council member Wayne Tipton. Vote on the matter was unanimous.

Quisenberry asked the council members to decide which of them will be going to the TML conference in Houston in October. Each of those present expressed an interest in attending. Room reservations and flights will be confirmed in the coming weeks.

Payment of monthly bills was approved and the minutes of the previous meeting were approved as presented. Brown reported on the day to day activities of the city, stating, "I am still amazed day to day and week to week at just what the citizens think the city should do for them."

Brown went on to say that many calls have been received concerning "when the city is going to mow their alleys." He told the council that no matter how many times he explains that the alley is the responsibility of the property owner,

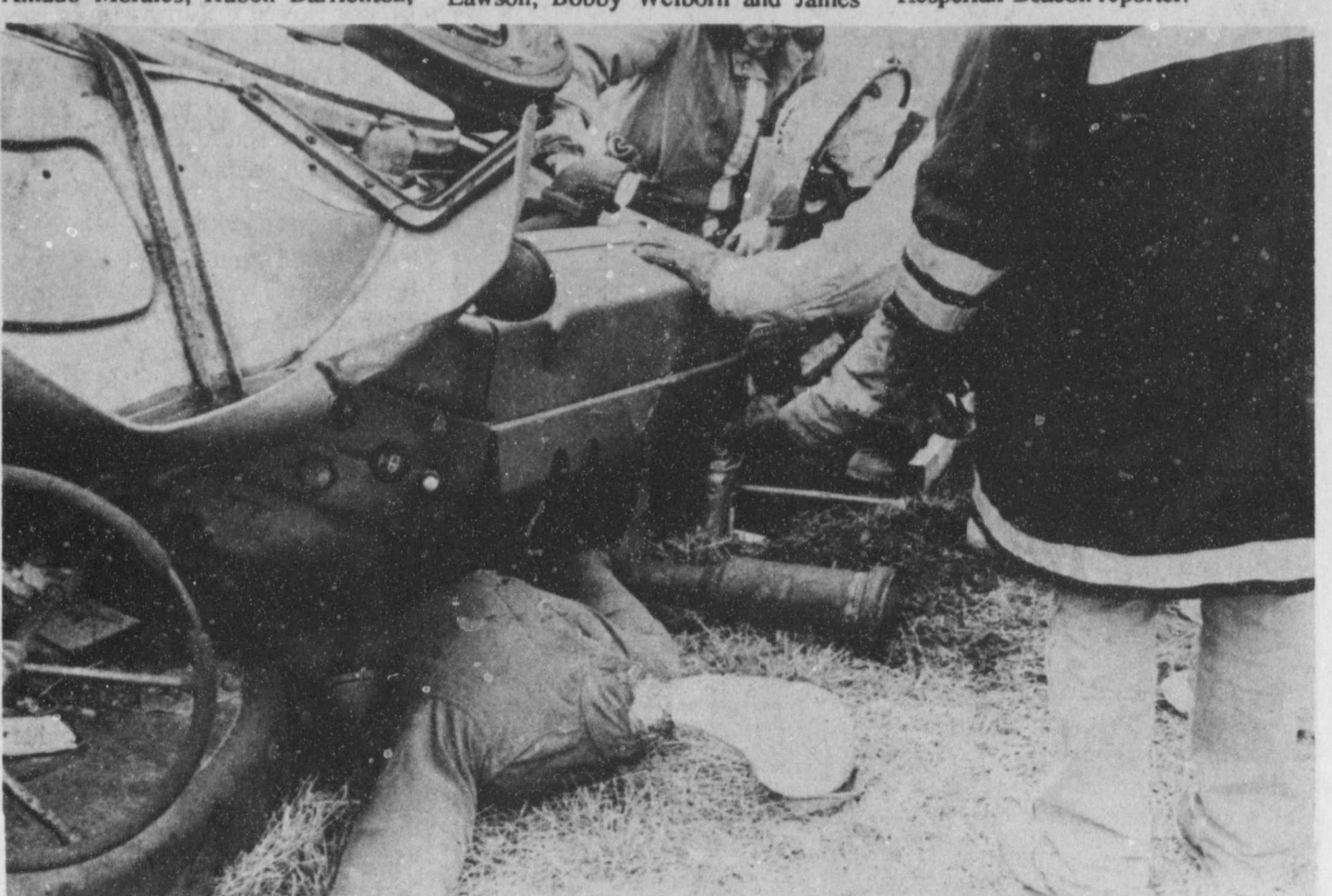

district decided what to do if the hospital could not be reopened.

Keltz assured the group "taxes for 1992 will be set this month and collected in the fall. We are only asking the taxpayers to give us the next twelve months to try and recruit more physicians and reopen the hospital. If this has not been accomplished by this time next year, we need to reconsider our options."

Asked if the district had any prospects for getting additional doctors, Keltz told the gathering, "We have several contacts with doctors now doing family practice residencies and Dr. Victor Hoang (the recently acquired physician who is now practicing at Cogdell Clinic) has a friend he has asked to come here following his residency in OB-GYN. I am also going to contact those doctors who had previously indicated that they would like to come to Floydada, but did not want to be the only doctor. We hope that the fact that we now have one doctor will make getting more easier for us."

"Doctors are hard to find and harder to recruit," said Keltz. "You have to look at paying a recruiting fee of around \$25,000.00 to \$30,000.00 to find one and almost all of them want a monetary guarantee before they will agree to come here to work." According to Keltz, Methodist Hospital is still willing to assist with the recruitment fees and an annual guarantee in order to get doctors here.

"Dr. Hoang did not ask for a guarantee and since he was located without the assistance of a recruitment agency, we had to pay no fees. He told us he only wants to work some place where a doctor is needed and he has chosen Floydada."

Keltz characterized the recruitment of additional medical staff as "the second hardest job we will have in order to reopen." Most of the previous staff has gone on to other jobs and would not want to give up their positions to come back here at lower pay and lower benefits added Keltz.

One of those present, L. B. Cozby, stated, "The next hardest thing you have to deal with is getting people here to use the hospital. The attitude of people here has to change if a hospital in Floydada is going to survive." He went on to say that in his opinion, there had not been a decent doctor here in fifteen years and that 60 percent of the people who are in favor of reopening the hospital "wouldn't stop here if they felt like they could get to Lubbock where they were ill."

Board members agreed that that attitude has prevailed in the past and a concentrated effort must be made to change that in order to reopen the hospital and make it a viable operation.

Cozby then asked Keltz, "Why do you keep fighting a losing battle? Do you honestly believe that you can swing this and make it work?"

Keltz replied, "Some days I do and some days I don't. I am feeling much more confident now that we have one

doctor, but I realize that there is a lot of hard work ahead to make it happen and make it work in the future." Keltz then asked the gathering, "What we need to know now is are you willing to go along with us for another year and do you really want us to keep trying to provide medical services and a hospital in Floydada?"

Lynn Marler, another in attendance, stated, "I think that the people demonstrated that they wanted to have the hospital here by voting in favor of the tax increase a year and a half ago."

Q. D. Williams added, "I think we are all for the hospital, we just aren't for taxes with the doors closed."

Keltz then explained to the group the process to be followed if the hospital could not be reopened and the taxpayers wanted to abandon the district. It would require a petition to dissolve the district followed by an election. If the election decided that the district should be dissolved, the board would have the responsibility for disposing of the assets including the hospital building and returning the proceeds or issuing tax credits to the taxpayers. The alternative would be for the board to turn the disposition of assets and the return of the proceeds over to the County Commissioners Court.

"We still would bear the responsibility for indigent health care, either as a hospital district or as a county," said Keltz. "It would be easier to provide for indigents in our own district, but if the district ceases to exist, the county will have to pay for indigent health care at another facility."

"Before we leave tonight, I want to compliment the board of Caprock Hospital District," said Keltz. "They have had a truly thankless job during the past few years. I would not want to be in their shoes and taking the kinds of abuse they have taken for trying to do what is right regarding the hospital and it's closing and recruiting new doctors and getting it reopened."

Thayer closed the meeting saying, "I also want to thank those of you who took the time to come to this meeting. We appreciate your interest and hope we have been able to answer your questions and help you understand what we are trying to do. We only wish that more people had chosen to attend."

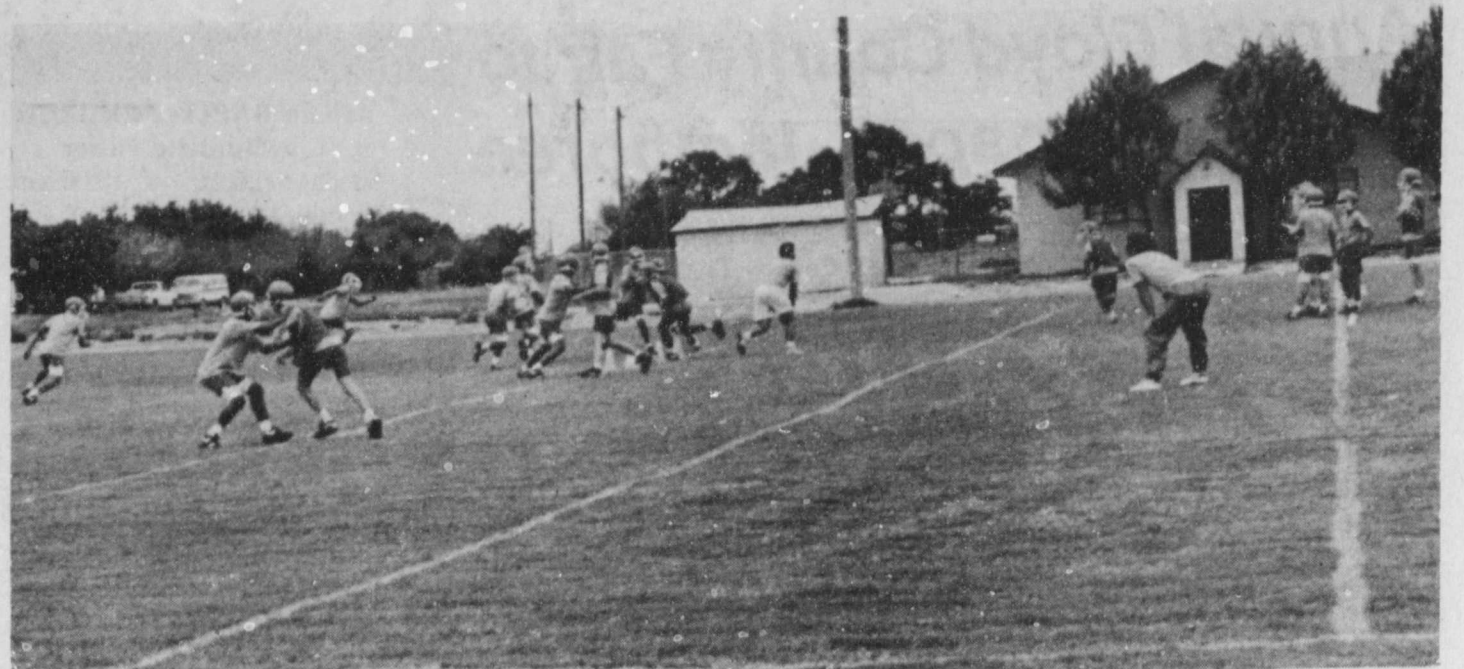

# Floydada grid success hinges on massive line

A number of years ago, there was a cigarette advertisement which featured the slogan, "It's what's up front that counts." The same can be said for the 1992 edition of the Floydada Whirlwinds. Historically, the success of "wishbone" attacks has been dictated by the strength and mobility of the teams' offensive lines — witness the Texas Longhorns of the 1960s and Oklahoma Sooners and Alabama Crimson Tide of the 1970s and 1980s. Those powerhouse collegiate squads were blessed with an abundance of huge and agile guards and tackles.

As Floydada mentor Dean Bates enters his fourth year at the Whirlwind helm, he, too, is blessed with a solid front wall to pave the way for his potent wishbone-option offensive scheme. Floydada's offensive line, the catalyst of last year's area leader in total offense (3,949 yards in ten games), returns virtually intact.

Center Scott Crader returns to anchor the offensive line. The personable senior was a unanimous All-District 2-3A selection as a junior and enters his final year at FHS at 6'1", 215-pounds. He tops out in the bench press at near 350 pounds, and demonstrated his agility with a team-leading 34-inch verticle jump during off-season drills. Crader's backup will be D.G. Hollums, a six-foot sophomore who tips the scales at 196

pounds.

1991's Top of Texas Football labeled guards Todd Cage and Micheal Gilliland as the "Twin Tanks." It may be hard to find a fitting nickname for the twosome this year. Cage weighs in now at 237 pounds and Gilliland is a little leaner at a mere 232 pounds. Teamed in the interior trenches with Crader, the trio may become known as the "Battle Group."

Cage had a superlative season a year ago, as he was named 2nd Team All-State offense and a unanimous 1st Team All-District pick on both sides of the line of scrimmage. Slotted in as backups to Cage at left guard are senior Wayne Wells and Pete Luna, a tough 240-lb. sophomore.

Micheal Gilliland also had an impressive junior year, as he was an All-District honoree at offensive guard. Gilliland will again handle the place-kicking chores for the Whirlwinds. Gilliland's backup on the right side is 200-lb. senior Rance Golightly.

Adam Gonzales, one of the more heralded younger linemen of last year, returns to the right tackle spot. The 6'3", 257-pounder was named 2nd Team All-District offensive lineman as a sophomore. He suffered a season-ending injury in the Littlefield game. Following a successful off-season rehabilitation, "Boom-Boom" is ready to take up where he left off in 1991. Gonzales is

also the strongest Whirlwind. He benches in the 350-lb. range, and is amazingly quick to be so large. Troy Johnson and Tyson Edwards fill the depth chart at this position.

Junior Rafael DeOchoa (5'7", 229-lbs.) will resume assignment at left tackle, where he saw considerable action in 1991. 220-lb. Tate Harris is an experienced hand, and is projected here as a backup for DeOchoa.

The receiving corps (tight ends and wide-outs) was the only area on the offensive front hit by graduation. Senior Jesse Rodriguez (5'9", 175 pounds) is the lone returning starter. Rodriguez gained 2nd Team All-District recognition last year. Brandon Gilliland, a 6'3-1/2", 197-lb. junior, has been moved from #2 offensive center to tight end, giving Floydada quarterbacks a huge target in short passing situations and a stout blocker in the running game on his side. Jason Pyle brings a lot of experience to the position. Others on the wing, who will be receiving threats, are seniors Jonathan Simpson, Jeremy Rubio, and Victor Mendoza.

No sooner had the final buzzer sounded in the Childress Bi-District game at Plainview on a dreary night last November, than the question went out, "Who will replace (Billy Joe) Villarreal at quarterback for 1992?" It was projected to be a big job to fill the shoes of the versatile, unanimous All-District

trigger man.

With two weeks remaining before the opener against Lockney on September 4, it now appears that 5'10" senior Josh Thayer is the heir apparent as the Whirlwind field general. Thayer experienced limited varsity action last year, mainly due to two seniors ahead of him (one of them an All-District selection). However, Thayer was at the throttle for most of Floydada's junior varsity games, which gave him time to develop the necessary skills to assume the role as the leader on the field. Junior Tate Glasscock (5'9", 130-lbs.) and sophomore Sammy Rodriguez (5'8", 150-lbs.) could also see a lot of playing time.

Fullback is still up for grabs. Juniors Mike Ochoa (5'8", 175-lbs.) and Tyrone Henderson (6'2", 197-lbs.) are expected to battle it out for the starting role. Henderson packs a lot of power in a big frame, but either one will have some giant shoes to fill in replacing four-year starter Ruben Chavarria. Tyrone is also expected to handle the punting duties, but many of the kicking and special units assignments are yet to be determined. Ronnie Hernandez will add some depth to the fullback position.

Seniors Michael Henderson and Jammie Davis bring a world of experience and a one-two explosive punch into the split-back positions of the Whirlwinds' wishbone. Davis, 6-0, 175-pounds, had successful off-season shoulder surgery, and is now at "full go." In all likelihood, Jammie, a 2nd Team All-District as a junior, is one of the few running backs in the area to bench-press 300 pounds.

Backups to Davis at right halfback are 5-8, 160-pound Israel Medrano and diminutive Gabino Suarez, a 5-3, 115-pounder. Much like older brothers and predecessors Frank and Jaime, he can hurt opponents in more ways than one — they might do well to respect this little man!

Henderson is a game-breaker and a quality running back. His All-District and honorable mention All-State performances a year ago attest to this. He rushed for over 700 yards in a balanced offense in 1991, with a 7 yards-per-carry average.

Henderson's quickness (4.53 in the 40), agility (a 33-inch verticle leap), and strength (benches 275 pounds), not only give him the necessary tools for an outstanding senior campaign, but also should place him high on the shopping lists of a number of collegiate recruiters.

Sophomore Pete Cooper and junior Joe Hernandez wait in the wings here at the left halfback spot.

The Whirlwinds' stopper units have been at or near the area's top in defensive statistics during the three years Dean Bates has been the Floydada grid boss. Granted, most of the defensive starters are also the offensive standouts. Their ability to go both ways in the "smash-mouth" wars of Class 3A football can be directly attributed to Bates' grueling off-season conditioning program. Most of this year's senior class have had four seasons of this mind and body-building regimen, and the results are impressive.

Rafael DeOchoa will solidify his position at nose guard, where he received 2nd Team All-District honors as a sophomore. Rance Golightly will be a capable substitute at this important position in the "50" defensive plans.

Todd Cage and Adam Gonzales were 1st Team All-District tackles a year ago, and both are being touted as All-State candidates this fall. Both are excellent rush defenders and, along with DeOchoa, will make it rough on opposing offenses on the inside of the trenches. Micheal Gilliland and D.G. Hollums both provide plenty of muscle here in backup roles.

Scott Crader returns at one defensive end (he was named 2nd Team All-District at the spot last year), and Jesse Rodriguez will man the other end assignment. There will be little letdown when subs Wayne Wells and Brandon Gilliland fill in for the starters.

The front five of the Whirlwind "50" defense returns intact from 1991, when they allowed only 113 total points in ten games. They permitted an average of 11 first downs and 221 yards-per-game total offense. An amazing statistic from 1991 was the turnover ratio. Ten opponents gave up 31 total turnovers to Floydada's 7! With new rules permitting the advancement of a fumble from any place on the field, look for the Whirlwind defenders to put a number of return yards and points on the board.

Last year the biggest ball hawk for the 'Winds was Ramiro Rios — with four fumble recoveries and four pass interceptions. Unfortunately, the All-District 2nd Teamer is no longer eligible. "Chucky" will also be missed on special teams, where he was a terror on the kickoff squad. Gone also via graduation is All-District and All-South Plains line-

backer Ruben Chavarria.

Junior Mike Ochoa moves into the strong side linebacker spot, with Ronnie Hernandez expected to see action as an able backup. 5-8, 160-pound Israel Medrano will take over at the "Mike" (weak side) linebacker post. Tyson Edwards and Johnny Eguia are capable substitutes here.

Jason Pyle, Victor Mendoza and Jonathan Simpson will battle for the left corner slot vacated by 1st Team All-District performer Quincy Johnson. Gabino Suarez and Sammy Rodriguez will contest for the vacated right corner-back position.

The safety duo of Michael Henderson and Jammie Davis are back to defend the deep threats. Strong safety Davis is backed by utility players Jeremy Rubio and Joe Hernandez, while Josh Thayer and Pete Cooper are slated to see action at free safety behind Henderson.

## BILL'S NOTES

The hard work and dedication shown by the Whirlwinds during off-season clearly establishes that they are a determined bunch to resume where they were when they were hijacked by Childress in last year's Bi-District clash. A lot of good things must happen for the Green Gang to duplicate 1991's fine 8-2 regular season record.

Four of the first five games will be against opponents picked to be strong contenders in their respective districts. Two of those foes, Hamlin and Reagan County, have been state-ranked by most pre-season pollsters.

How will the 'Winds fare against such quality teams in non-conference action? Find out next week when my 1992 Football Forecast appears (yes, Lane, I finally found that elusive Gypsy Lady!).

## LETTER TO HOUSEHOLDS (Multi-Child Meals) NATIONAL SCHOOL LUNCH PROGRAM/SCHOOL BREAKFAST PROGRAM

Parent/Guardian:

The Floydada school serves meals each school day. Elementary children may buy lunch for \$1.25 and breakfast for .40. Children may also get meals free or at a reduced price. For secondary, children may buy lunch for \$1.35 and breakfast for .60.

If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the same or less than the amounts on the Income Chart below, your children can get free meals or reduced price meals. A foster child may get free or reduced price meals regardless of your income. The reduced price is .40 for lunch and .30 for breakfast.

TO GET FREE OR REDUCED PRICE MEALS FOR YOUR CHILDREN, YOU MUST COMPLETE AN APPLICATION AND RETURN IT TO THE SCHOOL. WE CANNOT APPROVE AN APPLICATION THAT IS NOT COMPLETE.

### HOW TO APPLY

If you now get food stamps or AFDC for the child you are applying for, the application must have the child's name, a food stamp or AFDC case number for that child, and the signature of an adult household member. If you are applying for a foster child, the application must have the child's name, the child's "personal use" income, and an adult signature. If you do not list a food stamp or AFDC case number for the child you are applying for, then the application must have the child's name, the names of all household members, the amount of income each person got last month and where it came from, the signature of an adult household member and that adult's social security number or the word "none" if the adult does not have a social security number.

**Verification:** Your eligibility may be checked at anytime during the school year. School officials may ask you to send papers showing that your children should get free or reduced price meals.

**Fair Hearing:** You may talk to school officials if you do not agree with the school's decision on your application or the results of verification. You may also ask for a fair hearing. You may do this by calling or writing. You may do this by calling or writing:

**REPORTING CHANGES:** If your children get free or reduced price meals because of your income, you must tell the school if your household size decreases or your income increases by more than \$50 per month or \$600 per year. If your children get meals because you get food stamps or AFDC, you must tell the school when you are not getting AFDC or food stamps for them. You may then fill out another application giving income information.

**Confidentiality:** School officials use the information on the application only to decide if your children should get free or reduced price meals.

**Reapplication:** You may apply for meals anytime during the school year. If you are not eligible but have a change in status, like a decrease in household income, an increase in household size, become unemployed or get food stamps or AFDC for your children, you may then complete an application.

**Handicapped:** Meal substitutions at no additional cost for children who meet the definition of "handicapped" will be served, provided a physician has submitted a statement attesting to this fact and prescribing a substitute.

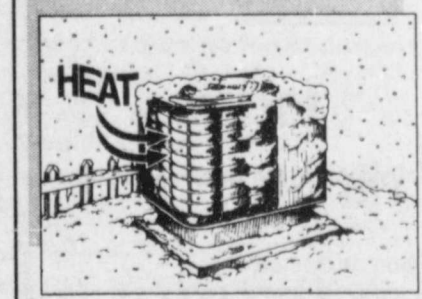

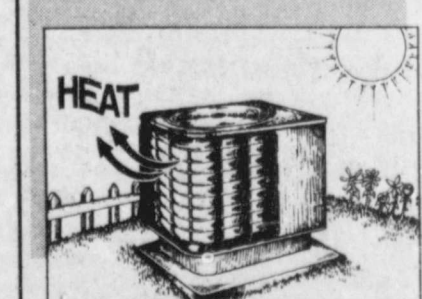

## FCED discusses budget, tax rate

of July 31, 1992, according to Collins.

Collins then presented a proposed budget for the 1992-93 school year totaling \$14,650,000. The basic budget includes expenditures for legal representation, appraisal district fees, insurance, travel and a first year audit. The proposed total expenditures would be divided between LISD and Fisd.

The FCED board was asked to study the budget and be prepared to make any changes and adopt the budget on Friday, August 28.

A separate escrow account contains \$7,762.00 in tax collections which were taken in over and above the 94% collection rate upon which the 1991-92 FCED budget was based. This money will be deducted from the amount the district must raise in tax revenues for the 1992-93 school year and will be disbursed to the two districts comprising the entity at the beginning of the next fiscal year.

State mandated formulas were used to determine the amount of tax revenue the FCED is required to raise through local tax revenues during the coming fiscal year. Collins told the group that the required amount is \$1,336,041.00. This is to be raised by increasing the current 72 cent per \$100 valuation in ad valorem taxes to a state dictated 82 cents per \$100 for the 1992 tax year.

"In order to raise the required amount," said Collins, "we have to apply the appraisal district's certified tax role and the proper formula to determine the local tax rate needed to yield the correct amount of tax revenue."

Calculating this, the local tax base is placed at \$198,934,715.00. Figuring a 94 percent tax collection rate, the district would need to set a tax rate of 80.37 cents per \$100 valuation in order to raise the required \$1,336,041.00 in local revenues said Collins. Total revenue calculated at a 100 percent collection rate would equal \$1,502,939.00 plus the \$7,762.00 in carry-over from 1991-92 collections according to Collins.

The total funds collected would be disbursed on a pro rata basis according to the local tax base in each individual school district. LISD would receive \$562,400.00 and Fisd would receive \$940,539.00 if all local taxes are paid as scheduled. Adding in the CED expenses, the total budget for Floyd County CED would be \$1,517,589.00.

A public meeting to review and adopt an FCED budget for 1992-93 and to set a tax rate for the 1992 tax year was slated for 12:00 noon on Friday, August 28, 1992, in the Fisd board meeting room at 226 W. California in Floydada. Motion for the meeting was made by Martin and seconded by Hinsley. Brown joined the pair in a unanimous vote to set the meeting at that time.

### WEED CONTROL

Weed control measures must be carried out on CRP, ACR, and CU for Pay acres throughout the calendar year. Weeds must be controlled so that they do not interfere with the established cover or create a problem with other farms. It is your responsibility to control weeds and failure to do so could result in

loss of program benefits.

### 1993 WHEAT PROGRAM

It has been announced there will be no set-aside requirement for the 1993 wheat program. The target price will remain \$4.00 and the national loan rate will be \$2.45.

### FAILED CROPS

Producers are reminded that crops must be certified and an ASCS-574 (Application for Disaster Credit) filed prior to destruction of the crop.

### SPOUSE SIGNATURE CHANGE

Effective August 1, 1992, spouse signature requirements will change to permit a husband or wife to sign on behalf of the other for most farm programs in which either has an interest. Written notification to the county office will be required to deny a spouse this authority.

### 1991 NL PAYMENTS

There will be no NL payments of wheat, barley and oats for 1991. The 12 month national weighted average market prices exceeded the loan rates before reduction. The NL payment is not limited to the \$50,000 payment limitation.

### HAYING AND GRAZING

Haying and grazing of acreages designated as ACR or CU for Pay is not allowed from May 15 through October 14 in Floyd County. Haying and grazing of CRP is not allowed at anytime.

## NGSP asks Bush to include Ethanol

The National Grain Sorghum Producers (NGSP) has asked President Bush to decide by August 25 if ethanol will be included in the reformulated gasoline program under provisions of the Clean Air Act Amendment. NGSP has joined the National Corn Growers and other farm groups in pushing for ethanol's inclusion in the program. The Environmental Protection Agency (EPA) is presently weighing options for ethanol's role in reformulated gasoline.

"National Grain Sorghum Producers supports the Clean Air Act Amendment of 1990," said NGSP President Jeff Casten, a sorghum producer from Quenemo, Kan. "Ethanol has been proven to be environmentally friendly, and it was Congress' intent that ethanol be included in the program. However, EPA's proposed regulations have prevented ethanol's use in reformulated gasoline."

The loss of the reformulated gasoline market for ethanol would have a significant impact not only on agriculture, but the rest of the economy as well, Casten said. The fuel ethanol industry adds substantial benefits to the economy, he added, with the benefits most obvious in the areas of jobs, personal income, agricultural income, energy, clean air and the environment and in industries using ethanol production by-products.

Because ethanol is produced in the United States from renewable resources, it lessens our dependence on foreign oil while decreasing both the federal deficit and the U.S. trade imbalance, Casten said. Every barrel of ethanol used replaces the gasoline derived from two barrels of foreign oil.

While most ethanol is produced from

corn, it is estimated that between 18 and 20 million bushels of grain sorghum are used annually in ethanol production. A significant amount of ethanol from grain sorghum is produced at plants in Nebraska, Kansas and New Mexico. Ethanol plants in these areas rely on locally grown grain sorghum as an economical and readily available source of ethanol production. The ethanol plants

in these three states consume approximately \$40 million of grain sorghum each year.
