Republicans in the county also chose Sam Bayless for the Court of Criminal Appeals, Place 2. However his challenger on the ticket, Sharon Keller, was picked statewide with 57% of the vote.


In Floyd County, on the democrat ticket, Texas Supreme Court Justice Raul Gonzalez was chosen with a total

Both Swate and Riney agreed that the dismissal of Walls and the resulting lawsuit would be a separate issue from a Dec. 7 board meeting in which Dr. Swate's contract was terminated by the Caprock Hospital Board of Directors. Swate also has a lawsuit pending against the Hospital District in a Houston Federal Court.

Judge Forbis has set the jury trial in the Walls Vs. Caprock Hospital and the December 21 meeting for two days, April 25-26. It will be held in the Floyd County District Courtroom.

County considers curfew ordinance

County discussed passing a county wide curfew ordinance during the April 11 regular session of the county officials. The discussion was prompted by the recent approval of a curfew ordinance by the City Council of Floydada.

"If the city's curfew is going to work," said Precinct 1 Commissioner Connie Bearden, "The county will have to go along, otherwise, all the problems are just going to move out in the

Precinct 3 Commissioner George Taylor expressed the view that the city ordinance allows young people to be out too late at night and Precinct 2 Commissioner Floyd Jackson added that it should really be up to the parents of young people to get them home at night. He added, "I know that is not always possible and someone else has to be responsible for setting limits on them." After discussing the proposed ordi-

County Treasurer Glenna Orman presented both monthly and quarterly reports to the court. These reports stated that the county began the month of March with \$338,617.23 in funds and took in \$279,831.14. Disbursements totaled \$287,410.13, leaving the county with \$331,038.24 as of March 31.

Orman also reported certificates of deposit totaling \$520,000.00 which have earned interest to date in the amount of \$7,239.39. \$350,000.00 in undivided tax collections accounts for the largest CD. Precinct 3 has a CD in the amount of \$130,000.00 and Precinct 4 has a CD in the amount of \$40,000.00.

Floyd County Ag/Extension Services made a mid-year report to the court. Kerry Siders presented a briefing of the agricultural and community development activities of the extension service and Melissa Long told the court of the activities involving 4-H programs and the home economics portion of the office.

Farm work contracts were approved for seven and three contracts were voided at the Monday morning session. Approved in Precinct 3 were: #1453 for Eugene Beedy to level land for soil conservation at a site 7 miles north of South Plains; and #1434 for Neil Langley to cleanup old improvements and cut a waterway for agricultural use and conservation at a site 10 miles east of Lockney.

Lockney City Councilmen hear waste management alternatives

LOCKNEY — Ron Coomer from Triple C Sanitation and Floydada City Manager Gary Brown met with the Lockney City Council to discuss waste management. During the Thursday, April 7, session, each discussed present and coming regulations regarding the disposal of municipal waste materials. Brown told the council that the Floydada Landfill has reopened and Lockney and Floyd County residents are welcome to utilize the facility. They will be charged \$20.00 per ton for waste materials they bring to the landfill. Brown stated that there is a \$5.00 minimum for loads weighing less than a ton. Other information Brown provided the council included the fact that loads must be secure when arriving at the landfill and that certain materials such as tires, lumber and tree limbs must be separate and deposited at designated locations at the landfill. He stressed that recycling is becoming a factor in waste management and will be of increasing importance in the future.

"We are going to work with Lockney where ever possible to make this work," said Brown. "We are all going to have to work together in order to serve our citizens."

Coomer told the gathering that recycling would help alleviate some of the waste management problems which exist now and would almost certainly be mandated in the future. He offered several suggestions concerning things the city might look into in order to control the cost of waste management for the City of Lockney.

If a condom won't keep her from getting pregnant-what makes you think it will keep you from getting AIDS.



FISD considers asbestos removal

FLOYDADA - Board members of Floydada Independent School District instructed Administrative Assistant Jimmie Collins to pursue bids for removal of deteriorating asbestos materials in a pipe chase beneath R. C. Andrews Elementary and additional materials at Floydada Junior High. Collins asked for permission to advertise for removal bids during the Monday, April 11, meeting. He will be working with King Consulting of Lubbock to develop specifications for the removal bid publication.

According to Collins, grant funds for asbestos removal are no longer available, but he indicated that an application for a grant could be completed and placed on file. If funds become available at a later date, a grant could be made retroactively. No cost estimates were discussed.

Collins was asked if this would get all the asbestos out of the schools. His reply was, "No, we're not ever going to get it all, but this will get the part that keeps us in trouble with the government." He went on to explain that asbestos can be found in many areas, such as under floor tiles, but is no danger unless it is fragmented and released into the air. "It has to be breathed to harm you," he said.

Roberta Hardin, Federal Programs Coordinator for FISD was given the floor for presentation of a prepared statement concerning positive input on behalf of the school principals. Hardin stated, "Events of the past few weeks have greatly disturbed me. Negativism seems to be creeping into our beloved community through our schools, public offices and churches."

Hardin next read statements praising each principal in the system. Following that, she asked that the entire community, including the school board and all school parents, display their full support for these educators. She told those present, "We will lose quality people if we fail to support them."

How was it possible for her to reap one-day profits from multiple contracts when she only controlled one, at best? It's all very curious.

Also curious is an even later revelation by the White House, that a separate trading account the First Two has said they (or she) lost money on, actually provided them a short-term capital gain in the amount of \$6,498. (That, plus some other overlooked income, has caused the President and Hillary to pay an additional \$14,615 in back taxes.) The President has repeatedly said Hillary got out of the market when the' strain proved too great during her pregnancy. Now it is evident this was not true. Records of the "overlooked" account show Hillary traded until May of 1980, several months after their child was born.



Moore, to level land around irrigation wells for soil conservation at a site 14 miles north of Lockney; and #1442 for R. W. Wilson to clean up old improvements to put into cultivation 3 1/2 miles west and 1 mile south of Lockney.

Precinct 1 contracts approved were: #1160 for Mark McCormick 4 miles south of Floydada to clean out a drainage ditch; and #1404 for Jim Jackson at a site 11 miles southwest of Floydada to clean out a drainage ditch and tailwater

Contracts voided included #1440 for Don Marble which was tabled on March 14, #1431 for Beth Kropp by Wilmer Gene Archer which was approved on March 5, and #1428 for Joe Cunyus which was approved on February 23.

... Two requests to cross a county right-of-way were granted. The first, to GTE Southwest, allows installation of a telephone cable and the second is for installation of a gas line by West Texas Gas, Inc. Each installing company will be responsible for all costs involved and for returning the county roadway to satisfactory condition following the installations.

Commissioners approved a contract with the City of Floydada for county use of the Municipal landfill. The county will be using the landfill for waste disposal as necessary and paying fees of \$20.00 per ton. Additional charges will be levied if landfill personnel are called upon to unload the materials or if the city is asked to pickup the materials and deliver them to the landfill for the county.





Your Health * Our Care

Polio is a very dangerous disease caused by a virus. Many of us remember working with patients in iron lungs after they became infected with polio or, at the very least, studying pictures of patients in iron lungs. You may even know someone living today who was a child during the 1940's and 50's who sustained damage to their nervous system as a result of the polio infection. The serious cases of polio may cause paralysis of the arms, legs and chest while severe cases can result in death.

There are two types of polio vaccines. Most experts recommend the live Oral Polio Vaccine called "OPV". "Live" means that the polio virus used in the vaccine is still alive but has been made very weak. This type of vaccine is given as drops in the mouth. The other vaccine is called IPV (inactivated polio vaccine). "Inactivated" means that the polio virus used in the vaccine has been killed. This type of vaccine is given by injection.

At least 90 out of every 100 people who receive three or more doses of either OPV or IPV will be protected against polio. The best way to be protected is to receive four doses of the vaccine. Most infants should receive two doses by 4 months of age, and a third dose at 15-18 months of age. The fourth is usually given at 4-6 years of age.

Very rarely, OPV causes polio in the person who receives the drops. The person who receives this vaccine, the chance of becoming paralyzed is higher after receiving the first dose of vaccine than after the second, third, or fourth. Nursery and she budded 120,000 pecan

Paralysis after the first dose occurs about once for every 1.5 MILLION doses of drops given. Paralysis after later doses occurs only about once for every 40 MILLION doses given. Polio is even more rare in unvaccinated people who are in close contact with the person who receives the vaccine. IPV injections cause slight soreness at the infection site.

OPV is contraindicated if the individual tests positive for HIV or has household contact with a person who tests positive for HIV (because HIV destroys tion.) OPV Is also contraindicated if the individual has been diagnosed with any type of disease affecting the immune system such as cancer, leukemia, or lymphoma. To make certain your children are up

FLOYDADA--Both Floydada track squads competed in the Wildcat Classic at Littlefield on April 9. The Whirlwinds amassed 73 total points to place fourth in team standings. Shallowater scored 121 points for the team championship. The Lady 'Winds scored 33 points and placed 6th in girls team totals. The Littlefield meet was the final tuneup before the District 2-3A track meet at Muleshoe on April 15-16.

Pinto bean farmers to get crop insurance


The Federal Crop Insurance Corporation has determined farmers who grow pinto beans in Floyd, Castro, Crosby, Dallam, Deaf Smith, Hartley, Lubbock, Ochiltree, Oldham, Moore and Swisher counties meet the agency's requirements to qualify for crop insurance, Agriculture Commissioner Rick Perry said.

"Without crop insurance, farmers find it difficult to obtain loans, so we are pleased that the FCIC has worked with our producers in these counties who wished to qualify for crop insurance," Perry said.

"These farmers have found new markets for pinto beans, and they want to diversify to meet this growing demand. However, many banks will not make loans to them unless they have crop insurance, and they can't expand their production without loans so they have been caught in a type of 'Catch' situation."



The Floyd County 4-H "Silver Spurs" Horse Project will be sponsoring a county-wide vaccination clinic to be held on Thursday, April 21, from 5 p.m. to 7 p.m. at the Lockney Vet Clinic. Vaccinations for Tetanus and Sleeping Sickness will be administered by Dr. Paul Glasson.

Horses should receive an annual vaccination to prevent illness and even death which can occur from both Tetanus and Sleeping Sickness.

Tetanus enters the horse's body through physical injuries such as cuts and puncture wounds. Sleeping Sickness is also known as equine Encephalomyelitis in which there are three types of this disease found in the United States. Sleeping Sickness is transmitted by mosquitoes and can be a problem in both pastured and stabled horses. The result of both diseases can be death, a death which can be prevented by annually having your horses vaccinated.


