## District makes contribution to EMS building fund

# Caprock Hospital District contracts with Dr. Albert

FLOYDADA — A special called meeting of the directors of Caprock Hospital District was held Friday, May 13, 1994. Board members approved contracting with Dr. Antoine Albert for physician services at Cogdell Clinic beginning May 23, 1994. Motion for the action was made by Joy Assier and seconded by outgoing board member Fred Thayer. All voted in favor.

Board president Tom Farris presented the board with a two year contract which he said had "been hammered out" with Dr. Albert who practiced in Floydada under the auspices of St. Mary's until last December. Farris asked for board approval to pay the physician on an hourly basis for his services. Farris told the board that the

district will be responsible for paying all expenses related to the practice including staff, supplies, necessary renovations and upkeep to the clinic and malpractice insurance for the physician. In return, all revenues generated by the practice will belong to the district. Albert's contract with St. Mary Hos-

pital will expire May 19 and he will use the ensuing week to establish his practice at the clinic in Floydada. Hospital employee Bob Ericson will serve as business manager for the clinic which will be open Monday thru Friday after May 23.

Farris indicated that the hospital district will not be actively recruiting another doctor until Dr. Albert has built up his practice and there are enough patients to warrant an additional physician. Albert told the gathering he might be able to bring a nurse practitioner to the clinic in a few months and that he would assist in setting up a rural health care facility here should the board decide to establish one in the future. Lab

and x-rays would be done on the premises whenever possible with the remainder of the work sent out when necessary.

Floydada will continue to be served by Floydada Emergency Medical Services under the terms of a second contract Farris presented for board approval during the Friday morning meeting. The

Mr. Michael Fay has taken his licks (four of 'em) from a split bamboo cane and is now recovering from that "cruel and inhuman" punishment in a Singapore jail.

His sentence, for a few nights of vandalism in a city that has laws against such behavior, and which enforces those laws, caused quite a stir among America's politicians and editorial writers. Even President Clinton got in the act. The hallowed chambers of the U.S. Senate echoed Mr. Clinton. Many editorial writers across the country, not a few of whom were sympathetic to, if not active participants in, the vandalism that marked the 60's in this country, decried the "torture" to which young Fay was subjected. It was only the American people who seemed to feel he deserved his punishment.

It didn't bother us at all. In fact, our own view is that the practice could be profitably utilized in this country as well. It won't of course, but a lot of spoiled brats could well be helped by a public flogging. It would, no doubt, improve their attitude, and their future course of behavior when it comes to life in a civilized society.

We really don't know what Singapore is like nowadays. We were there last in the early '70's, on the way to a meeting of allied officials in Australia when the war was raging in Vietnam. Then, it was a prosperous, clean, progressive, well-run city. More like a city-state, run by a Prime Minister, or whatever, named Lee Kuan Yew. He was a staunch champion of free enterprise, and of a safe and secure society, determined that the turmoil engulfing his neighbors to the north would not find a home in Singapore. In that, he evidently had the overwhelming support of his people, for he was elected and re-elected, time after time.

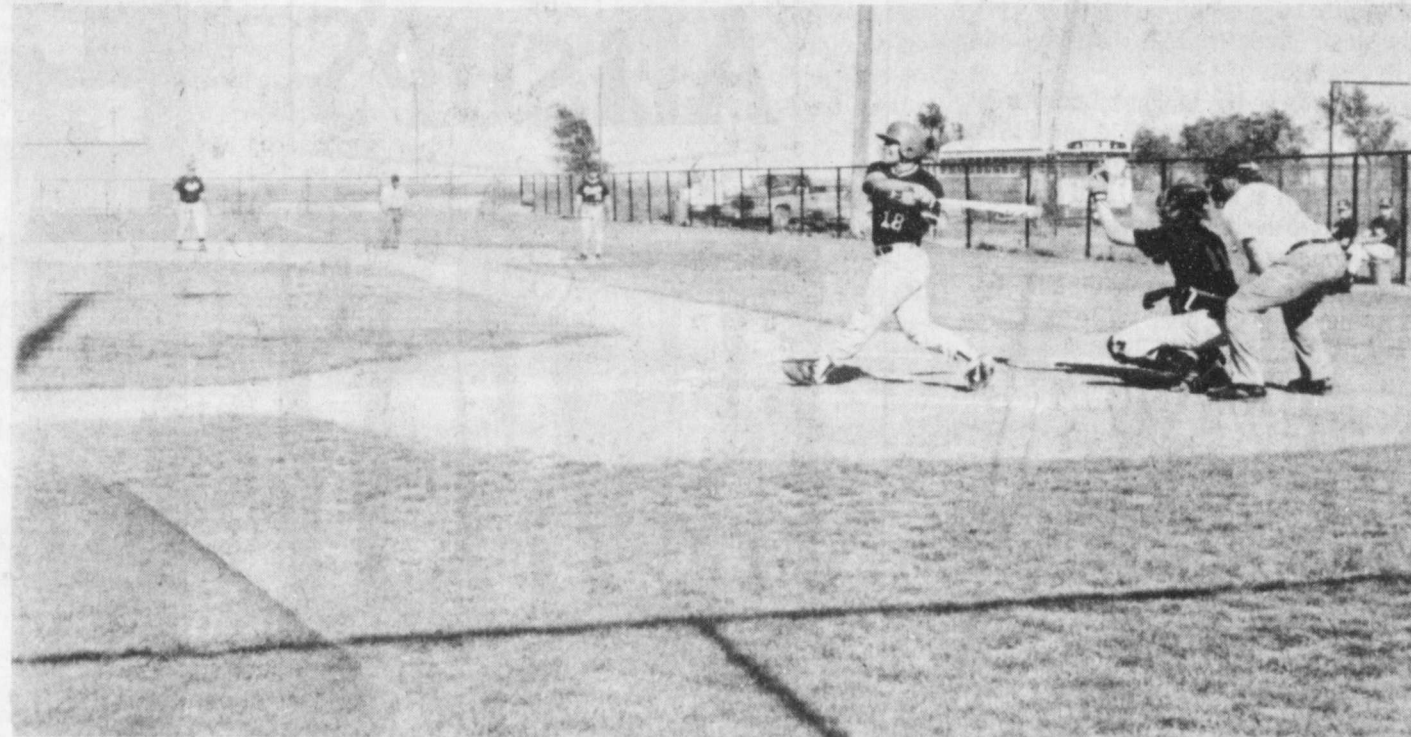
At that time it was common to see, whether in London, or Rome, or in Ball or Malaya or Indonesia, long-haired, unkempt, pot-smoking, American hippies from well-to-do families, doing their "thing" while their less affluent cousins slugged it out in Vietnam.

But they wore no in Singapore. I noticed this absence, and inquired about it among the Embassy personnel. The explanation was simple.

When one of them got off the plane in Singapore, he was met by the police, escorted to the barber, shorn of his locks, and welcomed to the city. It didn't take long, I was told, for the word to spread. They went elsewhere.

The tactics employed by the Singapore government couldn't, wouldn't and probably shouldn't, be employed here. But that is their country. They make the laws there. Their laws are not made in America. Singapore laws are not enforced in America, and American laws are not enforced in Singapore, despite the concerns of American politicians. When American politicians in Washington rid America of vandalism and other crimes, will be time enough for them to become involved in advising the citizens of Singapore how they should control their own.

After all, that shouldn't take so long. As everyone knows, those who run Congress have now suddenly become seized with the crime issue in America. Now that Washington has become involved we can expect the crime problem to be quickly solved. Along with the problems in Haiti, and Bosnia, and wherever.

# Appraisal District informs property owners of '94 values

Texas property owners have the right to be informed of changes in their property's value by local appraisal districts. On May 10, 1994 Floyd County Appraisal District mailed 2500 property

owners their notices showing the 1994 proposed value.

Shelia Faulkenberry, chief appraiser of the district, reminds property owners that the notice of appraised value is not a tax bill. Please do not pay from this notice, Faulkenberry said.

Faulkenberry emphasized the importance of the notice and the key information that it contains for a property owner. "A property owner has the right to appeal to the Floyd County Appraisal Review Board on any disagreement with the property's value, exemptions, ownership and other areas," she said.

The appraisal review board, more commonly called "ARB", is an independent panel of citizens responsible for reviewing the appraisal district's values. The ARB also hears and settles protests from property owners who disagree with some action by the appraisal district.

What should a property owner look for on the notice? "Take special note of the proposed value for 1994," Faulkenberry said. "The notice shows the land's value and any improvement value for the property for the current year." An improvement is a building, structure, fence or any other type of fixture to the land.

The appraisal notice also includes current year information on exemptions granted to the property. It provides last year's value, too.

Notices to property owners whose values went up or increased more than \$500 will also include "estimated" taxes. These "estimated" taxes are based on the new value and estimated tax rates if the taxing unit set tax rates for the same amount of operating dollars as last year. Generally, taxing units set final 1994 tax rates in August and September.

Faulkenberry asks that a property owner look carefully at the legal description and mailing address to be sure that there are no errors. "If the notice contains an old address, please let the appraisal district know. Mail is only forwarded to a new address for a short time, and tax bills do not go out until October," Faulkenberry added.

A property owner can be liable for additional penalties and interest on a tax bill not paid timely. A property owner is responsible for keeping the appraisal district informed of the correct mailing

# Gonzales captures state shot put title

FLOYDADA--In an almost "made for Hollywood" scenario, Floydada senior Adam Gonzales came from behind to win the shot put event in the UIL Class 3A state track meet in Austin on May 14. Capping a successful athletic career at FHS, Gonzales set a personal-best mark and broke his existing school record with a toss of 58'-1 1/2". Adam's "gold" didn't come easy.

Gonzales had earlier in the year registered an area-best throw of 57'-3" (in the first meet of the season), but trailed Rice Consolidated's massive Jerome Haynes by almost 12 inches entering the final round. It appeared that Haynes' toss of 57'-5 1/2" would hold for the championship. Adam utilized a recently-developed spin technique to overcome Haynes' mark . . . on his final attempt.

Interviewed by Amarillo Globe News' Jon Mark Beilue following his winning toss, Gonzales stated, "I finally got a good, decent throw. I got out good and gave it all I had. I jumped all over it. I'd been stuck on that 57 for so long. Boy, this feels great."

The third-place bronze medal was awarded to Atlanta's Pat Blaylock (56'-3 1/2"). Southlake Carroll's Zach Polling, runner-up to Gonzales in the Region 1-3A meet two weeks ago finished a distant seventh with a toss of 52'-1 1/2". Amarillo Tascosa's Joseph Foster, who pushed Gonzales for the area-best (regardless of school classification) throughout the 1994 track season, finished fourth at the Class 5A meet with a toss of 56'-9 1/4".

The only other participant from District 2-3A to capture a first place in Austin was Dimmitt's freshman sensation Joey Flores, who ran a swift, come-from-behind 1:55.8 for the gold in the 800 meters. Tulsa's highly regarded 1600 relay team finished a disappointing sixth and Andy Kendrick of Friona placed seventh in pole vault. Gilbert Brookins of Tulsa ran seventh in the 200 meters.

There is a good possibility that Gonzales is the first Whirlwind to win an individual gold medal at the state track meet. Some of the school records prior to 1960 are unavailable, but it is safe to say that it has been at least 25 years since a Whirlwind has accomplished the feat.

According to Floydada coach David Carr, "We knew we had something special when Adam was a freshman. He placed in the district meet with a throw of 46'-10". Adam has great work ethics. This, along with his competitive nature and friendly personality made him a pleasure to be around and work with."

The coach added, "Adam is deserving of all awards that come his way. He's paid the price for all of them. We'll miss him next year - in more ways than one."

In the past two years, Gonzales was entered in 17 track meets. He won the shot put in 15 of those outings as well as being very competitive in discus in all but the state meet. Adam was victorious in the shot put in all eight meets in which he competed in 1994 - including the state meet. It was an appropriate ending to an outstanding high school career.

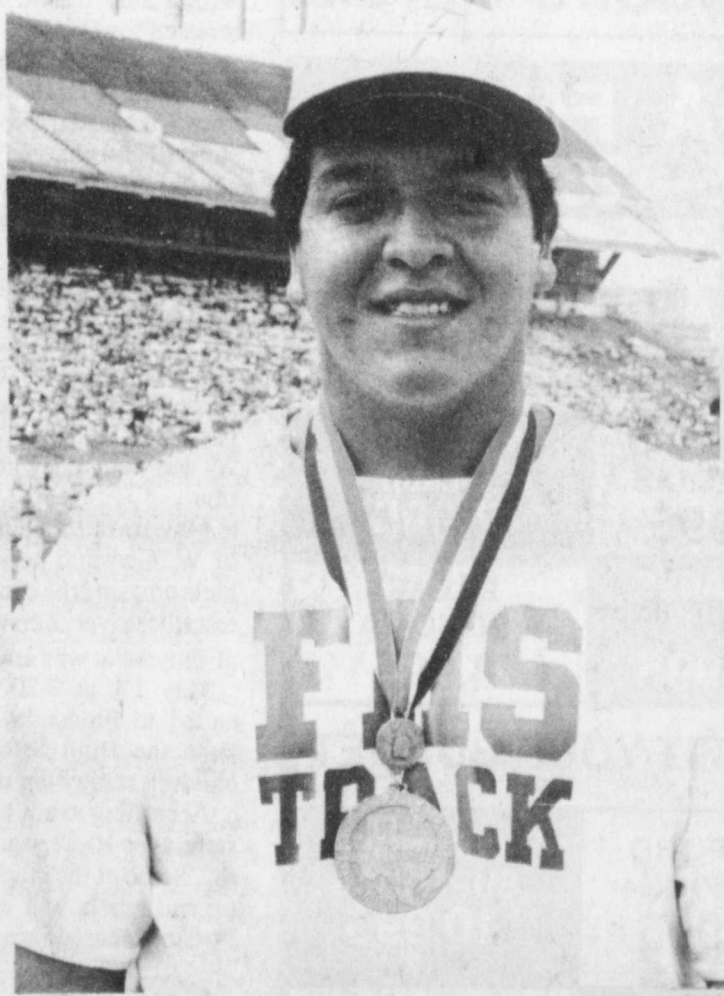
It wasn't a pot of gold, but rather a medal of gold, that Adam found at the end of the rainbow, following the torrential rains that flooded Austin's Memorial Stadium last Saturday.

The coveted gold medal, indicative of a state track champion, has come to very few Floydada athletes. The record-setting mile relay team of 1971 gave the Whirlwinds one of their finest hours on an athletic field. Floydada finished second in team standings that year to AA state champ Sealy (which was led by all-

everything Eric Dickerson). Adam accomplished something that a long line of Whirlwind predecessors failed to do . . . win a gold in shot put at the state meet. Leslie Soto came close in 1976 with a bronze. Others, such as Paul Radloff and Kim Rose - and, later, Adam Cates were all competitive at the district level, but none were able to make that final toss on that final day in Austin.

Adam did, and we are all very proud of him, coaches David Carr and Rex Holcombe, and the entire Floydada athletic department. Coach Bates' off-season program (weights, agility drills, etc.) played a very important role in the physical development of Gonzales. That 385-lb. bench press had a lot to do with Adam's ability and confidence to overcome the big guy from Rice Consolidated (a 300-plus pounder).

There are a lot of bows to be taken on behalf of our state champion, Adam Gonzales!

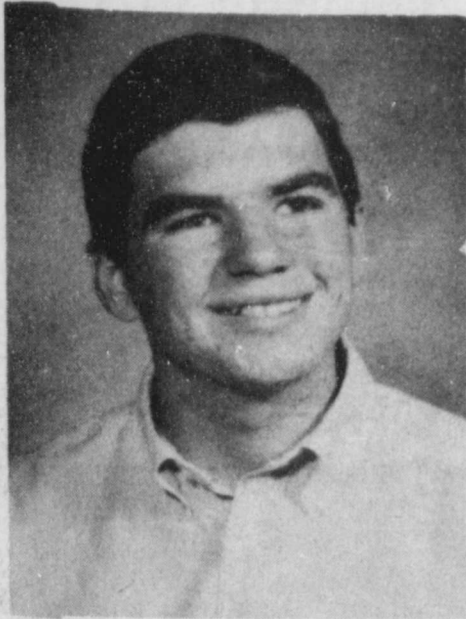

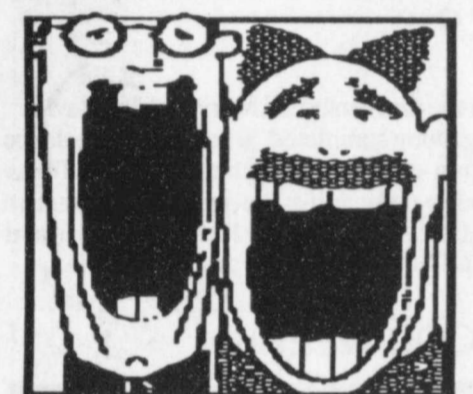

A new councilman, Richard Zavala, was sworn in on Friday, May 13, during a regular meeting of the Lockney City Council. Also sworn in were incumbent Councilmen Gary Marr and J.D. Copeland.

Election results were canvassed and the recent city election was declared legal and valid by the city council.

Councilman Gary Marr was elected Mayor Pro-Tem and Mayor Kenneth Wofford appointed the following department heads: Bill Anderson, fire department; Roger Stapp, police department; Gary Marr, water-sewer-streets; Dee Copeland, landfill; and Richard Zavala, city farm.

Copeland, Stapp, Wofford and City Secretary Charlotte Hooten were also named to the check signing committee.

City Engineer O.V. Johnson was present at the council meeting to present his recommendations on which streets were in the most need of seal coating. Dickie McCarty, city water superintendent, told the councilmen that seal coating of the streets was on an eight year schedule. "Every year we seal coat and in eight years we are ready to start over again," said McCarty.

Johnson informed the board that the city was handling the streets properly and had a good maintenance program.

The council considered a recommendation from Gary Burson asking for the city to move water and sewer lines on property he had purchased. The matter was turned over to engineer Jamie Johnson for a cost evaluation.

Johnny Dorman also appeared before the council and requested the city to

reroute a 6" water line from under his property at 702 1st Street. One estimate received by the city was \$8,000 for the project. Dorman was interested in building a driveway and possibly a garage in the future. His worry was that the driveway and garage would be on top of the line and if there was any future trouble with the line it would be a major cost to him to have his driveway or garage dug up.

The city agreed to look into other possibilities of rerouting the line but because of the estimated cost they could not agree to moving the line at this time. "We need to start being more aware of where people are building in the future," said Councilman Marr, "so that we can keep these types of problems from coming up. I'm all in favor of helping the citizens when we can but sometimes the costs are more than the city can handle."

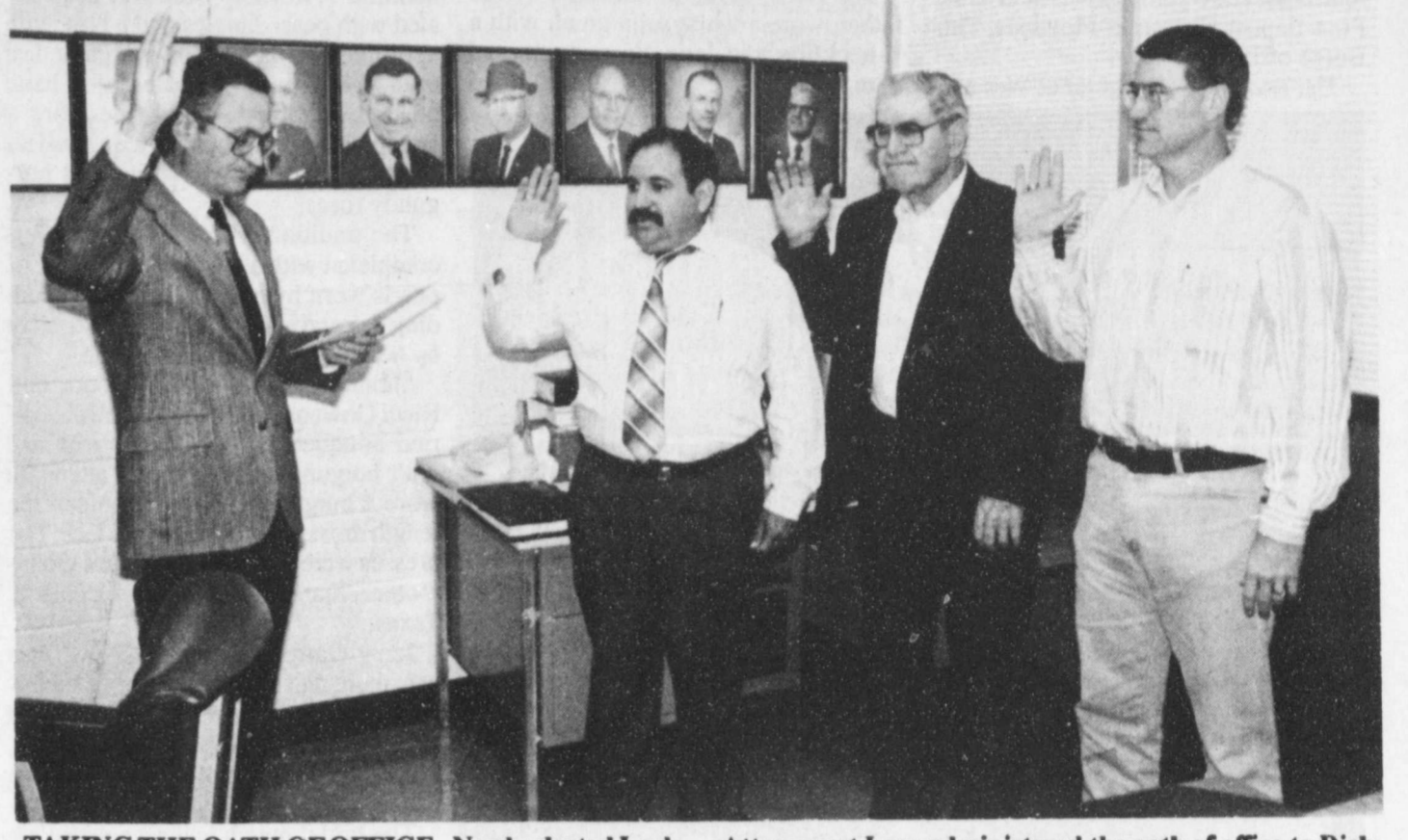
The council accepted bids on several properties, including: a \$600.00 bid from Dickie Hernandez for lots 22-23, Block 1, Tuttle addition; a \$2,500 bid from Paul & Teresa Martinez for lot 5, Block B, Amaya Addition; and a \$450.00 bid from Gordon Adams for lots 3-5, Block 1, Moore 2 addition.

Councilmen also approved the purchase of "light bars" which will be placed on the new police vehicle. Police Chief Lennie Gilroy appeared before the council and said, "There is no law which says you have to have lights on the roof of the police vehicles, but the alley lights and 'take down' lights on these light bars would make it safer for the officers at night it would also be easier for the citizens to see us coming at

night." The council agreed to have the lights mounted on the new car which will be used primarily by the officers patrolling

at night. Councilmen amended the budget to raise expenses of \$15,398.50. More than half of that amount will go toward main-

taining the "roll-off boxes." The council entered into an executive session to discuss personnel and adjourned with no action taken.

### HOW TO PROTEST

Official forms for a notice of protest are available at the appraisal district office. "A letter from the taxpayer is also acceptable," Faulkenberry said, "as long as it identifies the property owner and the property that is the subject of the protest and indicates dissatisfaction with some decision or action of the appraisal office."

Each protesting property owner may offer evidence or argument, either in person or by filing an affidavit with the ARB. Property owners should be aware that the ARB has no authority over tax rates or spending and will not hear pro-

tests on those matters. The ARB will schedule hearings as property owners file protests and will inform them of the time, date and place of their individual hearings at least 15 days before the scheduled hearing date. The property owner will also receive a copy of the State Comptroller's pamphlet entitled Texas Property Taxes: Taxpayers' Rights, Remedies & Responsibilities and a copy of the ARB's procedures.

Faulkenberry said that protest hearings will be held for one day and that the ARB expects to approve the final appraisal roll on June 23, 1994. State law requires the ARB to review and approve the appraisal records by July 20, or when not more than 5 percent of the total property value in the district remains under

protest. Property owners protesting their valuation should not attempt to contact ARB members outside the hearing, the chief appraiser stressed. Each ARB member must sign an affidavit stating that no such contact has occurred with a property owner or the appraisal office staff before the scheduled hearing. Texas Property Taxes: A Taxpayers' Guide to Rights, Remedies & Responsibilities is available at the Floyd County Appraisal District office. ## Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the value placed on your property
- any exemptions that may apply to you
- the cancellation of an agricultural appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- any action taken by the appraisal district that adversely affected you.

**Review by the Appraisal Review Board**  
If you can't resolve your problem informally with the appraisal district staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the appraisal district to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. The hearing will be informal. You and the appraisal district representative will be asked to present evidence about your case. The ARB will make its decision based on the evidence presented. You can get a copy of the protest form from the appraisal district office at:  
P.O. Box 249, Floydada, Texas, 79235

Note: You shouldn't try to contact ARB members outside the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

**Review by the District Court**  
After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order. If the appraisal district has appraised your property at \$1,000,000 or more, you must file a notice of appeal with the chief appraiser within 15 days of the date you receive the ARB's order.

### Deadline for Filing Protests with the ARB\*

**Usual Deadline**  
On or before May 31 (or 30 days after a notice of appraised value was mailed to you whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have a good cause.

Late protests are due the day before the appraisal review board approves records for the year. Contact your appraisal district for more information.

**Special Deadlines**  
For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change didn't result from the protest you filed), the deadline is the 30th day after the notice of determination was mailed to you.

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1). The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

\*The deadline is postponed to the next business day if it falls on a weekend or holiday.

The bridal march and accompanying music was furnished by Kay Crabtree of Floydada.

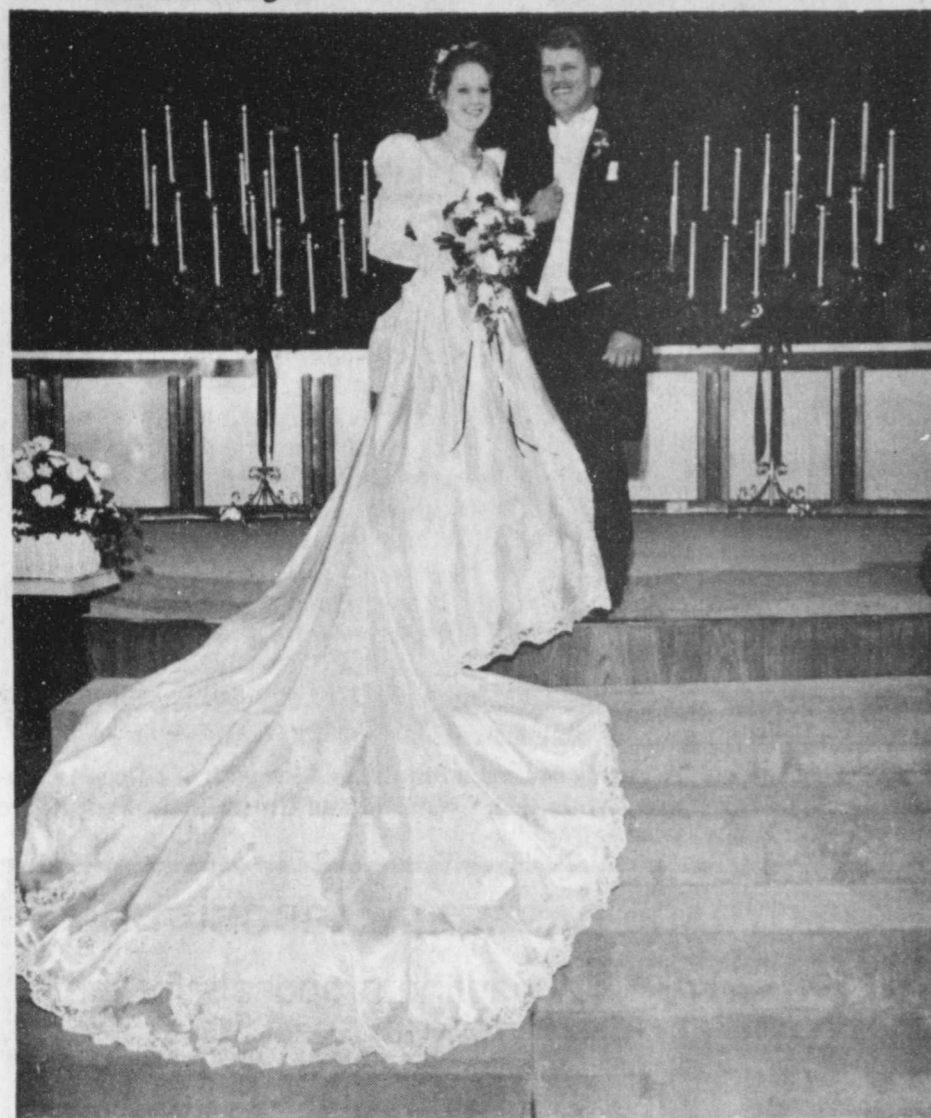

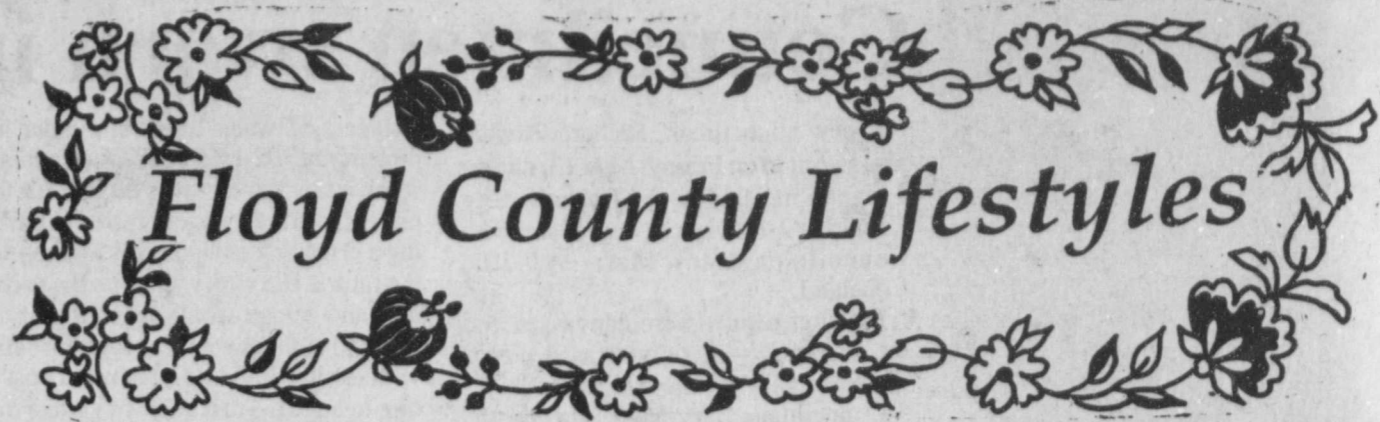
members who attended said the mothers really appreciated it and it was well worth the time and effort.

Sandra Schwertner volunteered to have a social after the Old Settlers dance at her home for members and their families. Members are asked to bring their favorite snacks and finger foods.

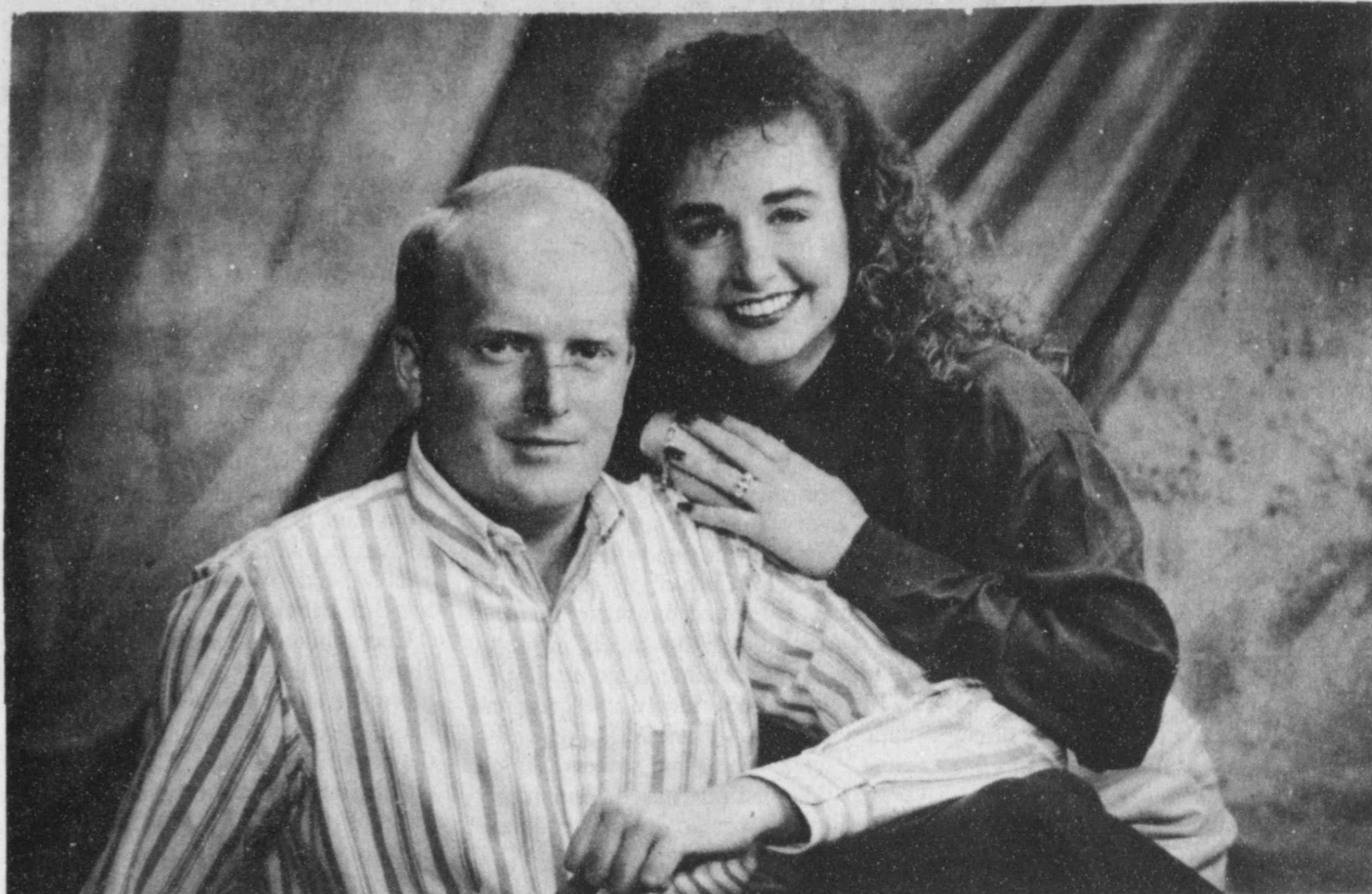

## Beverly Barker named head coach at Calallen High School

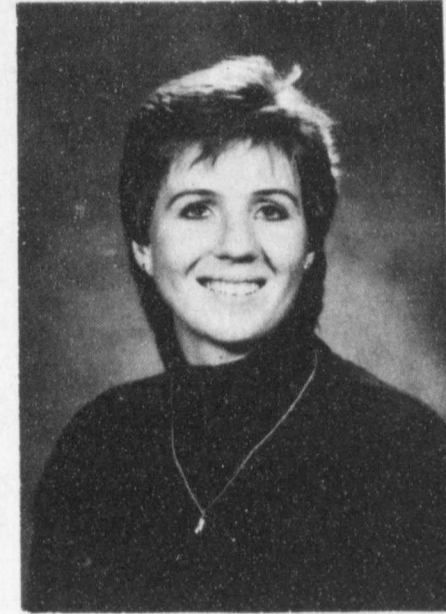
**LOCKNEY**—Beverly Barker has been selected as the new head girls basketball coach at Calallen High School in

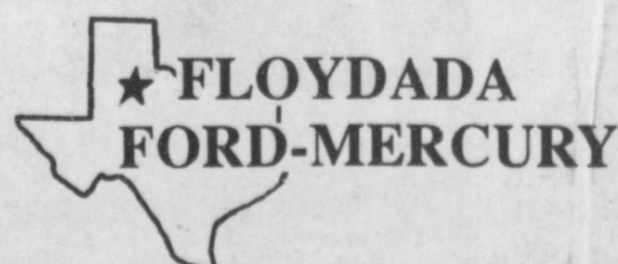

# Whirlwinds edged out by Chieftains in season finale

FLOYDADA--Frona rallied for two runs in the top of the third inning to break a 1-all tie, and squeaked by Floydada 5-4 at Ralls on May 7. An earlier return date with Littlefield was cancelled due to wet grounds at Wester Field, and the Friona game's location was moved for the same reason.

The victory assured the Chieftains a third-place tie with Dimmitt in the final district standings. Each finished with 6-4 district records. The Winds fell to 7-18 overall and 1-8 in district play in the season's final baseball game.

Tulia finished with an 8-2 district mark and will enter the post-season playoffs against Sanford-Fritch as District 2-3A's #1 seed. Muleshoe was prevented from sharing the district title with Tulia due to an earlier 11-10 loss to Floydada. It was the Whirlwinds' only district victory.

The 5-4 loss to Friona was typical of

Floydada's season. The Winds battled to stay close and had chances to win, but just couldn't do it. Eleven base runners were stranded (7 in the first 3 innings). Floydada just lacked the crucial hits with runners aboard.

Defensively, the Whirlwinds played better, but still committed three errors - which led to 4 of the 5 Friona runs. Angel Aleman threw very well. According to Coach Jimmy Webster, "Aleman's pitching has improved to the point that when he throws well, we have a chance to win."

The coach added, "We're going to miss our three seniors, who hit the ball well this year (Gilliland .378, de la Fuente .337, and Gutierrez .333). We'll return 9 players (7 starters), including all the pitchers, as well as 3 of 4 infielders and the entire outfield."

"We'll truly miss Gilliland behind the plate," said Webster. Monty (Anderson) will begin catching this summer and will do an excellent job. He's had a great

mentor back then who worked as hard as anybody in the years of Floydada baseball. I can't say enough about Brandon Gilliland, his work ethics, and his desire to be successful."

Webster, a strong advocate of the summer program stated, "Summer ball will be the best thing that has happened to these guys... You learn a lot about the game and yourself when you play that many games in that short time period. I am a firm believer the nothing is better than game situations. They'll get plenty of opportunities to prove it."

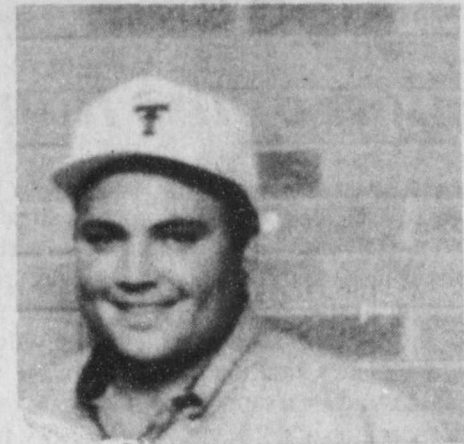

two year contract calls for the hospital district to continue to pay the \$1,833.33 per month subsidy they currently provide to Floydada EMS for operation of the ambulance (still titled to the district) and salary for a fulltime paramedic. In addition, the district will make a one time contribution of \$60,000.00 to Floydada EMS toward the construction of a building to house the ambulance.

According to Farris, CHD board representative on the Floydada EMS board,

the facility will have ample space for the ambulance and an office as well as training rooms, storage, bathroom and sleeping accommodations for 24-hour staffing. The \$65,000.00 project will be located across the street from the Floydada Fire Hall on West Virginia Street and will be erected by local contractor Walter Davis Construction.

The contract can be extended or terminated by mutual agreement. If the contract is terminated, according to Farris, the building will revert to the hospital district's possession.

Motion was made by Thayer to approve the contract subject to approval by Floydada EMS. Assiter provided the second and the vote was unanimously in favor.

The final action taken by the board during the Friday session was the canvassing of votes from the May 7 election. Farris stated that the canvassing had been added to the special session under an emergency addendum since May 13 was the last day to canvass without violating the state election code. The election results were reviewed with

two of the four candidates, incumbent Kenneth Pitts and Joseph Stepp, in attendance. The two candidates elected for the coming term, Rob Heflin and J. R. Turner, were not present. Results were accepted and approved by unanimous vote of the board. The new board members will be sworn in at the regular session of the board on May 17 at 7:00 a.m.

Attending the session were Tom Farris, Joy Assiter, Fred Thayer, Kenneth Pitts, Carmel Eastham, Bob Ericson, Dr.

Antoine Albert, Joe Stepp, Karen Lawson, Ralph Jackson and the Hesperian-Beacon reporter.

## MAY 17 REGULAR SESSION

The CHD board met in regular session on May 17 with Fred Thayer and Kenneth Pitts taking their last official action as directors. Thayer made the motion to approve the minutes of the April 19 regular session, the April 25 emergency session, the May 4 special session, and the May 13 special session including the emergency addendum item of canvassing the election results from May 7. Pitts seconded the motion and it was approved by unanimous vote.

The next item on the Tuesday morning agenda was the swearing in of new members Rob Heflin and J. R. Turner. Floyd County Judge Bill Hardin administered the pre-oath statement and the oath of office to the pair.

Election of officers followed with Tom Farris being elected president of the board by acclamation. Joy Assiter was elected vice president and Carmel Eastham will fill the post of secretary. Farris explained that the minutes of the meetings are kept by Bob Ericson, so the principal duties of the board secretary are to sign reports, various documents and possibly checks.

The board approved a resolution for the bank listing those authorized to handle banking activity for the district. Two signatures are required on all checks and the board president, vice president and secretary will be eligible to sign along with Ericson. Motion was made by Heflin and seconded by Turner.

Farris told the board that the district had approximately \$600,000.00 in bank balances at the end of April. The listed bills to be paid at this time total about \$42,000.00 and the listed bills already paid at this time was approximately \$12,000.00 according to Farris. He stated that these amounts include about \$27,000.00 in legal bills which have been paid. Farris added that the legal expenditures have been submitted to the

district's insurance carrier and reimbursement is expected.

New board members were informed that some of the items on the lists to be paid or already paid included things which were contracts or lease obligations which the district had previously committed to which now need to be honored.

Eastham asked if the hospital currently had only two employees. Farris responded that this is true temporarily. The contract with Dr. Albert will result in his staff members becoming employees of the district. The financial reports were approved on a motion by Assiter, seconded by Eastham.

Regarding physician recruitment, Farris indicated no current efforts are being made to recruit physicians. He stated that under the agreement with Albert, no physicians will be sought at this time. Albert is expected to add a physician's assistant and/or a nurse practitioner to his office staff before the end of the year.

Trina Wilson, a spectator at the meeting, asked if there would still be space for two physicians in addition to the dentist, Dr. William Dean, and Dr. Albert. Farris told her that by combining two office suites into one for Dr. Albert, there would only be one suite remaining. He added that the agreement between the district and Dr. Dean has a clause stipulating that Dean will vacate the office space he occupies if it is ever needed for a physician.

The board skipped a scheduled executive session for discussion of the pending litigation: Swate vs. Caprock Hospital District, Caprock Hospital District vs. Swate, and Walls vs. Caprock Hospital District. Farris reported that nothing new had developed to discuss in closed session.

Attending the early morning session were board members Tom Farris, Joy Assiter, Carmel Eastham, Rob Heflin and J. R. Turner. Also present were Kenneth Pitts, Fred Thayer, Bob Ericson, Ralph Jackson, Bill Hardin, Trina Wilson, Karen Lawson, Joe Stepp and the Hesperian-Beacon reporter.

## Irrigation of the home garden

Adequate soil moisture is essential for good crop growth. A healthy plant is composed of 75 to 90 percent water, which is used for the plant's vital functions, including photosynthesis, support (rigidity) and transportation of nutrients and sugars to various parts of the plant. During the first 2 weeks of growth, plants are becoming established and must have water to build their root systems.

While growing, vegetable crops need about an inch of water per week in the form of rainwater, irrigation water or both. Keep a rain gauge near the garden then supplement rainfall with irrigation water if needed. However with the current rainfall situation, I wouldn't spend too much time watching the rain gauge.

For control of many fungal and bacterial diseases of vegetables and flowers, plantings should be watered in a way that allows the leaves to remain wet for a short time. Several things can influence leaf wetting, especially how and when you water.

Several methods of watering the garden reduce leaf wetting. These include drip irrigation, use of soaker hoses or construction of basins or furrows to hold the water. An additional benefit of spot watering systems, such as drip or basin irrigation and soaker hoses, is that water is conserved and weed germination is reduced in drier areas. However, these types of watering can contribute to problems with thrips, spider mites and cabbageworms, which are decreased by hosing or over-head irrigation.

Watering during the day usually allows rapid drying, unless overcast or rainy conditions exist. Watering during midday, however, often results in substantial water loss through evaporation, an important consideration here in the water-short West. Watering in early morning usually solves this problem.

Early watering also has other benefits for pest management. Dew formation on plants is often the result of gutation fluids, which plants exude as droplets from leaf pores. These beads of water, often

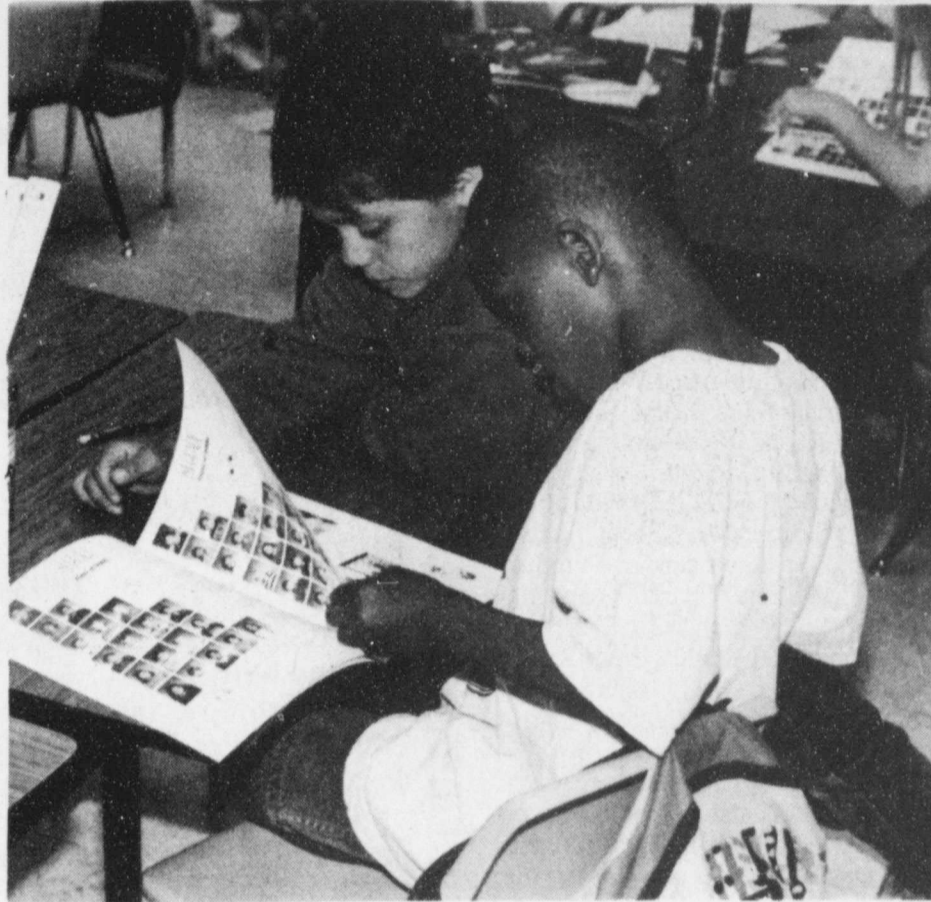
seen in early morning along leaf edges, contain sugars and other nutrients that provide a particularly good environment for fungus spores to germinate. Watering in early morning washes off these sugary droplets.

There are ways, however, to reduce the amount of water you have to add. During dry periods, one thorough watering each week of 1 to 2 inches of water (65 to 130 gallons per 100 square feet) is usually enough for most soils. Soil should be wetted to a depth of 5 to 6 inches each time you water and not watered again until the top few inches begin to dry out. Average garden soil will store about 2 to 4 inches of water per foot of depth.

Mulching is cultural practice which can significantly decrease the amount of water that must be added to the soil. A 4- to 6-inch organic mulch can reduce water needs by as much as one-half by smothering weeds (which take up and transpire moisture) and by reducing evaporation of moisture directly from the soil. Organic mulches themselves hold some water and increase the humidity level around the plant. Black plastic mulch also conserves moisture but may increase soil temperatures dramatically during the summer (to the detriment of some plants and the benefit of others) if not covered by other mulch materials or foliage.

Shading and the use of windbreaks are other moisture-conserving techniques. Plants that wilt in very sunny areas can benefit from partial shade during the afternoon in summer. Small plants, in particular, should be protected. Air moving across a plant carries away the moisture on the leaf surfaces, causing more water to be needed by the plant. In very windy areas the roots often cannot keep up with leaf demands and plants wilt. Temporary or permanent windbreaks can help tremendously.

During those times when cultural practices simply are not enough, when rainfall is sparse and the sun is hot, watering can benefit the garden with higher yields, or may save the garden altogether in severe drought years.

### INSTALLATION TIPS

When rolling out your Poly Tubing, you must put it in a shallow trench to prevent rolling and twisting. When making your trench raise up your rig about every 20 to 30 feet. This will create a dike for water to remain in the pipe and will keep the pipe from blowing when not in use.

It will take about 20 minutes to roll the pipe out and begin watering.

No more moving pipe for the next set or crossing ditches with cumbersome tubes. Leave it there, you can cross it with a tractor when you plant, cultivate, spray, etc. Just be careful not to stop and turn on top of the pipe.

## PCG committee gives preliminary approval to funding research projects

Members of the Texas State Support Committee met March 29 in Dallas to give preliminary approval to research projects that will receive funding in 1995 according to Lubbock-based Plains Cotton Growers, Inc.

Support for the statewide research effort comes from Cotton Incorporated's State Support Program. The program returns 5 percent of CI's yearly operating budget to states for use on cotton related research projects.

Approximately \$600,000 is estimated to be received by Texas for 1995. These funds will be used to support a variety of statewide and regional projects approved by representatives from each of the nine cotton growing regions in Texas. Funding for regional projects is based on the percentage of the Texas crop produced in each region.

Projects selected for funding in 1995 include 11 statewide projects ranging from development of new insect and disease resistant cotton varieties to the evaluation of new harvest aid chemicals. In addition to the statewide projects selected, 7 additional projects were approved as regional selections for the High Plains.

PCG officials report that the High Plains projects selected for funding each related directly to solving problems associated with High Plains cotton production.

The projects selected for funding in 1995 are all designed to learn more about the problems facing producers on the High Plains and find solutions says Donald Johnson, PCG Executive Vice President.

High Plains projects selected for 1995 were approved for a total of \$138,370 in state support funds. Funds approved for statewide projects totaled \$285,500. An additional \$30,400 was approved for the cottonseed project being carried out by USDA-ARS scientist Dr. Norma Trindler of Lubbock.

The remainder of the estimated \$600,000 to be received by Texas was divided between the other cotton growing regions in the state.

## SIDERS' SIDELINES

### Weather damaged cotton

With cotton producers being at the mercy of mother nature particularly at this time of year, I thought that the following would be of some assistance when making those tough decisions.

\*If a small amount of leaf tissue remains, recovery and bud life is more certain. Recovery rate is related to amount of leaves or fragments of leaves remaining.

\*Terminal growing point is important in cases of heavy defoliation as fruiting will occur much sooner, i.e., the resumption of fruiting is delayed more if terminal is lost or knocked out.

\*Stems cut low look totally destroyed, but potential yield in most cases is still higher at end of season that replanted cotton.

\*Crops surviving early hail damage often produce more mature lint than a replanted crop.

\*Higher node cut off (loss of terminal) will stimulate side branches-this often causes late fruiting and excessive vegetative growth. A bushy plant reduces harvesting efficiency, and could contribute to more barky samples due to higher stick content in the harvested

cotton.  
\*Stems severely damaged cannot move food to bud or recovery.

\*After hail damage crops start regrowth, it's important to protect young plants from aphids, thrip and fleahoppers. If insects are not controlled, the crop is delayed further with the possibility of rank, vegetative growth.

\*Thick planting for hail loss is not realistic. In thick planting, more spindly plants are grown and fruiting is delayed in nodal position.

\*Cool, rainy weather following hail injury can delay recovery, or even prevent recovery, if organisms attack injured tissue.

\*Cultivate as soon as possible to break up crust and improve aeration around the roots.

\*An average of two plants per foot with no long skips will still provide an adequate plant population.

There are other considerations if replanting is required. Such concerns as cut off date and herbicide injury must be considered. For more information on this, contact me here at the Floyd County office of the Texas Agriculture Extension Service.

### Estimated wheat yield

Many producers are currently trying to estimate their wheat yield potential to help decide whether to leave the crop for grain, graze it, or hay it. I have gathered up some information that should help in estimating potential grain yield by looking at three components, these are: number of viable heads per acre, number of kernels per head, and individual kernel weight.

The first step is to estimate the number of heads per acre by counting the number of heads per square foot in several places randomly in the field. Multiply the average number per square foot by 43,560 to give you heads per acre, i.e., heads/feet squared X 43,560 = heads/acre.

The second step is to estimate the number of kernels per head. This is done by counting the number of spikelets per head. Each spikelet will produce 2 to as many as 5 kernels. Usually wheat in our area produce 2 to 3 kernels per spikelet. If you are an optimist, use 3, if not assume 2 or 2.5 kernels per spikelet when calculating potential yield. Example: 14 spikelets X 2 kernels = 28 kernels/head.

The next step is the kernel weight. Kernel weight varies with variety and conditions during grain fill. For estimating yield, use 30 mg per kernel as an estimate of weight. Thirty mg per kernel is approximately 15,000 kernels per pound.

The final step is putting it all together for estimating yield. The formula would be:

$$\frac{\text{heads}}{\text{ft}^2} \times \frac{43,560 \text{ ft}^2}{\text{Acre}} \times \frac{\text{seed}}{\text{head}} \times \frac{\text{pound}}{15,000 \text{ seed}} \times \frac{\text{bu}}{60 \text{ lb}} = \text{bu/Acre}$$

Example: 15 heads/ft<sup>2</sup>  
14 spikelets/head x 2 seeds/spikelet = 28 seeds/head  
Assume 15,000 seeds/pound

$$\frac{15 \text{ heads}}{\text{ft}^2} \times \frac{43,560 \text{ ft}^2}{\text{Acre}} \times \frac{28 \text{ seed}}{\text{head}} \div \frac{15,000 \text{ seed}}{\text{pound}} \div \frac{60 \text{ lb}}{\text{bu}} = 20 \text{ bu/Acre}$$

This formula is an estimate and should be used as such to assist in decision making. For more information, contact me here at the Floyd County office of the Texas Agricultural Extension Service.

### National Cotton Council supports concepts included in reform proposal

The National Cotton Council told a House Agriculture subcommittee here that it supports concepts included in USDA's Crop Insurance Reform proposal, adding that for reform to be successful, credibility must be restored and program abuse minimized.

"Reform is essential if this program is to effectively replace disaster relief and entice more participation," said Myrl Mitchell, a Lenora, Texas producer and ginner who chairs the Council's Crop Insurance Advisory Task Force. "I must caution, however, that cotton producers are skeptical that a workable crop insurance program can be developed. That is why it is critical that the Federal Crop Insurance Corporation (FCIC) staff continue to listen carefully to regional concerns. We cannot design a one-size-fits-all policy.

Mitchell told a House Subcommittee on Environment, Credit and Rural Development hearing that U.S. cotton believes that proposal is moving in the right direction. He said the industry is encouraged by the proposal's reduced premiums for high coverage levels.

Mitchell relayed a summary of comment the Council received from producers during recent meetings it conducted across the Cotton Belt. Major elements that should be considered for the crop insurance proposal are:

\*inclusion of a catastrophic yield adjustment when calculating actual yields during disaster years.

\*Inclusion of a harvest incentive when determining losses to improve the program's effectiveness.

\*the need to entice non-users of the current program to use crop insurance by offering such options as insuring the cost of production and lowering premiums for producers with good loss histories or with lower risk operations.

\*Improvements in the quality adjustment provisions for cotton and elimination of the current 25 percent deductible

for quality losses because losses in crop quality often are more economically devastating than production losses.

\*addressing smaller farm units, such as fields or sections, rather than a producer's acreage on a county basis so that, for example, a farmer who irrigates his cotton does not have to pay the same premium as a farmer who does not irrigate.

Mitchell added that FCIC is to be commended for its effort at strengthening the crop insurance program's review and for evaluating optional products that enhance the value of crop insurance to the producer.

### Officers elected to Texas Grain Sorghum Board

Members of the 15-member Texas Grain Sorghum Board (TGSB) elected officers during a recent meeting. Jack Cobb of Plains was re-elected as board chairman. Wilbert Vorwerk of Taylor was elected vice chairman. Richard Kotzur of Edingburg is the new secretary-treasurer.

The fifteen-member board administers the funds collected by a statewide assessment on grain sorghum. The funds are used for research, education and promotion of grain sorghum. Board members are elected by the producers from their area who are subject to the assessment. Three representatives are elected from each of the five TGSB districts.

Representatives from the West Texas District are Cobb, Jim Boston of Roscoe and Pat George of Tulia. Representing the Panhandle District are Robert Green of Hartley, Troy Sublett of Hereford and Dale Artho of Wildorado.



### Corn fields should be monitored for Southwestern corn borers

Southwestern corn borers (SWCB) emerge from corn stubble in the spring to lay eggs on whorl-stage corn. Corn adjacent to or near unplowed or late-plowed stubble typically experiences higher densities of SWCB larval feeding in the whorl. Floyd-Crosby corn producers need to monitor fields for this situation.

Those corn stubble fields not plowed before February 1 in combination with the relatively mild winter temperatures will allow for increasing winter survival of SWCB. Therefore, economic levels of 1st generation SWCB may be possible this year.

Eggs are laid by adult moths of overwintering SWCB. Eggs are laid on the upper and lower surfaces of expanded leaves in the whorl. Freshly laid eggs are creamy white, and after about 24 hours, three red bands appear on each egg. Small larvae hatch from the eggs in about five days and begin feeding in the whorl. A leaf symptom commonly associated with SWCB feeding in the whorl includes longitudinal, transparent areas

on the leaf where young larvae feed only partially through the leaf tissue. After the larva has fed in the whorl, for a few days it crawls down the plant and bores into the stalk. Corn borer larvae reach a length of 1 to 1.5 inches. They have a regular pattern of raised black dots on a creamy white body.

The economic threshold for 1st generation SWCB is when 10 to 15% of the plants are infested with newly hatched larvae. Insecticide applications should be made before borers leave the whorl and enter the stalk. Fields need to be monitored closely to keep a handle on SWCB numbers.

## Livestock health regulations adopted for ratite and equine industries in Texas

- \* Ratites must have a certificate of veterinary inspection issued 30 days prior to entering Texas from any state, territory, foreign country or USDA-licensed quarantine facility. The birds must also have a TAHC entry permit

issued within 15 days prior to arrival.

- \* Before entering, each bird must be implanted with a permanent electronic identification device called a microchip. Information about where the identification device was implanted in the bird, and the individually coded number and device's brand name must be recorded on the health certificate.

- \* Birds or hatching eggs are to come from flocks with no history of Avian Influenza infection within the past six months. (Avian Influenza is a viral infection that can cause a wide range of symptoms.) Birds entering Texas are to have a negative blood test for Avian Influenza and Salmonella Pullorum-typhoid within 30 days prior to entry. The tests are to be performed in a state-approved diagnostic laboratory in the state of origin.

- \* Birds having a positive blood test for Avian Influenza may be admitted if the virus isolation test run on a swab sample is negative within 30 days prior to shipment. These birds also will be quarantined upon arriving in Texas and will undergo a virus isolation retest.

- \* Ratites destined for slaughter may only enter Texas with an entry permit, and a waybill or certificate of veterinary inspection. These birds do not have testing or permanent identification requirements.

- \* Ratites sold in Texas through a public or private sale must have a certificate of veterinary inspection, complete with information about the required implanted electronic identification device. The veterinarian must declare the ratites are free of external parasites, and that the birds have no clinical evidence of contagious or communicable disease. Also the inspecting veterinarian must state that he or she has no personal knowledge that the birds have been exposed to a contagious or communicable disease.

- \* Records concerning the microchip number and related information, and the

required test results must be retained for three years by the market, if the ratite is sold through a public sale; or by the buyer and seller, if the animal is acquired through a private treaty.

### EQUINE INFECTIOUS ANEMIA

For the past year, the TAHC has surveyed equine owners, held hearings and appointed an industry advisory committee to write acceptable, yet effective and scientifically based regulations for controlling the spread of equine infectious anemia (EIA). This is an incurable disease in which infected equine may exhibit no symptoms or develop severe anemia, bloating, depression, weight loss, and in some cases, may die. More than 400 cases are diagnosed through blood tests in Texas each year. Most cases occur in East Texas, where there is a prevalence of biting flies, vectors capable of transmitting the virus from infected to "clean" equine.

The TAHC adopted only a small portion of the EIA rules at the April session, as the commissioners and advisory committee continue to fine tune language for the major portion of the regulations.

The newly adopted language will allow new USDA-approved testing technology to be used as it comes on the market. This is in addition to the current tests—the agar gel immunodiffusion test (AGID), known as the Coggins' test, and the Competitive Enzyme-Linked Immunosorbent Assay (CELISA) test.

The other changes requires the veterinarian or TCHA authorized personnel to submit a completed EIA test document, called a VS form 10-11, along with a blood sample to the approved testing laboratory.

The EIA advisory committee is to make recommendations later concerning permanently identifying EIA-tested equine, requirements for changing ownership or participating in events, and testing horses exposed to the disease.

Until further adoptions, current regulations remain in effect. Out-of-state equine entering Texas must have had a EIA test within the past 12 months. All horses, including Texas horses, also must have had a test within the past 12 months if they are transported to interstate events at which any equine will remain on the grounds 48 hours or longer.

The TAHC will hold its next meeting on June 24 in Austin.

To keep the pyramid going, persons who have already paid are encouraged to continually recruit new contributors so that they will have a better chance at moving up the pyramid and collecting

According to information received from the BBB of Canton, this company has been in business since May 1968 and Benjamin Suarez serves as President. Suarez has many active divisions and Lindenwold creates many inquiries to our office. The company has been responsive to any complaints brought to their attention by the Bureau.

Complaints have alleged confusion over the conditions of winning or re-

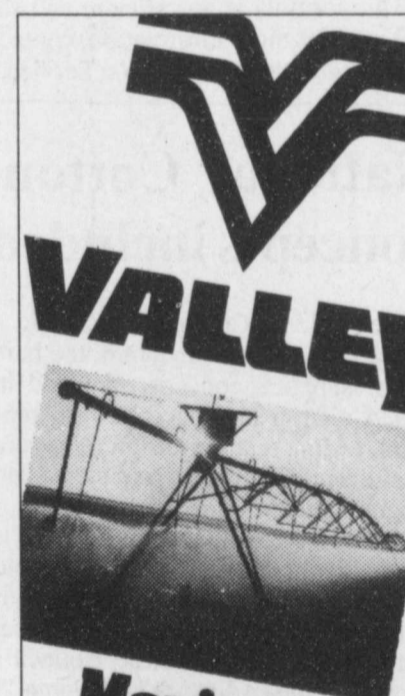

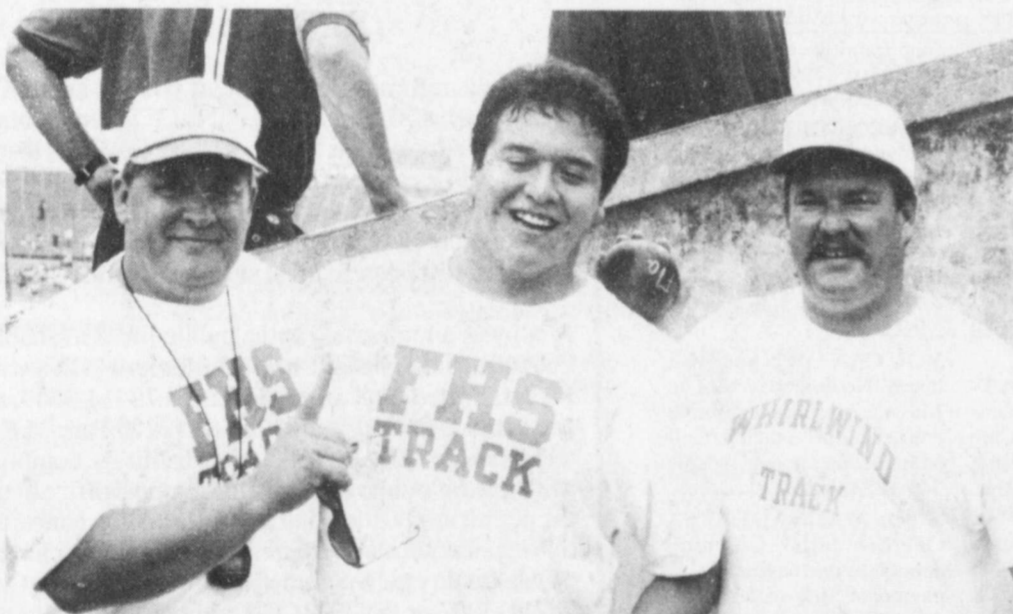
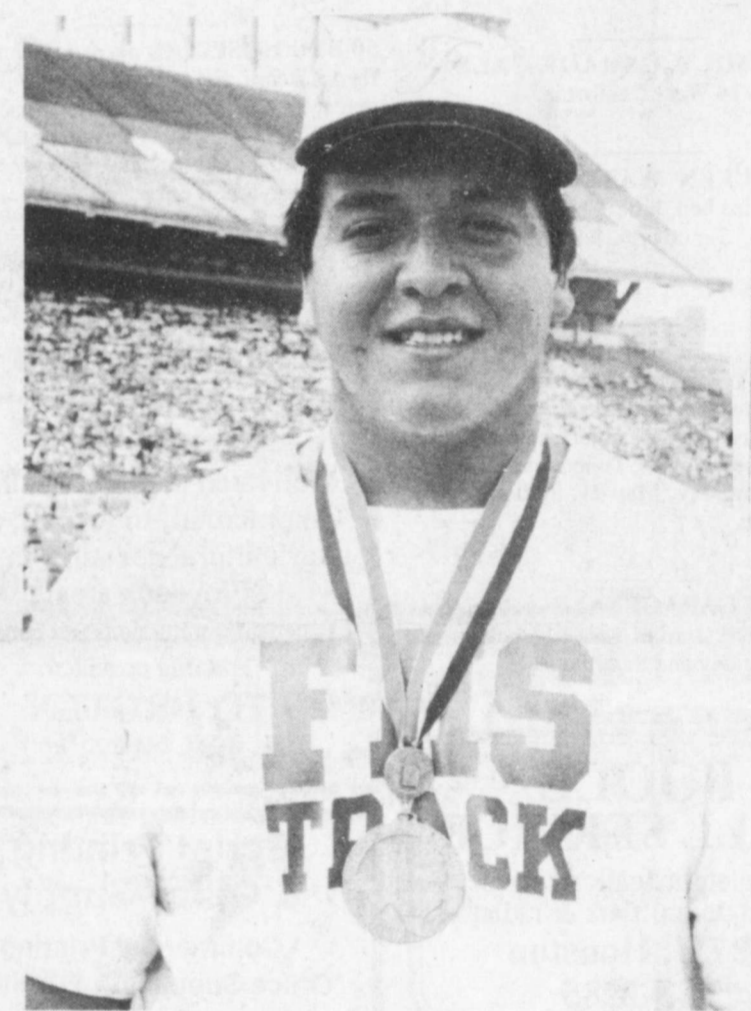
