Joint venture of prisoner transportation discussed

Cities and County consider vehicle

FLOYDADA-Members of the Floydada City Council discussed the possibility of purchasing a 12-15 passenger vehicle for prison workers from the J.B. Wheeler Unit in Plainview to drive from Plainview to Floyd County when they are scheduled to work in the county.

According to Floydada City Manager Gary Brown, two city employees now drive to Plainview every morning to pick up prisoners who come to work in Floydada at 6:15 a.m. They return them to the prison by noon.

At this time, Lockney utilizes an afternoon prison crew that works in Lockney. Lockney is also sending city employees to pick them up and return them in the afternoon.

"It doesn't bother me to send the employees to go pick them up but with a vehicle provided, these guys could do the driving themselves with Sgt. Bass, the Floyd County representative from the Wheeler Unit, accompanying them," said Brown.

"We would leave the vehicle at the Wheeler Unit and when they are coming to Floyd County, whether to work for Lockney, Floydada or Floyd County, it would be used to transport the prisoners here. It would save our sending city employees to pick them up and take them back," Brown to health reasons. The council did not

with a guard so you are usually hauling 9-11 workers and guards. A 12 or 15 passenger van would be sufficient," said Brown.

Extended calling ballots in mail

LOCKNEY—Southwestern Bell has notified the City of Lockney that ballots to vote on extended calling must be distributed to Lockney subscribers by April 9th and will probably be included with the next phone

Seventy percent of the returned ballots must be in favor of the extended calling in order to implement the service.

If the service is approved by sub-

scribers, a charge of \$3.50 will be added to each residential line and a \$7.00 charge will be added to each business line.

This monthly charge would then enable Lockney citizens to call Plainview and Lubbock for an unlimited amount at no extra charge.



Paper celebrates 100 years

One hundred years ago, on March 27, 1896, the first edition of the Hesperian was published.

Claude V. Hall was the first publisher and editor of this paper, known as The Hesperian-Gazette. Hall published The Hesperian for seven years, retiring in 1903 to return as a student to the Sam Houston Norman Institute. He graduated in

1904 with a degree in teaching. Concerning his years as editor Hall wrote, "I felt it was my duty to work in the ranks of the reformers, social and political. The editorial policy of the paper was active and aggressive. I championed principals which I thought were sound and policies which I deemed wise. For the positions which I took on many controversial questions I was frequently taken to task by those who did not agree with me. In these journalistic bouts I learned to fight with

might and main.... "I developed a sense of humor as an offset to the censure which was at intervals heaped upon me as a result of the ideas set forth by me in the editorials of The Hesperian."

The first edition of The Hesperian-Gazette was four pages of news and advertising. The front page reflects the debate over gold or silver coinage.

Lockney items and community events are also featured.

Claude Hall introduces himself on page 2, and outlines his plans for the newspaper. On the last page the results of the March 7, 1896 Prohibition Election were printed. The majority voted for Prohibition. Evidently the vote stuck.



A view from The Lamplighter

We see by the papers where Mr. Silverman, who won the Democratic nomination to oppose Congressman Mac Thornberry in the Fall, and Mr. Alejandro, who lost to Mr. Silverman, will join forces in an effort to do the Congressman in, when General Elections roll around. Or, at least they say

To be honest about it, that election was a minor surprise to us. We had expected Alejandro to take the race, primarily because he is, or should have been, better known throughout the District. Alejandro had been with former Congressman Bill Sarpalius for some six years, and worked the District rather diligently on his behalf. Alejandro won most of the Democratic vote in his hometown of Wichita Falls, which we thought would probably be the key, and in East Lubbock, but lost most of the rest of the District.

Silverman, a patent lawyer from Amarillo, says he won because he went out and met as many people as he could during the campaign. Perhaps so, but we doubt it.

We think Alejandro lost the Democratic nomination primarily because his name is Alejandro. And among some Democrats, he was viewed as being too close to Sarpalius. He was better known to Democratic movers and shakers than was Silverman. He had, in our opinion, a better grasp of the issues, even if his treatment of those issues was, like Silverman's, scripted by the National Democratic Committee in Washington. He is, from all we can gather, an intelligent, personable youngster, with much to learn but having the capacity to learn.

We had a long, rather detailed visit with Mr. Silverman during the campaign. We ran nothing on the interview at the time, relying instead on the candidate's prepared press handout. (Which he probably appreciated more.) Also, we had not had the opportunity to interview Mr. Alejandro, and felt it might be somehow unfair to give one more space than the other.

Actually, the Silverman interview was somewhat revealing, even if it was less than informative, in a policy sense. The present farm bill, he said, was "horrible", and he could find no farmer or rancher who was pleased with it. But he was completely opposed to Republican efforts at revision. Asked what his solution was, he replied that more money ought to be funnelled into the system. He really couldn't get too much into the details.

He accepted the conclusions reached by the President's Advisory

Commission on the future of Medicare (that the Medicare Trust Fund was in danger of going broke within five years, threatening the solvency of the entire system), but he was completely opposed to the mean spirited attempts by Republicans to "cut" funding for the system. Asked how an increase in funding, which the Republicans propose, could be described as a "cut" in funding, he replied that if Medicare recipients were expecting a 14 percent increase, and if they only got a 7 percent increase, that amounted to a 7 percent cut. We will let our readers figure that one out. In the area of foreign aid, Mr.

Silverman sounded somewhat decisive, for a moment. He was opposed to foreign aid, unless the Congress determined that it was in the U.S. national interest. (That, of course, has always been the ostensible, and official, rationale behind foreign aid.) We asked, then, how he felt about foreign aid for Israel, which gets from one third to one-half of all U.S. foreign aid, despite the fact that it has a population on a par with Harris County. Well, an argument could be made that aid to Israel was in the U.S., national interest, since we were "buying peace" there.

So it went. Mr. Silverman recognized that something probably ought to be done about welfare, but he was opposed to Republican efforts aimed at revision. And he was, of course, opposed to "tax cuts for the wealthy", he did not approve of the "contract with America", and he didn't like House Speaker Newt Gingrich. He didn't say how he felt about President Bill Clinton.

In an effort to pin down where Mr. Silverman might stand in the political makeup of Washington, should he

get there, we asked if he considered himself more conservative, or more liberal, than Mr. Sarpalius, who had a six-year voting record in Congress. Here, too, things got a little hazy. He was no fan of Mr. Sarpalius, he said, but his big problem with Sarpalius was that "he was all over the lot." One never knew where Sarpalius was going to be on any given issue, he said. But he still didn't say where he differed, or if he did differ, from the Sarpalius voting record. Clearly he wished to distance himself from Sarpalius, but not appear too distant, lest he alienate the former Congressman's friends and supporters. Nor did he wish to appear too close, lest he inherit certain unpopular positions Mr. Sarpalius took while

in Congress. Concerning his differences with Mr. Alejandro, if any, he noted that Alejandro had never really been anything but a staff aide to Sarpalius, while he, on the other hand, was a graduate of Princeton law school. Therefore he felt himself clearly the more qualified of the two. Evidently most Democratic primary voters in this district agreed with him on that.

The Silverman message, at this stage of the game, appeared rather truncated, recognizing that many things need changing...but. The budget needs balancing, but. Welfare needs reforming, but. Foreign aid is not good, but, and unless.

We expect, as the campaign goes forward, the message will be refined somewhat, and, one would hope, come forth with some specifics. Just how would he balance the budget? How would he reform, and save, Medicare? How would he judge which country gets foreign aid, and how much? What would he do about immigration, both legal and illegal?

And, among other things, is it morally right, even if politically expedient, to saddle future generations with taxes to pay for today's expenditures? If the answer to that question is "yes", then what's the argument? If it is "no", what would Mr. Silverman do about

Sign-ups end March 20 in municipal elections

and Floydada municipal spring elections and for FISD and LISD trustee elections was due to expire Wednesday, March 20, at 5:00 p.m.

If no offices on the ballot for any city or school entity have an opposed race following the period for declaration of write-in candidates, recent legislation allows those running to be declared the winners. Under current legislation, a write-in candidate for city office or school board posts must declare and submit an application for a place on the ballot by April 4th.

This would mean that no election would be held on May 4 for positions on school board or city council if there are no opposing candidates. Legislation allowing this course was enacted in an effort to save local taxpayers from the expense of an election in which only one candidate is seeking each office on the ballot.

CITY OF FLOYDADA

The City of Floydada has four offices with expiring terms this year, two at-large and District 1 and District 4 council seats. Incumbents Eric Cornelius and Clar Schacht have

The sign-up period for Lockney indicated they will seek re-election as has District 1 incumbent Albert Hill. District 4 Councilman Wayne Tipton had not indicated his intention toward the election as of press deadline time on Tuesday.

CITY OF LOCKNEY

The City of Lockney has three council seats which expire this spring. They include Richard Zavala in District 1, Tina Graves in District 2, and J. D. Copeland in District 3. At press time, only Graves and Copeland were officially seeking re-election.

Floydada Independent School District has two trustee positions on the ballot this spring. Incumbent Mitch Probasco is seeking re-election atlarge and Billy Joe Villarreal is seeking re-election in Precinct 3.



Floydada Police Report

March 8 a 10 year old boy was brought to the Floydada Police Department by Juvenile Probation Officer Bruce Ballou.

According to the Penal Law if an adult sells drugs to a minor the offender would be charged with an automatic 2nd degree felony, no matter the amount of drugs. If the adult sells to a minor within 1000 feet of a drug free zone, or within 300 feet of a public or private youth center, swimming pool, or video arcade, then the minimum sentence the offender could get for that 2nd degree felony would be doubled.

However, since a juvenile sold the drugs to a juvenile the law is not as harsh. In this case the offender would be charged depending on the amount of the drug and there would be no special sentencing based on the Drug Free Zone Law.

Because of the small amount (less than 1/4 ounce) sold to the 10 year old, and according to the present drug laws, the older boy will face a Class B misdemeanor charge for Delivery of

Whirlwinds sweep twin bill from Longhorns

FLOYDADA -- The Whirlwinds overwhelmed the Lockney Longhorns 25-12 and 35-8 in a double header at Preston Watson Field on March 12. The high-scoring games, both shortened to five innings due to the U.I.L. 10-run rule, marked the Whirlwinds' first twin bill sweep over the Longhorns since baseball was revived at Floydada in 1991. The 'Winds improved to 5-1 for the season, while Lockney remains winless in three outings.

The Longhorns jumped all over Floydada starting pitcher Jason Henderson to open the first game. Three Whirlwind errors, three walks, and singles by Josh Lambert and Tyson McDonald helped produce six runs for the visitors in the top half of the first inning.

The Whirlwinds stormed back in the bottom of the first with 9 runs on 5 hits and a couple of Lockney errors. Four walks, singles by Tomas Barrientos, Angel Aleman (2), Chad Hinkle, and a double by Neal Nelson all led to the downfall of Longhorn starting pitcher Carlos Perales. Coach David Norwood called Romualdo Chavira to the mound to replace the fifth, but struck out Veal and Perales after two outs.

The Longhorns returned the favor by knocking out Floydada starter Jason Henderson in the top of the second inning. Henderson walked the first two batters. A couple of wild pitches and two Whirlwind errors paved the way for Lockney to regain the lead 10-9. Angel Aleman made his first relief appearance of the year, and ended up as the winning hurler. Aleman allowed 4 hits, struck out 7, walked 2 and allowed only 2 earned runs in the 3 1/3 innings of relief.

The Whirlwinds regained the lead for good in the home half of the second inning. Nelson's two-out triple drove in Joe Sanchez to tie the game at 10-all, and started a 7-run rally that put the Whirlwinds in command. Other hits in the inning included a double by Aleman and Hinkle's second single of the game. Three more

Carson Johnson grounded out, and Aleman struck out Perales to retire the 'Horns. The Whirlwinds put more distance between themselves and the Longhorns by scoring three more runs in the bottom of the inning. Three additional Lockney errors helped the Whirlwinds' cause, along with Michael Mercado's first home run of the season with Ramon McCann and Neal Nelson aboard.

Josh Lambert homered for Lockney in the top of the fourth, followed by walks issued to Bradley Veal and Miguel Guerrero. Veal scored on Chavira's long foul fly, but Gerardo Luna struck out before the Longhorns could mount any more threats. A double by Chad Hinkle, along with singles by Aleman and Anderson and four more Longhorn errors, produced six more runs for the Whirlwinds in the bottom of the inning. Aleman gave up the last Lockney hit in the top of Guerrero to end the one-sided contest.

Chavira scored in the top of the first on a throwing error after his leadoff walk, but Whirlwind pitcher Chris Enriquez struck out Lambert for the third out. Floydada scored 5 runs in the bottom of the frame, with Monty Anderson's run-scoring triple triggering the big inning after Mercado's leadoff walk.

Lockney countered with 6 runs in the top of the second. A pair of singles by Guerrero, another single by Perales, a couple of wild pitches by Enriquez, and two Floydada errors all contributed to Lockney's run output.





mous in their vote to delay action on Morgan. The board was split in their vote 4-3 on renewing Lisa Mosley's contract. Voting to delay action on the contract were Jim Bob Martin, Mike Mathis, Carlton Johnson and Bernie Ford. Voting to renew her contract were Louie Bybee, Jessie Garza and Dan Smith. They will also delay action on making the final decision on Mosley. The board has 45 days in which to make these decisions.

A letter of resignation was read from girls basketball coach Kenneth Housden. Motion was made by Bernie Ford and the second by Dan Smith to accept the resignation. All voted for.

A group of approximately 40 parents and students met with the board to let them know of their feelings about the resignation of Coach Housden. Kenny Hooten was spokesman for the group and stated that they hated to see Coach Housden go. "We know there have been problems and that some didn't like him, but he was liked and respected by those in this room and we supported him. I think that we had a guy here with a decent program that most of the kids liked. We know that he has given you his resignation and that it is probably too late but we wanted you to know how we felt. I hope we can all get behind the next coach we have and get the girl's program going," he stated.

Approximate costs for the concession stand, restrooms and bleachers at the new track were discussed. The board voted to pursue more definite costs and advertise for bids at a later meeting. The plans are to complete the facilities before the track season beings next year.

Superintendent Raymond Lusk stated that the Lockney school district is eligible for a School Facilities Assistant Grant in the amount of \$500,000. This will be a matching grant in that Lockney will receive 71 percent of the total grant and must match it with the other 29 percent.

The application for the grant has been accepted. The work to be done will include a new science lab, class-

rooms at the elementary school, remodeling of more classrooms in the junior high and remodeling of the old science lab into classrooms.

After a motion by Jessie Garza and a second by Dan Smith the board voted to bid this out as one complete project and to use James Robison of Plainview as the architect. Each portion of the project will be itemized separately in order to keep the costs within the budgeted amount.

A resolution was passed placing the names of Alice Gilroy and Neta Marble of the Floyd County Hesperian-Beacon on the statewide Media Honor Roll.

The resolution reads ". . .We express our appreciation for your balanced and accurate approach to sharing with this community both the challenges facing our schools and the successes achieved by the teachers and students. Your work has aided this community in focusing on the goal of providing the best public schools we can for the students who attend them."

Bids were opened from four companies on the two busses that are to be sold. The bid of \$1125.00 from Daniel Hansen of Austin was accepted.

The board voted to approve Policy Update #50. The update focuses on changes to employee contracts, requirements for superintendents and disciplinary procedures.

Ballots were passed out and the board voted for positions 2 and 5 on the Region 17 ESC Board of Directors

Lusk reported on the estimate he received on lights for the tennis court. Southwestern Public Service stated that they would install and service new lights and poles for the court at a cost of \$1500 per year. After some discussion the board voted not to accept the SPS offer. Instead they will install three new poles and lights for a one time cost of approximately \$2,000.

In regular business before the board the minutes of the previous meeting were read and approved, bills were reviewed and approved for payment and the financial statement was reviewed and accepted.

CHD considers future of facility

FLOYDADA — Routine maintenance, repairs, disposition of equipment, and future use of buildings was the subject of discussion during the regular session of the Caprock Hospital District Board of Trustees on Tuesday, March 19. The discussion was prompted by an offer from Apotheus Labs in Lubbock to purchase part of the lab equipment now idle in the Floydada hospital location.

The offer to purchase was rejected on a motion by Rob Heflin with a second by Carmel Eastham after board members were advised that the equipment was worth at least twice the offer made by the Lubbock lab. Voting in favor of the motion were Heflin, Eastham, Tom Farris and J. R. Turner. Board member Denice Payne was not present.

Board President Tom Farris suggested that the board might consider holding the equipment in tact at this time and holding an auction to dispose of unused items at some point in the future. No action was taken concerning this.

UMC has cut the full time maintenance worker from their payroll for the Floydada Cogdell Clinic, leaving the district with no one to do routine maintenance and yard work. Since all employees of the clinic came under UMC last year, CHD has paid UMC a portion of the salary for that worker to do CHD maintenance and yard work.

Farris told the board he did not think it would be necessary to hire an employee to do the work. He suggested instead that the board authorize making arrangements for specific repair people to answer calls for maintenance such as plumbing and electrical problems and hiring a yard service to do the mowing. Board members present agreed.


Interior cleaning and routine maintenance will continue to be performed by those using each area of the facility at this time. Any problems arising concerning CHD responsibility will be reported to Tom Farris for repair. Action on indigent health care

claims was again tabled for action pending receipt of more information concerning the matter. Board members want to know more about the process of determining indigent status and eligibility for district payment of medical bills. They also requested as much information as possible concerning individual cases presented for payment.

One bid on a tax title property was approved. Donald Wiley's offer of \$300.00 for two lots at 209 E. Marivena was accepted on a motion by Turner with a second by Eastham. The sale will not be finalized until all taxing entities involved in the property have approved it.

Minutes of the previous meeting were approved and the board accepted financial reports as presented by Fred Thayer, accountant. Thayer reported income for the month of February in the amount of \$1,657.00 from accounts receivable and \$22,964.00 in tax collections as well as \$300.00 for Day Care rent and \$2,020.00 for clinic rent from UMC. This totals \$27,824.00.

Expenses for the month were placed at \$12,452.00 including the ambulance subsidy, the maintenance agreement on the heating and cooling system, utilities, and miscellaneous other costs. This meant a net gain of \$15,000.00 for the month of February.



According to Thayer, the district has \$368,154.00 in cash balances in bank accounts as of February 28th. This represents a gain of \$170,00.00 since the beginning of the fiscal year in October.

UMC representative Al Bendeck reported that Dr. Antoine Albert will be leaving the clinic at the expiration of his current contract on April 30. Two prospective replacement physicians are being considered and Bendeck stated that one should be installed by the time Albert departs.

Bendeck also noted that a new sign will be in place on the grounds within a week or two and that UMC is planning to landscape the clinic grounds this spring. He also asked the board to think about paying half of the cost to pave the clinic parking lot in front where clients park. Board members suggested getting bids from local pavers such as Thrasher and Lipham. Bendeck stated he would advertise for bid estimates on the project and get the information to the board so they could make a decision, possibly in April.

at this time and no action was taken.

The council then voted to appoint Jeff Johnson as a director to the Board of the Mackenzie Municipal Water Authority. He will be replacing C.J. Payne whose term expires in April of this year and does not wish to serve again. Motion was made by Councilman Hill to appoint Johnson to the position. It was seconded by Councilman Tipton and all were in favor.

City Manager Gary Brown gave his report during the meeting. He said that the Communi-Care System will be operating within the next week. He will be meeting with Senior Citizens and other organizations and giving people the chance to sign up. He also said that after Floydada citizens are entered into the computer and the project gets going, the service will be extended to Lockney citizens.

Brown reported that he had attended the West Texas Environmental Summit, a group of West Texas Panhandle city employees and elected officials working together concerning environmental laws and legislation. Representatives from the Environmental Protection Agency and the Texas Natural Resource Conservation Commission were present as well as Speaker of the House Pete Laney.

Brown also reported on the progress of the proposed 1996 water grant and the on-going process concerning the wells from the city farm.

"I have spoken to Mackenzie employees on getting people from all four towns surrounding Mackenzie together to talk about the plan they have in mind. I have not yet scheduled a meeting due to Spring Break, but we will meet," said Brown.

The council voted to allow Steven and Ann Assiter to operate the Floydada Municipal Swimming Pool for the summer of 1996.

The council also accepted a \$300.00 bid from Donald Wiley for two lots on a tax title sale by the taxing entities. The lots are located at 209 E. Marivena St. (Lots 13 and 14, Block 2, Bartley Heights Addition). The sale will not be final until all taxing entities involved in the sale have approved it.

The council also appointed election judges for the May 4, 1996 municipal election. Donna Henderson will be the election judge and Jimmie Lou Stewart will serve as alternate judge.

The minutes of the previous meeting were approved.

Dr. Dobson Answers Your Questions

QUESTION: I have a friend who was married for nine years before her husband left her for another woman. I think she was a loving and devoted wife, yet she seemed to feel that the break-up of her marriage was her fault. As a result, her self-esteem disintegrated and she has never recovered.

DR. DOBSON: It has always been surprising for me to observe how often the wounded marriage partner—the person who was clearly the victim of the other's irresponsibility—is the one who suffers the greatest pangs of guilt and feelings of inferiority.

How strange that the one who tried to hold things together in the face of obvious rejection often finds herself wondering, "How did I fail him?...If I only had been more exciting as a sexual partner...I drove him to it...I wasn't pretty enough...I didn't deserve him in the first place."

The blame for marital disintegration is seldom the fault of the husband or the wife alone. "It takes two to tango," as they say, and there is always some measure of shared blame for a divorce. However, when one marriage partner makes up his mind to behave irresponsibly, to become involved extramaritally, or to run away from his family commitments and obligations, he usually seeks to justify his behavior by magnifying the failures of his spouse.

By increasing the guilt of his partner in this way, he reduces his own culpability. For a husband or wife with low self-esteem, these changes and recriminations are accepted as fact when hurled his way. "Yes, it was my fault. I drove you to it." Thus, the victim assumes the full responsibility for his partner's irresponsibility, and self-worth shatters.

I would not recommend that your friend sit around hating the memory of her husband. Bitterness and resentment are emotional cancers that rot us

from within. However, if I were counseling her, I would encourage her to examine the facts carefully., Answers to these questions should be sought:

Despite my human frailties, did I value my marriage and try to preserve

Did my husband decide to destroy it, and then seek justification for his

Was I given a fair chance to resolve the areas of greatest irritation?

Could I have held him even if I had made all the changes he wanted? Is it reasonable that I should hate myself for this thing that has hap-

pened? Your friend should know that social rejection breeds feelings of inferiority and self-pity in enormous proportions. And rejection by the one you love, particularly, is the most powerful destroyer of self-esteem in the entire realm of human experience. She might be helped to see herself as the victim of this process, rather than a worthless failure at the game of love.

they are drawn upon. The interest rate will be 6 percent per annum as specified in the depository agency contract. Repayment will be made in monthly payments and the loan can be partially or totally paid at any time with no penalty.

Administrative Assistant Jimmie Collins told the board that the gym is approximately 54.7 percent paid for at this time from district funds set aside for the project.

Estimated cost to the district will be an additional \$162,000.00 in salary expenditures, most of which should come from state funds. The schedule does not cover employees working under federally funded mandates such as the Chapter and Title programs nor does it cover Alternative School staff and auxiliary personnel such as bus drivers, cafeteria workers, and custodians. Secretarial and Aide salaries are tied to the professional staff on a percentage basis and will be increased accordingly said Collins.

Discussion concerning the possibility of a salary increase for the cafeteria, custodial and bus driving staff followed. Collins told the board that a raise of 3 percent, the amount given last year, would add about \$13,029.00 to the budget. An increase of 5 percent would cost an additional \$21,730.00 said Collins.

Morales encouraged the board to "show these people that we support them and appreciate them by giving them more." He suggested setting up an indexed salary scale based on experience and senority. Collins said

that such a scale could be developed. Robertson stated, "I would rather see people paid based on performance, not experience."

Rather than wait to institute an indexed salary schedule this year, Morales proposed an increase of 7 percent for auxiliary personnel. This was seconded by Billy Joe Villarreal and all voted to approve the motion. Estimated cost of the 7 percent raise will be \$30,401.00 to the district.

Superintendent Jerry Cannon reported that the district is anticipating a possible cut of 17 to 25 percent in funding for salaries in federally man- April

dated programs due to congressional budget action. He told the board that no federal action has been taken at this time and the district hopes to reassign anyone effected and allow the staff to decrease by attrition without cutting any jobs if such action is taken by the federal government. No board action was required at this time.

The resignation of Kathleen Wood, music teacher at A. B. Duncan, was unanimously accepted on a motion by Brown with a second by Probasco. She has indicated that she wishes to retire from teaching at the close of the current school year.

Following an executive session, the board voted 4 to 3 to renew contracts for personnel as presented by building principals with one exception. The exception was Mike McCann's contract renewal which was tabled until the April board

Motion for the action was made by Morales and seconded by Villarreal. Voting in favor of the motion were Morales, Villarreal, Probasco, and Robertson. Voting against were Brown, Lloyd, and Simpson. Glickman also said that current CRP participants whose contracts expire on September 30, 1996, would have an opportunity to extend their contracts for only one year. "A one year extension is the most prudent option until a new farm bill is enacted giving USDA new enrollment authority and establishing a longerterm policy for the "CRP," Glickman said. After the farm bill is enacted, USDA will announce a policy for extension for all CRP contract hold-

"Today's action is consistent with both the obvious growing need for increased grain production this year and with the Clinton Administration's", Glickman said.

Assessment plan rewritten

By Shawn Wade

Lubbock based Plains Cotton Growers announces a monumental breakthrough for High Plains cotton producers following yesterday's Texas Boll Weevil Foundation meeting in Abilene.

EARLY PAYMENT: Cotton producers across the state will be given an incentive to pay boll weevil assessments early through the initiation of discounts for accounts settled prior to the scheduled due date in each area. The High Plains currenntly has an

assessment due date of July 15. Producers opting to pay their 1996 assessments 30 days before the scheduled due date will qualify for a 1 percent discount. Producers who pay 45 days before the July 15 due date will receive a 2 percent discount on their

assessment. **DELAYED PAYMENT: Some** producers may want to ask for a delayed collection schedule for their 1996 assessment. Assessments for which a Payment Extension Agreement has been properly executed will not be assessed any penalties but will be subject to a monthly finance charge of 1 1/2 percent on the unpaid balance. A ten percent downpayment will be required at the time the agreement is executed.

FAILED ACREAGE: Producers who suffer crop losses during the season will also be allowed to request relief from the TBWEF in 1996. Producers who have failed acreages may furnish the TBWEF with a signed FSA Form 574 and proof of crop destruction to apply for a refund, partial refund, or credit for paid 1996 assessments.

Huffaker notes that these are only the bare bones of the new collection procedures but that they mark a fundamental change in the manner in which assessments are collected across the state.

Legislation proposed to change livestock feed program

Proposed legislation in both the U.S. Senate and U.S. House of Representatives versions of the Farm Bill will drastically change LFP. Senate bill 1541 suspends LFP for 1996 through 2002 and House bill 2854 eliminates authority for LFP. Several State Offices have requested guidance for processing applications for LFP**IF** the program is eliminated or suspended.

Floyd County is eligible for a 90day feeding period (starting March 8, 1996) in the Livestock Feed Program. Remember the paperwork is extensive and very time consuming. Be sure to call for an appointment for your convenience and ours. Receipts for purchased feed fed during the feeding periods must be provided at the end of the feeding period. They must contain the name and address of both the buyer and seller, signature of the seller, date purchased and delivered, and the quantity, kind, and price of the feed purchased.


