

ONE OF OUR BEST FRIENDS **GONE ON BEFORE**

Every once in awhile it becomes the sad duty of an editor to chronicle the passing of one of their best and truest friends. It is a sad duty indeed, and it makes one wonder if they gave the time and trouble to pay the tributes that they should when their friend was living; if we passed out sufficient bouquets when our friend could have admired their beauty and scented their fragrance? i at life is a stern reality; we are too busy, most of us, in rowing our own boat to save the scattering raft of our friends, if we could, and express our regrets latter. We should think seriously on these matters.

Our friend, and the friend of every old timer in Terry County, Percy Spencer, was born in Mississippi Feb. 19, 1886, being 37 years, 11 months and 23 days old at his death. He came here in 1905 and made his home with his uncle the late Judge W. R Spencer. He attended the law department of the University of Texas graduating in 1707, and formed a partnership with his uncle in law practice. From the very beinning it was a foregone conclusion that his rise in his chosen profession would be rapid for he was a profound student and had a keen memory. Percy was not a large man in statute, in fact below the average, yet a giant mentally, and was able to maneuver mentally before the bar with the best in the land He found his life mate in the per n of Miss Gaster Randal, daughte. It was during our first few years Brownfield that we learned to adire and respect the counsel and adce of Percy Spencer. We officed ointly and used the same telephone nd were therefore thrown together every day, and our relations were always pleasant. He had a cheery word of greeting each day and an appropriate word of parting at night. TAX PAYMENTS GOOD We soon learned that his friendship went far beyond empty words. His riendship meant kindness, brotherly ove and actual service rendered. In the Hall of the Odd Fellow odge, he was a recogized leader, and any point of law or constitution was mmediately settled by him and corectly. 




Civilians to Be Used in Britain's Air Force

London .- Civilians will form a large part of the personnel of the British royal air force, which is being increased to more than twice its present strength. Two-thirds of the men in the reserve squadrons are to be civilians, and the auxiliary squadrons are to be organized on a basis similar to that of the territor'sl army, comparable to state militia in America.

According to Sir Samuel Hoare, secretary of state for air, the introduction of this extensive nonregular aviation force will reduce expenditure by large sums and have the advantage of getting citizens directly interested in air development.

Highly trained regular squadrons will, of course, form the backbone of Britain's air armada. These men will fly the fighting planes.

New Safety Device to Stop Speeding Trains

New London, Conn .-- Wrecks such as that which cost the life of "Wild Blil" Donovan and others when two sections of the Twentleth Century Limited crashed will be impossible on the New Haven road if the new safety device tried here recently proves as successful as early tests indicate. The line from Wallingford to New Haven will be equipped with the device.

The apparatus consists of powerful magnets under the tender, close to the rails. Block signals will be fixed so that if a train runs past a signal set against it by another train in the same block the magnets will attach themselves to the rails, stopping the train. The device, if out of order, automat leally will stop the train.
