In answer to many queries ently as to whether the U. Army, and U. S. Air Force will continue their extensive Voluneer Enlistment Program, the fol-

lowing statement was made by S-Sgt. James Hendrick of the Eastland Recruiting Station.

"The Volunteer Enlister Program will continue, even though Selective Service soo will be in effect. The Army and Air Force will rely heavily or -year volunteers to build and maintain their strengths at the new levels authorized by the Congress.

"Selective Service provides means for the Armed Forces to fill the gap between their volunteer recruiting intake and then manpower requirements the A Force intends to continue to rely

wholly on volunteers, where: the Army's manpower needs more pressing.

"The Army has a great deal offer career volunteers, far n than before the war. It is a N Army in a great many ways. Es ceptional benefits and opportuni ties have been created to attra alert, intelligent, and ambitic young men. The Army's personnel policy now is based on the pro fise that the individual is its

#### Moral Wisdom Must Rule

It should now be branded on our consciousness that, unless science is controlled by a greater moral force, it will become the hrist prophesied by early Christians." In that statement Charles A Lindbergh crystallizes the message of his new book, "On Flight The book, Lindbergh's first since the publication of "We' in 1927, is condensed as the leading article of The Reader's Digest for September

The American people's sense of values has been dangerously dis torted. Lindbergh believes, by the very scientific marvels which have country the most nowerful on earth. Holding that man survival depends, in the last analysis fully as much on the quality of life as on the power of arms," the author urges a re-evaluation of ards, based on spiritual truths, "We must measure education the amount of knowledge it instills than by he wisdom of creates. ing up as a disciple of science, Lindbergh says: "In my youth science was more important to me than either man or God . . But I have lived to experience the early results of scientific materialism I have watched men turn into human cogs in the factories they be lieved would enrich their lives. I have watched pride of workmansh leave human character decline as efficiency of production lines in creased. I have seen the lifesaving miracles of medicine perverted the murderous ends of biological warfare. I have seen the science I worshipped, and the aircraft I loved, destroying the civilization I expected them to serve."

Three times in his life, the flver says, he has felt an overwhelming compulsion to communicate a belief to his fellow men. "The first was as a young pilot, when I became convinced that man had a great destiny in the air." The second was just prior to World War II, "when I believed it best for America to keep out of Europe's internal wars The third time is at this moment of 1948. I believe that, if we do no ontrol our science by a higher moral force, it will destroy us with its materialistic values, its rocket aircraft and atom bombs."

Envisioning this country poised for a future war, Lindbergh sees the "intolerable concept" of our civilization existing from hour to hour, at the mercy of an enemy whose atomic rockets and other weapons wait only for some fanatic's fingers to close an electric switch. "It is a picture of the future toward which we are now heading," the author warns, "technically possible with bombs already tested, with known methods of biological warfare and with rockets soon to be designed."

To turn this trend we must resort to more than material power, he declares. "We must strive to achieve a civilization so satisfactory t men that its force can remain unused in the background . . . If we ceed it will be less by forcing our democracy on others than by ng an example others will wish to follow; less by pointing out the mote in another's eye than by removing the beam in our own; less by using arms than by avoiding them."
