AUSTIN, Dec. 19 - More than 87,000 Texans are enjoying better health today because of the Texas State Department of Health's program of hospital treatment of indigent and semi ndigent veneral disease patients according to information released here.


"The treatment program for these patients is carried on through two hospitals known as rapid treatment centers, located at San Antonio and Overton, State Health Officer George W Cox said.


