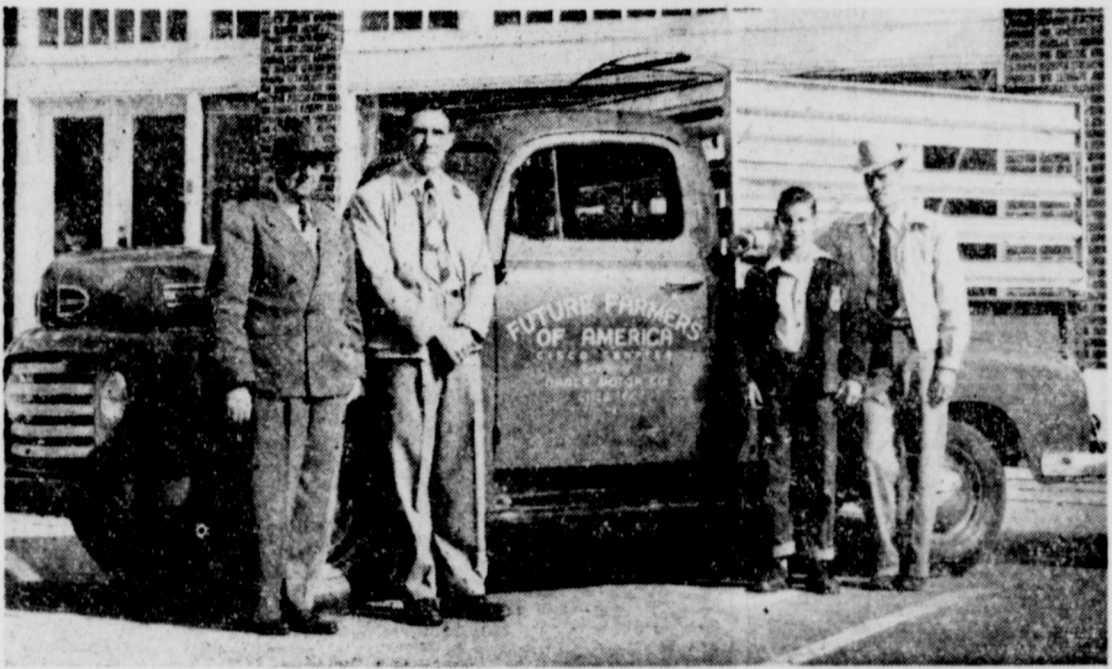

Sheriff Seeking Identity Of Woman Killed In Olden Crash Wednesday

Eastland County Sheriff J. B. Williams and Department of Public Safety officials Thursday were seeking to determine the identity of a woman who was killed in a pickup truck crash in Olden at 10 a. m. Wednesday.

The accident occurred at a curve in the western part of Olden on U. S. Highway 80. Dead was Thad Earl Stretcher, 57, of Levelland and the unidentified woman. Stretcher was driving a pickup owned by Dunn Piping Co. of Colorado City.

She was described as approximately 35 years of age, with brown hair and eyes. She was five feet two inches tall and approximately 120 pounds in weight. She had dentures and a triangular scar over her left eye.

Stretcher is survived by his wife and one child in Levelland. Funeral services were to be held in Mt. Pleasant with the arrangements to be announced later.

LIONS CLUB INSPECTS SHOP AT JUNIOR COLLEGE AFTER LUNCH

Members of the Lions Club rode school buses to Cisco Junior College for a tour of inspection of the Trade and Industrial Education department as their program for the regular luncheon meeting at noon Wednesday.

Lion Elmer Frede is supervisor of the department and he was in charge of the program. Lions boarded two school buses after eating lunch at the Victor Coffee Shop.

Frede told Lions that Cisco's ten school buses travel some 100,000 miles during the school year in transporting students. In addition, they cover 15,273 miles yearly to haul football, basketball and athletic teams and the band.

The buses cost the school system an average of \$1,359 monthly, including driver's salaries, gas, oil, tires and repairs. Repair and maintenance work is being done in the vocational shop building at the college under Frede's direction, assisted by Shorty Huff and Walter Denton.

The three men also serve the schools in other capacities. Huff is an automotive instructor in the night school, Denton drives one of the buses, and Frede supervises the Trade and Industrial Department.

Lions inspected the vocational shop building, which 6,500 square feet of floor space. Equipment of the plant is adequate to handle almost any job in electronic welding or the automobile field.

Considerable wood working equipment is included in the shop. Equipment inventory value is \$8,375.

Approximately 300 men are now enrolled in trade classes and use the shop a portion of each night, five nights a week.

Automotive instructors are: L. E. Sublett, D. Huff, Dick Thacker and John Payne. A. F. Caldwell and C. A. Carbery are the welding instructors, and Bill Scarlett and Jack Ledbetter are in charge of electronic instruction.

During the meeting at the hotel, Claude McBeth was introduced as a Lion Cub. President Clyde Karkalis announced that next week's program will be taken up with a business meeting, including election of officers for the coming year.

The livestock team is composed of Don Jobe, Dan Jobe, Lawrence Ingram, Don Stratton, Tommie Rice, and Marvin Anthony, all of Scranton 4-H Club.

Members of the dairy team are Franklin Myrick, Cisco 4-H Club, Jerry Sims, Richard Lane, and John D. Burleson all of the Eastland 4-H Club.

A SUBSTITUTE FOR DIVORCE -

A new model plan for ailing marriages - something besides divorce - has been termed "an absolute must" in the United States and a committee of the American Bar Association is formulating such a plan, according to press dispatches.

Legislators have been endeavoring since 1884 to work out uniform divorce laws in the nation.

But this doesn't seem possible, for it seems difficult for 48 states to agree on the same pattern. Statistics show that migratory divorce, involving couples who run to another state - Nevada, for instance - makes up only 3% of the total, so it's really the 97% who divorce at home that worries the bar association.

A noted jurist has said that the present method of dispensing divorce is like permitting a sick man to diagnose his illness and prescribe his own remedy.

Just about everybody will agree with the jurist. And just about everybody will appreciate the bar association's growing alarm over the divorce situation.

Rather than working for uniformity in divorce laws, perhaps the talents of the bar association could better serve the nation if they were put to work on find-

ing a solution to the causes for divorce. Preventative medicine often tastes much better than that prescribed for real illness.

A&P Denies U. S. Anti-Trust Count In Formal Answer

The Great Atlantic & Pacific Tea Co., has flatly denied Government anti-trust charges in U. S. District Court and has termed the Civil suit against it an effort to change the nation's "entire structure."

In its first formal answer to the complaint seeking dissolution of the 90 year-old food chain, A&P said there "is no justification in fact or in law for the drastic and confiscatory destruction" of the company. A&P denied in detail the charges of restraint of trade and monopoly brought under the Sherman Act.

Defendants John A. Hartford, chairman of the board, George L.

Hartford, Treasurer, and the A&P asked through counsel that the complaint be dismissed. The answer was filed by the New York Law firm of Cahill Gordon, Zachary & Reindel.

"The plaintiff," A&P contended, "is asking this court to adopt, by judicial fiat, new extremist principles of law which would result in a complete remodeling of the entire economic structure of this country."

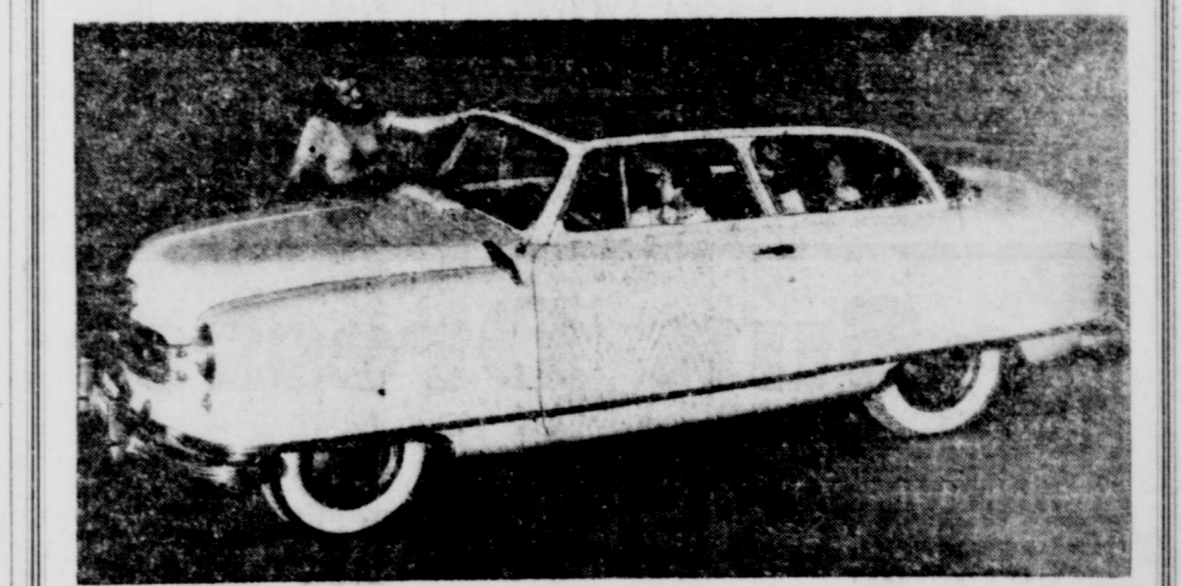
