

The others are being taught in subjects which will enable them to take civil service examinations for are eligible. Classes operate 30 hours a week, three soldier teachers and a like number of "Y" secretaries are engaged in the instruction.




on Toyah Schools

REPORT MADE BY STATE IN-SPECTOR L. E. DUDLEY FROM RECENT VISIT TO SCHOOL, AND RECOMMENDATIONS

The following report of the work in the Toyah schools, in which are included several recommendations for ttering the good work now being done, were made by State Inspector L. E. Dudley, after a recent visit to the schools:

The Toyah High School occupies a comfortable and well planned building that will accomodate the community when it has become much larger than at present. The school is at a stage that causes its maintenance to be a comparatively expensive business since the same number of classes are conducted and teachers employed as in a high school of a larger enrollment, without the revenue from the State that an increased number of scholastics would afford. The tax for school purposes however, is lower than in most communities of Texas. Two years of high school work are being done, the second and the third; there is no first-year class this year. It is planned to make of the school a standard third-year or second-year high school.

The school is falling short of the minimum requirements for a secondclass high school in the following particulars: 1. Number of teachers employed. 2. High school library. 3. Elementary library. 4. Laboratory equipment. 5. Number of classes taught daily by high school teachers. It was pointed out to the superintendent and trustees, however, that these requirements, with the excep-



ONE SHELL INFLICTS TWENTY WOUNDS ON THIS "Y" MAN

After surviving the effects of twenty wounds from a single high explosive shell in the battle of the Argonne, Henry Pinkerton of Jacksonville, Ill., has arrived in Houston to resume his duties at Ellington Field as a Y. M. C. A. secretary. Pinkerton was a "Y" worker with the Third division in France and had charge of the headquarters of the Y. M. C. A. canteen. He was with the division while it was in action in the second battle of the Marne and the Saint Mihiel drive last summer. While at work as close to the front as he could get in the battle of the Argonne, he was wounded by what he believes was an Austrian "77". So great was the concussion of the shell that it burst a blood vessel in his head, rendering him unconscious for over 48 hours.

The fragments of the shell that inflicted most of his wounds appeared to be pieces of the inside wrapping of the shell, one piece of which he has with him as a souvenir. He declares he experienced no pain whatever at

Mr. Pinkerton states that he saw little of the war except that part in which the third division was engaged up to the time he was put out of action. He says the "Y" canteens were forbidden to sell to any men outside of their own outfits and this caused a

great deal of trouble as the "Y" men were anxious to serve all who applied to the canteens and did not know just when to take a chance and break the Treasury and Postoffice Departments, rules. The canteen at the front, he declares, never did have sufficient supplies while he was there, as the doughboys would clean them out a few days after their arrival of several truck loads of supplies, regardless of the amount received.



PROPOSED AMENDMENT TO THE STATE CONSTITUTION PROHIB ITING THE MANUFACTURE AND SALE OF INTOXICATING LIQUORS

HOUSE JOINT RESOLUTION NO. 1

amending Article 16, Section 20 thereof by striking out and repealing said section and substituting in lieu thereof a new Section 20, prohibiting the vinous or malt liquors or medicated bitters capable of producing intoxication, or any other intoxicant whatever, except for medicinal, mechanical, scientific or sacramental purposes, and providing that the Legislature shall enact laws to enforce this section; providing that until the Legislature shall prescribe other or different regulations on the subject the sale of spirituous, vinous or malt liquors or medicated bitters, capable of producing intoxication, or any other intoxicant whatever, for medincinal purposes shall be made only in cases of actual sickness, and then only upon prescription of a regular practicing physician, subject to certain regulations with reference to the same; providing that this amendment shall be self-operative; and until the Legislature shall provide other or different penalties, the violation of any part of this constitutional provision shall be deemed a felony punishable by confinement in the penitentiary for a term by the Constitution and Laws of this State. of years specified, without the benefit of any law providing for suspended injunctions against infractions or threatened infractions of any part of proclamation, publication and election. this constitutional provision; providing that, without affecting the provisions herein, intoxicating liquors are declared to be subject to the gen- (A true copy) eral police power of this State: declaring that the Legislature shall have power to pass any additional prohibitory laws in aid thereof which it may deem advisable; fixing the time for the election for the adoption or rejection of said proposed constitutional amendment and prescribing certain rules and regulations with reference to the same; declaring that the provisions of the General Election Law shall govern in all respects as to qualifications of electors and methods of holding the election and in all other respects where applicable; directing proclamation for the election and making certain provisions for the election and ballots thereof and method of voting; prescribing certain duties for the Governor of the State; and making an appropriation to carry out this resolution.

Section 2-Every person, male or female, subject to none of the foregoing disqualifications, who shall have attained the age of twenty-one years, and who shall be a citizen of the United States, and who shall have resided. bidder, as the property of said R. N. in this State one year next preceding an election, and the last six months. within the district or county in which he offers to vote, shall be deemed a qualified elector; and all electors shall vote in the election precinct of their residence; provided, that electors living in any unorganized county may vote at any election precinct in the county to which such county it attached for judicial purposes; and provided further, that any voter who is subject to pay a poll tax under the laws of the State of Texas shall have paid said tax before he or she offers to vote in any election in this State and hold a Sewell, et al, for the sum of Three ceding said day of sale in the Pecos receipt showing such poll tax paid before the first day of February next preceding such election. Sec. 3-The foregoing constitutional amendment shall be submitted to the vote of the qualified electors for members of the Legislature at an election to be held for such purpose on the fourth Saturday in May, A. D. 1919, the same being the twenty-fourth day of said month; at said election, the votes shall be placed on an official ballot which shall have printed, or written, thereon the words, "For the amendment to Section 2, Article 6, of the Constitution of the State of Texas, providing qualifications for male and female voters," and also the words, "Against the amendment to Section 2, Article 6, of the Constitution of the State of Texas, providing qualifications A resolution proposing to amend the Constitution of the State of Texas, by for male and female voters." All voters favoring this proposed constitutional amendment shall erase the words "Against the amendment to Section 2, Article 6, of the Constitution of the State of Texas," and those opposing manufacture, sale, barter or exchange in the State of Texas of spirtuous, it shall erase the words, "For the amendment to Section 2, Article 6, of the Constitution of the State of Texas, providing qualifications for male and female voters," which said erasures shall be made by making a mark with a pencil, or pen, through said words. All ballots cast, as above provided, shall be counted as cast for or against a proposed amendment, and if a majority shall be for the amendment it shall be declared adopted; if a majority of the voes cast shall be against the amendment, said amendment shall be lost. All provisions of the general election laws, as amended and enforced at the time said election is held, shall govern in all respects as to the qualifications of the electors, the method of holding such elections, and in all other respects so far as such election laws can be made applicable.

SENATE JOINT RESOLUTION NO. 13

A resolution to amend Section 5 of Article IV of the Constitution of the State of Texas, as follows: Strike out the words "Four Thousands" found in the third line of Section 5, and insert in lieu thereof the words "Ten Thousand," and adding after the word "furniture" the words "and this clause shall be self-enacting," and making an appropriation to pay necessary expenses hereof.

Be it Resolved, by the Legislature of the State of Texas:

Section 1. That Section No. 5 of Article IV of the Constitutuion of the State of Texas be so amended as hereafter to read as follows:

Section 5. ARTICLE IV. GOVERNOR'S SALARY AND MANSION -He shall at stated times receive as compensation for his services an annual salary of ten thousand dollars, and no more, and shall have the use and occupation of the Governor's Mansion, fixtures and furniture (and this clause shall be self-enacting.

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors for members of the Legislature at an election to be held thoughout the State of Texas on the fourth Saturday in May, A. D. 1919, same being the twenty-fourth day of May, A. D. 1919, and the Governor of this State is hereby directed to make the necessary proclamation for said election and to have the same duly published as required by the Constitution and laws of this State. Said election shall be held under and in accordance with the general election laws of the State and the official ballot shall have printed or written thereon in plain letters the words, "OFFICIAL BALLOT," and also the words, "For the amendment to Section 5 of Article IV of the Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas," and also the words, "Against the amendment to Section 5 of Article IV of the Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas." All voters favoring such amendment shall erase, by making a mark through the words "Against the amendment to Section 5 of Article IV of the Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas," and all voters opposing such amendment shall erase by making a mark through the words "For the amendment to Section 5 of Article IV of the Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas." If a majority of votes cast shall be "For the amendment to Section 5 of Article IV of the Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas," said amendment shall be declared adopted. If a majority of the votes cast shall be "Against the amendment to Section 5 of Article IV of hte Constitution of the State of Texas in regard to the salary of the Governor of the State of Texas," said amendment shall be lost and shall be so declared.

Be it resolved by the Legislature of the State of Texas:

Section 1. That Article 16 of the Constitution of the State of Texas be amended by striking out and repealing Section 20 thereof and substituting in lieu of said Section 20 the following:

Sec. 20-(a) The manufacture, sale, barter and exchange in the State of Texas, of spirituous, vinous or malt liquors or medicated bitters capable of producing intoxication, or any other intoxicant whatever except for medicinal, mechanical, scientific or sacramental purposes, are each and all hereby prohibited.

The Legislature shall enact laws to enforce this section.

(b) Until the Legislature shall prescribe other or different regulations on the subject, the sale of spirituous, vinous or malt liquors, or medicated bitters, capable of producing intoxication, or an other intoxicant whatever, for medicinal purposes shall be made only in cases of actual sickness, and then only up the prescription of a regular practicing physician, subject to the regulations applicable to sales under prescriptions in prohibited territory by virtue of Article 598, Chapter 7, Title 11, of the Penal Code of the State of Texas.

(c) This amendment is self-operative, and until the Legislature shall prescribe orther or defferent penalties, any person, acting for himself or in behalf of another, or in behalf of any partnership, corporation, or association of persons, who shall, after the adoption of this amendment, violate any part of this constitutional provision shall be deemed guilty of a felony, and shall, upon conviction in a prosecution commenced, carried on and concluded in the manner prescribed by law in cases of felonies, be punished by confinement in the penitentiary for a period of time not less than one year nor more than five years, without the benefit of any law providing for suspended sentence. And the district courts and the judges thereof, under their equity powers, shall have the authority to issue, upon suit of the Attorney General, injunctions against infractions or threatened infractions of any part of this constitutional provision.

(d) Without affecting the provisions herein, intoxicating liquors are declared to be subject to the general police power of the State; and the Legislature shall have the power to pass any additional prohibitory laws, or laws in aid thereof, which it may deem advisable.

(e) Liability for violating any liquor laws in force at the time of the adoption of this amendment shall not be affected by this amendment, and all remedies, civil and criminal, for such violations shall be preserved.

Sec. 2-The foregoing constitutional amendment shall be submitted to a vote of the qualified electors for members of the Legislature at an election General, Land Commissioner, Comptroller of Public Accounts and the State to be held throughout the State of Texas on the fourth Saturday in May, being the twenty-fourth day thereof, A. D. 1919. At said election, the vote chasers. The Legislature shall have authority to create by law such agenshall be by official ballot, which shall have printed or written at the top thereof in plain letters the words, "Official Ballot." Said ballot shall have also written or printed thereon the words. "For Prohibition," and the words, 'Against Prohibition.'

All voters favoring said proposed amendment shall erase the words posing it shall erase the words, "For Prohibition," by making a mark through the same.

If a majority of the votes cast at said election shall be "For Prohibition," said amendment shall be declared adopted. If a majority of the votes shall be "Against Prohibition," said amendment shall be lost, and so declared.

All the provisions of the General Election Laws as amended and in force at the time of said election is held shall govern in all respects as to the qualifications of the electors, the method of holding such election, and all other respects, so far as such election laws can be made applicable.

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and to have the same published as required by the Constitution and laws of this State. Sec. 4-The sum of Five Thousand Dollars (\$5,000.00), or so much thereof as may be necessary, is hereby appropriated out of any funds in the State Treasury, not otherwise appropriated, to defray the expenses of such proclamation and election. PROPOSED AMENDMENT TO THE STATE CONSTITUTION, GIVING THE LEGISLTURE POWER TO GIVE OR LEND, OR AUTHOR-IZE THE GIVING OR LENDING, OF THE CREDIT OF THE STATE FOR THE PURPOSE OF ASSISTING CITIZENS, HEADS OF FAMILIES, TO ACQUIRE OR IMPROVE THEIR HOMES

HOUSE JOINT RESOLUTION NO. 19

To amend Section 50, Article 3, of the Constitution of the State of Texas, to provide that the Legislature shall have power to give or lend, or authorize the giving or lending, of the credit of the State for the purpose of assisting citizens who are heads of families to acquire or improve their homes; authorizing the State to acquire, improve, sell or lease real estate or assist such citizens to acquire or improve their homes upon terms and conditions prescribed by the Legislature; authorizing the Legislature to create such agencies as may be necessary to carry out the purposes of this section; providing that obligations created under this section shall never be taxed; and providing that the Legislature shall have authority to provide a method of securing any deferred payments for lands purchased hereunder, and that such obligations shall be secured in addition to the usual liens by an annual assessment collected as a tax against the land; and providing that the Legislature shall have no power to relieve any person from any obligation entered into under this provision or any any statute enacted thereunder; and providing for the classification of lands acquired under this Act, and limiting acreage sold to any one person where lands are classed as agricultural.

Be it resolved by the Legislature of the State of Texas:

Section 1. That Section 50, of Article 3, of the Constitution of the State of Texas, be so amended that the same will read and hereafter be as follows: Sec 50. The Legislature shall have no power to give or to lend, or to authorize the giving or lending, of the credit of the State in aid of or to any person, association, or coroporation, whether municipal or other, or to pledge the credit of the State in any manner whatsoever, for the payment of the liabilities, present or prospective, of any individual, association of individuals, municipal or other corporation, whatsoever, except that the Legislature shall have the power to give or to lend, or to authorize the giving or lending, of the credit of the State for the purpose of assisting native born or naturalized citizens who are heads of families and who will become in good faith actual occupants, to acquire or improve their homes; and for this purpose the State is authorized to acquire, improve, sell or lease real estate or assist such citizens to acquire or improve their homes upon such terms and conditions and in such manner and subject to such limitations as the Legislature may from time to time prescribe. Provided that no land shall be acquired by the State under the terms of this amendment to the Constitution until the said lands are examined, and the value of said lands is appraised and ascertained as to its actual value for agricultural purposes, by a commission hereby authorized, composed of the Governor, Attorney Treasurer; and their report shall be available to all prospective land purcies as may be deemed necessary to affect the purposes of the Act. Obligations created under this section shall never be taxed, and the Legislature shall have authority to provide a method of securing deferred payments for lands purchased hereunder, and in addition to the usual liens may secure the same by an annual assessment collected as a tax against the land; pro-'Against Prohibition" by making a mark through the same, and those opfrom any obligation entered into with the State under this provision or any statute enacted hereunder. The terms of this Act shall not apply, or be extended to any person who is not a bona fide resident citizen of the State of Texas and who has not been such citizen at least two years prior to the extension of such aid, nor shall the terms of this Act ever be applied to any lands outside of the State of Texas. Provided further that all land acquired by the State under the provisions of this section for which the State may lend its credit shall be classified as agricultural lands or otherwise, and if classified as agricultural lands, then no more than 200 acres shall be sold to

Sec. 3. There is hereby appropriated out of the funds in the State Treasury, not otherwise appropriated, the sum of Five Thousand Dollars (\$5,000.00), or so much thereof as may be necessary to cover the necessary expenses attached to the proclamation and publication of this amendment, and the Governor shall issue the necessary proclamation and cause the same * to be duly published. 


