

All of these reports may have delayed man from utilizing this wonderful country of West Texas but it did not stop him and consequently West Texas is now a widely scattered farming district, because human endeavor has made irrigation possible, whereby rivers are harnessed to supply man's demand

The pioneers that first came to Barstow, in 1892, this town lying 220 miles east of El Paso, 393 miles west of Fort Worth, on the Texas and Pacific railroad, realized that the Greator had placed the Pecos river for man to master for his uses, and so an irrigation project was installed, being the first to be installed by white men in the Southwest.

The town of Barstow grew and prosperd in spite of the many difficulties that continually confronted those pioneers, until at one time the population was 3000, and 14,000 acres of land were under cultivation, and irrigated from the Pecos river. Of this amount only about 9000 acres are now under cultivation, and the population is about 1500. This decrease came through no fault of the land, the people, or any other than lack of water caused by the people in New Mexico, along the Pecos

river, utilizing almost all of the waters of that river, according to geological reports using more than their pro rata. This controversy has been the main issue





The most Teasible plan of creating that reputation is to support every worthy enterprise that is ant up to the town. To be progressive, a town must be in an active and not in a passive state. The merchants and business men must lead the procession and the rest of the community will follow.

There are always a few citizens who will pull back and for that reason the others will have to shoulder an increased load then there are a few citizens who always like to ride in the band wagon but are too indifferent to take the trouble of tooting a thorn; they like to be counted in on the thonors of the town but they don't like to expend any efforts for an enterprise.

If we are to have a live town that will be known for miles around as a good trading center, we must wake up to the fact that co-cperation is the only thing that will get us there.

A town is no place to foster jealousies and nourish contentions. All should know That whatever will conduce to the welfare sol the town cannot injure her citizens. The disposition made manifest by her citizens point to her rise or downfall. The character sof the people make the town, not her struc-"tures, towering houses, domes and monuments, and when people lose interest in wheir town, both as a place to live in and us a trading and assembling place, they meed never sustain any hopes for prosperity. Harmony among the people of a community is indicative of its progress. Farmers cannot be at variance with one another, merchants cannot, churches cannot, nor scan any similar organization, nor can any community bid for growth that cannot get together on a single issue.

Pecos is now enjoying one of her greatest booms and it is time for the community to get down and pull together towards building up the town.

Pecos has on several occasions had two and even three print shops, none of which had a decent support which would enable the owners to pay their bills promptly, much less donate to the public good of the community. There are two in Pecos now, with another shop in the station. It remains to be seen whether or not our busi-

ness men are going to divide the work and make inefficient their one best asset-that of a first class newspaper and job shop.
