



# PETERSBURG ELATION.

The people of the Petersburg section are much elated over the flotation of the Altus, Roswell and El Paso bonds. The report from Kansas City is to the effect that \$8,000,000 worth of bonds will be underwritten by Chicago and Kansas City financial interests. This, added to the \$1,000,000 in the way of bonuses raised, will complete the road and put it in running condition. There has been considerable grading done in the Petersburg section, and a better country has never been found. The railroad will be a boon to them.

Mr. Kennedy, the promoter of this line, has made a proposition to Oklahoma City to extend from Altus to that place. If the "live wires" of Oklahoma City should become interested in this line, it will be only a little time before we will see something doing in this section. ## **IS HE SINCERE?**

President Taft has said, so we are informed from Washington, that he will divide the census supervisors in certain southern states between the by the South. He has issued the following order directed to Secretary of Commerce Nagel, and if it be lived up to, we will have no occasion to find fault:

"It is not an unreasonable requirement that anyone who accepts an appointment and service, avoid an active participation in politics.

"I therefore order that in the preparation of regulations for the taking of the census, you and the director of the census embody therein a provision that any supervisor or enumerator who uses his influence with his subordinates or colleagues to assist any party or any candidate in a primary or general election, or who takes any part other than merely casting his vote, in politics, national, state or local, either by service on a political committee, by public addresses, by the solicitation of votes or otherwise, shall at once be dis-

missed from the service. "I wish to make this regulation as broad as possible, and wish it enforced without exception. It is of the highest importance that the census should be taken by men having only the single purpose of reaching a just and right result, and that the large amount of money to be expended in the employment of so vast a machine as the census shall not be made to one. 





# OUR TAX RATE.

As many of our readers have asked for the tax rate in the county and town we give it below:

State rate is 5 cents on all listed property and the county rate outside the independant school district is 69 1-6 cents, divided as follows: General fund 10 cents, court house and jail 12 1-2 cents, road and bridge 10 cents, county school fund 20 cents. state schol fund 16 2-3 cents.

In the independent school district but outside the town of Plainview the county school tax will be 50 cents in lieu of the 20 cents.

The city rate for Plainview is as follows: 60 cents for city, 50 cents for Independent school district, 21 2-3 for the state, and 32 1-2 for the county making a total of \$1.64 1-6 per hundred for all city taxes. The total in the county is 74 1-6 outside the independent school district, and \$1.04 1-6 outside town of Plainview but within the independent school district.


