### Poisonous Liquid Put in Bonded Bottles by Oklahoma Bootleggers.

Davis, Okla., Nov. 17 .--- The latest scheme of the bootleggers has been exposed by Deputy Sheriff Mook here. A sanctified appearing old cripple, with a book under his arm marked in big gold letters "Holy Bible," was seen at the mining camps in the Arwest of here. The officer supposed he was a preacher.

Mook started an investigation. Several "empty Bibles" were lying around, which gave the scheme away. A box of heavy cardboard, in size and color resembling a Bible, contained a shrort pint of liquor. A local

chemist analyzed the stuff, which he pronounced to be brown sugar, plug tobacco, arsenic, pepper, etc. It is believed that a pint, if drunk within a

few hours, would cause death. Revenue officers are looking for the makers of the "Holy Bible" kind of stuff that makes men crazy. One of the officers said today that thous-

ands of bottles of "bonded" bottles of whiskey had been sold in Oklahoma that had contained a poisonous liquid. The scheme is to melt a hole in the bottom of the bottle and extract the real whiskey and substitute the preparation. An electric needle was used both for cutting the bottle and for sealing it up again. The revenue stamp would be found unbroken, and the consumer imagined he was drinking bonded whiskey.
