THE STATE Legislature convened this week in Austin, and lawmakers are faced with a critical problem.

The problem isn't necessarily new: lack of money. This time around, however, the solution may cause lawmakers more than a little concern.

The legislature is aware that many parts of the state are in a depressed condition, due to the collapse of the oil and gas industry. And the bad situation in agriculture leaves this portion of the state not far behind in the "woe" category.

Local and county officials already have agonized over the tax situation, as was evidenced here last summer when the new evaluation procedure was established. With income down, taxpayers are understandably cautious about the tax situation.

State comptroller Bob Bullock pointed out this week that the big problem facing lawmakers is a \$5.8 billion deficit in the state budget. This amounts to about 15 per cent of the current budget total, and Bullock warns that you cannot cut everything 15 per cent across the board without doing serious damage to the responsibilities of state government.

The deficit amounts to more than will be brought in by the state sales tax in one year, and more than will be raised through the state's franchise tax and oil and gas taxes over the next two years, so it is a serious problem.

Bullock says the state's current tax structure leans too heavily on the oil and gas industry, and that the only way to deal with the problem is to broaden the state's tax base. The state official has predicted a tax collection decline of 2.9 per cent for 1988-89, the first revenue drop in the state in 30 years.

One of the proposals to help the state's budgetary problems is that of creating a state lottery. Bills have already been introduced to create such a lottery. Backers say a state lottery would bring the state up to \$600 million a year in a "painless" tax, a program in which those taking part do so willingly.

But the lottery question is bound to face a lot of debate before it is passed. Lawmakers will be hesitant to pass such a program that deviates somewhat from the state's historically conservative outlook.

However, desperate times may dictate desperate measures.

In addition to the budget problems, the legislature has a number of items that will demand a lot of their time.

These include prison reform. Texas is being faced with a possible \$24 million a month fine due to failure to complete numerous reforms such as increased capacity and additional guards. This week, the state penitentiary in Huntsville had virtually reached its capacity.

Also, higher education will receive a lot of priority. Lieutenant governor Bill Hobby thinks budget cuts made earlier may have severely damaged the state institutions of higher learning.

Public education also will come into its share of discussion. A major item will once again be the "no pass, no play" rule. Governor-elect Bill Clements favors rolling back the suspension period from six weeks to three weeks.

All in all, it bids to be a busy and important session for state lawmakers. And, with all of the business they have to conduct, some observers are predicting even now that it won't all be completed without a special session after the conclusion of the regular legislative session.

Excel Hit By Electrical Blast

An electrical explosion occurred at Friona's Excel plant at an early hour on Thursday.

Friona Fire Department was called to extinguish the blaze. No injuries were sustained, but the plant was shut down for most of the day on Thursday.

The "disconnects" blew out, according to plant manager Von Blum, and this caused a loss of power to approximately one-third of the plant.

Clean-up and re-wiring was underway on the large cables late Thursday. The explosion happened at about 1 a.m. Thursday.

Blum was at a loss to explain the cause of the explosion, saying that the reason may have been destroyed by the ensuing fire.

"We appreciate the quick response by the Friona Fire Department, as well as the ambulance which was brought out," Blum said.

Workers in the fabricating department of the processing plant were at work in the second shift late Thursday, and Blum said it was hoped to again start slaughter operations with Friday's second shift.

The work stoppage came during a busy time at Friona's beef processing plant. Excel officials say they have been slaughtering over 20,000 head of cattle a week, killing six days a week.

Excel is the largest employer in Parmer County.

DRIFTING SNOW RECEIVED

Area Rebounds From Double Arctic Blast

Old Man Winter has dealt the Friona area a double-barrelled blow during the past week, with more than a foot of snow, which fell during blizzard-like conditions which caused the snow to drift, making problems for motorists, farmers and virtually everyone.

Last Thursday night and Friday morning, the area received an inch or two of snow, which was just a "taste" of things to come.

After a virtual standstill Saturday morning, the Arctic storm really got wound up late Saturday night, when most of the estimated one-foot of white stuff was deposited. Again, the snowfall was accompanied by high north winds, which caused the snow to drift, and made it hard to determine exactly how much snow was received.

The temperature had begun to plunge with the approach of the Arctic front. The temperature was in the "teens" all day Friday, and again Saturday it barely made it into the low 20s. The mercury dropped to around the zero mark for a time Saturday night, when it reached the coldest point.

Sunday dawned with a clearing trend, with the sun breaking through at about mid-day. The temperature climbed up to about the 30-degree mark, and some melting was observed, due to the exposure to the sun.

Monday was a beautiful day from a weather standpoint. The mercury finally climbed above the freezing mark for the first time in four days. The sun shone for most of the day, which again facilitated the melting.

However, the melting and clearing process was short-lived, as another front moved into the area late Monday. Residents awoke Tuesday morning to find another two or three inches of snow on the ground. Once again, the wind was involved, so that streets, driveways and sidewalks which had been cleared of snow Sunday were once again covered with the white stuff.

At about noon on Tuesday, the skies began to clear and the latest snowfall stopped. The area has had three clear days, with some melting. However, as temperatures drop into the single digits at night, the daytime high had barely made it into the middle 30s.

Fortunately for the local school system, Monday had been designated as a work day for teachers, with students being dismissed. School started an hour late on Tuesday, but since then has remained on schedule.

Highway crews have been working practically around the clock since the storm hit Friday, clearing the roads,

which for the most part have remained in good shape except for the periodic weather blasts. No bad wrecks had been reported so far during the storm, although a number of cases of people being stuck in snow or ice have been noted.

Track Request Tabled

The Friona School board heard representatives from the Chieftain Parents organization at its January 12 meeting. The group asked the school to install an all-weather track at Chieftain Stadium, at a cost of around \$63,000.

The school board, after considerable discussion, voted not to proceed on the new track at this time, due to the present economic conditions in the area.

Superintendent Tom Jarboe reported that a local family has

decided to teach their first-grade student at home, under a recent ruling that allows "home" school under certain qualifications.

Jarboe pointed out that the recent ruling is considered temporary, and a final decision on home schooling is expected in the near future.

Jarboe also reported that the school district received a waiver from the Texas Education Agency on the class size for grade one in the local system. The TEA requires classes to be from one to 22 students in size.

"This was the only place we were over, and at the present time we are in compliance. It looks as though in the future we won't have to request this waiver," Jarboe said.

An update to the school policy manual was approved on the first reading, bringing the policy in compliance.

The board approved advertising for bids for a new small maintenance tractor, to be used for mowing and other small jobs. The school's present tractor is 22 years old.

Stock Show Is Slated January 24

The Friona local 4-H and FFA Project Show is scheduled for Saturday, January 24, at the Friona Community Center.

Animals may be weighed in Friday evening or by 8:30 a.m. Saturday morning.

Judging will begin at 9 a.m. with the barrows, followed by lambs, heifers and steers, as judging is completed on each class of livestock.

Scotty Windham of Abernathy, former Vocational Agriculture teacher at Lazbuddie, will do the judging this year for the second time.

Court Disposes Of Routine Agenda

In a full agenda, the Parmer County Commissioner's Court disposed of a number of items of business at their regular meeting on January 12.

The court approved the salary schedule for county employees, which calls for no increase in salaries from 1986.

The county's holiday schedule for 1987 was approved: April 17, Good Friday; May 25, Memorial Day; July 3, Independence Day; September 7, Labor Day; November 26 and 27, Thanksgiving; December 24 and 25, Christmas; January 1, 1988, New Year's Day.

An employees' salary grievance committee was appointed, with the County Judge as the non-voting chairman. Members will be Dorothy Sorley, Roger Dale Gallman, Patrick Riley, Jon Mack Roden, Dale Gober, Randy Lee Richards, Phyllis Steelman, Ronald Dean Smiley and Karen Kirkpatrick.

School To Elect Three

The Friona School board will be electing three members this April.

Terms of Pat Fleming and Dee Willard are expiring. In addition, a two-year term for the unexpired seat formerly held by Bryan Johnston will be filled.

Those wishing to file may do so in the superintendent's office through March 4.

A motion was passed to pay the four county fire departments \$3,500 each. This money is budgeted each year and is paid to the departments to use as they see fit, in appreciation for rural fire calls they have made.

Since the justice of the peace office in Bovina is no longer in the City Hall and the county is to furnish an office, a motion was passed to pay \$35 per month for rent and utility assistance for this office beginning January 1, 1987.

Boarding care bills for the foster children in Parmer County were approved, in the amount of \$3,518, which amount will be reimbursed to the county.

Dr. Paul L. Spring of Friona was appointed as the County Health Officer for 1987-88.

A motion was passed to pay an electric bill of \$44.95 plus \$70 deposit and \$5 re-connect fee for a resident so they could get their electricity turned back on. The citizen is to repay the \$70 deposit and \$5 fee at \$5 per month until paid back.

The treasurer's quarterly report was approved, with notation that the report be published in the county's three newspapers.

Another citizen requesting financial help so their utilities could be turned back on was advanced \$200. This amount is to be re-paid to the county in monthly payments.

To take advantage of a monetary saving, a motion was passed to prepay for the computer ordered by the clerk's office.

FmHA Establishes Operation Bootstrap

"Operation Bootstrap"--an association of attorneys and agricultural loan counselors attempting to educate farmers on FmHA lending regulations while educating the public on farm problems--will meet with area farmers in 20 different communities during the month of January, according to an announcement by Bruce Magness, Operation Bootstrap Director.

In announcing the latest effort by the group, Magness emphasized the impact on the South Plains--including the city of Lubbock--of the loss of \$91 million in FmHA operating loans in the State of Texas during the fiscal year completed September 31, 1986, and the imminent loss of even more funding for the current year.

Magness said FmHA lending had dropped from \$367 million in 1984-85 to \$267 million in 1985-86 in the State of Texas--a drop of 25 per cent in one year, and a loss of \$91 million to the economy.

Funds for the upcoming year have been cut \$500 million nationwide, another 25 per cent drop, so that Texas can expect no relief so far as direct lending is concerned. Guaranteed Loan funds will be increased 25 per cent at the same time, but Magness warned that a strong and sincere effort to convince South Plains bankers to take on FmHA Guaranteed loans will be needed if Guaranteed funds are to make up for the cuts.

Texas lost all the farmers it can stand this past year, Magness said, "unless we agree that our highest and best use is as a nuclear dumpground for the rest of the nation."

"We want to see what is happening out in the country, with the farmers and the FmHA offices in the countryside as well," said Magness. He urged farmers to bring documentation if they have been denied applications (get the denial in writing), told they cannot get copies of their files (number the pages, make a written request for a copy of the file, get a written denial) or told they cannot file an application until all crop proceeds

or government deficiency check totals are in (ask for written confirmation of this policy).

"If farmers will tell us what is happening in their counties, and if they can provide documentation, we may be able to help them. Hopefully, opening up communications will do it," Magness said.

Videotapes on the new Chapter 12, debt forgiveness, discharge in bankruptcy, reorganization, FmHA Regulations, and agricultural loan counseling, will be available at each stop according to Magness, along with books on getting along with FmHA.

Proceeds from these sales will go to Agricultural Loan Counseling, Inc., a new, non-profit loan counseling group of farmers set up at 2229 34th Street in Lubbock, Texas, Magness said.

Magness's "Operation Bootstrap" previously sponsored a seminar on October 1 at the Texas Tech law school, featuring Bill Shoop and Cheryl Parsons, farm

counselors from Missouri.

"Operation Bootstrap" videotaped that seminar and sells the tape, entitled "Bootstrap I," for \$25. The second videotape, dubbed "Bootstrap II," features attorneys from Lubbock and Agricultural Loan Counseling counselors on Chapter 12 reorganizations, debt forgiveness and discharge and the IRS, Raising Money in Chapter 12, and FmHA and the Farmer, and other topics, and sells for \$25 also.

Bob Gibson, of the Texas Department of Agriculture office in Lubbock, has agreed to arrange for locations for meetings in each of the communities. Persons or organizations wishing to serve as host to "Operation Bootstrap" may contact Mr. Gibson or Mr. Magness.

HP Water District Measuring Depths

On January 5, personnel at the High Plains Underground Water Conservation District No. 1 began measuring the depth to water in more than 950 water-level observation wells scattered throughout the Water District's service area. The measurements will record what effect 1986 pumpage had on the water level of the Ogallala aquifer within the Water District's 15-county service area.

In Parmer County, Dan Seale will be measuring observation wells for the Water District.

Data gathered from the water-level measurements will be compared to water-level data from previous years to ascertain changes in the Ogallala's water level within the District's service area. Hydrologic maps showing the saturated thickness of the Ogallala Formation, the elevation of the water table and both annual and long term changes in water levels are compiled using this information. Annual water-level measurements are also used to

calculate the amount of water depletion for landowners who wish to claim a cost-in-water income tax depletion deduction on their federal income tax.

Water District Geohydrologic Division Director Don McReynolds expects that last year's trend, in which water-level changes averaged a zero net change throughout the District's service area, will continue because of the wet growing season in 1986 and other factors.

The water-level measurements determine the distance from the land surface to the water table in each well measured. A blue and white tag containing the state-assigned well number and the measured depth to water in feet will be attached to some conspicuous part of the well-head equipment after the measurement is taken.

The tag informs the landowner or well operator of the depth to water in the well and the date that a Water District employee visited the well.

Judge Is Named For Election


The Lazbuddie School Board Tuesday appointed Billy Powell to be the election judge during the school board elections in April.
