# FRANCE REJECTS PLANS OF BRITISH

#### Separate Notes Are Forwarded to London By France And Belgium Over The German Reparation Question.

SUNDAY WAS QUIET IN GERMANY

Failed To Materialize-Inclement Weather And Police Prevent

#### By The United Press.

LONDON, July 30 .- The French and Belgian replies to the British note delivered here tonight.

Premier Stanley Baldwin has an Sweetwater. nounced that he will, if possible, make a statement concerning them in the House of Commons tomorrow.

It is learned from well informed sources that the French reply criticizes the English suggestion for an impartial commission to determine Germany's ability to pay reparations and rejects the British proposal that France and Belgium withdraw from the Ruhr as a concession for the termination of the German's passive resistance to the occupation. The note Railroad Brakeman Lying in Hospital is couched, however, in very tactful and diplomatic language.

Belgium is forwarding a separate reply. She flatly refuses to refer her war claims to a commission. There is no suggestion that the Franco-Belgian partnership is broken but Belgium is in the attitude of attempting to bring Shooting Followed Scuffle-Nervous

SAN FRANCISCO, California, July 30 .- Late today physicians in altendance upon President Harding, issued the following optimistic statement:

"The president had a fairly comfortable night with several hours sleep and is resting easily. His temperature is 101, pulse 115, respiration 33. The abdominal symptoms following the digestive disturbance are now localized in the gall gladder region. There are no peritoneal symptoms. The white blood cells number 10,800. The kidneys are functioning sufficiently and there is no disturbance of the nervous system except that incidental to fatigue."

Or in plain language, the president strained his heart by speaking while ill but nothing is organically wrong and as soon as he recovers from the acute indigestion and has had an opportunity to rest, he will be as well as ever.

SAN FRANCISCO, California, July 30 .- President Harding has suffered a serious turn for the worse following the illness which attacked him in Seattle, Washington. Serious heart symptoms have developed and a consultations of physicians has been called.

The physicians in consultation are Dr. Lyman, Dr. Wilbur, head of Leland Stanford University, and former head of the American Medical Association, a noted stomach specialist, Dr. Cooper, a noted San Francisco heart specialist, and Dr. C. E. Sawyer and Dr. Boone, the president's personal physicians.

The following statement was issued this morning by the presidant's physicians:

"The cause of the president's illness was diagnosed as ptomaine poisoning. The appearance of new symptoms indicating complications in the case has made it destrable that consultation be sought. Bulletins will be issued for the information of the public."
