TEMPLE, Texas, Nov. 5 .---"You bet I'll have an inaugural ball," Mrs. Miriam A. Ferguson, leading her Republican opponent for Governor, Dr. George C. Butte, by approximately 31,000 votes, told the United Press at her home here today.

"I have a cold," Ma continued. "but I imagine I'm better off than Dr. Butte at that. 1 expect he is having a chill."

A statement issued by Mrs. Ferguson when the early returns indicated that she was the apparent victor in the gubernatorial race praised the Democrats of Texas as "loyal to the ideals of true Democracy despite the mouthings of political preachers and some school teachers seeking to lure Democrats into betrayal of their honor.

Coolidge was elected vice-president in 1920 and became president in August 1923 following the sudden death of President Harding. Dawes first achieved prominence in army circles, later as director of the first governmental budget system and more recently he ramrodded the latest plan for the settlement of German reparations, in company with Owen D.
