SEER FISHER CONSTABLE Jones Polk, Fisher County Officer, Being Sought in Connection With Shooting, Authorities Say. A youth named Tipton, about 18 years old, of Royston, Fisher County, died Sunday morning en Route to Stamford, where he was being taken to a sanitarium, after chapter. he had been shot in McCaulley late Saturday night. According to Fisher County authori ties, Jones Polk, Fisher County constable, is being sought in connection with the shooting. Complete details of the affair were not available here.

At Royston, the shooting was reported as accidental. Tipton was employed at a cotton gin there. He is survived by his mother, who is a widow, and several other members of his family. Funeral services are to be held at Roby, probably Tuesday afternoon.

Various reports of how the shooting occurred were received in Sweetwater Monday. The report from the Sheriff's office at Roby said that details of how Tipton met his death were lacking, but that officers were searching for Polk. It is indicated that several men will be implicated in the investigation of the youth's death.
