Star Lites B y Bill Ellis

THE TRAGEDY this week, the bombing of the Federal Building in Oklahoma City, has been almost unbelievable to those of us who are life-long residents of this area. We have a number of relatives in

We have a number of relatives in Oklahoma, and spent much of our growing-up years spending "vacations" by visiting various of our kith and kin in the Sooner State. Since we more or less grew up with many of these folks, the bombing in Oklahoma City was just as unbelievable to us as if it bad, hangened in Amarillo or had happened in Amarillo or Lubbock.

These things just don't happen in our part of the country. That's the type of things we're used to seeing on the 6 o'clock news-happening in New York or Los

Angeles. Ye Editor called our first cousin, Leta Ray Tate, who lives in the Oklahoma City suburb of Jones, Oklahoma, to find out if we might have had relatives hurt or killed in the explosion.

the explosion. Luckily we didn't, but Leta said that she and her husband Joe have made periodic visits to that Federal Building, and to the HUD office in particular. They have gotten into the rental business in a serious way, and have bought several houses from HUD, remodeled them, and then rented them out

and then rented them out. "We've gone to the HUD office to check on the list of homes available, pick up bid forms, leave bids, or check on bid results. We were well familiar with that particular office, which was located on the eighth floor," Leta told me

on the eighth floor," Leta told me Thursday night. In fact, they were well-acquainted with one of the lady employees at the HUD office, and this lady's desk was situated where some heavy damage occurred. But by the hand of fate, the lady had gone Wednesday morning to begin a computer class, in the southwest part of the building. This was a section of the building that

was a section of the building that wasn't as badly hurt, and the friend felt as though she might owe her

tett as though she might owe her life to the fact that she had gone to the class that particular day. HUD had offices on both the seventh and eighth floor of the Oklahoma City building. The friend had gone to an office on the ninth floor when the explosion happened. A number of other federal offices are located in the building

are located in the building, including Social Security, the Army and Navy recruiting offices, the ATF headquarters, Social Security and Secret Service.

Leta told us that they regularly went by the Social Security office on their way to visit the HUD office, and "it was always full of people." If you've ever had business at the Social Security office, you know exactly what she was talking about about

Our relatives said that the HUD office itself had a total of 129 employees. After I called them Wednesday night, Leta called her friend from HUD, who told her that 30 of her co-workers are among those on the "unaccounted for" list, and presumed dead

and presumed dead. In fact, Leta's contact had heard that various offices had "entire sections" of employees who were on the "unaccounted for" list.

These relatives live 12 or 15 These relatives five 12 of 15 miles from downtown Oklahoma City, and Joe said he immediately felt the jolt from the explosion. "I thought perhaps there had been a plane crash, perhaps at Tinker Air Base.

My cousin Leta said she was at the beauty shop, and her attendant was just leaning her back for a rinse when they heard a strange noise. "Who is moving furniture?" her beauty operator asked.

Residents Hear Tax Specialist

A good crowd attended the Town Meeting and Candidate Forum at Friona Jr. High Cafeteria last

Thursday evening. Bob Bearden, of Texas Comptroller John Sharp's office, explained the 1/2-cent economic development tax, as well as the 1/2cent property tax abatement, which Friona voters will decide on the

May 6 ballot. In regard to the tax relief, City Manager Paula Wilson stated that if the proposition passes, the city should be able to reduce its ad valorem tax rate by seven cents per

\$100 valuation. Mrs. Wilson told the Friona Star that the seven-cent reduction would amount to \$35.00 for city taxes on a \$50,000 residence. "And, if we're able to attract more businesses through the

this construction of the economic development program, this would mean more sales tax collected and more savings to property owners," the city manager added.





Parmer County ground water levels declined an average of 3.46 feet in 1994 in 97 privately-owned wells in 1994 the 95 pirtuely-owned wells in the observation well network maintained by the High Plains Underground Water Conservation District No. 1 in its 546,400 acre service area within the county. This represents a decrease of 283,581 acre-feet of water in storage in the Ogallala Aquifer last year in the portion of Parmer County within the Water District

boundaries. "Dry soil conditions during the past two years have increased the demand for ground water. In some heavy water use areas, there was a greater amount of decline in 1994 than in previous years," says Don McReynolds, High Plains Water District Technical Division Director.

Ground water levels within the Ground water levels within the Water District's Parmer County service area declined 1.57 feet during the 10-year period from 1985 to 1995. An average annual decline of 2.32 feet was recorded during the

five-year period from 1990 to 1995. Ground water levels in the Ogallala Aquifer within the 6.7 million acre Water District service area had an average decline of 2.15 feet from January 1993 to January 1994. This is a net decrease of about 2,160,750 acre-feet of ground water in storage in the Ogallala Aquifer within the Water District

A zero average annual change in ground water levels was recorded for the first time in the Water District's history in 1985. Depth-to-water measurements revealed an average ground water level rise of 0.50 of a foot in 1986; an average rise of 0.90 of a foot in 1987; an average decline of 0.51 of a foot in 1988; counties



By comparing the current depth-to-water measurements with those taken the previous year, McReynolds says Technical Division staff members can determine what changes have occurred in the ground water levels. Of the 15 counties or portions of counties making up the High Plains Water District, only Randall County recorded an average rise in County recorded an average rise in depth-to-water levels in 1994. The depin-to-water levels in 1994. The counties with average declines in depth-to-water levels in 1994 were Armstrong, Bailey, Castro, Cochran, Crosby, Deaf Smith, Floyd, Hale, Hockley, Lamb, Lubbock, Lynn, Parmer, and Potter Counties Lubbock, Lynn, Parmer, and Potter Counties. Maps showing the location and well number of observation wells in each county or portion of a county served by the Water District will be published in the April issue of The Cross Section.

Tables listing observation wells in each county within the District and the depth-to-water levels at one-, five-, and 10-year intervals are also printed.


