EXPLOSION KILLS A FAMOUS NOVELIST

Niagara Falls, N. Y., May 24.-Ar thur Stringer, one of the best known and most talented nevelists in America, was killed and his beautiful wife, formerly known as Janyna How land, the actress and their twomonths-old haby girl were faially injured in an oil stove explosion in their home here.

Mr. Stringer was heating some milk on the stove for the baby. What caused the explosion is not known. but it was heard by people in neighboring houses, and a number of persons ran into the Stringer house. All three were on the floor of the kitchen. The wife and baby were stunned by the force of the explosion and their clothing was ablaze. Mr. Stringer had been instantly killed. At the Memorial Hospital it was said there was practically no hope of saving the lives of Mrs. Stringer and her baby. Both were so badly burned as to be almost unrecognizabel.
