EMDEN'S CAPTAIN IS TAKEN PRISONER

GERMAN PRINCE IS ALSO CAPTURED WHEN CRUISER IS BURNED

200 KILLED, THIRTY WOUNDED

Cruiser Had Just Commandeered Two Months' Supplies When Fight Took Place

London, Nov. 11.—Captain Von Muller of the German cruiser Emden, which was attacked by the Australian cruiser Sydney and driven ashore on the Cocos Islands where she was burned and Prince Franz Joseph of Hohenzollern, chief of the German and Austrian armies operating against Russia with General Hindenburg commanding the left wing and General Dankl the right.

PRIZE DAIRY CATTLE ARE THREATENED BY DISEASE

Love letters from another man to the woman were found in the room and it is thought jealousy prompted the crime. The letters which were signed "Bill" indicated the writer was planning to help the woman get a divorce. The letters indicated that "Neeley and 'Bill'" had business dealings in Cushing or in Tulsa, Okla.

ALLIES' ADVANCE OFFSETS IMPORTANT GERMAN GAIN

Believed Advance Of Russian Forces Will Soon Affect Western Campaign In War

London, Nov. 11.—On this, the 100th day of the war, the German machine has battered its way into the Belgian town of Dixmude. As an offset the French war office states the allies forces have been advanced along the North Sea Coast.

The warring nations await with keen suspense the outcome of the struggle in Belgium which for the moment overshadows the conflicts on the many other fields of battle. The capture of Dixmude was the first indication that the new attack of the Germans, described as their supreme effort and as possibly marking a turning point in the war had brought definite results, between Dixmude and Ypres which lies to the south, close to the French border.

On October 15 during the advance on Ostend the Germans occupied Dixmude but later were compelled to fall back. The Berlin view of the situation is optimistic. Paris also is hopeful as to the outcome in Belgium. Military critics there take the view that the Germans are faced with the imperative necessity of defeating the allies in order that they may turn their attention to the menacing armies in Russia.

Petrograd contradicts the German claim to an important victory along the northern border, asserting that a brilliant Russian success has been won there and that the Russians have begun an invasion of East Prussia. On the southern end of the line, Cossacks are approaching Cracow. It is said however that the Russians are employing new tactics placing their main reliance on huge bodies of infantry rather than on their cavalry. With disregard of German artillery solid masses of men are thrust forward leading to hand-to-hand fighting of a most desperate nature.

There were further indications today that the Turks were offering determined resistance to the Russian advance. Heavy fighting continues on Servian soil.

The Austrian government announced that its forces had made several important advances repulsing the enemy and capturing many prisoners.

TURKS MEETING WITH SUCCESS ACCORDING TO BERLIN REPORT

Berlin, Nov. 11.—(Via Wireless). The Turks are meeting with considerable success in their operations in the Caucasus and on the Egyptian frontier, according to official announcement made by the Turkish government and given out in Berlin. They have occupied Shiekzar fort at El Arish, Egypt, and taken four guns from the enemy.

The Russians in the Caucasus have been forced to retire to the second line of defense. El Arish is on the Mediterranean near the boundary of Egypt and Palestine. It is important as a point of water supply.

One of the German prisoners of war in England has written a letter to the Frankfurter Zeitung in which he declares that as a result of bad treatment, bad food, housing in cold barracks, forty-six out of 700 German prisoners died within one week of pneumonia and typhoid fever. Lieutenant General Hellingrath, inspector of German military roads with headquarters at Cambrai in northern France, is making public exhibitions of dum dum bullets found on British prisoners and also of British rifles equipped with a contrivance to cut and perforate the heads of bullets. The above information was given out officially today to the press in Berlin.

It is reported from Athens that Bulgaria has refused to adopt the anti-Turkish attitude suggested by the Triple Entente. The Bulgarian minister at Rome has said Bulgaria will keep neutral in the present war, and under no circumstances will she fight Turkey.

AUSTRIANS AND GERMANS IN ENGLAND ROUNDED UP

Many Apply For Naturalization Papers But Very Few Requests Are Granted

By Associated Press. London, Nov. 11.—Great Britain's now rigorous round-up of Germans and Austrians within her dominions caused a rush to the home office of those who by virtue of advanced age, sex or other disqualification for military service, are allowed to go to the Fatherland through reciprocal arrangements for a transfer of a like number of British men and women. It is stated that within the last few weeks two thousand German and Austrian women and twelve hundred men left this country.

At the outbreak of the war many Germans and Austrians deluged the authorities with applications for naturalization papers. The number seeking British citizenship has been placed at ten thousand; yet fewer than twenty applications have been granted.

Between eight and ten thousand Germans and Austrians are under arrest and in detention camps—all taken from Greater London. Hundreds of others are yet to be arrested. Only this week there was a brief respite in the round-up due to the fact that there were not enough adequate detention camps. The agitation is not over, however; daily the newspapers are urging the authorities to more action. The exclusive German clubs are under surveillance; buildings built by or known to have been recently occupied by Germans are being watched and great precautions are being taken to guard the vaults of the stock exchange. 

FRENCH SUPPLY OF FUEL DECLARED TO BE SHORT

Efforts Being Made To Provide Sufficient Coal Before Real Winter Sets In

By Associated Press. Paris, Nov. 11.—The approach of winter, and the continued occupation of the mining districts of the north of France and south of Belgium, brings up question of fuel supply. Stocks at distributing points not in the hands of Germans are considered insufficient to last more than a month. In order to avoid unfair distribution or stocks in hand, the military governor of Paris has decided that the fuel shall be divided among the different dealers by the intermediary of one of the three coal syndicates. The president of each has been asked to centralize the orders from dealers and control them so that no one gets more than the approximate stock for one month.

The public has been advised that there should be no worry as measures will be taken in an emergency to bring fuel to Paris by water routes that are secured against attacks by the enemy.

The man who is holding his money waiting to pick up a piece of Wichita Falls property at a ruinous price is doomed to disappointment. Things have changed for the better in the last two weeks; the bottom has been struck, and business of every kind is now on the up-grade. Wichita Falls property is cheaper now than it ever will be again. At least, it looks that way to The Times. Therefore, the man who has money that is idle and wants to put it to work can't do better than invest it in a piece of business or residence property in Wichita Falls. This city has doubled its population and health during the past six years. The prospects are that it will do better than that in the next six years.

Congressman John H. Stephens who has been serving this, the 13th, congressional district, well and faithfully for the past eighteen years, is back home now for a few days, or until Congress, which has been in session continuously since President Wilson was elected, convenes again. Mr. Stephens is taking advantage of the recess to cover as much of his district as possible in order to meet his friends and thank them personally for what they did for him in the recent election. He was unable to leave Washington during the campaign, and was not in the district during that time, but was re-elected, although by a somewhat reduced majority as compared with other campaigns in which opposition, or rather an opposing candidate, was in the race. He feels very grateful to his friends who took care of his interests during the campaign.

GERMANY IS NO EASY CONQUEST.

A country which controls the enormous forces that have been brought into operation in the last month will not be conquered easily or quickly. There has been a great deal of talk about the arrival of the Russians at Berlin as if it would necessarily mark the end of the war; but it is as easy for the Germans to transfer their capital from Berlin to Frankfurt as for the French to transfer theirs from Paris to Bordeaux. It is not likely that Germany will be started, beaten into surrender, and competent judges estimate that she will not be starved to death in less than twelve months—how much longer only the event can reveal. She will never be starved out at all if our power on the sea is broken. This she knows as well as anybody, and you may take it for granted, knowing her energy, her resources, her foresight, and her desperate necessity, that she is preparing to aim a furious blow at us on the sea when the right time comes.—London-Truth.

TWENTY-SIX YEARS AGO AND TODAY.

The Houston Chronicle makes the following observations of the results of the recent election, contrasting the political conditions of 1888 and 1914: The Democratic party has in the last eighteen months grappled with and solved many perplexing problems, and has enacted legislation—namely a reform in the financial system—for which there was no precedent; yet the fact remains that the tariff, old as it is, was the question which excited most interest and aroused most antagonism. The beneficiaries of a protective tariff had enjoyed its benefits (to them) so long and had grown so rich, and the pool of protection as the main object instead of being an incident had so long prevailed, that millions had come to look upon a protective tariff as a legal right. It touched their pockets, and when it did it found the pockets of their patriotisms, and any interference with the graft which they enjoyed at the expense of the masses aroused their fiercest resentment. The same resentment was aroused when Mr. Cleveland, during his first term, insisted on a revision of the tariff downward in obedience to the pledges of the party. He was an honest man, who saw no difference between dishonesty in politics and dishonesty in business, and he sought to force his party to reduce the tariff as it had pledged itself to do, and when it passed a tariff bill which was but little better than the existing one, he

He was warned that revision of the tariff meant defeat in 1888, but he was as stubborn as he was honest, and held on his way, and defeat came to him as was predicted.

He was not a man whom defeat could cause to change his convictions, and in 1892 he was again chosen the party leader and reaped a victory, the harvest for which he had sown the seed in 1885, 1886 and 1887.

Twenty-six years have rolled away, and Woodrow Wilson urged a revision of the tariff downward, as the platform on which he was elected promised should be done. The tariff barons are just as inimical to a reduction of the tariff as ever they were, and they made their opposition felt in the election. Then the European war has demoralized business and reduced the demand for manufactured products, and many laborers are out of employment, and the party is responsible for such conditions.

This combination the Democrats faced in an off year, but, despite a radical reduction of the tariff and legislation to curb the fruits, and the adverse conditions brought about by the war, the Democrats hold their majority in both branches of congress.

When we contrast 1888 and 1914 there is no ground for discouragement. A reduced tariff is no longer a bogey with which to frighten the voters. Nearly every county in this part of the State will make three times as much cotton this year as they realized last year, though in most of the counties, like that of Wichita, the acreage for cotton for this year, compared to last year, was considerably less. The most conservative estimate placed on the crop of this county this year is 13,000; most people contend it will reach the 15,000 bale mark. Last year only about 4,500 bales were produced. Baylor county produced 8,000 bales last year. This year it is estimated the county will produce at least 25,000 bales. And it is the same way in Archer, Young, Wilbarger, Clay, Childress, Hall and other counties. Taking the amount produced in consideration, and even if it does not sell on an average of about six cents per pound, the cotton crop will bring to the cotton raisers of this section of Texas at least one-third more actual money than they received for their cotton last year. And aside from their splendid cotton crop, the best grain and feed crops that have been produced for two years have been made and harvested. The grain crop sold for a good price early in the season. Had it been held until now it would have brought a much better price. And again, a sufficient amount of feed stuffs have been made to last for more than a year. Aside from the fact that rain is now needed for wheat growing purposes, there is absolutely no cause for this cry of hard times and bad business.

The total Russian captures amounted to 223 officers, 21,750 soldiers, four mortars, fifty-two cannons, fifty-two quick-firers and a large amount of munitions of war."

Who's What In The European War.

(A sarcastic essay on the contending nations, from the St. Louis Mirror.) Serbia, which has the proud distinction of having started the greatest war that the world has ever seen, is about as large, comparatively, as the match which fires the powder keg. It has 19,000 square miles, and it has been prancing about vigorously in history for the last 11300 years.

Germany has the finest musicians, the deepest thinkers, the largest airships, the fastest automobiles, the greatest steamships, the tallest cathedrals, the highest lieutenants, and the most obedient private citizens in the world. The whole duty of Germany is to obey the army, and the whole duty of the army is to obey the Kaiser. He rules everything in the empire, but the crown prince, and is equal in power to four ordinary kings, a captain of industry and a municipal boss.

Austria is an invention of European statesmanship which is maintained for the purpose of keeping the Slavs, Germans and Turks from rubbing elbows too vigorously. It is a polygot purgatory, composed of fragments of a score of races in a state of violent altercation. And yet Austria is a vast improvement over what was there before it. For many centuries this section of Europe was a hell in which various races met to settle their little hatreds, far from civilization and a referee who could keep them from biting in the clutches.

Belgium, which has lately surprised the world by holding Germany with all the fury of a 111-pound quarter tacking a Percheron fullback, is an enlarged wheat field into which 7,000,000 people have been stuffed by industry and an entire lack of race suicide. Belgium is no bigger than a congressional district in Kansas, and an energetic automobile can cross it in two hours. But it is one of the busiest spots on the globe. It exports \$4,000,000,000 worth of goods each year, and raises almost enough to produce on its own lot farms and pocket gardens

its history, which is congested with romance. The greatest Frenchman was Napoleon, who had all Europe at his feet one hundred years ago. Anyone who will produce another Napoleon for France at this minute will receive a liberal reward.

France is a republic, with a president used only for ornament, and a chamber of deputies, which is as explosive as gasoline. The French government supervises everything in France very earnestly and has succeeded in piling up \$6,000,000,000 in debts without impairing the credit of the country.

Russia is a vast, opaque nation extending from the hot sands of Asia on the south to the midnight sun on the north, and from umbrageous savagery in the police department to the civilization of tomorrow in the works of Tolstoy.

The Republic of France, which is now engaged in a desperate attempt to get even with Germany for the beating up which the latter country gave it in 1870, is a state of enthusiasm varying from inspiration to hysteria. It comprises one of the western corners of Europe which is about 400 miles square and goes up in the air as far as 30,000 feet at times during great political crises.

France has 35,000,000 people, but it sounds like more than that when a few of them are talking. It is a sunny, smiling, fertile country, full of thrifty citizens, who can live comfortably and fill a stocking full of gold on a few dollars a year, and who love nothing so much as a chance to talk about their beloved country. France is famous because, it has 35,000,000 press agents.

France produces about two billion gallons of wine each year and drinks most of it. Sitting on the sidewalk at a small table and drinking wine at the rate of two sips an hour, with conversation between, is the great French recreation. France is most noted for Paris, aeroplanes, actresses, the Eiffel tower, the Louvre, the Latin quarter and



CITY OF CROESUS AND MIDAS

Situated in Spot Rich in Legends of Ancient Geography and Mythology.

There is a river which flows northward, eastward and northward again, finding its hazardous way through the rugged mountains of ancient Lydia, in Asia Minor. Its waters, now swift and limpid, now voluminous and turbid, are poured at length into a larger and more sluggish stream, which, fed by a hundred other snow-born fountains that descend from the almost perpetually snow clad mountains on the south, flows westward, in its turn, through a broad and fruitful plain and then through a narrow defile, to lose itself and its yellow life at length in the clear expanse of the Bay of Smyrna, which at this point represents the Aegean sea.

The smaller river is the ancient Pactolus—the gold bearing stream of classical legend and song—in which mythical Midas washed to cleanse himself of the "golden touch" and from which historical Croesus washed his wealth by the simple process known as placer mining. For Croesus was no other than the last king of the ancient Lydian nation, and the Pactolus cut in halves the market place of no less a city than Sardis, his capital. The greater river was anciently the Hermus. Beside its bank the armies of Xerxes and of Alexander encamped. It made of the plain of Lydia a great nation's granary and garden; but it did not appeal to the poets and the builders of legends as did its little mountain arm with the sands of gold. The snow-capped mountain was Prometheus to the Greeks. Its rugged fastnesses saw the birth and youthful sports of Pan. Thus, in a few words, we may place the setting of this story in the ancient geographical chart, and, in the mythology and legends of the ancient Greeks.

JUDGE STEPHENS VISITOR HERE TODAY

CONGRESSMAN BACK IN HOME DISTRICT AFTER LONG TIME AT CAPITOL

DISCUSSES NEW LEGISLATION

Several important matters to come up next session—Foresees victory in 1916

Congressman John H. Stephens was a visitor here today coming in last night from Bowie and leaving today for his home at Vernon. While here Congressman Stephens saw several friends and discussed legislative matters. Mr. Stephens is chairman of the committee on Indian affairs, one of the most important in Congress and involving a vast amount of work, and that, with the fact that Congress has been in session 22 months out of 24, has kept him from visiting his district as much as he would like to.

In the session of Congress which convenes next month Mr. Stephens believes that one of the most important pieces of legislation will be an amendment to the banking laws to permit, in cases of emergency, the issuance of reserve currency to the full value of the securities given to the

government. Under the present law only thirty per cent of the value of the securities can be issued in emergency currency. The amendment would provide for just such a situation as has confronted the South in the cotton crop this year, Mr. Stephens believes.

For Merchant Marine. Another important piece of legislation that will come before Congress at the short session, says Mr. Stephens, will be an amendment to the navigation laws to encourage a merchant marine. "This is embodied in the Alexander bill," he said, "which provides for the creation of a corporation to which the government will loan 51 per cent of the value of the ships. This will immediately open the way for a big increase in the American merchant marine. The amendments to the registration laws have already given the American marine a start. The proposed new legislation ought to put it firmly in service. Proper provision is made for the use of the ships by the government in case of war and I believe the new law would greatly increase the efficiency of the United States navy, even more than the building of new battleships."

Although Mr. Stephens admits that the slump of the Progressives will make a harder fight for the Democrats in 1916 he expects the Democrats to retain control of all branches of the government.

"In 1916 we will have the president and the great record of his administration."
