

PANAMA CANAL CHANNEL BLOCKED BY SLIDE

FORT SILL IN 38 MINUTES Six Machines Make Quick Trip And Alight South Of City Without Mishap

Motorcycles And Trucks Expected To Arrive This Afternoon--Large Crowd Witnesses Landing

TO GO DIRECT FROM HERE TO FORT WORTH

Flying from Fort Sill, Okla., the six aeroplanes comprising the Fire Aero Squadron of the United States army arrived here at 9:26 this morning completing the first leg of their flight to San Antonio. The flight was made in 38 minutes, the first aeroplane having left Fort Sill at 8:48. This would make the speed of the aviators at the rate of about 87 miles an hour.

Approaching the city at a height of 3,500 to 4,500 feet the acroplanes circled widely to the south and west flying upon the landing grounds in the Huff pasture south of town from the south The big biplanes soared down upon the field gracefully one after aonther and within five minutes after Lieutenant J. E. Carberry's aeroplane, the first to reach the grounds, had landed all six were on the ground and had been wheeled into a row, and the aviators were covering their engines with canvas.

Ideal weather prevailed for the flight, the machines got off at Fort Sill in perfect order and the flight was made without an unfavorable incident. Lieutenant Carberry who piloted the squadron after leaving the aviation field at Fort Sill mounted to a height of about 4,500 feet and with a map and compass before him headed straight for Wichita Falls. He had only fairly started before he was able to discern the bend in Red river and when he reached the river he could see the outline of the city. 'Ten or twelve miles out he picked up the signals that had been set on the landing field by Master Electrician Idzorek. Lieutenant Carberry's aeroplane is a little faster than the other machines and Lieutenant Bowen following him lost sight of him but had no trouble in finding the town and locating the landing ground Following Lieutenant Bowen came Lieutenants T. D. Milling, I. A. Rader and C. G. Chapman. Captain Foulois who was the last to start at Fort Sill, was the last to land.
