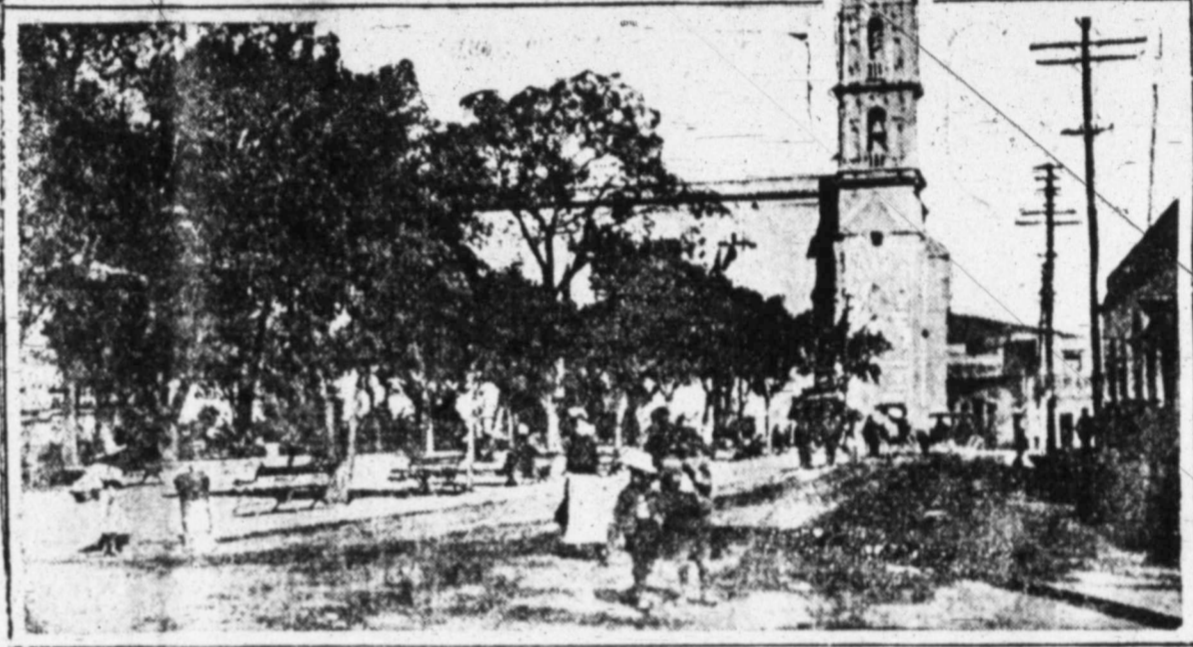
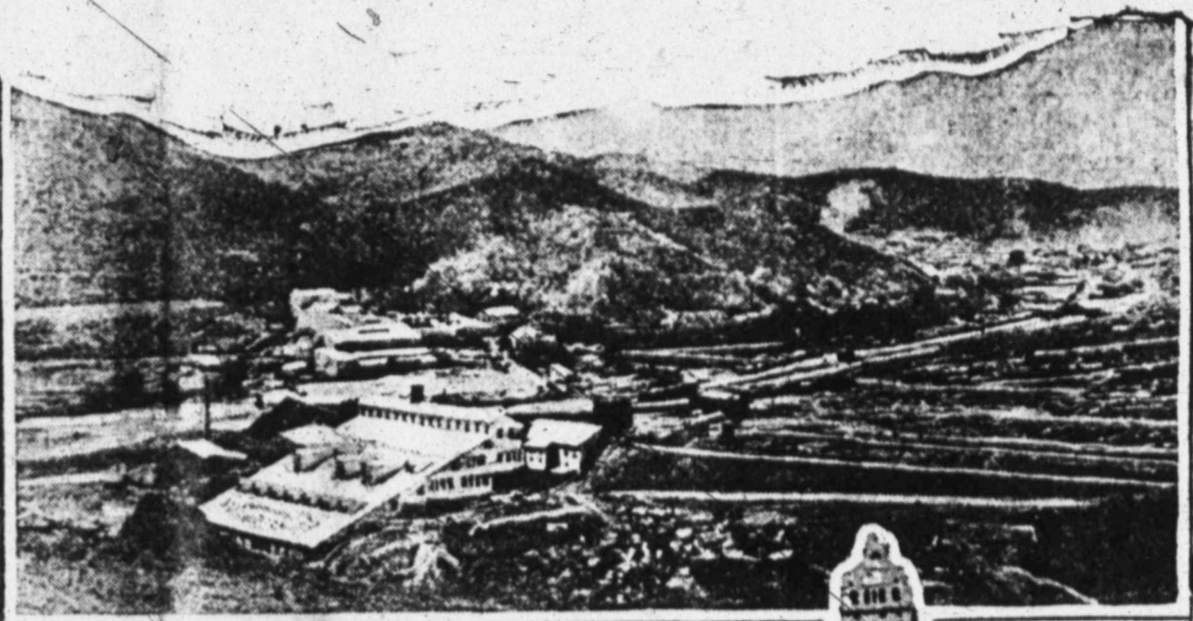

Great Britain contends that the men were engaged in intrigue and plots against the British government and were fleeing to Manila to continue their efforts and would have embarrassed the neutrality of the United States.

GETS 1000 LETTERS FOR ARMS EMBARGO

Wisconsin Senator Tells of Campaign Conducted in His State By Chicago Organization.

By Associated Press. Washington, April 27.—Senator Huston, democrat, told the Senate today that the American embargo conference had conducted a campaign in Wisconsin to induce him to support an embargo resolution against shipment of war munitions to Europe.

Senator Huston said thousands of telegrams deluging Congress emanated from the embargo conference. He declared there was a deep laid plot to poison the minds of citizens all over the country with the thought that the president wants war, "when every fact gives the lie to such an assertion."

CONFERENCE ON 8-HOUR DEMAND

MEETING IS BEING HELD AT CHICAGO TODAY BY AGENTS OF BOTH SIDES.

SATURDAY LAST DAY

Neither Side Has Shown Any Disposition to Arbitrate Question as Yet.

By Associated Press. Chicago, April 27.—Three men representing virtually all of the railroads of the country, and four officials representing approximately 300,000 railroad traffic employees were to meet here today to arrange for a conference at which the trainmen's demand for an eight-hour day and time and a half for overtime will be discussed.

The ultimatum of the employees calling for a written reply to their demands, expires next Saturday. It is stated, however, by officials of the general managers' association that practically all the railroads have already refused the demands. Neither side has shown any disposition to arbitrate.

STATEMENT IS ISSUED BY BROTHERHOODS TODAY

Cleveland, Ohio, April 27.—A statement issued here today by the railroad transportation brotherhoods campaigning jointly to secure an eight-hour day, says:

"If the railroads are really sincere in desiring to conserve their revenue a recent report of the Interstate Commerce commission shows that they would save millions of dollars which now are lost in hauling private cars and granting rebates. Fines imposed by the courts because of rebates amounted to \$264,000 in 1915."

BIG INCREASE IN WAGES OVER THOSE OF YEAR AGO

Washington, April 27.—Manufacturing industries in the United States are shown by figures published by the department of labor to be spending generally from 20 to 60 per cent more for wages than they were a year ago. Much of the increase is accounted for by the additional number of men employed but a considerable amount is credited to higher wages.

Cotton-manufacturing alone of the bigger industries shows only a nominal wage increase. Cotton mill employees are receiving 5 per cent more pay than a year ago, but the average daily wage is increased by the fact that 15 per cent less cotton mill employees are at work than were in the mills a year ago.

CHARGE ENGLAND WITH SINKING OF DUTCH WARSHIP

By Associated Press. Berlin, April 27.—The Overseas News agency says a report has been published in the Dutch newspaper De Tribune, that the British sank a Dutch warship several weeks ago, that the crew was sent to India to conceal news of the affair and Great Britain promised to pay damages.

PRISONERS SEEK TO MOB ANOTHER

TRY TO ATTACK MAN BROUGHT IN FOLLOWING DEATH OF LITTLE GIRL.

VIOLENCE AVERTED

Prisoner Taken to Penitentiary After Chase By Men Who Threatened Summary Action

By Associated Press. Lansing, Mich., April 27.—Angered by stories of the outrage and murder of nine-year-old Edna Dismore in Topeka Tuesday, 200 prisoners in the state prison were dispersed early today after making an effort to mob Fred Bissell of Topeka, accused of the crime.

The prisoner had heard of Bissell's being brought to the prison to escape violence from the mob that invaded Lawrence, and with the cry "come on, boys" they swooped down upon the prisoner. Deputy wardens and prison guards clubbed the mob into submission.

Bissell was taken by prison guards and rushed to a solitary well guarded cell. The suspect arrived at Lansing late midnight after a wild ride from Lawrence. From that city to Konzo, on the motor car in which Bissell was riding was chased by automobiles equipped by men yelling threats. At Konzo the sheriff's car studied the pursuers.

Prison records show that Bissell was paroled from the penitentiary April 14, 1915. He had been sentenced for a revolting crime.

SAFETY FIRST MAY RESULT IN STRIKE

Discharge of M. O. & G. Engineer For Intoxication Threatens To Cause Breach

Muskogee, Okla., April 27.—A breach between 250 employees of the Missouri, Oklahoma & Gulf railroad and the federal court, which is operating the line under a receivership, may result tonight, as a result of the receivers' strict adherence to the safety first policy. The men threatened to walk out unless an engineer discharged for alleged intoxication is reinstated. The receivers, Alexander New and Henry C. Ferris, who operate the road under orders of Federal Judge W. C. Hook assert the company will take no chance with an employee who drinks.

MANY REFORMS ASKED BY LABOR

FEDERATION AT HOUSTON FAVORS LARGE NUMBER OF NEW MEASURES.

FREE SCHOOL BOOKS

Minimum Wage Law for Women Also Favored—Mothers' Pension Enactment is Asked.

By Associated Press. Houston, Texas, April 27.—The state federation of labor in convention here placed itself on record today as favoring a minimum wage scale for women, a mothers' pension law, free text books in the public schools and the making of the workmen's compensation bill the first preferential measure at the next session of the legislature.

Among the other legislative matters favored by adoption of resolutions were a bill limiting cotton bales to 500 pounds, and backs of seed, products to 150 pounds each, an electrical inspection bill, a bill for protection of men required to enter steam boilers, favoring the use of non-combustible roofing materials, favoring the employment of only citizens of the state on public work, seeking legislation against the use of irration or orders in case of strike favoring the establishment of seven free employment agencies under the direction of the bureau of labor statistics, a stationary boiler inspection law, legislation to compel insurance companies to make prompt settlement under the commission act, favoring a law to protect the interests of chauffeurs; a state engineer's license law, favoring an anti-trust law in harmony with the Clayton bill and other minor measures.
