Perhaps the situation was pretty well summed up this week when we heard a Bairdite remark, "Walking in space? They haven't convinced me yet that an airplane really flies.



#### **Points of Agreement**

Last March attorneys representing the three counties compiled a list of five basic points of agreement in the case -which should save time when the case gets in court. The five points are:

1. That in 1882 Taylor County conducted a survey, markers of which can be located on the ground, which could constitute the common corner of all three counties.

2. That in 1885 Coleman County surveyed a line between Coleman and Callahan counties, beginning at the northwest corner of Brown County, markers of which can be located on the

3. That in 1898 Callahan County made a survey, as ordered by the General Land Office, beginning at the southwest corner of Stephens County, of which markers can be located on the ground.

#### Line Approved


4. That in 1894, the line between Brown and Callahan counties was surveyed and approved by the courts.

The line claimed by Coleman lowing the latter's election as County is an extension of that line.

5. That no representative from Callahan County took part in the Coleman survey, and that a representative of Coleman County took part in the Callahan survey but did not sign the report.

There is no direct precedent for the court to study in settling the matter. But Callahan County Attorney James Paul Shanks said that in most suits involving county lines, the boundary generally in use is usually declared the legal one.

"Although there may not be boundary generally accepted a in this case, Callahan County contends that our line is used by the General Land Office and by abstract companies in Callahan and Coleman counties," Shanks said.



### CORLEY PLUMBING CO. AN Aug. 24 Is Callahan Deadline For Cattle Brucellosis Test

Callahan County has until Aug. 24 to complete re-testing cattle herds for brucellosis.

In 1962 tests when Callahan County was certified, there were 42 suspect herds and 68 reactor herds in the county. All of these herds have been retested except

eight, and all were free except County during the past week: one herd. In order for the county to be recertified, 189 other herds in lene. addition were required. Appro-Baird ximately 60 herds have been retested. About 129 additional Cross Plains.

herds must be tested if the county is to retain its certification. If these herds are not tested by the recertification date of 17-12-c Aug. 24, the county will lose its certification. This loss will seriously restrict movement of cat-

tle out of the county. Health certificates will be required before cattle can be shipped to certified areas. All adjoining counties are certified.

Should we not be recertified by Aug. 24 and lost our certification, it will be necessary to start with petitions as in 1962, and all herds will then have to be tested.

Cattlemen working their cattle are asked to contact either Jim Ellis of Animal Disease Eradication, or the county agent and make arrangements to have the cattle tested.

People with milk cows are urged to have these cows tested because brucellosis is one disease that is transmissable from the infected animal to man. It can be a most prolonged and serious disease in man. Raw milk from an untested
