An informational workshop on how area employers can develop a strong apprenticeship program is set for Thursday.

"For the last several months we have been working with the U.S. Department of Labor to meet with employers and educators about an apprenticeship program," said Virginia Belew, area manager for the Texas Workforce Network office in Big Spring. "This is a training tool and something we really don't use in our area."

Belew said apprenticeship programs can offer an avenue to increase skilled workers in the community.

Vela helped the team achieve its first-place sweepstakes award of the school year.



BSISD trustees to review survey

Big Spring Independent School District trustees will take a hard look at goals Thursday and what their staff and the community believe should be the district's

Trustees will be reviewing the results of a community survey that asked participants to rate the importance of 10 suggested goals for the district.

"As of today, (Tuesday) we've received more than 900 responses," said BSISD Superintendent Michael Downes. "Of those 900 responses, 688 came from the community and parents. We'll probably have a few more in a couple of days."

The process is part of the board's participation in the Texas Association of School Boards' effectiveness audit.

According to the TASB. embracing a vision and set of


clearly defined priorities is one of the characteristics of an effective board.

"The board has been considering this process for three months," Downes said.

Review of the survey will be held during the discussion portion of the board's meeting and no action or official setting of goals will be held until a later meeting, Downes added.





Why not give the Legion your oratory best?

rea high school students looking for a way to pick up a little money for college ought to consider taking part in this year's American Legion High School Oratorical Contest.

Eldon Erickson, the American Legion's commander of the 19th District, and contest chairman Robert Bland announced the rules for this year's contest during the district's fall convention.

Contestants must be students under the age of 20 who are currently enrolled in grades 9-12 in public. private or home schools.

The contest consists of two parts — an oration and an assigned topic. The prepared oration of eight to 10 minutes in length must be on some phase of the U.S. Constitution which emphasizes the duties and obligations of a citizen.

The three possible assigned topics for 2004 include: Article 1, Section 3, Clause 6 that deals with the Senate having sole power to try all impeachments; Article 4, Section 2, Clauses 1-2 that deal with citizens of one state having the same privileges in several states; and Article 14, Section 1 that no state shall make or enforce any law that abridges the privileges or immunities of United States citizens and that no state shall deprive a person of life, liberty or property without due process of law.

The assigned topics will be three to five minutes in length and will be given to each contestant just prior to delivery

District competition is set for Saturday, Jan. 3, 2004 A \$300 scholarship will be given to the district winner, who will then advance to the division contest where a \$500 scholarship is at stake.

At the state contest, prizes will be \$1,000 for first place, \$750 for second, \$500 for third and \$250 for fourth. The winner at state will also receive a \$1,500 scholarship just for participating in the ensuing regional contest. Another \$1,500 is available to sectional contestants that do not reach the national finals. At the national level, first place earns an \$18,000 scholarship, while the second-place award is worth \$16,000 and third place is a \$14,000 scholarship.

We here at the Herald encourage all schools in our area to send a contestant to the district competition.

After all, with college tuition costs rising with each successive year, the American Legion's contest is an excellent opportunity for at least a few youngsters to get a headstart on meeting those expenses.

Brother Tom and the Bacardi deal

hat I like about the right-wing Republican takeover of this country is how easily they blow past all our defenses against deja-vu, they-all-do-it cynicism.

There you are — thinking you're way too old and have been around this block too many times to suddenly up and evince moral outrage over a little callousness here or a dollop of favoritism there. Suddenly, you find yourself whomperjawed, outraged, stupefied with

disbelief. A Girl Scout again, after all these years. It's enough to make me believe in that nutty fundamentalist theory about "secondary virginity," which claims you can become a virgin again even if you're not a virgin. I swan to goodness, these folks can indeed produce



miracles. Mylatest walking-on-water moment came whilst I was reading an Austin American-Statesman article about Brother Tom DeLay, now the second-most powerful man in America, right after Dick Cheney. It was a familiar story to those of us who follow DeLay (who is, he has said, hell-bent to "stand up for a Biblical worldview in everything I do and everywhere I am.")

Brother Tom is given both to preaching holy propriety and running a political machine so shameless it would make Boss Tweed blush. Those who were privileged to see him in action during the last days of the peculiarly hideous process of redistricting the state of Texas know that ruthlessness and Christianity can be combined, no matter what Jesus had to say on the subject. Among those newly startled by

DeLay's tactics last week were, American-Statesman, "Four House Judiciary Committee members who

protested after an article in the here is fix 211 to bring it into tech-Capitol Hill newspaper Roll Call reported that DeLay planned to slip an amendment revising U.S. trade statutes into the annual defense authorization bill."

Now, you may think that revising trade statutes by way of a defense-authorization bill is procedurally unusual — and such was the content of the protest: "The amendment had not been properly vetted by the Judiciary panel, which is supposed to oversee trademark law." Still not in a stew over this, eh?

The amendment itself is a little charmer designed to help the Bacardi rum folks (vague memories of many good tropical drinks are stirred) with a trademark problem they have with one of the world's oldest rum labels, Havana Club. Not being an expert on fundamentalist theology, I have no idea whether assisting a rum company fits into a Biblical worldview, but I can tell you that Bacardi-Martini Inc. is a Bermuda-based company run by a family of prominent Cuban exiles who happen to be very generous, very large campaign donors. They have been especially generous to Tom DeLay for several years now.

This li'l ol' amendment of DeLay's carries some history. In 1998, then-Sen. Connie Mack, a Florida Republican, inserted an obscure amendment called Section 211 into a bill that was 4,000 pages long. Turns out 211 gave Bacardi a way to win its long-running lawsuit over Havana Club, a label also claimed by Pernod-Ricard, the French company that now sells that brand name in partnership with the Cuban government.

Oops, this touched off a major international stink. France complained to the World Trade Organization, which ruled the United States had violated treaty obligations to protect copyrights. The WTO has given the United States until the end of the year to revise the law.

So what DeLay is trying to do

nical compliance with the WTO ruling, while continuing to give Bacardi the edge. According to the Statesman: "Critics charge the ëfix' would still violate U.S. treaty obligations going back to the 1930s. Several major corporations have joined in asking Congress to repeal Section 211 altogether to avoid possible retaliation by the Castro government against their own trademarks.'

Citizens Against Government Waste, a conservative watchdog group, opposes special treatment for Bacardi. "We think it has an adverse influence on the taxpayers. on consumers and on the economy," said the group. (Note: In the now-defensive, formerly liberal media — "Oh God forbid anyone should ever call us part of the Liberal Media" — we are pleased to have an actual conservative group protesting along with us here, because if it were just liberals, who would care? A connection between special legislation for Bacardi and huge campaign contributions? What are you, a commie?)

OK, now that you have been fully prepped on this deal, I give you the Outrage Moment. One Jonathan Grella, spokesman for Tom DeLay, when asked about all this, said, "It's wrong and unethical to link legislative activities to campaign contributions."

Let's make sure we all understand what is being said here. Grella asserts that there is no conflict of interest between a public official using his power to change the law in exchange for a hefty campaign contribution — the immorality occurs when the press and/or public interest groups point out this connection. That's when I went slack-jawed.

What's new at the library... with Hollis McCright

ere are some books we have received on the Old West. 'Three Years Among the Comanches: The Narrative of Nelson Lee, the Texas Ranger' (976.0049 LEE N), is by Nelson Lee. This is a reprint of the original that was printed in 1859. Full of extreme situations and

near deadly encounters, Lee's narrative tells of life as a Texas Ranger, his capture by the Comanches and his har-

fascinating book. Three volumes of stories by Ben E. Green have also come in. "Wild Cow Tales" (976.0409 GRE B), "Horse Tradin' (636.1092 GRE B) and "Some More Horse Tradin'" (636.1081 GRE B) are absolutely the best in stories of cowboying, horse trading and cattle dealing. Ben was a vet who practiced his profession in one of the last big horse countries in North America. When he gave up his practice, he returned to his home town of Cumby, Texas, where he raised horses and cattle until his death in 1974.

Another great western book is "100 Years of Western Wear" (391.0097 BEA T) by Tyler Beard and Jim Arndt. Do you know what a "Nudie" suit is? Western actors and singers knew they had arrived when they could afford one of his suits. You can still see some the style of his work if you watch Porter Waggoner on the Grand Old Opry with his sequined suits and decorated boots. This is a great book; do check it out.

Next on the list is a photographic history of the American cowboy. Edited by Richard Collins, "The American Cowboy" (978 COL R) is absolutely beautiful. While technology has enabled man to capture life in living color, the

simplicity of black and white photos cannot be underestimated. The early photographers had much to contend with as they chronicled the life of the cowboy. Roping a mustang, "throwing" down a herd, or the simple pathos of a cowboy's funeral; all of these will take you back in history. A must "check-out" for fans of the cowboy.

A third book that has

been added to our collection is "The American Frontier: Pioneers, Settlers, and Cowboys 1800-1899" (978. DAV W) by William C. Davis. Davis chronicies the history of the territory beyond the Mississippi, with attention paid to exploration, expansion, conflict and settlement. "The American Frontier" portrays their lives through artifacts from the collection of the Buffalo Bill Cody Historical Center in Cody, W.Va. This is the first time they have been displayed in more than 30 years. This collection shows both the legend and the reality as never before. This will give the amateur historian an excellent historical perspective on life in the Old West.

William C. Davis has also written "The Fighting Men of the Civil War" (973.742 DAV W). Even though the Civil

War is among the bestdocumented wars, the story of the individual soldier has not fared as well. In his book, Davis shows that to the regular soldier, the Civil War was not about slavery, state's rights or the movement of armies. Instead it was a simple matter of life and death. This is a most interesting book, full of illustrations and text.

This is a Master Gardener alert! The library has just received "Landscape Plants for Dry Regions" (REF 635.9525 JON W). While it is a reference book and not available for checkout, do come in and look at it. It contains information on more than 600 species from around the world; trees, shrubs, groundcovers, vines and succulents.

Do you want some quick and easy recipes? "Simple Southwest Cooking" (641.5979 WAL J) by Judy Walker is full of everyday recipes with a Southwest flair. How about preparing Cranberry Salsa this Thanksgiving instead of the same old canned cranberries? Or how about Killer Cornbread & Sausage Stuffing? Again, do check this out for some new dishes to try.

A quick, easy read novel has come in: "Out To Pasture (But Not Over

the Hill)" (F WIL E) by Effie Leland Wilder is the first novel by Ms. Wilder. Her book stars Hattie McNair, an inveterage journal-keeper and eavesdropper extraordinaire. Hattie lives in a retirement community in South Carolina. While at dinner, she overhears a fellow resident planning her funeral, right down to the food. Hattie begins her journal that evening to capture the scene and thus her book begins. Telling the highs and lows of life in a retirement home, Hattie presents her story of living life to the fullest, no matter your age.

Don't forget the TexShare databases at Howard County Library. These are authoritative, fulltext articles from verifiable, subscription-only sources. Former president greets conference

LUBBOCK (AP) - Former President Bush said business deals were different when he began digging for oil in West Texas back in 1948.

There were no lawyers scrutinizing every word in an oil deal contract, no escrow agreements tacked on. "You looked a man in the eye, you shook his hand and you had a deal," George Herbert Walker Bush told a group of about 1,400 gathered Tuesday for a conference in Lubbock on ethical leadership. "I don't think we'll ever get back to that simplistic but wonderful way of doing business."

The former president was the keynote speaker at the conference sponsored by Market Lubbock Inc., an economic development corporation.

The time is right to look at the issue, Bush said. It was in late 2001 that Houston-based Enron began its quick decent into bankruptcy.

Father says children were evil

BROWNSVILLE (AP) - A father on trial in the slayings of his three children said he decapitated his kids because they had become evil after being possessed by

the soul of his-grandmother.

John Allen Rubio is charged with capital murder in the deaths of 3-year-old Julissa Quezada, 1-year-old John Esthefan and 2-month-old Mary Jane Rubio.

"My daughter started to speak like my grandmother." who had passed away. ... She told me that she had taken Julissa's soul," Rubio, 23, said in a statement to police a day after the children's bodies were found. "Julissa started to laugh and was making growls at me. ... My wife told me to kill the children because they were evil.'

The children were killed March 11 with the help of Angela Camacho, a Mexican citizen who is his common-law wife. Two of the children were assumed to be the couple's. The oldest was Camacho's child.

It has not been determined whether Camacho, 23, is mentally competent to stand trial. She remains jailed without bond in Brownsville.

Abortion literature testimony ends

AUSTIN (AP) - As mandated by the Texas Legislature, the Texas Department of Health is drafting a brochure that Texas doctors next year will be legally required to offer women at least 24 hours before performing all abortions.

Doctors, former abortion patients, religious groups and community activists offered their critiques of a proposed draft with the health department Tuesday,

the last day of public testimony before the department prepares a final version in time to meet a Dec. 1 dead-

Last spring, the Legislature passed a law requiring that women are offered specific literature at least 24 hours before a pregnancy is terminated.

Several witnesses objected to the use of the term "unborn child" in the 18-page draft.

"The appropriate terminology is fetus and to exclusively use the term 'unborn child' conveys a pro-life agenda by the authors," said Kimberly Carter, an obstetrician and member of the Texas Medical Association.

Durst jurors to view bay area

GALVESTON (AP) - The courtroom in the Robert Durst murder trial will get a view by the bay.

Defense attorneys were set to lead jurors Wednesday on a field trip to the area along Galveston Bay where police recovered the body parts of 71-year-old Morris Black, the neighbor Durst is accused of intentionally killing. Everything but Black's head was found.

Testimony was to resume after the trip, with the defense expected to begin its case. The defense hopes to convince jurors that authorities didn't search a large enough area of the bay and to show that the area is so vast that the head — which could determine the cause of death - easily could have been lost.

NATIONAL NEWS AT A GLANCE Sniper trial continues

VIRGINIA BEACH, Va. (AP) — Wiping away tears at times, a restaurant owner told a jury how he was shot and robbed in an attack prosecutors say was linked to last year's sniper spree.

Then, Paul J. LaRuffa found himself being crossexamined Tuesday by the man accused of being the mastermind of the shootings, John Allen Muhammad.

Prosecutors were prepared to present evidence Wednesday from another Maryland shooting, this one on Sept. 15, 2002, outside a Brandywine, Md., liquor store. Like LaRuffa, victim Muhammad Rashid survived, raising the possibility that Muhammad again will cross-examine one of his alleged victims.

Muhammad, who is acting as his own lawyer, began questioning LaRuffa Tuesday by saying he meant no disrespect and that "I understand how you feel when

your life is on the line." LaRuffa did not respond.

Prosecutors complained to the judge about Muhammad's introductory remarks to LaRuffa, saying they were gratuitous and intended to curry favor with the jury. Circuit Judge LeRoy F. Millette Jr. told Muhammad to stick to questions.





MIAMI (AP) - Even when he's at his best, every pitch appears to be pure torture for Mike Mussina. His pained expression seems to be permanent.

It was especially true Tuesday night. Trailing early, getting hardly any run support and working on a messy night, Mussina looked to be well on his way to another tough-luck loss.

In the World Series, no less. And yet somehow, the ace who could never quite win these games won Game 3. He outdueled brash Josh Beckett and the New

6-1 victory over the Florida and Bernie Williams. Marlins and a 2-1 lead.

"I'm leaving here with a better feeling than I've had in some past games," Mussina said.

"Every situation that you can have in a postseason, me and Bernie have been through it," Jeter said. "We've been in big games. We've won, we've lost. I think the experience helps in terms of keeping your emotions under control."

Lady Steers end drought

Big Spring spikers earn first loop title since 1977

For years and years, Ka'Rissa Magers has heard the stories of how her aunt, Rose Magers-Powell, dominated the West Texas scene during a high school career that eventually led her to a spot on the U.S. Olympic volleyball team.

Times are changing, however. When the phone rings in California later this week, Aunt Rose will have to sit through a story or two about how the Big Spring Lady Steers ended their 25-year championship drought in volleyball play.

The Lady Steers, powered by an aggressive hitting performance from Magers, LaKenya Wrightsil and Leina Braxton, swept the Levelland Loboettes Tuesday and claimed the school's first district crown since 1977.

"This is awesome," said Magers. "I've never been on a team that won a district championship so I'm not really sure how to react. I'll probably call my aunt though and tell her she isn't the only one who can do it.

"I think she's going to be very happy for us," she added.

Magers-Powell led Big Spring to back-to-back district titles — and state tournament berths — in 1976 and 1977.

With the victory over Levelland, Big Spring improved to 26-8 for the year and, more importantly, moved to within one game of finishing its 2003 district slate with a perfect mark.

"This is great," said Braxton. "We're the first team in 25 years to win a district championship. But we still have one more to go. Our goal is to go 10-0."

The Lady Steers began their run at Levelland early. Anchored by a solid setting performance by Kendall Adams and the hitting of senior Lindsay Phillips, the BSHS giolsu rolled to an easy 25 03 win in Game 1.

The news got even worse for Levelland in the second game as Big Spring opened up an early lead and cruised to a 25-12 win.

The Loboettes managed to battle to within 8-5 in the decisive third game until Timmi Blackshear and Shannon Higgins all but buried Levelland's hoped by combining for nine straight points and a 17-7 advantage.

Following the win, Big Spring High School Athletic Director Dwight Butler presented the team with the same trophy school officials handed the 1977 squad that went

Florida finally managed to get an extra-base hit after 13 singles, but has scored only five runs in three games.

"It's not an easy task against those guys,' Marlins manager Jack McKeon said.

Despite his 199 career wins and Cy Young potential, Mussina had never quite delivered the ultimate big game for the Yankees. Then again, New York never made it easy for him, rarely scoring when he was on the mound.



WARM-UPS

Karen Stellick, a Colorado Springs, Colo.-based physical therapist who traveled with the LPGA Tour for five years, offers warm-ups that will keep you nimble.

Leg crossover: Lie on your back with legs straight and arms open to the sides in a T position. Cross your right knee over your left thigh, allowing the weight of your right leg to rotate your pelvis to the left. Look over your right shoulder. As you relax into the stretch, extend the top leg out by pushing it farther away from your body. If you feel comfortable, place your left hand on your right thigh, gently pressing to increase the stretch. Hold for 20 seconds, then switch legs. Do three reps on each side. Swing bonus: Helps overall back, chest and hip flexibility.

JUDGMENT DAY

NBC analysts were too hasty when criticizing Gustafson

Shame on Roger Maltbie, the hanging judge.

Shame on NBC and its band of henchmen. Sorry, make that henchpeople, because Dottie Pepper was part of the broadcast crew that managed to convict Sophie Gustafson before she had a chance to defend herself.

Over and over, NBC replayed the episode from the final round of the Samsung World Championship on Oct. 12 — Gustafson on the 14th green, Gustafson standing over her putt, Gustafson backing off, the ball

rolling 20 feet down a slope on its own. "There are people in prison who were convicted on less evidence than this," said Maltbie, sounding like a man who was trying to make a joke. All the NBC toadies laughed heartily.

There was only one problem. It wasn't funny. Gustafson, who remarkably was 7 under par for the first seven holes of the round, was battling to win her first LPGA tournament since 2001. She was fighting valiantly to overcome a recent reputation as a weekend wimp, a player who comes unraveled in the last two rounds.

And there was NBC, tossing journalistic objectivity out the window, saying definitively that Gustafson had addressed her putt and thus should be penalized, telling viewers that a videotape provided enough evidence to convict and penalize the Swede.

Maltbie was presumptuous and imperious. Even after Gustafson was ruled innocent by LPGA officials, Maltbie cackled, "That's not what I saw."

The issue ultimately revolved around whether Gustafson was soling her putter as she assumed a full address position. Even though NBC showed the video at least a half-dozen times before the round was over, the announcers never mentioned the possibility that Gustafson held the putter head off the ground.

They simply assumed that Gustafson soled the club throughout her address routine. No, she said, the club was not soled as she took her stance. She knew the rule, and she knew the ball might move. Juli Inkster, her playing partner, did not dispute this. LPGA rules officials, after watching and rewatching the tape, did not dispute this. The camera angle did not lend itself to close-ups of the putter head.

> In such a case, the ruling must favor the player. Because golf is a game of honor, the player must be believed. When the LPGA failed to make an immediate

> > ruling, choosing instead to wait for Gustafson to finish so she could be questioned, Maltbie whined incessantly about the delay being unfair to the other players. It wasn't an ideal situation, of course. But it was fair,



tackle it. Aggressively. Good for NBC. Said Maltbie, "The decision (ruling) wasn't made until the very end of the show, but in the meantime, I have a responsibility to say this is

what I saw. If you watch the whole thing, the probability is 99 percent — at least as far as I'm concerned, in fact -(that) inadvertently she soled her club and the ball moved."

Personally, I wanted to see the matter resolved quickly to

Sure, NBC's picture was grainy when magnified, but there seemed to be an awful lot of golf ball above her putter blade. Hence, unfortunately, if the ball were addressed and then moved, Gustafson was "responsible" for moving it. Barb Trammell, vice president of tournament operations for the LPGA, even acknowledged that the first LPGA official who viewed footage in NBC's truck said "you could interpret that the club did touch the green.'

Gustafson told officials afterward she was acutely aware of the ball's precarious situation, and for that reason she made sure not to sole her putter. In his playing days, Maltbie said he'd make sure to inform his playing partner as a safeguard when presented with such a situation. That might serve as good advice for Gustafson and others in the future.

The LPGA isn't the NFL (thank God), or Gustafson immediately would have been whisked to the sideline next to the 14th green and asked to wait as official Marty Robinson put on a headset a 1 stuck his head into a monitor to get one more look at a replay. Thankfully, in golf, in the end, the player makes the call.

Gustafson said afterward she never soled her club, and I'm fine with that. It's a game of honor, and she's an honorable champion. Nobody questions her integrity. And certainly nobody in Samsung's field played better than the powerful Gustafson did on Sunday.

At the same time, I'm not ready to condemn Maltbie, Pepper and NBC, either, for their perceived rush to judgment. They might have exercised more care and added more qualifiers to their verbage, but essentially, in the heat of the moment, they simply told

us what they saw. What many of us thought we saw.
