Rezoning OK'd on split vote

Tuesday night's public hearing concerning the rezoning of two lots in the College Heights Addition drew only

one public opponent, but spawned an almost split vote from members of the Big Spring City Council. The council approved first



reading of an ordinance that would allow the rezoning of Lots 1 and 12, located in Block 41 of the College Heights Addition between 22nd and 23rd Streets, for neighborhood services on a 4-3 vote. Council members Jo Ann Staulcup, Gloria McDonald and Joann Knox all voted against the measure, which comes in preparation for a mini-storage facility to be built on the block, which is part of Goliad Street.

Also approved were ordinances allowing the issuance of a specific use permit for the storage facility and replatting of the block, something City Public Works Director Todd Darden explained was necessary to realign the right-of-way of the area following the expansion of Goliad in the 1980s.

"The lot where Ponderosa Nursery is now has its right-of-way about 7 1/2 feet out in the street," Darden explained to the council. "These additional ordinances will allow us to correct existing problems such as this." While the addition of a new business

to Big Spring is palatable for most. Clem Jones, who lives near the block being developed, said it's a step in the wrong direction for the city and everyone who lives in that area.

"I call what's happening in our neighborhood, for lack of a better term, a zone creep," Jones told the council. "It started with the car wash and the nursery, and now they want a metal storage building. What are we going to







put in next? It just keeps creeping up the hill.

"This is our neighborhood. This is where we live. And each time you permit something like this it downgrades our neighborhood decreases our property value. I think you should be trying to improve the quality of the neighborhood, not degrade it."

Jones said he recognizes the benefits the addition of the mini-storage facility could have for the city financially, but believes rezoning is a nowin situation for everyone involved.

"I realize this will mean additional income for the city," said Jones. "But I think the benefit to the city is far outweighed by the degradation of our residential neighbor-

Jones likened the effort to "spot zoning," but Mayor Russ McEwen said the zoning map of the area tells a different

"In this case it was two lots that are single family dwellings out of basically two blocks of neighborhood service," said McEwen. "For me, it was illogical not to go ahead and change that over because it appeared to me it was just an oversight when you have these two lots in the middle of an area that's zoned for neighborhood service."

McEwen said he understands Jones' position on the rezoning, and had the lots been located in a predominantly single family zone and not a neighborhood services zone, he would have rejected the ordinance.

"You don't want to have an area that is zoned a certain way and have

someone come in and say they want to put in something that's out of character for that zoning," said McEwen. "If there were single family dwellings throughout that area and someone said there is a vacant block there that's zoned for single family dwelling and said they wanted to put mini storage buildings in there, I would absolutely vote against it every single time. Because that takes away from the integrity

Votes on the issuance of a specific use permit for the storage facility and replatting of the block also met resistance from council members. McDonald and Knox both opposed the replatting for a 5-2 vote, while Staulcup joined the two in opposing the specific use permit for another 4-3 vote.

lunar eclipses give scientists a chance to assess the quality of Earth's atmosphere. Ash from volcanic eruptions, for example, can make an eclipsed moon look much darker. The recent eruptions of Mount St. Helens in Washington have consisted of far more steam

the moon should appear bright and coppery red on Wednesday night, NASA said. In the Howard County area, the eclipse will



Popcorn balls: A Halloween tradition

Every Halloween trick or treaters of all ages go to Bettye Parrish's house in Coahoma for popcorn balls. She's been handing them out for 25 years. It all started when a friend gave her a recipe for making popcorn balls in the

microwave. "That next Halloween I decided to make popcorn balls for the kids and grandkids," says Bettye. "Then when the kids from the neighborhood started coming by trick or treating, they smelled the popcorn and asked what we were



Bettye, her daughters and granddaughters make the popcorn balls. We get the popcorn popper

going and the microwave going at the same time," says Bettye's daughter Connie Murley. "We have big bowls full of popcorn and as soon as the syrup gets ready you have to pour it in and stir. And then some of us are standing there with butter on our hands to make the balls, which are a little bit bigger than a tennis ball. And then as soon as some of them get cool, then the next person bags them up in sandwich bags. It's just kind of an assembly line. Mother's got a big kitchen and when we're all working in there, it all looks like a disaster area, but we know what we're doing."

TUMBLEWEED They all wear the same type of t-SMITH shirt to add to the festivities.

The kitchen crew starts early and stays late. Some adult trick or treaters are at Bettye's house at 8 o'clock Halloween morning.

"Later that night, Daddy always fixes big pots of chili and stew," says Connie. "So the rest of the family comes and sits around everywhere eating while we're passing out popcorn balls. To the people coming by, they think we're just having a big party so they may come and stay thirty

minutes. They don't just come get a popcorn ball and leave. They stay awhile."

Bettye says if their visitors haven't had supper, they'll stay and have some chili or stew. "My husband Charles makes enough to feed the whole community."

The ingredients for the balls are popcorn, syrup, butter, sugar and vanilla from Mexico.

"The Mexican vanilla really makes them taste wonderful," says

Coahoma is located 8 miles east of Big Spring. The community has a population of just under one thousand. Nearly all of the residents of Coahoma go by Bettye's house for a popcorn ball.

"And half of Big Spring," says Bettye. "Last year we were playing Stanton in football and all the Stanton kids came by. When they come to my house, they don't go home hungry. Some take bagfuls for all their kinfolks."

They use a hundred pounds of sugar and a case of butter to make more than a thousand popcorn balls at Halloween.

Dodgin wolves and meteorites

h, you sweet, innocent, carefree citizens in nonswing states. You have no idea how much fun and slime you are missing.

It seems the majority of Bush supporters, according to recent polls, still believe Saddam Hussein had ties to Al Qaeda and even to 9-11, and that the United States found weapons of mass destruction in Iraq. Many of you are asking how that could possibly be. since everybody knows.

But everybody doesn't know. There it is. And if you are wondering why everybody doesn't know, you can either blame it on the media, always a shrewd move. or take notice that the administration is STILL spreading this same misinformation.

Both Donald Rumsfeld and Bush have publicly acknowledged there is no evidence of any links between Saddam Hussein and Al Qaeda. However, as Dick Cheney campaigns, a standard part of his stump speech is the accusation that Saddam Hussein "had a relationship" with Al Qaeda or "has long-established ties to Al Qaeda." He makes this claim up to the present day. The 9-11 Commission,

however, found that there was "no collaborative relationship" between the two.

Cheney, of course, also has never given up his touching faith that Iraq had weapons of mass destruction, recently referring to a "nuclear" program that had in fact been abandoned shortly after the first Gulf War. Bush and Cheney misled the country into war using these two false premises, and it turns out an enormous number of our fellow citizens still believe both of them to be true. It's not because they're stupid, but because an administration they trust is still telling them both

phony propositions are true. Normally, when you get a situation like that — where people are simply not acknowledging reality it is considered a cult, a form of groupthink based on irrational beliefs propagated by what is normally a charismatic leader. So those Kerrey volunteers earnestly engaging Bush supporters on the latest outrage are way off base. They need to go all the way back to the Two Great Lies that got us into this: Many American soldiers marching into Iraq believed it was "payback for 9-11."

A third slightly blinding fact (to me) is that more people now think Kerry behaved shamefully in regards to Vietnam than did W. Bush. Incredible what brazen lying will do, isn't it?

A friend of Bush's dad got him into the "champagne unit" of the Texas Air National Guard, a unit packed with the sons of the privileged trying to stay out of Vietnam, and he failed to complete his service there. Kerry is a genuine, bona fide war hero. The men who served on his boat are supporting him for president, but those who didn't serve with him, who weren't there, who don't know what happened, have been given more credence. Wolves will get you!

In further unhappy evidence of how ill-informed the American people are (blame the media), the Program on International Policy **Attitudes found Bush supporters** consistently ill-informed about Bush's stands on the issues (Kerry-ans, by contrast, are overwhelmingly right about his positions). Eighty-seven percent of Bush supporters think he favors putting labor and environmental

standards into international trade agreements. Eighty percent of Bush supporters believe Bush wants to participate in the treaty banning landmines. Seventy-six percent of Bush supporters believe Bush wants to participate in the treat banning nuclear weapons testing. Sixty-two percent believes Bush would participate in the International Criminal Court. Sixty-one percent believes Bush wants to participate in the Kyoto Treaty on global warming. Fiftythree percent does not believe Bush is building a missile defense system, a.k.a. "Star Wars."

The only two Bush stands the majority of his supporters got right were on increasing defense spending and who should write the new Iraqi constitution.

Kerry supporters, by contrast, know their man on seven out of eight issues, with only 43 percent understanding he wants to keep defense spending the same but change how the money is spent and 57 percent believing he wants to up it.

So what's going on here? I do not think Kerry people are smarter than Bush people, so why are they better-informed? Maybe a small percentage of ideological rightwingers don't believe anything the Establishment media say, but I don't think this is a matter of not believing what they hear, but of not hearing what's factual.

The great triumph of the political right in this country has been the creation of a network of alternative media. There are people who listen to Rush Limbaugh for more hours every day than the Branch Davidians listened to David Koresh. Watch Fox News, read The Washington Times hey, that's what the Bush administration does, according to its own words.

But it's not just the right-wing media purveying lies - they are quoting the administration. These misimpressions come directly from the Bush administration, still, over and over.

Spokesman: No search for explosives

(AP) - One of the first U.S. military units to reach the Al-Qaqaa military installation south of Baghdad after the invasion of Iraq did not have orders to search for the nearly 400 tons of explosives that are missing from the site, the unit spokesman said Tuesday.

When troops from the 101st Airborne Division's 2nd Brigade arrived at the Al-Qaqaa base a day or so after other coalition troops seized Baghdad on April 9, 2003, there were already looters throughout the facility, Lt. Col. Fred Wellman, deputy public affairs officer for the unit, told The Associated Press.

The soldiers "secured the area they were in and looked in a limited amount of bunkers to ensure chemical weapons were not present in their area," Wellman wrote in an e-mail message to The Associated Press. "Bombs were found but not chemical weapons in that immediate area.

"Orders were not given from higher to search or to secure the facility or to search for HE type munitions. as they (high-explosive weapons) were everywhere in

The 101st Airborne was apparently at least the second military unit to arrive at Al-Qaqaa after the U.S. led invasion began. Pentagon spokesman Bryan Whitman told The Washington Post that the 3rd Infantry Division reached the site around April 3, fought with Iraq forces and occupied the site. They left after two days, headed to Baghdad, he said.

Scientists find prehistoric dwarf skeleton

(AP) — In a breathtaking discovery, scientists working on a remote Indonesian island say they have uncovered the bones of a human dwarf species marooned for eons while modern man rapidly colonized the rest of the planet.

One tiny specimen, an adult female measuring about 3 feet tall, is described as "the most extreme" figure to be included in the extended human family. Certainly, she is the shortest.

This hobbit-sized creature appears to have lived as recently as 18,000 years ago on the island of Flores, a kind of tropical Lost World populated by giant lizards and miniature elephants.

She is the best example of a trove of fragmented bones that account for as many as seven of these primitive individuals. Scientists have named the new species Homo floresiensis, or Flores Man. The specimens' ages range from 95,000 to 12,000 years old.

"So the 18,000-year-old skeleton cannot be some kind of 'freak' that we just happened to stumble across," said one of the discoverers, radiocarbon dating expert Richard G. Roberts of the University of Wollongong in Australia.

"It is arguably the most significant discovery concerning our own genus in my lifetime," said anthropologist Bernard Wood of George Washington University, who reviewed the research independent-

British troops in Iraq begin deployment

BAGHDAD, Iraq (AP) — Nearly 800 British forces left their base in southern Iraq on Wednesday, heading north toward Baghdad to replace U.S. troops who are expected to take part in an offensive against insurgent strongholds.

The deployment came hours after Iraq's most feared militant group released a video threatening to behead a Japanese captive within 48 hours unless Japan withdraws its troops from Iraq.

Iraq," he wrote, British Lt. Col. James Cowan said British troops, accompanied by 40 U.S. Marines, left the southern city of Basra to head for a base located north of Hillah, about 60 miles south of Baghdad, Forty U.S. Marines were with them, he said.



IRVING (AP) Cowboys Dallas receiver Terry Glenn will be out at least two weeks because of a sprained right foot.


Coach Bill Parcells said Monday that the injury won't require surgery but is "pretty severe."

ST. LOUIS - He has been loved and revered, maligned and smeared.

He's a one-word name, Pedro, the way Reggie used to be.

And now he and the rest of the Boston Red Sox are one win away from an event that will change their lives and alter the universe of a long-suffering team.

With all of baseball watching and wondering whether he would come through, Pedro Martinez allowed just three hits in seven scoreless innings Tuesday night, retiring his final 14 batters in a 4-1 victory over St. Louis that gave the Red Sox a 3-0 World Series lead.

"It's been a great ride," he said. "I hope everybody enjoyed it as much as I did. Even with the struggles that I've had up and down during the season, I really enjoyed it. I enjoyed every moment."

It was perhaps his final game with the Red Sox. He can become a free agent after the World Series, and it's unclear whether he'll be back for an eighth season in Boston.

"If they don't get me, it's probably because they didn't try hard enough," he said. "My heart is with Boston. I consider Boston my house."

Martinez got out of a bases-loaded jam in the
