CONTRACTS FOR NEW WELL TO BE SIGNED SOON

The City Council reviewed the bids to drill the new water well this past week and awarded the contract for the well drilling to the Lane Company and the pump contract went to Smith Pump Company.

The base bid for the project totals \$52,901 and is expected to produce 750 gallons of water per minute.

The actual capacity of the well will not be known until the Land Company completes the "test hole". The 900' hole will be approximately 4" wide and a geological study of the forma-

New Drivers License Law Effective Jan. 2

As of Tuesday morning January 2, drivers license renewals will have a "thumb nail" color photo on them.

The drivers license office moved to 310 West Main St. late in December and Friday to perform the expanded function of picture taking.

Equipment is set up at the new office to take the color photo when it comes time to renew your license. Persons receiving an original license, of course, must take a written test and a driving test. The written part of the exam can be taken during regular office hours but the driving part must be taken on Fridays when Department of Public Safety officer, James Smith is at the Gatesville office.

The new procedure will change many things but the notice of renewal is the same as under the old law.

When a person receives a notice to renew he must go to the nearest regional or branch office in person. The old procedure of mailing the required cash to the (DPS) will not be

The Gateville office is one of more than 200 full time facilities throughout Texas which have been built to take care of the new demand on drivers license offices.

Renewal procedure is not complicated just drop by and take a simple eye test and have a photo taken. The driver will receive a temporary permit until the new "laminated plastic" license can be mailed in an estimated 4 to 6 weeks.

CITY SALES TAX IS POPULAR WITH MANY TEXAS CITIES

Voters in 158 Texas cities containing 70% of the state's urban population approved the 1% municipal sales tax in elections held during 1967. The tax was defeated in only 22 cities.

Actual collection of the tax, authorized on a load option basis by the legislature last spring, began January 1, 1968. in 14 cities where elections were held and results reported to the state comptroller before the end of September. The comptroller administers the tax and returns proceeds, except for his expenses, to the city of origin, but the law allows a full calendar quarter to elapse be-

Woman Dies After Being Hit By Car

Mrs. Ella Davis ,70, of 409 Leon Street, was taken to Coryell Memorial Hospital with injuries suffered in a car-pedestrian accident around noon Saturday December 30, 1967.

The accident occured at the intersection of 5th Street and Main Street. Police Chief Gene Goins reported the woman was hit by a car driven by Darrell Randall Belt, 15, also of Gatesville.

Mrs. Davis died at 1:40 p.m. Saturday and was buried in Hemmline Cemetery on January 1, tween election and collection. In 144 cities voting the tax between October 1 and December 31, 1967, collection will begin April 1.

The 158 cities approving the tax in 1967 contain a total population of 6,231,211. Population of cities defeating the tax last year totaled 377,987.

Elections during the first month of 1968 have been called in at least a dozen more cities.

Voter Registration Ends January 31.

Voter registration in Gatesville totals 3078 as of Thursday morning. The Copperas Cove count to date in only 917.

Officials term the registration as light considering the fact that all persons 21 years old and older must register this year. Many of the persons registered so far were not required to do so last year.

The deadline for registering to vote is January 31, 1968. Beat the last minute crowd stop by the courthouse and sign up . It only takes a minute.



A HERITAGE FOR THE WORTHY

Above all else, 1967 appeared to be a year when the verities were questioned -- in politics, in economics, in religion and in virtually every other element of the structure of presentday society. What does it all mean? No one really seems to know. Some claim the tearing down of old standards reflects what might be called a healthy renaissance of advanced thought. Others viewwith foreboding a trend they feel is leading to a moral breakdown and anarchy. The experts are the most confused lot of all. Sometimes their judgements of coming events are ludcrous. Typical of their inability to assess the future was the recent statement of one of this country's leading financial authorities that devaluation of the British pound was unlikely because the English program of austerity was so fundamentally reassuring as to make a crisis improbable. By the time this particular forcast was in print, the British pound had been devalued, and no one knows what the future holds for the monetary systems of the world.

Out of all the confusion of 1967, one fact has become clearly obvious—self-government itself is on trial. This is so because the very truths which are the mainstay of self-government are being altered or swept away one after another—truths that were once called "self-evident." These truths have to do with financial responsibility, the intergrity of the family, the inviolate rights of persons and property under the law and concepts of individual self-reliance and initiative that are inseparable from freedom under representative government. A gradual decline in respect for these prerequisites of liberty was never more apparent in the observation of many people than during the crucial months of 1967.

Outwardly, the United States is invincible. But, the founding fathers warned nearly 200 years ago that the greatest danger to the American experiment in free government could well come from within. A debauched currency, a weakening pride in individual independence and the gradual ascendancy of state authority are undeniably changing the outlook for constitutional government as we have known it in the United States. Few now living have the capacity to view the present era as it will be recorded in the history books at some distant time in the future. Our present civilization, and more specifically our own country. measured by material progress and the potentail for future progress, opens a vista that staggers the imagination. The precepts under which civilization has advanced to this point, and which have brought a greater measure of well-being to more people than has ever been known in the world before, must have a validity that the hippies, the malcontents and the anti-American demonstrators have failed to perceive.

No political party, no single group of citizens is solely to blame for the dismal drift that has put self-government on trial, and as the elections of 1968 approach, we should expect no miracles from our elected representatives. They but reflect the temper and attitudes of the electorate. The signs became abundant during 1967 that a turning point has been reached in the affairs of the world and of our country. As we enter 1968, everyone of us should resolve to be worthy of the heritage of self-government—a heritage for which 500,000 men in Viet Nam áir lives on the line.



BOB POAGE REPORT

This is the last Newsletter that I will write in the year 1967. Actually, it will be 1968 by the time you receive it. I want to wish everyone who reads this a very Happy, Prosperous and Successful New Year.

I don't want to start the year on an unpleasant note, but I do think that while we are considering our opportunities for the future that we should ask ourselves why we establish government. I think that our Constitution sets it out very well, and among the purposes therein recited is one "to establish domestic tranquility." This clearly means to maintain law and order here at home. Unless we can do this, we can't have government, because if laws are to be ignored by all those who dislike them, we have anarchy, and anarchy is always followed by dictatorship.

It seems to me that in its zeal to protect every imaginable right of those accused of crime our Supreme Court has gone a long way toward making it impossible for our law-enforcing officials to prevent crime. I believe in protecting the rights of the accused to establish his innocence, and I believe the burden to prove guilt rests with the State, but I don't believe that anyone has the right to advocate the destruction of his government or to advise others to violate the law whether he likes the law or not.

I want to congratulate the officers of Central Texas, particularly in Bell and McLennan Counties--in McLennan County for locating the perpetrator of the horrible murder that recently occurred, and in Bell County for promptly arresting the hoodlums from Austin who came up to Killeen and tried to interfere with the President's speech. We clearly need a more practical Supreme Court, but I think we must go one step further. Most lawlessness develops from childhood disobedience. The obedient child is likely to make a good and successful citizen. The disobedient child is a mighty good candidate for the penitentiary, and when that child, or for no better purpose than to hear the glass fall, he is likely to get the idea that it is all right to take any property he wants. And sometimes I wonder if there is not really more justification for the thief who convinces himself that he needs what he takes, than there is for the vandal who breaks street lights, descrates cemeteries,

FARMERS, RANCHERS AND FISHERMEN'S INCOME TAX ESTIMATES DUE BY JANUARY 15, 1968.

Farmers, ranchers and fishermen were reminded today that Monday, January 15, is the last day for filing their estimated Federal income tax returns for 1967, unless they plan filing their final return on or before February 15.

Stanley Ferguson, administrative officer of Internal Revenue Service in Waco, Texas, explained that those farmers, ranchers and fishermen who file an estimated return on January 15 and pay the tax due thereon have until April 15 to file their final return and pay any balance of tax due. Otherwise, the law requires that they file their final return and pay

the full amount of the tax due


by February 15.

The IRS representative cautioned that this option is available to farmers, ranchers, and fishermen only. Tax law defines these taxpayers as those who earn two-thirds or more of their gross income from farming, ranching or fishing. He said that if these taxpayers filed a Federal income tax return last year the necessary forms for this year will be mailed to them. For those who did not file, or for some other reason did not receive their forms in the mail. blank forms are available from any Internal Revenue office or post offices or banks.

Farmers, ranchers and fishermen must file an income tax return and pay a self-employ-ment tax, if net earnings from self-employment were \$400 or more. However, only farmers and ranchers who have actual net earnings from the operation of their farms of less that \$400 may, under certain circumstances, elect to pay a selfemployment tax and may qualify to receive benefits under the Social Security system.

Many taxpayers can complete their own tax returns by using the helpful free booklet "Farmer's Tax Guide," which can be obtained from IRS offices and agricultural agents.

Highlights and Sidelights by Vern Sanfard

Any way you look at it, 1968 shapes up as the most actionpacked political year for Texas in more than a decade.

It will start with a wideopen governor's race in the Democratic primary perhaps the roughest since 1956. Also, there may be some other close races for less exciting offices. And of course, the presidential battle will hold the November general election spotlight. If Texas Republicans make good their threat to field a strong candidate for governor, and it seems they will, there will be plenty of action on that front almost the year around.

There is no sure way of predicting at this point whether U.S. Sen. Ralph Yarborough, Lt. Gov. Preston Smith, Secretary of State John Hill, former Atty. Gen. Waggoner Carr, Dallas radio man Gordon McLendon, Houston attorney Don Yarborough or an unheralded dark horse will emerge the Democratic nominee for governor. Neither is it clear who the Republicans will put up to oppose him. Congressman George Bush of Houston? Sen. John Tower? An unknown?

While Texas national Democratic convention delegates obviously will be pledged to support President Johnson, state Republican leaders have not tipped their hands as to their favorite candidate for nomination.

Although the winners can't be picked in advance, red letter dates can be marked on the 1968 calendar. Here are the

main ones: *February 5--Last day for filing as candidate in primaries. *May 4--First primary election and party precinct conventions. *May 11--County party conven-

*June 8--State conventions to pick national convention dele-

*September 17--State conventions to pick Texas party leadership (executive committees) and write the state party plat-

*November 5--General election Remember that, to participate in any of the action, you must register (it's free) with the county tax assessor-collector or authorized deputy by January 31. Registration is simple and can be accomplished through the mail on forms provided by most newspapers.

Where the county wants to make a contract under competitive bidding requirements, bids must be stated in terms of gross price without "trade - in". However, county commissioners may ask for trade-in data and consider it in awarding the contract.

COURTS SPEAK

A Negro mathematician at the spacecraft center in Houston who had a plate yanked out of his hand by a private club manager is entitled to \$900 in damages for "battery", State Supreme Court agreed. Decision reversed lower courts.

Fourth Court of Civil Appeals, in a Webb County case, agreed the state has the right regulate picketing in labormanagement dispute. Labor group unsuccessfully attacked a ban against more than two pickets at a time within 50 feet of the struck establishment or other pickets.

POLICY CANCELLATION **GUIDELINES SET**

State Board of Insurance announded these general guidelines for cancellation of certain insurance policies or company refusal to renew coverage:

Family auto policies and auto coverage should be cancelled only for premium non-payment or for license suspension or revocation.

Companies should not balk at renewing family auto policies strictly on account of ages of

Thirth days' notice of nonrenewal should be given before declining to renew family auto policies and auto coverage, homeowners policies and standard fire policies on one-family

Cancellation cannot be ordered on home owner and standard fire policies for onefamily dwellings solely because the company changes underwriting requirements during the policy term.

FOURTEEN CITIES START SALES TAX--

January 1 marked the start of actual collection of the new one per cent city sales tax in 14 of more than 150 cities which have approved the tax since September. These 150 cities represent 65 per cent of Texas' urban population.

Cities starting the tax January 1 included Aransas Pass, Austin, Bracketville, Corpus Christi, Elgin, El Paso, Henrietta, Ingleside, Nacogdoches, Orange Grove, Port Aransas, Taylor, Texarkana, and Wichita Falls.

Collections of one percent levy (added to the two percent state tax) will begin April 1 in at least 140 other municipalities. Only about 20 city sales tax elections have failed.

State comptroller has a full quarter of a year to set up collection machinery after a city reports approval of the tax.
