Section 4. That the ballots of said election shall conform to the requirements of section 2, Subsection G, of Article 1966c Vernon's Texas Civil Statutes Acts 1967, 60th Legislature, Regular Session, Chapter 36 page 62), and the requirements

of Chapter 6 of the Election Code of the State of Texas, as amended, and the language to be printed thereon shall in-

clude the following: OFFICIAL BALLOT Instruction: Place an "X" in the square beside the statement indicating the way you wish to vote.

FOR adoption of a one percent (1%) local sales and use tax with the city.

AGAINST adoption of a one per cent (1%) local sales and use tax with the city.

Section 5. That election judges and clerks are directed to comply with Article 6.06, Election Code of the State of Texas, as amended (Section 2 of House Bill 181, Acts 1967, 60th Legislature, Regular Session, Chapter 452, Page 1026, 1028), which provides that a square shall be place beside each proposition in which the voter is instructed to place an "X" or other clear mark to indicate the way he wishes to vote. but which also provides that the failure of a voter to mark his

ballot in strict conformity with the directions on the ballot shall not invalidate the ballot, and the ballot shall be counted if the intention of the voter is clearly ascertainable, except where the law expressly prohibits the counting of the ballot. It is

specifically provided that the election officer shall not refuse to count a ballot because of the voter's having marked his ballot by scratching out the







Mrs. Edna Fay Jones, of 1108 Pidcoke, passed away on July 29, 1968.







This is the last o' my regular reports for this congressional session. As you know, it has been my practice in past years to suspend this nonpartisan report during the convention and campaign periods of election years. That time is once again upon us.

In this last report of 1968, I'd like to talk with you about jobs.


A good deal of our nation's attention has been centered in recent months on the need to improve employment opportunities for all our citizens. For several years Congress has been trying to assist by developing programs of job training supported at least in part by federal funds. We also have proposed the providing of tax incentives to private industries that devote resources and efforts to job -

training programs Recently a further idea has been put forward that may go a long way toward helping us meet our national goal of increased job opportunities. It has been called the "National Job Bank", and I'd like to bring it to your attention.

Today, many of our people are enveloped in a vicious cycle of poverty . Because they do not have a good education, they cannot get a good job and they cannot afford decent housing, Because they live in slum housing, they find it dif-ficult to establish a sound and stable home for their children. This dependency cycle must

be broken at every point --jobs, education and housing. In the long run, of course, quality education is the most important factor. But, even if we were to transform our

educational system overnight, the result of the miracle would not be felt for years -- for education, by its very nature, is a time-consuming process that proceeds and builds in logical Moreover, for twonps. thirds of today's poor, the days

of basic education have passed. Decent housing is vital; and as the ranking minority mem-ber of the Senate's Housing subcommittee I have sought for years to establish federal programs which would assist lowincome families to acquire their own homes. Just this spring, Congress has approved the first of these low-income home ownership programs. I think it will work and I'm hopeful it can later be expanded to provide assistance to even more low-income families.

But, housing alone can never resolve the basic conditions of ignorance, joblessness and despair.

Decent housing -- and furniture and clothing and food and entertainment -- are the products of a good education and good jobs, not the reverse.


What is needed now, I believe, and what can be provided now, is the dignity and satisfaction of working for a living and earning the money that will give a person the economic power to buy the things that make for a decent home and a good life.

What can we do to make it possible for more people to hold productive jobs?

Well, we know there are three requirements for a man to be productively employed. First, he must be qualified for the job; second the job must be available; but third, he must know about the job. Thus far, we have concentrated on the first two conditions, which is certainly not wrong, but we have failed to place adequate emphasis on the third.

It is in this area, I believe, that rapid progress can be made and it is to this area that the National Job Bank proposal ad-

dresses itself. In our concern to create job opportunities and to train people, we have largely ignored the problem of communication about jobs. Today, tens of thousands of jobs are going begging because people qual-

sional job opportunities, There

seems to me to be no real bar-

sential facts to a computer op-erator -- what kind of training he had, what kind of educa-tional background he had, in what area he wanted to work, the income he needed, how many hours he cold work. This information would then be fed into the computer which would have been previously stockpiled with job opportunities in private industry and business in nonprofit organizations and in government.

The computer could then provide the applicant with a report of the opportunities available in the community, the city, the state and even the nation. This would expand his range of job options, to expand his freedom of choice.

I believe the time has come to put computer technology to work resolving a part of our complex job crisis.



"Captain" Kidd may be turning the tiller over to someone else, but he certainly isn't abandoning ship.

Rodney J. Kidd, University Interscholastic League director since 1948, goes on modified service Sept. 1. Mr. Kidd has reached the compulsory retire-ment age for University of Texas administrators.

'Summer is the time when the League starts all over again,"Mr. Kidd says, "and I can't wait until September."

This fall, Mr. Kidd's time will be dedicated to the UIL Foundation scholarship program which he helped to institute. The program, organized in 1959, has grown from no funds at all to more than \$229,000, and Mr. Kidd hopes to see it develop even further.

'Think of the scholarship in terms of some boy or girl going to school for a year," he says, adding:

"It is most rewarding to see these kids come in and out of a University. They may be entirely different; they may even have a new mission in

life." Mr. Kidd is never hesitant to brag on the League or the Texas high school students who make it outstanding

The Texas UIL, Mr. Kidd says, is the "biggest and best" in the United States because it reaches many more students and has the only scholarship program for "blue chip" academic champion.

Before the League initiated its scholarship program, students who were state winners in literary and scientific contests were virtually ignored in favor of talented high school athletes.

"We have all kinds of champions from football to poetry reading, and their accomplishments tell the true story of the League," Mr. Kidd emphasizes.

Mr. Kidd's own contact with the League began on the parti-cipant level. He lettered in football, basketball, baseball,






