

Accidental shooting victim is recovering

CORPUS CHRISTI (AP) A 78-year-old hunting companion of Vice President Dick Cheney was recovering in stable condition Monday after Cheney accidentally shot him during a weekend quail hunting trip, a hospital official said.

Whittington Harry "rested well last night," said Peter Banko, hospital administrator at Christus Spohn Hospital Memorial. The hospital continued to Whittington's condition as "very stable," he said.

Whittington, an Austin attorney, was flown to the hospital after Cheney accidentally shot him Saturday at the Armstrong Ranch. The owner of the ranch said Cheney was shooting at a bird but didn't realize Whittington had stepped into his line of fire.

"It's not critical. It's not serious. It's just stable at this time," Banko said, adding that admitting

FEMA reforms expected

House criticizes responses to hurricanes

WASHINGTON Homeland Security Secretary Michael Chertoff is announcing wide-ranging changes to the nation's embattled disaster-response agency

on the heels of a House report blaming government-wide ineptitude for mishandling Hurricane Katrina relief. The Federal

Emergency Chertoff

Management Agency reforms that Chertoff was unveiling today range from a fulltime response force of 1,500 new employees to establishing a more reliable system to report on disasters as they unfold. They are the first steps to overhauling which was overwhelmed by the Aug. 29 Gulf Coast storm.

"We know there's considerable work to do," a Homeland senior Security official said Sunday on condition of anonymity because the changes had not been announced. Most of the changes are to be completed by the start of the 2006 hurricane season on June 1, the official said.

Democrats on Homeland House Security Committee issued their own recommendations Sunday for changing FEMA, including having the agency's director report directly to the president during major disasters. They also said the director should be an experienced emergency manager.

Chertoff chose a meeting of emergency responders to detail the changes. White House Homeland Security adviser Frances Fragos Townsend also expected to discuss parts of her upcoming review the federal about response to Katrina.

The FEMA changes follow the results of an House inquiry that found unheeded warnings, poor planning and apathy in recognizing the scope of Katrina's destruction led to the slow emergency





response from the White House down to local parishes.

The 600-page report by a special Republican-dominated House inquiry into one of the worst natural disasters in U.S. history concluded that late state and local evacuation orders exacerbated an untrained and inexperienced force of federal emergency responders.

It also said President Bush received poor and incomplete counsel about the crisis unfolding in the Gulf Coast.

Overall, the House report said, the federal government's response to Katrina was marked by "fecklessness, flailing and organizational paralysis."

"Our investigation revealed that Katrina was a national failure, an abdication of the most solemn obligation to pro-

vide for the common welfare," said a summary of scathing report obtained Sunday by The Associated Press.

"At every level — individual, corporate, philanthropic, and governmental — we failed to meet the challenge that was Katrina," the report concluded.

"In this cautionary tale, all the little pigs built houses of straw."

The House findings mark the first of two congressional inquiries and a White House review of storm response expected over the next six weeks.

Today, the Senate or not at all." Homeland Security and Governmental Affairs Committee was to continue its own investigation into the storm response by examining potentially widespread abuse in federal emergency cash assistance programs for disaster victims.

Up to 900,000 of 2.5 million applicants received

aid based on duplicate or invalid Social Security numbers, or false addresses and names, congressional investigators found.

"Everything that we have found ... confirms exactly the indictment of the House Republicans," Sen. Joseph Lieberman of Connecticut, that committee's top Democrat, said Sunday. "It's shocking and it is unsettling."

The House investigation criticized Chertoff, saying his overall responsibilities for the federal disaster relief during Katrina were fulfilled "either late, ineffectively

concluded Chertoff unnecessarily delayed naming a top federal coordinator for relief efforts and the activation of an internal disaster management group.

It also faulted Chertoff for not following a response plan specifically for catastrophic disas-

Among the planned changes at FEMA:

—Tracking trucks carrying food, water, ice, blankets and other emergency supplies by satellite to ensure they arrive at disaster sites quickly and with enough equipment.

-Sending employees to emergency shelters and other temporary housing venues to register victims for aid, instead of relying on victims to register by phone or the Internet.

—Creating a database of already-approved private contracting firms from disaster regions to remove debris and provide services faster.

-Creating "reconnaissance teams" to report disaster conditions to Homeland Security and FEMA operation centers within hours, improving communication channels to ensure the information quickly gets to the president and Cabinet-level officials.

salaries, but their benefit packages as well.

Along those lines, he also supports restoring teacher retirement and health care packages to previous levels.

• Vouchers — Mouton is strongly opposed to the state providing vouchers to parents to send their children to private schools.

"Don't tax me and give it to someone who will send their children to a private school," Mouton said. "That is unconstitutional ... I'm opposed to legislation that would take public tax dollars to pay for private education.'

 Standardized testing Mouton supports raising the passing standard on the Texas Assessment of Knowledge and Skills (TAKS) and other standardized tests, but he said that must be accompanied by increased support of school districts to help them accomplish the higher goals.

"You want to make sure standards continue to go up," Mouton said. "But you need to supply students with the tools to meet those higher standards."

 Merit pay for teachers With so many pressing education issues facing the legislature in the near future, Mouton thinks the idea of merit pay can wait for now.

"I pretty much support putting this one on the back burner for now," he said. "Once we get around to (more important issues), we can address this at a later time."

With almost 60 school districts in the 16-county District 85, Mouton said he has a practical reason for courting the education vote.

"If half of the teachers in this district, and their spouses, voted for me. I would win in a landslide," he said. "There is no group that has failed to take advantage of its power like educators."

Motion filed to stop eviction of Katrina evacuees from hotels

NEW ORLEANS (AP) -About 12,000 families made homeless by last year's hurricanes were scheduled to be forced out of their federally funded hotel rooms Monday, but lawyers for the evacuees were hoping for a lastminute reprieve.

Sunday, attorneys delivered papers to the home of U.S. District Court Judge Stanley Duvall, asking him to grant a restraining order to stall the evictions.

"We have provided the court with statements from people showing they have not been treated fairly by FEMA," said Bill Quigley, an assistant dean of the Loyola University Law School.

Armstrong said the shotgun pellets broke the skin.

"It knocked him silly. But he was fine. He was talking. His eyes were open. It didn't get in his eyes or anything like that," she said.

Each of the hunters was wearing a bright orange vest, Armstrong said.

because they were deferring to Armstrong to handle the announcement of what happened on her property. Armstrong said everyone at the ranch was so "focused" on Whittington's health that it wasn't until Sunday she called the Caller-Times to report the accident. Her ranch is about 60 miles southwest of Corpus Christi.

Sally Whittington told The Dallas Morning News her father was being observed because swelling from welts on his neck. His face "looks like chicken pox, kind of," she said.

Emergency personnel traveling with Cheney tended to Whittington before he was taken first to a hospital in Kingsville and then transferred to Corpus Christi. Whittington has been a

private practice attorney in Austin since 1950 and has long been active in Texas Republican politics. He's been appointed to several state boards, including when then-Gov.

George W. Bush named him to the Texas Funeral Service Commission.

Armstrong said Cheney is a longtime friend who comes to the ranch to hunt about once a year and is "a very safe sportsman." She Whittington is a regular, too, but she thought it was the first time the two men hunted together.

50,000-acre The Armstrong ranch has been in the influential South Texas family since the turn of the last century. Katharine is the daughter of Tobin Armstrong, a politically connected rancher who has been a guest at the White House and spent 48 years as director of the Texas and Southwestern Cattle Raisers Association. He died in October. Cheney was among the dignitaries who attended his funeral.

Cheney was legally hunting with a license he purchased in November. Texas Parks and Wildlife Department spokesman Steve Lightfoot said.







No, this paragon of pomposity gets a complete pass from the left for the jaw-dropping hypocrisy he displays every time he has the singular audacity to lecture anyone about anything.

He's entitled to lifetime immunity for his presumably good intentions in having promoted the failed policies of liberalism during his entire public life.

Sadly, there is recurring evidence that to liberals, one's political predilections trump everything else so that if you stand for the

right things, you are virtually exempt from scrutiny. Conversely, if you stand for the wrong things, you are fair game for any type of verbal abuse, no matter the circumstances or the intended solemnity of the occasion.

If you are reputed to be a conservative, particularly one with influence who will stand in the way of the liberal agenda, a special kind of contempt is reserved for you. And, by definition, you cannot be mistreated because people who stand for the things you stand against are not worthy of respectful treatment.

As a conservative public figure, you are especially vulnerable to attacks from the left when cameras are in proximity because, whether or not the ordinary rules of decorum for events like funerals require an extra measure of politeness, no opportunity can be missed to proselytize to a mass audience.

The religious fervor of the left, in its high evangelical mode of spreading the gospel of liberalism, can be seen in its willingness to ignore the facts in furtherance of advancing its dogma.

It didn't matter that Judge Alito repeatedly provided a convincing explanation for the innocuousness of his failure to recuse himself in a case involving Vanguard, a company in which he had a relatively insignificant financial interest. It didn't matter that he convincingly testified that he was unaware of certain alleged bigoted attitudes of an organization he was supposedly affiliated with in college.

Kennedy and his colleagues were impervious to the actual facts. What mattered to them was that Alito was a conservative, and therefore, even if he was not guilty of those particular ethical infractions, he might as well have been because, to them, conservatives have a dark heart.

This is precisely the same mindset that militated against

Kennedy's colleagues reprimanding him for playing fast and loose with the facts and for treating the eminently decent and respectable Judge Alito indecently and disrespectfully.

It's precisely the same mindset that led reverends Jimmy Carter and Joseph Lowery to take racebaiting, wiretapping and WMD digs at President Bush during the King funeral. Bush hatred is so pervasive that liberal eyebrows were not even raised when the "No Iraqi WMD" mantra was invoked at the event.

And, it's the same kind of mindset that prompted liberal commentator Bob Beckel to tell radio talkshow host Sean Hannity that not only were Carter's remarks not inappropriate (sorry for the triple negative), but civil-rights advocates would have been surprised and rightly disappointed if he hadn't made them. And Beckel is one of the intellectually honest liber-

In case you harbor the fantasy that the mainstream media or liberal blogs will give Carter the brush back, think again. The Washington Post's Howard Kurtz detailed how the media largely ignored Carter's jabs at Bush and quoted a number of liberal blogs expressing outrage at conservative outrage over the Carter outrage. How dare we suggest to them any limits on their licentiousness? Why, that's totalitarian censorship!

So, if you're looking for accountability from the left for the inexcusable behavior of its leaders, get a Hubble telescope. It's not that they don't have the courage to discipline their own. It's that they agree with them, applaud them and encourage them to give it to us even harder next time. They have a higher calling.

So ashamed for Al Gonzales

nce upon a time, in the middle of a nasty constitutional crisis in Washington, a most unlikely hero emerged — a Texas lawyer from one of our state's notoriously discriminated-against racial minorities. Think how lucky we were.

It is one of the most famous sentences in all of American rhetoric: "My faith in the Constitution is whole, it is complete, it is total." But what catches the eye today is the sentence that followed that famous declaration, the sentence that makes one so ashamed for Al Gonzales. Barbara Jordan's great, deep voice brought the impeachment hearings against Richard Nixon to an awed silence when she vowed, "And I am not going to sit here and be an idle spectator to the diminution, the subversion, the destruction of the Constitution."

Thirty years ago, this state could produce Barbara Jordan and now we send that pathetic pipsqueak Al Gonzales. Enough to provoke a wailing cry of "O tempera, O mores!" even from the depths of Lubbock.

As a New York Times editorial succinctly put it, Attorney General Gonzales' Judiciary Committee appearance was a "daylong display of cynical hair-splitting, obfuscation, disinformation and stonewalling."

How fortunate that Republicans running the committee did not insist the chief law enforcement officer of the United States take an oath before testifying. God forbid that he should actually be held to the truth.

I realize it's a cliche for those of us who remember the Beach Boys to mourn the days when giants roamed the Earth and all was on a grander and finer scale. But I knew Barbara Jordan, and I know

Al Gonzales, and it is damned depressing — he's too lightweight to even be a mediocrity.

It seems to me the trumpery excuse for a hearing raised graver issues than those of 30 years ago. Gonzales kept trying to frame the issue as a question of whether or not a domestic spying program without warrants is illegal — in fact, it is against the

law. Gonzales maintained the law is superseded by some unwritten constitutional power due the president during time of war and further that Congress had authorized warrantless spying when giving the president the authority to

invade Afghanistan. Strange, so few who voted for invading Afghanistan recall having warrantless spying in mind.

One problem of legal logic is to "define war." We have not been attacked by another nation — in fact, we were clearly the aggressors against Iraq. We were attacked by a private group of ideological zealots led by a Saudi millionaire. This war — against no nation, flag or territory - can presumably last indefinitely, like our wars against drugs and crime.

Barbara Jordan observed: "(Impeachment) is designed to 'bridle' the executive if he engages in excesses. ... The Framers confined in the Congress the power, if need be, to remove the president in order to strike a delicate balance between a president swollen with power and grown tyrannical. and preservation of the independence of the executive. 'A president is impeachable if he attempts to subvert the Constitution."

Nixon was accused, among other things, of misuse of the CIA. I highly recommend James Risen's new book, "State of War: The Secret History of the CIA and the Bush Administration." Risen is the New York Times reporter who broke the story of the National Security Agency spying scandal.

Thomas Powers, an authority on American intelligence, reviewed the Risen book for The New York Review of Books and notes: "If the Constitution forbids a president anything, it forbids war on his say-so, and if it insists on anything, it insists that presidents are not above the law. In plain terms, this means that presidents cannot enact laws on their own, or ignore laws that have been enacted by Congress. ...

"In public life, as in kindergarten, the all-important word is no. We are living with the consequences of the inability to say no to the president's war of choice with Iraq, and we shall soon see how Congress and the courts will respond to the latest challenge from the White House — the claim by President Bush that he has the right to ignore FISA's prohibition of government intrusion on the private communications of Americans without a court order and his repeated statements that he intends to go right on doing it." The time is coming when some-

one will have to say no. Sadly, I have a vision of the impeachment panel, and I see Tom DeLay in the seat once occupied by the great Barbara Jordan.

Isabelle Dinoire says she just wanted a face like everyone else, which seems like not too much to ask. At a news conferlast week, Frenchwoman who received the world's first partial face transplant showed off the results.

The picture was all anyone wanted to see, and it was reassuring: Her lips were full and her nose was pert. While that might not seem like a medical advance, for Dinoire, that's exactly what it was.

"I have a face like everyone else," said Dinoire, 38. Speaking to reporters in Amiens, France, she said she wanted to resume a "normal life" after her face was disfigured in a dog attack last year. That meant returning home to her two daughters, getting a job and being able to go out in public without stares.

Dinoire received facial tissue, new lips, a chin and a nose from a brain-dead female donor. Dinoire still has difficulty moving or closing her mouth, more than two months after the Nov. 27 operation, but doctors said that should improve over time.

"I expect to resume a normal life," she said. "I pay homage to the donor's family. My operation could help others to live again."

While transplants of hearts,

longer garner much attention, the face transplant drew intense public interest. The face has always been central to a person's identity. It's how we think of each other, how we reflect emotion and pain, and its primacy is reflected in our language.

In other words, how you look is not simply a matter of vanity. "It matters tremendously,"

said author Barbara Robinette Moss, 51, of Iowa City, Iowa, whose face was disfigured as a child because of malnutrition. "It's not just how we identify ourselves. It's how other people identify us. And when there's a problem, when we don't fit into what people consider the norm, you can be ostracized terribly."

Moss empathizes Dinoire's desire to simply look like everyone else. "You want to be able to go to the grocery store without someone insulting you," said Moss, who has undergone two major surgeries. She went online Monday morning because she was so curious to see what Dinoire looked like.

"I think it's going to be beautiful," she said of Dinoire's face. "All the scars down her cheeks a lot of that will completely fade away, and she'll get feeling back in her lips and it will become her face.'

Dinoire still faces hurdles in regaining a normal life. She will lungs and other vital organs no continue taking drugs so her no difference."

body does not reject the transplanted tissue, and the doctors could not say how long the tissue would stay alive. Still, the doctors have asked French health authorities for permission to perform facial transplants on five other patients.

A Baltimore doctor said that once the medical and psychological issues surrounding facial transplant are resolved, it may come to be seen as common and as necessary — as a heart transplant.

"Your face is the most central part of your body," said Dr. Richard J. Redett of the Johns Hopkins Burn Center. "I have patients who have come to terms with facial disfigurement and do pretty well, and I have patients who haven't and they have a very difficult life. The ability to give them a new face I think it would significantly change their lives forever."

Moss hopes facial transplants common. become more Although she criticizes a society that has become preoccupied with beauty, she notes that candidates for facial transplants are striving not to be beautiful but simply ordinary.

"Why do we think we should be able to use someone's heart or their liver or their kidney but there's something wrong with using part of their facial structure?" she said. "There is

Amazing pill that kills the cravings! Go all day without being hungry! Lose weight by losing the urge to snack!

The spam ads that fill our in-boxes and the television commercials featuring actors wearing white lab coats all promise a miracle in a single pill — an appetite suppressant that makes dieting a snap by killing your desire to eat. If smokers have the patch to stop nicotine cravings, why not a pill to eliminate the desire for food?

South African succulent ment. The only known favored by the Spartanlike San Bushmen of the Kalahari desert, may be a dieter's dream — or it could be just another empty promise.

Hoodia first burst onto our consciousness more than a year ago, when CBS' "60 Minutes" sent a correspondent to the Kalahari to try the plant herself. She reported that after chewing on the bitter leaf, she had no desire to eat for almost 24 hours. A BBC reporter soon followed, and he reported the same results.


Interest in the plant skyrocketed after a rumor began to circulate that hoodia is the diet drug of choice for the "Desperate Housewives." But popularity aside, experts say proof that hoodia works is anecdotal, that little research has been done to confirm the assumption it has no side effects, and that consumers who are buying the supplements over the Internet or at health food stores may not be getting they're paying for.

Nutritionists say even if the supplement works, it might be better if it didn't. Dieting by starving the body is not a good idea, says Pam Wilson, chief clinical dietitian at Calif., Ramon, Regional Medical Center.

When the body is starved, the metabolism slows and any calories it gets are stored as fat.

"It can lower our metabolism by 30 percent," Wilson says. "That's not what you want to do if you're trying to lose weight."

That's often a problem with herbs and supplements. The products are not tested and regulated in the same way that prescription medications are. A product may be on the market a long time before a pattern of trouble is revealed. There is a history of weight-loss products that were initially considered benign - fen-phen, ephedra — and later were discovered to cause serihealth problems, some of which resulted in deaths.

"(Hoodia) could be a nightmare," Wilson says. A British pharmaceutical company, Phytopharm, has patented what it says is the active ingredient in hoodia, which the company calls P57. In 1997, the company entered into an agreement with Pfizer to develop hoodia, but Pfizer abandoned the plan, say-

ing it was too expensive to extract and synthesize. Phytopharm has since struck a deal with Unilever, which is said to have begun its own stud-

Some people have questioned whether products boasting of hoodia actually contain the supplement. Critics have argued that there isn't enough cultivated hoodia account for all the products claiming to have it. While the plant grows in the unforgiving sands of the Kalahari, it apparently is not easy to propagate in nurseries or in commercial fields.

Michael McGuffin, president of the American Herbal **Products** Association, says believes consumers are receiving hoodia in products purchased from AHPA members. The association requires its members to comply with federal law and AHPA guidelines, McGuffin

"I know of several companies that import it," McGuffin says. "I've seen several companies selling it on trade show floors and Internet Web sites."

McGuffin says that with herbal supplements as well as prescription drugs consumers shouldn't expect the pill to solve all the problems. They should be treated as aids, he says, not cures.

"There is no silver bullet when it comes to weight loss," McGuffin says. "Drugs aren't silver bullets; over-the-counter substances are not silver bullets; herbs aren't silver bullets. You can't sit on the couch and eat potato it back in five years.'

McGuffin's reasoning seems to be reflected in the instructions packaged with the hoodia pills. Dieters are told that for the pills to work effectively, they must be combined with reduced calorie intake, reduction of carbohydrates and fats, lots of water consumption and exercise. One manufacturer recommends walking one to two miles a day, and drinking one ounce of water for every two pounds you weigh.

Woman accused of severing baby's arms to stand trial

McKINNEY (AP) - A housewife accused of fatally severing the arms of her infant daughter in 2004 was expected to enter a plea of not guilty by reason of insanity when her capital murder

A jury of seven women and five men was selected to hear the trial of Dena Schlosser, which was to begin with opening statements Monday in Collin County. Prosecutors have said they will not seek the death penalty.

Schlosser was arrested in her Plano home in November 2004 after telling a 911 operator she had hacked off the arms of her 10-month-old daughter,

The police found the dying baby in her crib and Schlosser in the living room, covered in blood, holding a knife and listening to a church hymn.

Schlosser had reportedly stabbed herself deep in the left shoulder.

Brush fire burns 1,200 acres in fire-weary region

RISING STAR (AP) - Firefighters scrambled to control numerous wildfires in an area of West Texas trying to recover from a rash of fires earlier this

The largest fire broke out Sunday afternoon in Brown County and burned from 1,200 to 1,500 acres before firefighters controlled it by evening, officials

The fire threatened seven houses, but only one barn was burned. There were no injuries, said Capt. John Wilkerson of the Comanche Volunteer Fire Department

The fire spread from pastureland into

heavily brushed, hilly terrain where several helicopters repeatedly dropped huge buckets of water drawn from a nearby stock tank.

Wilkerson said government agencies and private owners provided bulldozers and tractors to create firebreaks to slow and stop the flames.

White House acknowledges photo of Bush and Abramoff

WASHINGTON (AP) - Sunday, the White House acknowledged the authenticity of the first photograph made public that shows President Bush and embattled lobbyist Jack Abramoff, while stressing it does not mean the two had a personal relationship.

The photo, published by *The New York* Times and Time magazine, shows Bush shaking hands with an Abramoff client, chairman Raul Garza of the Kickapoo Indian tribe in Texas. Abramoff's bearded face appears in the background, small and slightly blurry.

White House spokesman Allen Abnev said the photo was taken in 2001, when the president dropped by a meeting of about two dozen state legislators to thank them for supporting tax relief.

Originally, the White House said it had no record of Abramoff's attendance at the meeting.

"We now know that Mr. Abramoff attended this meeting," Abney said Sunday. "The president has taken tens of thousands of pictures. This does not mean he has a personal relationship with each individual that is in those pic-

The White House would not release the photo or any others that Bush had taken with Abramoff, who helped raise more than \$100,000 for the president's re-election campaign. Abramoff has since pleaded guilty to federal charges related to an influence-peddling scandal on Capitol Hill.

Northeast digs out from record snowstorm; classes, flights canceled

NEW YORK - Road crews scrambled to clear highways for Monday's morning commute and travelers stranded at airports still waited to get. home as the Northeast dug out from a recordbreaking storm that dumped 2 feet or more of snow.

Utility workers were restoring power to tens of thousands of homes and businesses blacked out when wind gusting to 50 mph knocked down power lines.

The weekend storm blanketed the Eastern Seaboard from the mountains of western North Carolina to Maine, dropping 26.9 inches of snow in Central Park — the heaviest since recordkeeping was started in National | the Weather Service said. The old record was 26.4 inches in December 1947.

While the storm was bad, it would have been worse on a weekday.

"It was good timing for a storm of this magnitude," weather service meteorologist Patrick Maloit said.

Fairfield, Conn., got 30.2 inches of snow and Rahway, N.J., had 27 inches, according to unofficial observations reported to the weather service. Just west of Philadelphia, 21 inches of snow was recorded in West Caln Township; the average snowfall for an entire winter in Philadelphia is about 21 inches. On Massachusetts' North Shore, Salem measured 18 inches, and some areas of the state had 3-foot drifts.



That run offered the typical brilliance from this California kid, a 19-year old who got his first endorsement deal six years ago.

days. Her withdrawal is a loss for everyone, USOC chairman Ueberroth said.

"Michelle Kwan means more to the United States Olympic Committee than maybe any athlete that's ever performed for the U.S. Olympic Committee," Ueberroth said. "She's been a leader, she's been gracious, she's somebody that cares for so many youngsters that are training in our coun-

"She's a real loss to all of the United States Olympic Committee and to the United States of America, and I think to the world. She's made a courageous decision."

Olympic officials wasted little time approving the petition to put Hughes on the team. The 17-yearold, younger sister of 2002 Olympic champion Sarah Hughes, was third at last month's national championships.

She said in a Saturday interview with WNBC-TV in New York that she would be ready to travel to Turin if needed.

"Just point me in the direction and I'm there," Hughes said.

But that could be a challenge: Blizzard warnings were posted for the New York City area, where she lives, and dozens of flights were canceled at the city's three major airports.

When Hughes gets here, she'll join Sasha Cohen and Kimmie Meissner on

This was Kwan's last gasp for Olympic gold. Though she's defined the sport for the past decade, winning five world and

nine U.S. titles, she came up heartbreakingly short at the Olympics.

The favorite in both Nagano and Salt Lake City, she settled for silver in 1998 and a bronze in

Now 25, she hung around the past four years for one more shot at gold. But her hopes faded fast.

She missed the Grand Prix season with a hip injury, then missed the nationals with the groin injury.

She looked sharp during a Jan. 27 monitoring session that solidified her spot on the team, doing back-to-back throughs of her long and short programs.

But she said the long plane ride to Italy, followed by marching in the opening ceremony, took a toll. By the time she returned to the athletes' village, she was starting to hurt.

When she woke up Saturday morning, it wasn't any better.

"It's an honor to represent your country. I didn't think twice about not going to the opening ceremony, or not going to practice. I have to get my legs under me," she said Sunday. "When I felt stiff, it's the Olympics, you've to Unfortunately, it happened."

"Doc" in Love Dear Doc: The pharmacies, hospitals and doctors should be keeping records of Lizzie's prescriptions, but it's possible she is obtaining Vicodin in so many different places, or under different names, that they have no documentation of abuse.






