

# Perry makes stop to endorse Landtroop

Texas Gov. Rick Perry made his 1,512th landing on the runway at the McMahon-Wrinkle Airpark Thursday afternoon, as he and several other state officials gathered to endorse Texas House District 85 candidate Jim Landtroop (R-Plainview).

Perry, who was stationed at Webb Air Force Base when he was just 22 years old and learned to fly at the facility that has become a Big Spring landmark, offered his support to Landtroop during a special ceremony at the Hangar 25 Air Museum.

"It's going to be a joy to have someone like Jim in the legislature, who is going to be truly working with us as a team," said Perry, who was introduced to the audience by State Sen. Troy Fraser. "The team approach is very important... We happen to have the same political initial behind our names, but more importantly, we have Texas before our names."

Perry, who is facing Carol Keeton Strayhorn, Chris Bell and Richard "Kinky" Friedman for governor November, said Landtroop will be an asset in the coming legislative sessions.



DALLAS — The state attorney general is using a 2003 law about mail-in ballots to intimidate elderly, disabled and minority voters who typically favor Democrats, according to a civil lawsuit filed Thursday by the Texas Democratic Party.

The lawsuit aims to overturn parts of the **Texas Election Code that** criminalize people who help voters with their mail-in ballots.

The defendants are Secretary of State Roger Williams and Texas Attorney General Greg Abbott, a pair Republicans accused by Democrats of selectively targeting blacks, Hispanics and old people through his voter fraud task force.

The statutes in question

make it illegal for anyone other than voters to possess their own mail-in ballots. That prevents political parties and community activists from helping voters mail their ballots, a "common practice by individuals, political parties and other organizations ... to maximize voter turnout," the

Abbott's voter fraud task force has 13 open cases, all involving Democrats, according to the Texas Democratic Party. Twelve of the 13 defendants are black or Hispanic, and in eight of those cases Abbott prosecuted someone for mailing or delivering someone else's sealed ballot.

#### Officer fatally shot during traffic stop

HOUSTON (AP) - A 12year Houston police officer was shot and killed as he sat in the front seat of his patrol car during a traffic stop, police said.

Citing their ongoing investigation, Houston Police Department officials would not disclose a suspect in the Thursday evening shooting of Rodney Johnson, 40, or details of the incident.

Officer Gary Blankinship, a friend of Johnson's who spent time at the crime scene, said a handcuffed suspect allegedly fired multiple shots at Johnson from the

rear seat of the patrol car. "To get killed on something as minor as a traffic stop really drives home how dangerous the job Blankinship said. "Rodney was a really good police officer. It's just one of those really

tragic events." A suspect had not been charged as of late Thursday.

Johnson is survived by his wife, Joslyn Johnson, an officer with the Houston police, and the couple's five children.

#### Two teens laying on tracks killed by train

HAWKINS(AP) - Twoteenage boys were killed when a train struck them as they lay on a rail line in East Texas, officials said.

The unidentified boys died early Thursday in Hawkins, about 90 miles east of Dallas.

Hawkins police investigator A.J. Randell said the deaths were being investigated as homicides. The bodies of the boys, who carried no identification, were being sent to Dallas for autopsies.

Union spokesman Joe Arbona said the train engineer reported that the teens were not moving as they lay on the tracks. The train was traveling at about 30 mph.

The crew applied the emergency brake, but it takes moving trains at least a half mile to come to a stop once the brake is applied, Arbona said.

#### Radio ad says to arm against evacuees

HOUSTON (AP) - Aradio commercial for a local gun shop advises Houstonians to arm themagainst selves "Katricians," adding to growing tension the between Houstonians and the Katrina evacuees who have been blamed for a rising crime rate.

Gun shop owner and radio talk-show host Jim Pruett said Thursday he started running the ad a few weeks ago after hearing a local television interview with a Katrina evacuee living in Houston who implied he would have to turn to crime if his government assistance ran out.

Katrina evacuees are suspects or victims in 59 of Houston's 262 homicides between Jan. 1 and Aug. 26. Some residents have blamed evacuees for an increase in violent crime rates.

Black activists held a community meeting Thursday evening where they blasted negative stereotypes of evacuees created by Pruett's ad.

#### Air Force says it will fund terrorism study

SAN ANTONIO (AP) — The Air Force has announced that it will administer a \$1 million grant to the St. Mary's University Center for Terrorism Law to study states' protection of information about infrastructure and cyber security.

Funding for the study was included in the 2006 Department **Defense** appropriations bill, but it had been unclear who would administer the grant.

The study has raised concern among some freedom of information advocacy groups and St. Mary's national security interests could trample those of public disclosure.

#### Hutchison removes antitrust wording

WASHINGTON (AP) -Kay Bailey Sen. Hutchison, hoping to push through a compro-Wright mise on the Amendment, Wednesday she removed language from the bill that opponents saw as unwarranted antitrust protections.

Hutchison said the change gives her a majority in moving forward with the legislation, which would lift restrictions on long-haul flights from Dallas Love Field after eight years.

The revised bill no longer includes wording that stated the agreement complies with anti-competition laws and gave the Department Transportation sole authority to decide claims

#### Immigrants found in sealed duffel bags

against the arrangement.

FALFURRIAS (AP) Agents working an immigration checkpoint found three illegal immigrants hidden in sealed nylon duffel bags, Customs and **Border Protection said** Thursday.

None of the immigrants found during the two con-

secutive stops Wednesday was harmed. All declined medical attention, though agents said they were sweating profusely.

In the first stop, agents searched a Dodge Durango with a Border Patrol dog after the driver and passenger appeared nervous. They found five people, \*\* including a woman and 5-year-old in a zipped duffel bag.

The driver, a 39-year-old alumni that U.S. citizen, and the passenger, a 23-year-old U.S. citizen, were arrested and charged with alien smuggling.







#### **Bidding Quiz**

You are South, both sides vulnerable. The bidding has been: East South

What would you now bid with each of the following four hands?
1. ♠ AJ852 ♥ 74 ♠ — ♠ AQ9763 2. ◆.AQ95 ♥ 84 ◆ 93 ◆ KQ754 3. ♦ KJ94 ♥ Q63 ♦ 5 ♠ AK842 4. ♦ KQ73 ♥ Q5 ♦ 8 ♠ AJ9532

1. Three spades. The purpose of this bid is to apprise partner of your 6-5 distribution in clubs and spades. Since you are bidding spades for a second time, you are guaranteeing five cards in the suit. At the same time, partner learns that you have at least six clubs, since you would have bid spades first if the two suits had been of equal length. This would be in keeping with the principle that when holding two five-card suits, the higher-ranking suit is bid first.

2. Pass. Given partner's bidding, this is not a game-going hand. After opening one heart, partner has twice indicated minimum values with his two-heart and two-notrump rebids. In both cases he was fulfilling his obligation to answer your two forcing bids. With more than minimum values, he could have shown more signs of life. Furthermore, you have already shown all your values and have nothing in reserve to add.

Another way of looking at the situation is to apply the general principle that it takes about 26 points to make a game. Since partner has a mini-mum opening bid and you have less than an opening bid, the total adds up to less than game.
3. Four hearts. Game is certain

despite partner's signoffs. However, there is a mild chance for a slam, and the jump to four hearts, in conjunction with your two previous bids, is made to encourage partner to go on with a suitable hand 4. Three hearts. It is not clear at

this point whether the best game contract lies in hearts, notrump or clubs. The best way to define your shortness in diamonds, after having bid clubs and spades, is to show the ability to play in hearts also. Partner will then be in a position to select the best final contract.

Ordinarily, Q-x is not regarded as sufficient support for partner's rebid suit, since partner might have only five hearts. But because there is a good possibility that he has a six-card suit, a trial raise to three hearts (forcing) is perfectly proper.

#### **Bidding Quiz**

You are South, both sides vulnerable. The bidding has been: East Pass Pass Pass What would you now bid with

each of the following four hands?

1. ♠ AJ852 ♥ 74 ♠ — ♠ AQ9763 2. ♦ AQ95 ♥ 84 ♦ 93 ♠ KQ754 3. ◆ KJ94 ♥ Q63 ◆ 5 ◆ AK842 4. ♦ KQ73 ♥ Q5 ♦ 8 ♣ AJ9532

1. Three spades. The purpose of this bid is to apprise partner of your 6-5 distribution in clubs and spades. Since you are bidding spades for a second time, you are guaranteeing five cards in the suit. At the same time, partner learns that you have at least six clubs, since you would have bid spades first if the two suits had been of equal length. This would be in keeping with the principle that when holding two five-card suits, the

higher-ranking suit is bid first.

2. Pass. Given partner's bidding, this is not a game-going hand. After opening one heart, partner has twice indicated minimum values with his two-heart and two-notrump rebids. In both cases he was fulfilling his obligation to answer your two forcing bids. With more than minimum

values, he could have shown more signs of life. Furthermore, you have already shown all your values and have nothing in reserve to add.

Another way of looking at the situ-

ation is to apply the general principle that it takes about 26 points to make a game. Since partner has a minimum opening bid and you have less than an opening bid, the total adds up to less than game 3. Four hearts. Game is certain

despite partner's signoffs. However, there is a mild chance for a slam, and the jump to four hearts, in conjunction with your two previous bids, is made to encourage partner to go on with a suitable hand 4. Three hearts. It is not clear at

this point whether the best game contract lies in hearts, notrump or clubs. The best way to define your shortness in diamonds, after having bid clubs and spades, is to show the abil-ity to play in hearts also. Partner will then be in a position to select the best final contract

Ordinarily, Q-x is not regarded as sufficient support for partner's rebid suit, since partner might have only five hearts. But because there is a good possibility that he has a six-card suit, a trial raise to three hearts (forcing) is perfectly proper.





# Golf Insider

IT'S GOOD FOR YOUR GAME

## Restoring the radius

For purposes of discussion, let's assume that the golf swing is a circle, even though it is not exactly so. The radius of the circle is a combination of the target arm (the left arm for righthanders) plus the length of the club.

With you at the center, the radius is a line extending from the tip of the target shoulder to the bottom of the club face. This line folds into a 90-degree angle when the wrists hinge during the backswing, forming a powerful lever that must be released to the ball just before impact.

In other words, the backswing loses the radius, then the downswing restores it - a power-packed process that requires intricate timing. Restore the radius too early and it's a weak pull, restore it too late and you push it wide of the target.

But there is more than just pulls and pushes in this litany of mistakes. It's obvious that the shoulders are connected to the arms, but what is not so obvious is that the arms swing along the shoulder line, making the shoulders the arbiter of correct radius management.

If the front shoulder drops toward the ball as the club is released, the radius grows longer and you'll hit the ball fat. If it pulls up and away from the ball prematurely, the radius shortens, causing thin shots and, in some outlandish cases, the dreaded whiff.


Why are radius problems so common? I believe the cause is related, at least in part, to the rotator cuff made up of four muscles that connect the collar bone, humerus (arm) and scapula (back). These muscles are covered by the largest and most dominant shoulder muscle, the deltoid.

The deltoid gets a lot of work in everyday life as well as in exercising, such as weight lifting, and it is likely to be more developed than the rotator muscles. Unless care is taken, this imbalance in development prompts the deltoid to override the rotator cuff and causes the problems outlined above.

Research done by renowned surgeon Dr. Frank Jobe and published in his book "30 Exercises for Better Golf" shows that the deltoid needs to be quiet so the rotator group can do its thing: "Our research showed that if you swing correctly, the deltoids contribute relatively little output on either side, while the rotator cuff does considerable work. In all the golfers we studied, the deltoid was virtually inactive throughout the swing."

What can you do to ensure that you're using the correct muscles in your golf swing? Jobe has the answer: "The rotator cuff muscles in the shoulder need to be stretched and strengthened separately, with special exercises that are different from those done for the rest of the

Those special exercises are detailed in Jobe's book, which can be difficult to find. But just hitting a lot of balls using correct swing mechanics also builds up the shoulder joint for golf.

# Langer's absence is felt at K Club

est Palm Beach, Fla. or only the second time in the past quarter-century. the Ryder Cup matches will take place this week without Bernhard Langer being a part of

Langer, a German who makes his home in Boca Raton, Fla., played for Europe 10 times and was captain in 2004 when the Europeans scored their most lopsided win on American soil (181/2-9 1/2) at Oakland Hills.

Langer, 49, ranks second to Nick Faldo in most Ryder Cup points won (24) and most matches won (21) by a European. The only Ryder Cup that Langer wasn't a part of was in 1999, but Langer isn't misty-eyed at his absence from this week's matches at the K Club in Ireland. He instead will be playing in the Valero Texas Open in San Antonio.

"Life goes on. Younger players come along," Langer said. "I don't know what it will be like watching on television, but I'll be watching as much as I can.

Langer had a brilliant game plan at Oakland Hills, instructing his players to mingle with American fans in practice rounds and to interact with them as much as possible (the Americans followed PGA of America protocol and passed on autographs on the course). Langer's strategy seemed to take away some of the home-country advantage.

Langer could have been a part of this Ryder Cup, but he choose not to seek a second captaincy because he felt other top European players deserved an opportunity

Even without being the captain, Langer has gotten plenty of attention because he has spoken with U.S. captain Tom Lehman several times about the Ryder Cup and not European boss Ian Woosnam.

Of course, that's because Lehman — who attends Bible study sessions on the PGA Tour with Langer - approached the German for advice and Woosnam chose not to seek out Langer's expertise. Lehman said he made sure not to put Langer in a difficult situation with his questions.

"It was nothing about strategy or what's going on in the locker room," Lehman said. "It was all about the honor and responsibility of being captain, the impact you have on people's lives. There was nothing that would put him (Langer) in a bad spot with his European teammates.

For his part, Langer tried to downplay the fact Woosnam, who has played in eight Ryder Cups, didn't seek his advice.

'I'm maybe surprised, but I don't know what's going on in his mind," Langer said. "He probably thinks he is experienced enough to handle it. He is doing it his way and I don't blame him for anything, but I thought he might pull me aside for five minutes.'

Since much of the excess cargo will be consumed, Lehman said there should be a room on the plane for the Ryder Cup trophy on the return trip. "If push came to shove, we would be fine," he said.

#### **Playing footsies**

If you're not hitting the ball as far as you should, it may be that you need to rearrange your feet and then change how you use them. There are two things you do with your feet that can sap your power supply: pointing the tips of your toes directly at the target line, and letting your feet lose contact with the ground.

If the tips of your shoes point directly at the target line, you won't be able to do much more than slap the ball with your arms unless you're super flexible. Let the tips of your shoes flare out a bit - the back foot to the right just a shade, and the front foot to the left just a

Moving your feet correctly is another important element of creating power. I see a lot of golfers who pull the front heel directly upward in the backswing and the back heel up too soon during the downswing.

The danger here is that you'll simply lift your target knee straight up without moving it behind the ball going back, and do the same with the trail knee going forward. This can do some serious damage to the amount of tension you're capable of producing.

To accommodate the shifting of your body's weight during your swing, think of "rolling" your weight to the insides of your feet. T.J. Tomasi

#### **ASK THE PRO**

Q: I'm interested in the claw putting grip that Chris DiMarco uses. How does it work? — T.K., from the Web

A: While Chris DiMarco didn't invent his unusual grip, he certainly publicized it more than any other player with his titanic struggle against Tiger Woods in the 2005 Masters. And the best thing about this grip is that it works for him, which is the only

benchmark on the PGA Tour. In order to quiet his overactive right hand, DiMarco creates a major amount of cup in his left wrist, then he curls his right thumb and index finger gently around the handle. The rest of his fingers simply sit on the handle with no force applied at all.

To be a good putter, you need to get both the distance and direction right. He handles the direction using the club face and the left wrist as one every place the left hand goes, the club face goes too.

It's simple — line up the left hand correctly and he's solved the direction part of the equation.

The distance is produced by the left arm swing. Di Marco feels as if his left arm pushes the club head away, then drags it though the ball with no force applied at all by the right hand. While it takes a bit of practice to get

Wins and losses don't always tell the whole story when it comes to high school sports, especially for a young volleyball team that returns one player and has only three seniors on the squad.



# Vanderjagt hopes to silence critics

**AP Sports Writer** IRVING— Scribbled on a strip of tape across the front of Mike Vanderjagt's locker is the phrase,"Less is more."

The full meaning comes when you see another strip of tape going down the left side of his locker. On that one, the new kicker for the Dallas Cowboys has written the distance of every field goal he's missed in the NFL. The list is broken down season by season, with a"B" marking the ones that were blocked.

Less is more, indeed. "That's the motivation: Don't run out of tape,"

Vanderjagt said. It's worth noting that Vanderjagt only jots down his misses from games that count - not preseason and not practice.

So for coach Bill Parcells or anyone else

Vanderjagt wants everyone to know he's not hurt. He hasn't lost confidence. He's not still dwelling on his awful miss that knocked Indianapolis out of the playoffs. And he hasn't gotten lazy because of his \$2.5 million signing bonus.

He's simply a slow starter who knows what he's doing, as reflected by his 87.6 percent success rate, the best in NFL his-

"People just don't know me here," he said."If I was a rookie coming in and people thought, 'Can he really do it?' that would pretty good eight years in Indy. It should've been, 'You know what? He's good. Just let him go,' instead of, 'Oh, my God, he sucks."

The Cowboys signed Vanderjagt expecting to no longer have to worry about their kicking game. Field goals were a constant concern last season, with Parcells blaming three losses on the three kickers he went through.

Vanderjagt wanted to make a good impression early on and pulled a groin muscle. That led to some messed up mechanics, which in turn sidelined him for most of the preseason. Finally given a chance to perform, he missed two short potential winning kicks in overtime of the preseason finale and wound up being inactive for the opener.

Parcells seethed over having to keep a second kicker on the 53-man roster and remains perturbed that he had to use Sunday night against Washington. The Shaun other one, Suisham, was used strictly on kickoffs, which meant one less roster spot for another position.

"That will hurt us even-**Parcells** tually," said."Something will happen where we will suffer from that. There isn't any doubt about it. It may not happen in the next 14 games. But, someday, you do it long enough it will happen."

Vanderjagt hasn't kicked off regularly for years. He believes the Cowboys are better off with Suisham doing it. Parcells even grudgingly acknowledges

# Woods tallies for U.S. Ryder team

STRAFFAN, Ireland — Tiger Woods had a new partner and got a much different result Friday in the Ryder Cup, teaming with Jim Furyk for a 1-up victory over Colin Montgomerie and Padraig Harrington for the first point of these matches.

Woods yanked his first shot into the water and took a while to get on track, but consecutive birdies on the 11th and 12th holes staked the Americans to a 3-up lead, and they held off a late rally by the Europeans.

Ryder Cup victories often mean having the right partners, and Woods had a good one in Furyk. The former U.S. Open champion birdied the opening hole after Woods was in the pond, then made a 25-footer at No. 9 to give the Americans the lead for good.

"I was struggling," Woods said. "I didn't warm up particularly well. Starting off on the first hole, I snapped one in the water. It was nice to have a steady partner

Moments after Woods earned his first opening-day point since the 1999 Ryder Cup, Europe tied the match when the latest edition of the "Spanish Armada" - Sergio Garcia and Jose Maria Olazabalhad no trouble beating David Toms and Ryder Cup rookie Brett Wetterich, 3 and 2.

Paul Casey and Robert Karlsson halved their match against Stewart Cink and J.J. Henry, and the final match appeared headed to the 18th hole, typical of an opening session with so many close games.

Tied at 1 1/2 points each with one match still on the course, the Americans were trying to win the first round of the Ryder Cup for the first time since 1991.

Montgomerie long has been Europe's ringleader, and the Europeans thought if he and Harrington could knock off Woods, as they did when Woods paired with Phil Mickelson in 2004, the momentum could build to a third straight

victory

As the back nine went Monty Harrington did, indeed, appear to be charging toward a terrific comeback. Harrington hit his second shot on the par-5 16th hole onto the green after Montgomerie had gone in the water. Woods and Furyk both chose to lay up. But Furyk's third shot hit the green and trickled into the water, and Woods blasted his over the green and into the rough.

That shaved America's 3-up lead to 1-up in the span of two holes, but it's where the rally ended. Montgomerie made a nice run at a 40-foot birdie putt in an attempt to tie the match on 18, but it scooted past. Moments later, the Europeans conceded,

and Woods and Furyk hugged.

"We had opportunities and just didn't take them," said Montgomerie, who fell to 19-9-5 lifetime in Ryder Cup matches.

Woods improved to 8-11-2 and got ready for the afternoon alternate-shot match, where he and Furyk will take on Garcia and Luke Donald.

In the Garcia-Olazabal match, Wetterich was the only player to reach the par-5 10th in two. He made birdie to cut the U.S. deficit to one. Toms followed with a 40-foot birdie on the 11th that looked like it would square the match, only to watch Garcia make his from 15 feet to stay 1 up.

Wetterich and Toms both went in the water on the 13th and made bogey.
