Judge Gary Refuses to Deal With Unions Cicotte Batted Out Of

FIRST WITNESS FOR EMPLOYES TESTIFIES REGARDING THE ATTITUDE OF THE COMPANIES

WASHINGTON, Oct. 1—Flat refusal to deal with union labor was made to the Senate labor committee today by Judge Elbert H. Gary, chief of the United States Steel Corporation.

In face of repeated questioning, the industrial leader stood without budging on his contention that to deal with union leaders would result in the closed shop, a thing which he declared would be "inimical" to the country and prevent industrial prosperity.

Gary specifically told the commit-

"There is no basic industry in this ecuntry or in the world which has paid higher wages to its employes than the steel corporation or has treated them with greater respect or consideration than the steel corporation."

Gary offered the committee figures which he said would prove the truth of his statements.

"It has been charged that during the existing strike some of our subsidiary companies have been guilty of attacking and mistreating the strikers." Gary continued. "That is without foundation. There isn't a vestige of truth in it."

Gary denied that Mrs. Fannie Snell-ing was killed by any one connected with the steel corporation or its sub-sidiaries. He said she was killed at Brackenridge, Pa., and that his com-

Want to Know What Will Happen If It Is Revised and Then Rejected.

DEADLOCK IS REPORTED TO EXIST IN THE SENATE

Declare If Treaty Fails Men Who Oppose It Must Bear the Full Responsibility.

(United Press Staff Correspondent.)

WASHINGTON, Oct. 1.—Senators today were beginning to hunt the answer to this question:

What will happen if the peace treaty is rejected, either by direct Senate vote or by President Wilson's refusal to accept it with reservations which, in his estimation, destroys it?

Many democrats declare that if the treaty falls, the men who cause its rejection must bear the full responsibility and take action to meet the situation. In such an event they expect the President would decline to initiate negotiation of another treaty with Germany, and would not go out of his way to make easier the task of negotiating such a settleme.

Deadlock Exists.

A deadlock exists in the Senate today. One way out is for the President to yield on strong reservations. Another is for him to flatly refuse them, which might cause rejection by senate vote. Or he could withdraw the treaty from further senate consideration or pigeon hole it when it reaches him with reservations which he considers objectionable.

Some of the President's supporters believe he may yet find a way to yield on, these reservations without seeming to yield too much.

One of the most prominent democrats in the senate who has made it his business to learn the exact situation on both sides of the chamber declared recently that "if senators voted their convictions, there would not be twenty Democratic votes for the treaty in its present form."





NEW YORK STRIKE OF PRINTING PRESSMEN IS OPPOSED BY INTERNATIONAL

U. S. SUBS ARE BETTER THAN GERMAN U-BOAT

WASHINGTON, Oct. 1.—Tests conducted by the navy department show that the much-praised German cruising submarines were inferior in officiency to American vessels of the

officiency to American vessels of the same class.

The enemy craft had less speed above and below water, and had a smaller cruising radius.

The best of five German submarines brought to the United States for the Victory Liberty Loan campaign was used in making the comparison—the U-111, built at Kiel in 1918. In competition with it was the S-3, built at Portsmouth in 1918.

The maximum speed developed by the U-111 was 18.8 knots, while the S-3 made 14.7 knots. Submerged, the U-111 made 7.8 knots, and the S-3 made 12.4. The U-111 can cruise 8,500 miles at 11 knots, and the S-3 made 12.4. The U-111 can cruise 8,500 miles at 11 knots compared with a radius of 10,000 miles at 11 knots, of which the S-3 is capable.

Both boats can carry 12 torpedoes. The U-111 mounts fwo 4-inch guns, while the S-3 carries one, in accordance with the mavy department's practice.

The U-111 is congested and complicated. The S-3 is comparatively "roomy" and much simpler in design.





PLAN A CAMPAIGN FOR CORRECTION OF **SANITARY CONDITIONS**

A sustained fight for the correction of sanitary conditions in Wichita. Falls referred to in the course of discussion by W. S. Curlee, members of the city council, as "deplorable," was initiated at todays luncheon of the

initiated at todays luncheon of the Wichita club.
Co-operation in this campaign from the Chamber of Commerce. Rotary club and Civic League in this fight is to be asked by the club, which voted for the appointment of a permanent committee to take the lead in the fight on present unsanitary conditions which is planned. The decision was precipitated by the request of W. B. Hamilton, chairman of the present public affairs committee to be relieved from the position, saying that a very few minutes investigation of Wichita Falls conditions had convinced him that the undertaking would occasion a fight

minutes investigation of Wichita Falls conditions had convinced him that the undertaking would occasion a fight which his private interests did not allow him time to carry on.

On the protest of the club members, however, Mr. Hamilton agreed to make a sanitary survey of the city similar to one which he had previously made in Austin, and furnish the resulting information to the permanent committee which will be appointed, and which will take the responsibility for carrying on the campaign.

In the course of the discussion over this matter. E. H. Eddleman, secretary of the club stated that he was in Austin, as a special representative of the Texas University and the city of Austin, made a sanitary survey of the city of Austin, which was an issue in local politics for two years following that time, and he believed that he would be rendering the city an invaluable service in making a similar survey in Wichita Falls.

"Fifteen minutes investigation of the situation in Wichita Falls was enough to show me the deplorable state of affairs existing here in the matter of sanitation." said Mr. Hamilton. "Just as an instance, you can walk down any alley in the business section, and you

"Just as an instance, you can walk down any alley in the business section, and you will see open garbage cans, running over with filth, and surrounded by flies who go right from the garbage cans into the kitchens of the nearby restaurants. And this is only a single instance of the conditions to be met with. In this connection, I would like to say that the conditions in the city of Austin at the time I made my survey were not anything like the conditions existing in Wichita Falls today."

"The council has perhaps been somewhat derelict in their duty in this respect," said W. S. Curlee, member of the council, whose efforts in behalf of improved conditions in this respect, had been very warmly attested to by Mr. Hamilton, "But I will say that they are not wholly to blame for the present deplorable conditions, as they have not been getting the support of the town that they are entitled to in this connection. "I think you will find that the council will welcome your assistance in this matter, and that they realize fully that something along this line must be done immediately."

CRITICISE ACTION OF THE WEST TEXAS CHAMBER COMMERCE

Sharp criticism of the action of the West Texas Chamber of Commerce in requesting the appointment of a ter minal manager in Wichita Falls with out consultation with local shippers and against the wishes of Wichita Falls interests, featured the regular Wednesday meeting of the Wichita Falls traffic board, composed of representatives of the Chamber of Commerce and officials of the railroads entering the city.

After considerable discussion the action was strongly condensed.

After considerable discussion the action was strongly condemned in a motion advanced by F. N. Lawton and seconded by M. A. Bundy in which it we stated to be the sense of the meeting that the traffic board was fully satisfied with traffic conditions existing at present time and with the co-operation they were receiving from the officials of all railroads entering this point. Hubert Harrison, secretary of the board, was also instructed to ask officials of the West Texas Chamber of Commerce for their reasons for making this request for the appointment of a terminal manager at this place, without consultation with local interests and knowing the opposition of Wichita Falls shippers to this arrangement, and further to request that in future anything affecting Wichita Falls Chamber of Commerce.

"I believe that we can better take care of the situation here than they can take care of it for us," said T. B. Noble, chairman of the board in this connection.

Measures being taken by the Denver to increase their power in the Wich-ita Falls district, were sketched by S. for a week yet, according to information available at headquarters today, since not all of the government supplies have been shipped out.
