

## MINERS ENHORSE SETTLEMENT

### NIKOLAI LENINE HAS NEW PEACE OFFER TO ALLIES

Is Being Forwarded to London By British Representative Baltic States

### PROMISE TO ABOLISH THE REIGN OF TERROR

Also Agree to Discontinue Activity of the Revolutionary Tribunal

STOCKHOLM, Jan. 7.—Nikolai Lenin, Russian Bolshevik premier, has made a new peace offer to the allies, which is being taken to London by Colonel Tallent, British representative in the Baltic states. Among other conditions included in the offer is a promise to discontinue the activity of the revolutionary tribunal, according to an Estonian newspaper.

LONDON, Jan. 7.—The recently launched Polish offensive against Bolshevik forces in northwest Russia was inspired by the Allies to force the Reds to withdraw from the southern front, where their armies are putting the finishing touches to General Denikin's forces, a Moscow wireless dispatch claimed today.

The Reds also claimed capture of Baranov, an important port of the sea of Azov. Denikin forces defending Baranov fled partly in steamers and partly along the coast, the Bolsheviks asserted. A dispatch to the Times from its correspondent at Abo, Finland, today said fighting had been reported between the North Russians and Karelians and that intervention by Finland to help the Karelians was probable.

Another Bolshevik wireless claimed that the Russian government in Siberia, had resigned. The Bolsheviks also claimed resignation of Chairman Lunacharsky of General Denikin's special council.

Premier Lenin of the Soviet government is making every effort to placate the people of South Russia, it was indicated.

A Moscow wireless said he had allowed the Ukrainian proletariat and the societies of peasants and workers to determine their own national future.

STREALS COLLECTION BOX AT DAME CATHEDRAL

DALLAS, TEX., Jan. 7.—A man disguised as a woman yesterday afternoon stole a jewelry box from the Sacred Heart Cathedral. "She" then went to the home of Mrs. A. C. Carter and asked to use the bathroom. When the thief left, the jewelry box was found behind the bath tub. Friends eyed casual pedestrians with renewed interest today.

ROBBERS OF BANK ESCAPE WITH A FEW POSTAGE STAMPS

OLATHIE, KAN., Jan. 7.—The vault of the State Bank of Olathie, Kan. miles east of here, was blown up by five armed bandits early today who escaped with \$3,200 in postage stamps after wounding John Schaefer, a resident of the bank.

The town was awakened by an explosion about 5 a. m. and Schaefer, who rushed to the bank, was fired upon by one of the bandits.

### PETROLEUM IS SPOUTING SINCE RECENT QUAKE

Hundreds, Possibly Thousands of Lives Lost in State of Vera Cruz

### ESTIMATE A THOUSAND KILLED AT COUXTLAN

Three Slight Shocks Were Felt Tuesday Detected Only by Instruments

MEXICO CITY, Jan. 7.—Hundreds, possibly thousands of lives were lost as a result of the earthquake which shook Vera Cruz Saturday night. So widespread was the damage done and so wide some of the sections that suffered from the quake that it is probable the number of casualties will never be known.

Private dispatches received here from Vera Cruz and Jalapa state that 1,000 persons lost their lives at Coxtlan. These reports, which are said at both cities to be reliable, confirm information given out last night by presidential military headquarters. Thirty lives were lost at Tecoala, where three churches and 40 houses were destroyed.

Volcanic eruptions have occurred at Coxtlan de Perite, from which point the volcano of Orizaba the shock seemed to center, according to rumors. Flood waters pouring down the Papacosta river have inundated Tehuacan, Huasteca and Tlaxcala, while many ranches are under water. Durango Grande and Los Simones are also suffering from floods. It is reported from Vera Cruz, twenty bodies have been recovered from the Papacosta.

There were three slight shocks yesterday, according to information given out yesterday evening at the astronomical observatory at Coxtlan. They were so feeble that they could be detected only by instruments. Subterranean noises are still noticeable in the Papacosta.

Great cracks have appeared in the earth. Travelers returning here from Vera Cruz say some streams were dried up as a result of the shock and it is feared that many miles near Orizaba which depend upon water power will be compelled to close.

At least a thousand persons were killed

MEXICO CITY, Jan. 6.—General Francisco Uruquiza, secretary of war, announced late today he had received official advice that at least one thousand persons were killed at Coxtlan in the state of Vera Cruz in Saturday night's earthquake.

Dispatches indicated that with clear away of the wreckage, the toll of the earthquake all through the state was much heavier than at first believed.

The war department advice indicated that about 300 were dead at Barranca Grande and Chilochila. In many villages in the Jalapa district of Vera Cruz all houses and property were destroyed, according to the advice to the war department.

Government officials expressed hope that because of poor communication and consequent possibility of exaggerated reports, it would be found when the final check-up is made that the death toll may not be as large as the present figures indicate. They admitted, however, there can be little doubt the devastation is widespread. Floods and fires added to the suffering in many districts. Thousands of persons are known to be homeless and many threatened with starvation.

The crippling of the railways and the flooded roads have made difficult the work of sending relief. Handicapped, it was reported, in many districts have taken advantage of the situation to plunder and rob the homeless people of the few remaining possessions.

NEW YORK, Jan. 7.—The celebration of "Prohibition Eve" January 13 promises to surpass any New Year's Eve event in the history of New York, judging by the rush of applications for reserved places at the Waldorf Astoria, the McAlpa and other hotels announced today that patrons who wished to be present at the "swan song" of the old, the new, the waning of the old, the coming of the new.

The patrons will carry to the tables their own wines and other alcoholic liquors, and celebrate in honor of the last time, "the passing of the old, the coming of the new."

Chain of Circumstantial Evidence Is Collected by District Attorney

MOUNT CLEMENS, MICH., Jan. 7.—Lloyd Prevost today stood definitely charged with slaying his friend, J. Stanley Brown, whose body was found Dec. 24 in his auto on a road near here. Prevost is a cousin of Brown's wife.

Attorney General Grosbeck, who conducted the secret investigation, asked for the warrant and Prevost was arrested last night. Malcom county authorities today believed they had a complete chain of circumstantial evidence upon which to press their charge against Prevost. Since there were no known witnesses, they said the prosecution will be based entirely on circumstantial evidence.

Witnesses were found who can check up on every hour of Prevost's time the evening of the murder, officials said.

With the arrest of Prevost, the release of Cecil Beatrice Vester, arrested on information given by a former friend, Gladys Summit.

It was said today other arrests are unlikely immediately.

After careful investigation authorities said today this theory of the crime was developed:

Brown and Prevost were seen riding about town in Brown's car the evening of Dec. 25 until about 9 o'clock.

In his first alibi Prevost said he left Brown alone and went to bed.

Erwin went to the home of Arnold Marzen, a relative by marriage, where he remained until nearly 10:30 p. m. He said, according to the report, he went to meet Prevost and search for some buried liquor along the road where Brown's body was later found.

### TOTAL OF 499 ARE HELD FOR DEPORTATION

Fifty-Eight Are Added to Group of Alleged Alien Radicals at Ellis Island

### RAID IS MADE ON THE ORGAN OF COMMUNISTS

Fourteen Men, One Woman and Large Quantity of Literature Were Seized

NEW YORK, Jan. 7.—Fifty-eight persons were added to the group of alleged alien radicals at Ellis Island during the last 24 hours, bringing the total held there for deportation hearings to 499.

Department of justice agents continued their raid yesterday. Topping the day's activities was a sudden descent upon the Navy Mir, organ of Communism, at one time edited by Leon Trotsky, 14 men and one woman and a large quantity of literature were seized. Dr. Victor Pachachsky, an associate of Trotsky, was among those arrested.

Pachachsky was connected with the revolutionary movement in Russia in 1907 and was exiled to Siberia. He escaped and made his way to Germany and South America. He came here with Trotsky in 1918 after working with Lenin in Switzerland. He is known as a lecturer on radical subjects.

ORDER DEPORTATION OF LUDWIG MARTENS

WASHINGTON, Jan. 7.—A warrant for the arrest and deportation of Ludwig C. K. Martens, self-styled ambassador of the Russian Soviet government, has been ordered executed by the department of justice.

Martens, regarded as a spy, was in the United States, was said to be in Washington. His arrest was expected soon.

To provide a place of concentration for the radical aliens taken in the recent raids by the department of justice, the department of labor today took steps to re-open Ellis Island to its full capacity.

Assurances have been received that sufficient funds will be forthcoming from congress to enable the bureau to handle the deportations without difficulty, it was said.

HEARINGS BEGIN AT ELLIS ISLAND TODAY

NEW YORK, Jan. 7.—Hearings in the cases of more than 500 alleged radicals held at Ellis Island on deportation proceedings began today.

They were singly taken to small hearing rooms to re-open Ellis Island to its full capacity.

### STILL ANOTHER AMERICAN HAS BEEN MURDERED

Employee of Penn-Mexico Company Is Killed at Tuxpan December 21

### PROMPT INVESTIGATION OF MATTERS PROMISED

Petition Forwarded to Senators Requesting Demand Be Made for Reparation

WASHINGTON, Jan. 7.—The Mexican government has been called upon by the state department to use every means possible to apprehend and punish the murderers of F. J. Roney and Earl Boyle, American oil men in the Tampico fields.

WASHINGTON, Jan. 7.—Gabriel Porter, an American citizen in the employ of Penn-Mexico company, was shot and killed by a Mexican federal officer at Tuxpan on December 21, according to advice received by the state department today from the American consul at Tampico.

The consul immediately was ordered to report further information and if the circumstances warranted, to urge the local authorities in the Tampico district to arrest and punish the guilty persons. This makes a total of 30 Americans killed in the Tampico district by Mexicans since April, 1917. Eighteen of them were employed by American oil companies.

The Mexican authorities first reported that Porter had been accidentally shot by a companion in a party returning from a dance. Investigation by the Penn-Mex officials and by the American consul was said to have developed, however, that he was shot by an army officer. Porter's home in Fullerton, Calif., yesterday the consul at Tampico reported the murder of F. J. Roney and Earl Boyle, oil men employed in the Tampico fields. The state department immediately instructed the embassy at Mexico City to urge the state department immediately to take steps to bring the guilty to justice and to the Mexican government for the punishment of the murderers.

The state department so far has been advised who murdered the Americans, F. J. Roney and Earl Boyle, but the American consul at Tampico has been instructed to make a report on the details of the crime. The American embassy at Mexico City also has been directed to make urgent representations to the Mexican government for the punishment of the murderers.

It was believed here today that the Americans were killed by roving bands of Carranza soldiers. The belief was expressed that the consul at Tampico certainly would not have notified the state department so quickly of the murders had they been the result of a fracas among employees of the oil company or had they been committed by native Mexicans under circumstances which tended to show that the Americans were in the wrong.

It was pointed out here that the Carranza troops are in absolute control of the Tampico oil district, in which the Americans were killed, and that therefore it was not likely that there was any organized band of bandits operating there.

KILLING OF AMERICANS WILL BE INVESTIGATED

SAN ANTONIO, Jan. 7.—The slaying of the Americans, Earl Boyle of Houston, Texas, and F. J. Roney of Houston will be promptly investigated by the national association for the protection of American rights in Mexico and the facts laid before the Full Senate sub-committee investigating the Mexican situation which opens hearings here within the next few days, according to Joseph T. Quail, field secretary. The association today is endeavoring to get in touch with Tampico.

Rose Bowles of San Antonio, a Tampico oil man here once, yesterday received a telegram from the International Petroleum Co. at Tampico, advising him of the death of Boyle and asking him to communicate the relatives as to the disposition of the body. Bowles is no relation of Boyle.

A telegram signed by 60 citizens of Thordale was sent last night to U. S. Senator Culberson and Charles E. Deming, secretary of the Texas Commission for the International Petroleum Co. He was born and reared on a Milan county farm near Thordale, Texas, where his parents reside. He leaves three brothers and three sisters. The funeral will take place at Thordale.

### BY VOTE OF 1,639 TO 221 THE CONVENTION APPROVES THE PLAN OF PRESIDENT WILSON

### RESOLUTION OF ENDORSEMENT IS ON PROGRAM

Democratic Leaders Plan to Give Their Approval to President and the League

WASHINGTON, Jan. 7.—A resolution endorsing President Wilson's stand on the peace treaty and commending his efforts to establish a league of nations is to be laid before the Democratic national committee at its meeting here tomorrow with the backing of the committee officials.

"If I have anything to do with it," said Chairman Cummings today after consultation with various party leaders, "the resolution will be so clear as to leave no doubt about our position. We are behind the President."

The announcement that formal action by the committee would be taken was taken as enhancing the prospect that the treaty would be passed by the committee. The general expectation was that the committee would adopt the resolution, helping to open the way for discussion of the subject at the Jackson Day banquet Thursday night.

Both in a letter from President Wilson and in a speech by William Jennings Bryan, the treaty is expected by committeemen to be brought forward by the committee. What they will say and how far their views will coincide was the subject of spirited discussion today, some leaders forecasting an interesting situation should they seemed opposite.

The committee resolution is understood to go no further than endorsing the position of the President, avoiding any direct declaration for ratification without reservations. Mr. Cummins said that the views of the executive had been made known in numerous addresses and messages and needed no interpretation.

The fight over the place of this year's national convention also to be decided tomorrow, became more spirited today. Of the six cities asking for the honor, only three seemed to be serious contenders. They were San Francisco, Kansas City and Chicago, with the two former making the most vigorous fight.

Meantime committee officers heard from St. Louis, which withdrew from the race some weeks ago, might again extend an invitation before the selection is made. Party representatives from Missouri said, however, that no active fight would be made unless the committee decided that San Francisco, Kansas City and Chicago were unacceptable.

OHIO DEMOCRATS ATTEMPT ELIMINATION

YOUNGSTOWN, O., Jan. 7.—Ohio Democrats today will try to eliminate either Senator Alton Pomeroy or Governor James M. Cox from the list of potential presidential candidates at a meeting in Washington following the Jackson Day rally.

The announcement was made today by National Committeeman E. H. Moore before leaving for Washington. Mr. Moore said that the latter country agreed to abandon its claims in Eastern Galicia.

COLUMBUS, O., Jan. 7.—The United Mine Workers of America in convention here today ratified the action of the international officers in accepting President Wilson's proposal to end the coal strike on a 14 per cent increase in wages and a commission to draw up a new agreement.

The vote was taken just before noon after President Lewis had made a plea for ratification. The vote was taken on the motion by President Murray of the Pennsylvania miners' organization that the report of the international officers be accepted. According to Acting President Lewis, the ratification carries with it acceptance of any award to be made by the President's commission. The vote was 1,639 for ratification to 221 against.

MEXICO TO COMPILE A LIST OF KILLED

MEXICO CITY, Jan. 7.—Commenting upon similar action by the United States the foreign office announced today that Mexico had been instructed to compile lists of Mexicans killed, robbed or otherwise mistreated in America.

The lists will be designed to show Mexico has as much cause for complaint of treatment of her citizens in the United States as that government has over-treatment of its citizens in Mexico. It was said.

THREE HUNDRED ARE ARRESTED IN RAIDS

BUTLER, PA., Jan. 7.—Three hundred persons were taken in raids conducted at Lyndora, Pa., here, by department of justice agents and troops of the state constabulary during the night. Fifteen known leaders of the "Communist party" were detained. The rest were allowed to return to their homes.

ACCIDENTALLY KILLED IN VIEW OF COMPANY

PITTSBURGH, PA., Jan. 7.—Gabriel Porter, an employee of the Penn-Mex Company was accidentally killed at Tuxpan, Mexico, December 21, in view of the company officials here.

The report which we received from our Mexican manager was to the effect that Porter met his death accidentally. It was said at the company's office. "We do not know what gives the state department has, but we believe that our information is correct."

STATE ASSEMBLY VOTES TO EXPEL SOCIALISTS

ALBANY, N. Y., Jan. 7.—By an almost unanimous vote the state assembly today voted to suspend the five socialist members who were elected to the assembly in November. They will be permitted to appear for an examination before a committee later on.

FIRE DOES \$60,000 DAMAGE AT FORT WORTH

FORT WORTH, Jan. 7.—Fire that did \$60,000 damage in the warehouse area, bounded by Thirteenth, Fifteenth and Throckmorton streets, and Jennings avenue, broke out at 3 a. m. today and was not controlled until almost daylight.

## Report Villa Surrounded And Capture is Expected

GALVESTON, Jan. 7.—Francisco Villa is surrounded by Mexican federal troops in the desert of Mesquero (between the state of Chihuahua and Coahuila, and his capture is expected momentarily, according to advice received here today by Mexican Consul G. M. Fierro. Generals Murguia and Delgado are in command of the pursuing columns.

## GERMANY HAS NOTE OBJECTING TO THE PROPOSED TRIAL FOR THE SCUTTLING OF INTERNEED FLEET

PARIS, Jan. 7.—Germany has sent a note to the peace conference objecting to the proposed trial of Teuton officials which scuttled the interned German fleet at Scapa Flow by an allied tribunal. It was learned today.

The Germans also renewed their objections to give up the light cruisers demanded by France, declaring their surrender would leave Germany without sufficient ships of this type for necessary patrol duty.

The note reiterated the German demand that marine materials demanded in the Scapa Flow compensation article of the protocol had been sold since November 5, 1918, as the allies have claimed.

Germany said she did not object to the absence of American representatives on the various commissions charged with the execution of the peace treaty which is to be declared effective Saturday.

The Hungarian delegation has arrived here to prepare for bringing about peace between Hungary and the allies.

## McADOO SENDS A MESSAGE TO BE READ AT BANQUET

CONTENTS NOT DISCLOSED BY FORMER SECRETARY OF THE TREASURY.

### DECLINES TO TALK POLITICS

Two Days Plan to Leave in Wichita Falls on Monday.

The heading for one chapter, perhaps the most interesting in the nation's history might be written today in the *Wichita Times* if W. G. McAdoo, visiting in this city, had not started his business career as a copy boy in a newspaper office. Mr. McAdoo has been a member of the Democratic committee since 1912, in Washington, D. C., but his early newspaper training, including a knowledge of the danger of releasing information in haste, has kept him from doing so.

Local Democrats would give much to know what that was from a former secretary of the United States treasury, and a probable nominee for the presidency. Mr. McAdoo, however, frankly admitted to a representative of the *Times* this morning that he had not the message from Wichita Falls.

"I am not here to discuss politics, but simply to handle certain legal matters. I am out of public life."

"There are many voters who refuse to accept that," the reporter suggested.

Appropriate Tribute.

"If any single individual feels that I should be a candidate for any public office," Mr. McAdoo answered, "I most sincerely appreciate the tribute, but inasmuch as I regard myself as a private citizen, not holding office and engaged only in private business, I cannot consider it proper for me at this time to discuss politics."

Questioned whether the Democratic party's platform could be expected to contain any plank that might promise even some slight measure of relief to the thousands suffering from the economic cost of living and the general industrial unrest, Mr. McAdoo smilingly decided at once that the question was "too broad."

"No man can hope to discuss those two problems, or promise anything regarding them, without uncovering such detail as would keep him talking indefinitely," Mr. McAdoo said. "Legislation has done a great deal and wise legislation can do a great deal more. But legislation alone cannot increase production; you cannot force a blade of wheat to grow simply by passing a law that it shall grow. Many of our most serious problems must be solved by individual and co-operative effort and education and the development of community interest in all matters affecting any community's welfare."

Side-Steps Discussion.

Mr. McAdoo also "side-stepped" discussion of the fuel situation, declaring that he had committed himself on that topic; that the commission he had sought to investigate the cost of operators' profits had been appointed and that he believed the results obtained by the commission will justify his earlier charges.

"You can say for me," however, he continued, "that on this my second visit here, I am more than ever impressed with the growth of Wichita Falls and its favorable prospects. I am sorry to find the transportation facilities so inadequate, especially as regards passenger facilities. This section has grown so rapidly that the railroad facilities have been unable to keep pace, and an increase in those facilities is badly needed. It is not the government's fault. We cannot blame everything on federal control, as the situation here would undoubtedly be the same with any other city of the railroad. We should all pull together to get the facilities needed, and to build the city right. It will be brought about in time, but the results will be obtained quicker if the leading men in the life of the city and in the life of the railroad companies join in earnest effort to meet the situation."

The regard in which Mr. McAdoo holds Wichita Falls, as a city of opportunity is shown in his statement that two of his sons, W. G. McAdoo Jr. and Robert H. McAdoo, will probably locate in this city, to engage in the oil business. Both of the young men were in the United States army aviation division for two years, and were discharged in February, 1919. The younger son, Robert H., is in Princeton university, but expects to leave there next month, and come to this city. W. G. McAdoo Jr., who is here with his father, will remain in this city.

Mr. McAdoo expects to be in Wichita Falls throughout this week.

## PUBLIC HEALTH NURSE IS READY TO ASSIST WITH CHARITY CASES

Wichita Falls Red Cross public health nurse wants something to do. Miss Mary Quinn, who arrived last week from Austin to take up the duties of public health nurse, working under the Red Cross, is up to date finding too much leisure on her hands, and is taking this means of asking the physicians of the city to call on her to assist them in charity cases, or in cases where the individual can not afford a full time nurse, or need instruction as to the home care of the patient.

Miss Quinn has just finished a course at the School of Civics and Philanthropy in Chicago, and is very enthusiastic over her work. She is anticipating a very interesting line of activity in Wichita Falls, and hopes to find as much demand for her services as she was told there would be. When Dr. West, the county health officer, secures an office for the full time health nurse, which the county is maintaining under the Rockefeller Foundation, Miss Quinn will have an office with the board. For the present she can be reached at the office of Dr. Beckman and Walker. Anyone desiring her services should call phone 713.

"Many people do not understand the meaning of a public health nurse," says Miss Quinn. "She is a graduate nurse doing any form of social work in which the health of the public is concerned and in which her training as a nurse comes into play and is recognized as a valuable part of her equipment. She may be an infant welfare nurse, a school nurse, a medical social service worker, a tuberculosis nurse, an industrial nurse, a district or visiting nurse. If she is working alone in a small community, or in a rural district she may combine these functions."

The first duty of the visiting nurse is the bedside care of patients in their homes, and the instruction of the family in how to give the care between her visits, the teaching of health habits and demonstration of how health rules may be carried out. She goes to rich and poor alike, caring for cases only when there is a doctor in attendance."

**FOSTER IS RELEASED ON A \$500 BOND**

W. W. Foster, charged with complaint in federal court with theft of an interstate shipment of commerce, was released Tuesday afternoon on \$500 bond. Foster has been retained here as a federal prisoner in default of bail since his arrest last October. Foster was represented in his bond proceedings by an attorney from Cheney, Kans., the defendant's home town.

Jack Hollingsworth, returned soldier, was acquitted of charges of vagrancy, by a jury in county criminal court Tuesday afternoon. Trial of the case occupied most of the afternoon following which trial of criminal cases was postponed until Wednesday afternoon.

**"HOMELESS DOG" IS EXTINGUISHED IN SEAMONT**

SEAMONT, TEX., Jan. 7.—The "homeless dog" is extinct in Seamount, the chief of police announced following a street round-up of unlicensed dogs in which 400 were killed. License records show only 500 dogs in the city, or one to 100 persons.

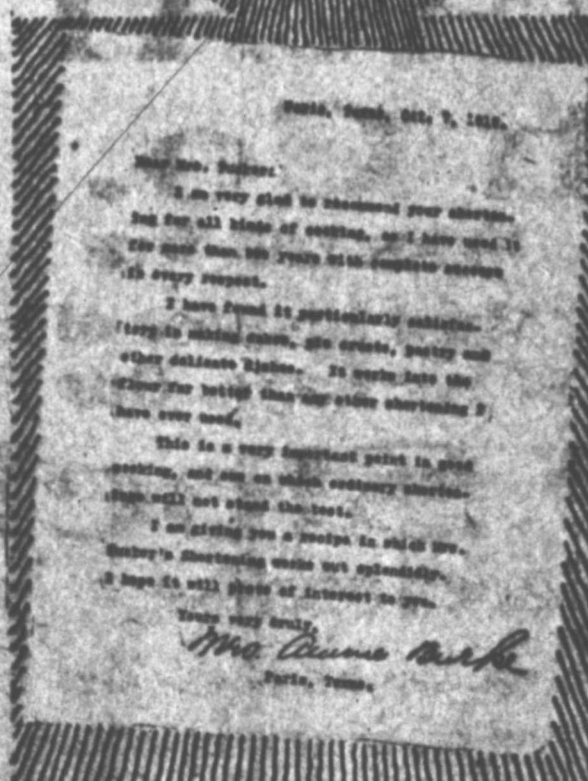

The playwright received me in the green room adjoining Miss Taylor's dressing room.

Hold! No lifting eyebrows, please. The merry little star with the nose of pathos in her voice, in private life a happy and devoted wife, Mrs. J. Hartley Manners by name. The Taylor-Manners combine is not for stare purposes only. It is for home use as well.

On His Guard.  
"My word," exclaimed Mr. Manners, when I explained what I had come to ask. "When are women most interesting? That is rather an awkward question, isn't it? One scarcely would dare risk answering it, would he—with his wife in the next room?"

"Now Hartley," came a laughing voice from behind the dressing room door, the slightly closed door, "you know you are not competent to answer. How could you when you've had only one wife?"

"You see," agreed the accused, "Mrs. Manners is right. I am a poor judge, a very poor judge."

"But surely," I insisted, "you might mention some one age when woman is more attractive than another."

"Yes, I might but"—from the other side of the door—"it took him 10 years to get his wife into the twenties and now he has her in, he can't get her out again."

"There you are," deprecatingly, from the husband. "A chap would no more dare tell his wife's age than—well, you have no idea of what a hideous lot of trouble such a confidence might cause him. "I know what I will do," he declared. "I refuse to be intimidated. I shall say exactly what I think on the subject."

Strict silence on the other side of the door. What might best be termed a "listening" silence.

Youth Scores—Almost.  
"The most interesting age is from 15 to 18 years, when the first call of youth comes with all its imaginings."

"There is nothing so pure, so high, so free from the taint of selfishness of the world as the dreams of a young girl. Castles in Spain are lovely places in which to live, with rose vines trellised to their windows and the soft thrum of music echoing through their shining halls."

"Youth does not ask if the roses must fade, if the sound of the music will be hushed. Youth believes. Imagination bridges over every gap of doubt, colors every canvas with gayety, lines every cloud with silver. An enviable age, the age of youth."

The silence on the other side of the door continued. So did Mr. Hartley Manners, playwright.

"The most interesting age of woman is from 18 to 21 years, when romance enters in and the world takes on a different tinge."

"In birdland we might call this age the mating age. Not every girl finds her mate during those three precious years. At this time she realizes the full meaning of love. Romance grips her. The love affairs of her friends are fascinating chapters in the book of life. Cupid is her patron saint, a bow and arrow her talisman. A magic age."

Still silence beyond the door. But Mr. J. Hartley Manners was not still. He had started, and he meant to finish, despite discouraging silences.

"The most interesting age of woman is when the realization of perfect womanhood crystallizes in the wife and mother."

"Above all, a woman is most interesting when, as a complete woman, she wields the full power of effort and influence and shares in the destiny not only of her family but of her country."

There was no mistaking the rustle now. It grew into a muffled applause. Apparently the Taylor half of the combination approved of the Manners handling of the topic.

"I never realize the value of a good woman so much as when I see her in the midst of her family, using her nature mother influence to secure for her family the greatest possible amount of success and happiness," continued the speaker. "I might say never so much with but one exception—and that is when she has renounced even her hunger of motherhood and placed on the altar of country her very heart's blood—her husband, father, brother, sweetheart and last and greatest of all, her sons. A magnificent age, the age of completed womanhood."

"But, Hartley," from the other side of the door, "you've named three distinct ages and you've said each one was the most interesting."

Verdict for All Ages.  
Mr. Manners smiled. His dark eyes danced a whimsical delight. His boyish face was mellowed by laugh furrows. He ran his hand over his dark hair to smooth out the curl that had surreptitiously crept in and there was triumph in his voice, as of a man who has saved a delicate situation and disposed of it creditably.

"Exactly," he retorted. "I've named four ages, and every one of them is the most interesting. What I mean is interest can never be a question of age."

"I can spend hours playing with a little girl, a child of 12, and enjoy every moment of it, providing she is an interesting child. On the other hand, I like nothing more than to have an entire afternoon in which to chat with a grandmother, providing she is an interesting grandmother. The most beautiful creature on earth, who was neither interested nor interesting, would bore me to death in five minutes. The woman who desires to be interesting should study herself. She should discover her most effective ways of arousing genuine interest. It is certain to be a highly profitable study. Worth trying."

Why, Hartley, a face with wide gray eyes and hair inclined to tawny appeared at the narrow crevice in the doorway. "I never suspected you thought so seriously of this subject."

Playwright Manners smiled like a bashful boy at a kissing party.

## ANNOUNCEMENT STIRS INTEREST IN HEAVYWEIGHT BATTLE PLANNED FOR TIJUANA, LOWER CALIFORNIA

LOS ANGELES, Calif., Jan. 7.—J. Dempsey, heavyweight champion of the world, woke up this morning to learn from the public prints that he and George Carpentier, whom he had expressed a desire to meet in the ring, would meet some time soon at Tijuana, Lower California.

James D. Coffroth, recently obtained an agreement from Dempsey's manager, Jack Kearns, for the champion to fight Carpentier at Tijuana and Carpentier's manager, who brought word that Carpentier's managers had agreed to the match. The only stipulation was that if he was not over 15 pounds in length, and at this Coffroth in San Diego, expressed no disagreement.

A fight of that length ought to be decisive, especially with heavyweights, he said.

Every effort to reach Dempsey or his manager here failed last night. Reporters who flung the door bell at Kearns' Hollywood home were answered only by blank dark windows and silence. Nobody could find him either to tell him the news or obtain his comments.

**Date Not Selected.** Regarding the date for the match, Coffroth, in a statement given out at San Diego, said he could not fix it definitely, although he expressed a desire to hold it as soon as the arena he plans could be constructed at Tijuana. This arena, he announced, would cost \$1,000,000. Construction, he declared, would take several months.

The site of the arena will be near the track and big grandstands of the Lower California Jockey club. Referring to participation in the negotiations by Charles Harvey, his representative in Paris, Coffroth said the only instructions given to Harvey were to offer the best terms possible to Carpentier's manager.

"Until I hear from Harvey or Dempsey," he said, "I shall be more in the dark, of course, but it will not take long to start operations here when we hear from the other side. I am sure I am not over sanguine when I say I hope for an attendance which will total \$1,500,000."

**Tijuana Accessible.** There will be no trouble in getting the crowd here, San Diego men said, a direct railroad line to the east which passes through Tijuana. Those coming from the north will take other lines or steamships for automobiles.

"Naturally, I should like to have the fight in the summer time, when we can be absolutely sure that the weather will be good. But the most depend largely on what the boxers themselves say about it."

The division of the money is another question which the boxers must decide. That it will be the greatest match the world has known, at least in the point of interest, is certain. It is more than national; it is more than racial. Everyone knows of Carpentier's fame from his war fame; everyone has a good idea of what Dempsey can do. The whole world will be interested in the outcome.

**ANNOUNCE DATES FOR CHAMPIONSHIP EVENTS**

NEW YORK, Jan. 7.—Dates for a number of A. A. U. championship events have been announced by Fred W. Ruben, chairman of the A. A. U. committee.

The national boxing championships are to be held in Boston April 5 and 6; the wrestling championships in Birmingham, Ala., April 13 and 14; basketball at Atlanta, Ga., the first week in March and the tug of war in New York March 15.

## TIJUANA WILL GET DEMPSEY-CARPENTIER FIGHT SAYS KEARNS

LOS ANGELES, Jan. 7.—Tijuana, Mexico, will get the Dempsey-Carpentier fight, said Jack Kearns, manager for the world's champion, when advised today by the Associated Press of George Carpentier's conditional acceptance of Promoter Coffroth's offer. Kearns said he would prepare a further statement within a few hours.

NEW YORK, Jan. 7.—Back in the old wild and woolly days they used to back a six shooter when they were in quest of a fight. Now they do their gunning with contracts.

With a pair of signed papers protruding from their hip pocket rendezvous where the old timers told their shooting of trons, two noted emperors are running around looking for a fight. A fourth man is their concealed weapon, and their target is William Harrison Dempsey, king of the heavies and Georges Carpentier, the heavy fighter and peer of the European canvas.

Charles B. Cochran, who has shown a deadly aim in bringing down the main battles of England, is in ambush for Dempsey.

On his paper Carpentier has scratched his desire to meet Dempsey. James W. Coffroth, the American, got the best first on Dempsey and scored a bullseye in the scumper when the champion signed his paper.

But the fight is only half won. It's a

two man killing mission on which the promoters are bent. Unfortunately for them, it seems, the necessary rules require the presence of two men in the ring. Both Cochran and Coffroth have their bigger game yet to bring down.

**Object to Long Ride.**

Cochran has to get Dempsey and the American fighter down, not want to take a long boat ride to the scene of the encounter. His manager, Jack Kearns, argues that it is necessary for the challenger to invade the stamping grounds of the champion. Carpentier tells Coffroth he is willing to listen to him, but he cannot see forty-five rounds, which the American promoter seems to fancy. The fans, by far the most important group to consider, do not like either proposition. They do not want to journey to England for the fight and neither do they wish to run a line of Villistas to the main entrance of the proposed Tijuana Stadium.

This bunch of stumbling blocks confronting the two leading contenders for the fight have led the fans away from getting excited over the prospect of a fight and a conviction is growing that the real offer is yet to come.

A bunch is growing that New York will be the scene of the battle late in the fall, may be around election time. A boxing bill is confidently expected at the next session of the legislature and with legal sanction the fans are expecting Mr. Tex Ricard to take the center of the stage and get all the necessary signatures.

**EIGHT GIRLS AND BOYS MISSING IN FORT WORTH**

FORT WORTH, Jan. 7.—Eight boys and girls have been reported to police missing since December 3, and no trace of any of them has been found. All were under 20 years, two of them a mother and her baby and two others the step-children of an oil worker.

## STATE DEPOSITORIES FOR SIX MILLION TO BE SELECTED ON THURSDAY

AUSTIN, Jan. 7.—State depositories to care for about \$8,000,000 in state funds which will come in a flood as taxes are collected early in the year will be selected tomorrow when bids of banks will be opened.

State Treasurer J. W. Baker estimates that 100 additional depositories will be necessary and two days before the bids were to be opened only about 50 banks had submitted bids.

The law creating the depository system was recently upheld in a district court here, and interest on state money has averaged around \$20,000 a month, or enough each month to pay the expenses of maintaining the treasury for a year.

With the additional accumulation of funds the interest will rise to a higher figure and remain there until the end of the year, when expenses of the state government will absorb most of the funds which are on deposit.

Only available funds are placed in state depositories, and interest is collected upon daily balances. Permanent funds of the state are invested in bonds and other securities.

**WIDESPREAD SEARCH RESULT OF REWARD**

DALLAS, Jan. 7.—The finder of German police dog, owned by Paul C. Greene, this city, will be rewarded with a bottle of whiskey and \$25 in cash. Mr. Greene has advertised the dog was captured by the French after having been wounded in action and was presented to Greene by a French captain.

## New Sand in South Field Increases the Interest In That Particular District

Picking up of a new oil sand just below 1,400 feet in the South Burkhurst district, with particularly good indications for production, is indicated in reports from the field of the Dave Carl well on the Dodson, a half mile west of the Texhoma well, which got the 1,300-foot sand on the Daniels. Present depth of the Carl well is 1,443, 15 feet into the new sand, which is reported as looking better the deeper the drill goes into it. The drill went into the sand after penetrating a lime shell at 1,425-1,430 feet.

At the point where this test was expected to get the Texhoma 1,300-foot sand, only a very slight oil showing was encountered, with the result that it was decided to reduce and go down, if necessary, to 1,500 feet or more. The hole is now being reamed down and casing will be set on the lime shell.

The Texhoma Oil and Refining company's test on the Dodson is just 400 feet north of the Carl.

One of the Texhoma's tests on the Dodson, just 400 feet north of the Carl well, is reported to have drilled through the lime shell Tuesday and to be drilling into the same sand today, results from which are being watched with interest, as the two tests should afford a very definite line on the possibilities of the new sand. The report of this new sand has renewed interest in the Connor operations on the H. Willis, in the same section, which have been shut down for some time, and which are now believed to have gotten the same sand found in these later tests.

## TESTS ON RED RIVER CENTER OF INTEREST

Interest in oil circles at present is principally centered around the several Red River tests, which are under course of completion, and which will be the first to give any indication as to the possible extension of the pool, which the General well is considered to indicate. The McDowell and Clark No. 1 Roberts fired up the boiler to set the liner late Tuesday evening, and was expected to start in today. The key was reached at 1,460 feet.

The C. L. Green No. 1 Allen in Block 331, the first test to the southwest of the General to reach the sand, is being drilled in today. Mr. Green, leaving for the field early this morning to superintend the drilling in.

The Burk-Waggoner Oil company has its No. 1 Allen, a southern offset to the C. L. Green No. 1 Allen, drilling around 1,500 feet.

Officers of the Hightower Oil company were in the field today, and the only report available from the No. 1 Roberts of the company were that completion was being held up still on delayed pipeline connections.

The United Oil Company has paid its stockholders dividends amounting to 160 per cent and when they receive full payment from the sales, those persons who held stock in that company originally will have made 1,150 per cent on their investment in less than one year's time.

In the sale of its property on Block 74 and its tank farm, Mr. Bradley calls attention to the fact that the company has disposed of only a part of its holdings in the Northwest Burkhurst field. A well is now being drilled on a nine-acre tract in the Durfee survey, located between the Burk Senator, General and Sky Lake wells.

The company is also negotiating for other acreage in that section of the field, where the derricks are not yet as thick as in the main portion of the Northwest Extension of the Burkhurst, and where they will never be as thick, due to Rule 27 of the Oil and Gas Division of the Railroad Commission, which prohibits the drilling of wells closer than 300 feet from another one.

Cash Disbursements.

The casing, automobiles, drilling machinery and other property of the Bradley Company on the Durfee survey lease is not included in the sale to the Dominion Oil Corporation.

There are seven producing wells on the twenty acres acquired by the Dominion Oil Corporation, the total production being about 1,600 barrels per day.

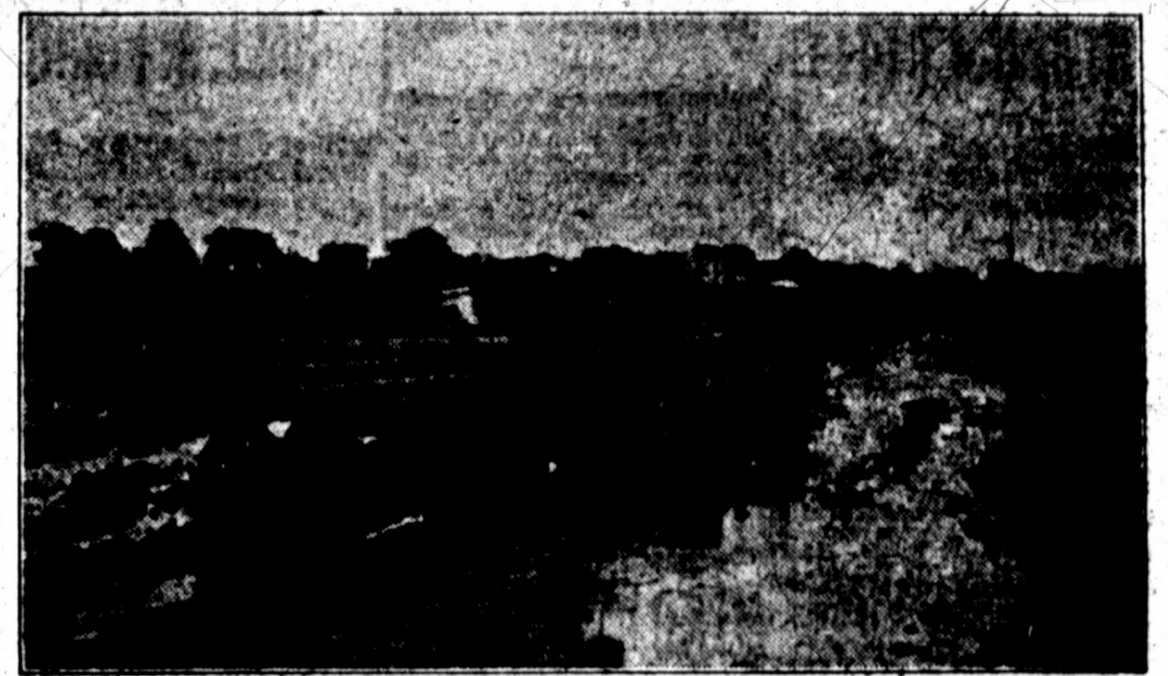

## VICTOR BERGER NOT WELCOME IN JERSEY CITY

Is Conducted to Ferry and Told  
to Leave the City at Once  
Will Enter Suit

NEW YORK, Jan. 7.—Victor L. Berger, congressman-elect, Milwaukee, under 20-year sentence for violating the espionage law, today promised early action against the chief of police of Jersey City who refused to permit him to speak before the socialist education club there last night.

Berger, accompanied by Oscar A. Neuringer, a socialist editor of the Milwaukee Leader, was refused permission to enter the building where the speech was scheduled to take place. They were escorted by police to a ferry landing where they had alight only a few minutes before, and instructed to "leave the city at once."

Richard C. Battersby, chief of police of Jersey City, acting under instructions from Charles Francis O'Brien, director of public safety, personally conducted the deportation from the Jersey side back to Manhattan, where Berger recently has been making speeches un-molested.

"I shall sue the chief of police of Jersey City to find out if the constitution of the United States still exists in Jersey City, or whatever there is left of it, as it has been pretty nearly abolished during the war," Berger said upon arrival at his hotel in Manhattan.

**TO FURNISH BREAD ON  
GOVERNMENT CREDIT IS  
ONLY DUTY OF THE U. S.**

NEW YORK, Jan. 7.—Herbert Hoover, on his way east in connection with the relief work in Europe, in a statement made public here today, declared that if the United States contributes the bread supply on government credit to the starving cities in Central and Southern Europe, plus business credits, we will be doing our share of world responsibility.

Hoover declared taxes must be lowered, not increased, and that it was time for the United States to carry its own burden.

"The statement was made to offset European propaganda," who are depicting the country with opinions concerning the volume of Europe's financial needs from the United States and the content on that the great bulk of these needs cannot be met by ordinary commercial credits.

## INTER-CHURCH WORLD MOVEMENT CONFERENCE

ATLANTIC CITY, N. J., Jan. 7.—A three-day conference of the Inter-Church World Movement, which is a program of Protestant denominational cooperation for the "evangelization of the world" will be formulated and the amount of money necessary for this purpose will be determined, opened here today.

More than 1,000 delegates, representing about 20 denominations and 20,000 churches in all sections of the United States are here for the meetings. The conference was called by Robert Lansing, secretary of state, chairman of the general committee of the Inter-Church movement.

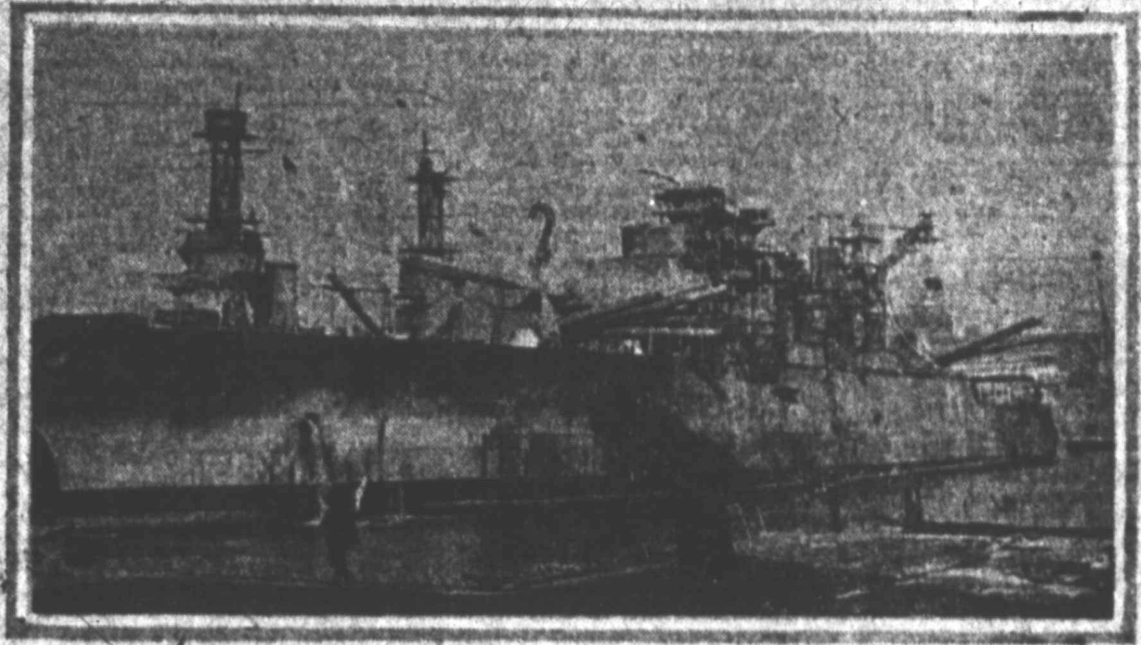

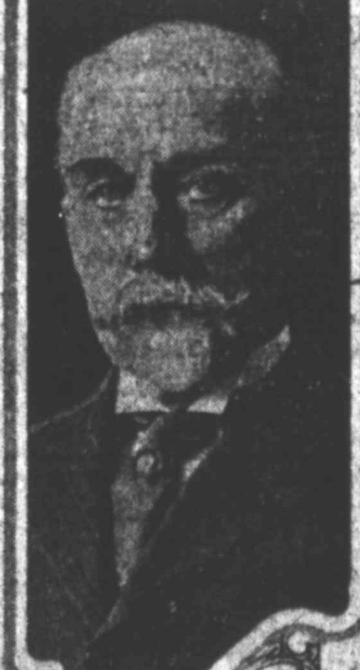

TWO NEW INSURANCE RATES ARE EFFECTIVE.

AUSTIN, TEX. — Two new insurance rates for Texas became effective Jan. 1, 1926, and have been announced by the state fire insurance commission as follows:

"Policies covering mixed feeds, shops, barn and by-products of grain and stock, when stored in elevators or warehouses, completed exclusively by such, are to be written subject to the provisions of the 100 per cent reduced rate and co-insurance clause, but the clause is not to be attached to policies covering hay."

"In rating dwellings, barns, private automobile garages and other outbuildings in connection therewith and contents thereof, and on apartment houses of less than three apartments and attached to the dwelling schedule, and on outbuildings in connection therewith and contents thereof, in cities, towns and villages, one-third of the key rate is to be included and not one-half of the key rate as heretofore."

"The Texas general basis schedule will at a later date be amended to conform to the above changes."
