LEGISLATURE CALLED TO MEET

ONE MAN IS KILLED IN CONNECTION WITH PRIMARY IN ILLINOIS

BITTER FACTIONAL FIGHT AMONG REPUBLICANS FEATURES CAMPAIGN.

MAYOR THOMPSON AND LOWDEN ARE LEADERS

Neither is Candidate for Office But
Are Directing Contests For
Political Control.

CHICAGO, Sept. 15.—One man was
killed, three wounded, several beaten
and a half dozen arrested on charges
ranging from election fraud to assault
to commit murder, marked the balloting
in Chicago's primary election today.

Michael Fennessy, aged 35, a pre-
cinct worker, was shot and instantly
killed at a 17th ward polling place by
a policeman. Detectives who ap-
peared the slayer said he had been
drinking.

John Smolan, a political worker in
the 23rd ward, was stabbed by five
armed men, who after robbing him
of jewelry and more than \$100 and
severely beating him, threw him out
of a tenement with his hands tied
to return to his precinct. Two other
political workers who were kid-
naped have not been found.

Thomas J. Fitzgerald, a second
ward polling place, a policeman was
beaten into unconsciousness and a
deputy sheriff kidnapped by a hand
of armed men, who attempted to vote
twice. The kidnappers fled in an auto-
mobile on which they displayed a
"Lee Small for governor" sign, according
to the authorities. Sergeant John T.
Coyne, the patrolman, who was beaten,
may die.

CHICAGO, Sept. 14.—Voting in Illi-
nois state primary today opened break-
ly in Chicago during the morning
hours, with indications that the total
vote may be split nearly equally be-
tween the two candidates. Considerably
more than half the number
registered.

Up to 11:00 o'clock one precinct cap-
tain had been reported kidnapped by
the opposition, forty arrests had been
made and one of the special deputy
sheriffs sworn in by Sheriff Peters
to guard the ballot boxes, had been
kidnaped by a policeman. Threat-
ened trouble between the police and
deputy sheriffs, which leaders on both
sides predicted would lead to blood-
shed, failed to materialize, and no
alarming scale.

The weather was fair and the day
promised to be hot.

As the day wore on reports of con-
flicts grew more frequent. Three
automobile loads of armed men kid-
naped an election worker at a polling
place in the 12th ward, and then
drove to another polling place,
and shot up a saloon. Both the man
kidnaped and the one beaten are anti-
Thompson supporters, according to
Sheriff Peters.

Police and Special Deputy Sheriff
Fitzgerald in the second ward, and
Thornton, a colored deputy sheriff
was arrested during an assault to
commit murder after he is said to
have drawn a gun and threatened
to kill Detective Sergeant Anthony
Nagle.

The campaign in Chicago has centered
about charges of "tammanyism"
directed against Governor Lowden
administration by the friends of Governor
Lowden. The anti-Thompson forces
charged the mayor's administration
with extravagance and asserted he
was now seeking to hold on to
government through the nomination
of Len Small for governor.

The mayor's friends have countered
with charges of "tammanyism" against
Governor Lowden. The Lowden
whipped his personal hotel bills while
maintaining presidential campaign
headquarters at the state and that his
personal valet is on the national guard
payroll at the salary of \$3500 yearly,
\$100 more than a lieutenant-colonel
receives.

LONG LIST OF OFFICERS INCLUDED ON THE BALLOT

CHICAGO, Sept. 15.—Republican and
democratic candidates for United
States senator, representatives, gov-
ernor, and judges, were listed on the
campaign which developed between
two factions in the republican party
was said to result in the largest vote
in the state history. Warm weather
with probably showers by night was
predicted.

The republican factional fight cen-
tered around the ticket headed by Len
Small of Kanawha and supported by
Mayor William Hale Thompson of Chi-
cago, to which was opposed that head-
ed by John G. Olesby, lieutenant gov-
ernor, supported by Gov. Frank G.
Lowden.

The announcement by Sheriff Peters
of Cook county of the appointment of
more than 1,000 deputies for duty at
the polls drew charges from the
Thompson faction of attempted intimidation
and instructions to the police to
arrest any deputies found violating
city ordinance on election regulations.
Sheriff Peters warned that inter-
ference with the deputies "might lead
to bloodshed."

One of the principal campaign argu-
ments advanced by the Thompson re-
publicans related to recent increases
of from 5 to 6 cents in Chicago sur-
face car fares. Under a contract be-
tween the city and the street car com-
pany having several years to run the
fares were to be retained at 5 cents.
Mayor Thompson charged Governor
Lowden with undue interference in
Chicago affairs because of the permis-
sion given to raise the fares by the
state public utilities commission. In
addition to Small and Olesby, two
other republicans, Oscar E. Carlston
of Aledo and Edward N. Woodruff of
Peoria are seeking the republican gov-
ernatorial nomination.

The principal senatorial fight on the
republican ticket also was between
Lowden and Thompson candidates. The

GOV. COX WAGING CAMPAIGN IN UTAH; WELCOME IN IDAHO

INVADES THE HOME OF SENATOR ROOT WHOM HE HAS BEEN ATTACKING.

NEARLY SIX THOUSAND HEAR SPEECH AT BOISE

Reception in Senator Borah's Home
State Comes As a Big
Surprise.

POCATELLO, IDAHO, Sept. 15.—Gov-
ernor James H. Cox waged his stump
battle in Utah, the home state of Sen-
ator Reed Smoot, whom the democratic can-
didate has been attacking as one of
the three leaders of the "senatorial
oligarchy."

All records for "before breakfast"
speeches for the tour were broken
when Cox closed his Idaho campaign
with rear-platform talks to early risers
here this morning.

Considering Senator Borah's ap-
parent strength in Idaho, Cox's reception
in Boise last night was a surprise.
Nearly six thousand persons listened
to him speak nearly two hours. Many
times he drew applause, although the
demonstration was somewhat less than
the governor spoke of the league of
nations. He was heckled several times,
once on the Irish problem.

In Salt Lake City tonight Cox will
address a mass meeting in the labor
arena. He has not indicated how he
will deal with the Utah situation, other
than that he favors diverting arma-
ment expenditures to development of
western lands and construction of
highways, if the United States by the
November election, decided to enter the
league.

Tomorrow Cox will devote consid-
erable time to study of the Japanese
question as he again travels west for
his invasion of California.

Cox today indicated that in Califor-
nia he will attack Senator Harding's
statement of yesterday on his Pacific
coast policy as being "too indefinite."

NEWSPAPER REPORTS DENIED BY VISCOUNT

Repudiates Statement Credited To Him With Reference To The Japanese Note.

TOKIO, Sept. 14.—Newspaper re-
ports that Viscount Uchida, foreign
minister, told members of the oppo-
sition yesterday that the Japanese note
regarding the island of Sachalin
was considered tantamount to
acceptance of the Japanese attitude
as denied at the foreign office. It
is said that the foreign minister
merely informed his callers that Japan
had answered the American note re-
garding the presence of Japanese
forces in the Russian section of the
island.

There have been various press in-
terpretations of Viscount Uchida's re-
marks relative to Japanese children in
Hawaii studying the Japanese lan-
guage, and possible objection to the
presence of Japanese children in the
island. The foreign minister said it
was true that Japanese children were
learning their mother tongue outside of
the public schools in Hawaii and that, per-
sonally, he saw no reason why there
should be any interference with this
work. He added the matter had not
been subject to negotiations between
the American and Japanese govern-
ments.

WOULD ABOLISH SUMMER VACATIONS FOR CHILDREN BETWEEN EIGHT AND 16

SACRAMENTO, CAL., Sept. 15.—Abol-
ition of summer school vacations for
all children between 8 and 16 years of
age, because the vacation period "in-
duced habits of idleness and criminal-
propensity," was advocated by
Will C. Wood, state superintendent of
schools today.

Wood said exceptions should be made
in the cases of children who stand in
harvesting fruit and similar work, "but,
of course, only children over 13 would
be permitted to work even in agricul-
tural districts."

REPORT MACSWINEY IN RAVING DELIRIUM

Imagines He Leads Sinn Fein Army, Talks Loudly And Shouts Commands.

LONDON, Sept. 15.—Terence Mac-
Swiney, hunger striking lord mayor
of Cork, was in a raving delirium dur-
ing a recent part of last night, his sis-
ter Annie, declared today as she left
British prison after visiting him.

Imagining he was leading a Sinn
Fein army, MacSwiney talked wildly
and shouted commands, his sister said.
This morning, realizing he might be
sent to a lunatic asylum, MacSwiney
asked his relatives to forbid him
from going in if he became delirious
while in prison doctors were present.

MacSwiney suffered severe pains
across his shoulders this morning. His
sister said his mind seemed duller than
heretofore.

Physicians said death at any time
would be no surprise. They pointed
out his body had weakened long ago,
but until today MacSwiney's mind had
been clear. His delirium and his
apathy today, they said, indicated a
complete breakdown was near.

LONDON, Sept. 15.—Little change in
the condition of Lord Mayor Terence
MacSwiney was reported this morn-
ing by the physician of Brixton
prison where MacSwiney is impris-
oned. In his report to the home of-
fice, however, the physician declared
"increased weakness" was noticeable.

LONDON, Sept. 15.—The latest bul-
letin from Sinn Fein headquarters to-
day said the condition of Terence
MacSwiney, lord mayor of Cork, remained
unchanged.

Physicians were puzzled over Mac-
Swiney's grip on life. Although prac-
tically in a comatose condition, the
hunger striking prisoner was con-
scious. He talked with his wife yester-
day, and they talked with her as if
as to funeral rites. He asked her to
arrange for simple Catholic services
with the funeral orations all in the
Irish.

Despite MacSwiney's request, Sinn
Fein leaders said they planned to make
the services the greatest demonstration
in Ireland's history.

Physicians reiterated their asser-
tion MacSwiney will be given nourish-
ment when he becomes unconscious.

Medical men refused physicians as to
how long the prisoner can live. His
alternating gains and relapses have
puzzled them. Yesterday a
stroke could not detect a faint
beat, yet he was conscious and strong
enough to whisper.

Nine former lord mayors of Cork
signed joint appeal to Premier
David Lloyd George. The petition, Mem-
bers of the Irish "peace confer-
ence committee" wired the premier
that the freeing of MacSwiney, and
other hunger strikers from Cork, was
"indispensable to a successful Irish
peace." This was signed by Sir Hor-
ace Plunkett, Major General Sir Hickie
MacGowan and others.

The Dublin association of munici-
palities honored MacSwiney by electing
him president of the organization.

Mary MacSwiney, appealed to
Americans to force their government
to call in British loans. Her ideas
were that withdrawal of support from
British industry would mean a virtual
blockade of England and that her
brother's freedom could be forced
thereby.

The bulletin issued by the Irish
Self-Determination league, read:
"This is the thirty-fourth day of the
strike. The Lord mayor passed a
somewhat better night and had a few
hours sleep. The pulse in the body
and limbs continue. He is still con-
scious and his mind is active."

GOVERNOR HOLCOMB WITHHOLDING NOTICE

Certified Copy Of Resolution Of Re- solution Carried To Capital By Woman.

HARTFORD, CONN., Sept. 15.—Gov-
ernor Marcus H. Holcomb, doubting
the legality of the ratification of the
nineteenth amendment by the legis-
lature yesterday, has withheld certifi-
cation of the action.

Miss Catherine M. Flanagan, for the
suffrage association, last night secured
a certified copy of the resolutions of
ratification and left for Washington
to file it with Secretary of State Colby.
The legislature has been called into
special session next Tuesday to re-
peal the law which made it necessary
to ratify the amendment.

Under the terms of the bill the board
to be appointed by the governor and
to be made up of representatives of
capital, labor and the public, would
have power to summon witnesses and
examine records with a view of settling
industrial disputes.

Meanwhile, the commission appoint-
ed by the governor last week to in-
vestigate the strike continues to hold
informal sessions.

At the headquarters of the United
Mine Workers it was stated today that
twenty-five mines have closed down
and many others are working with re-
duced forces. The coal operators' as-
sociation, however, insists production
is about normal. Union leaders assert
15,000 miners are on strike, while the
operators declare only 7,000 are out.

None of the larger industrial plants
have been affected to any extent, but
several smaller factories have been
forced to curtail operations. Coal con-
sumption is to the household at \$12
a ton.

MISSOURI REPUBLICANS ADOPT THEIR PLATFORM, BABLER IS SIDETRACKED

JEFFERSON CITY, Sept. 15.—The
Missouri republican platform conven-
tion, which went into session here yester-
day, adjourned early today. Ad-
ditional action was taken after the con-
vention proper had adopted a platform and
the state central committee had ap-
proved a resolution ratifying an agree-
ment between Jacob L. Babler of St.
Louis, national committeeman for Mis-
souri, and Will H. Hays, chairman of
the national committee, whereby all
communications pertaining to cam-
paign matters would be directed to the
state and national committees,
leaving Mr. Babler, the resolution said,
to retain the empty title of national
committeeman.

Mr. Babler's name was mentioned in
connection with the distribution in
Missouri of the proconviction funds of
Governor Lowden of Illinois, a candi-
date for the republican nomination as
president.

APPROVE PLANS FOR CO-OPERATIVE COMPANIES

CHICAGO, Sept. 15.—Approval of
plans to establish co-operative live-
stock commission companies at the
Chicago and St. Louis stockyards was
voted at a meeting of the executive com-
mittee of the Illinois Agricultural asso-
ciation, which was announced today. The
Illinois farm bureau, it was also an-
nounced, plans to join the movement
with bureau and other farmers' or-
ganizations in the middle west.

COURT MARTIAL PAPERS WILL GO TO GOVERNOR DURING THE DAY THURSDAY

AUSTIN, Sept. 15.—Court martial
findings in the case of Colonel Billie
Mayfield, who was tried at Galveston
on charges of violating the 36th ar-
ticle of war in connection with the al-
leged attempt to arrest a Houston edi-
tor, reached the adjutant general's
department here today, said Adjutant
General W. D. Cope, and they will be
referred to the judge advocate of the
Texas national guard before being sent
to the governor for final action. Gen-
eral Cope said the papers will be pre-
sented to the governor tomorrow.

CONVENED TO CONSIDER QUESTION OF SAFEGUARDING FALL ELECTION AND TO PRESCRIBE QUALIFICATIONS

AUSTIN, TEX., Sept. 15.—The Texas legislature was called
to convene in special session at 11 o'clock, September 21, by Gov-
ernor Hobby today.

The governor stated that he had called the legislature to
"give consideration to the question of safeguarding the general
election of November, 1920; to prescribe qualifications for vot-
ers; to prevent discrimination among voters in the exercise of
the franchise at said election.

"Second—To consider and act upon such other matters as
may hereafter be presented, pursuant to section 10, article 3, of
the constitution of the State of Texas."

The governor said in a statement
accompanying the proclamation: "I
shall urge the legislature to pass a
law, though all which extra tax not
paid poll taxes 15 days in which to
pay a fee or tax equal to the poll tax
which those voters who have qual-
ified have paid, in order to qualify for
voting in the November election. I
shall further urge that all the funds
derived by the state from the collec-
tion of such fees, shall go to the
university school fund under this plan,
all voters will vote in the November
election on an equal basis."

Another interpretation of the
governor's statement said: "I accept the
governor's interpretation of the
19th amendment as applied to the next
general election of Texas, and therefore
convene the legislature, because in my
judgment it creates an emergency
which can be dealt with only by im-
mediate action on the part of the
state's legislative authority. . . .
Without legislative action the oppor-
tunity is afforded for fraudulent vot-
ing, though to what extent has not
yet been determined. The situation
is a grave one. Whether there is dan-
ger of repeaters, and the casting of
fraudulent votes at such an election
is a matter which makes grave
concern to the state. The situation
should be avoided by statute."
Higher Consideration.

"But there is a higher consid-
eration than that which makes action
necessary. There are about 750,000
persons in Texas, men and women,
who qualified themselves to vote in
the November election, but who have
not paid poll taxes or obtained exemp-
tion certificates. There are at least 2,500,000
men and women of voting age in Tex-
as. Under the constitution, if the 19th
amendment by the attorney gener-
al all of these will be permitted to
vote regardless of whether they have
paid poll tax. This should be
avoided because it is unsafe. Even
though this situation is due to cir-
cumstances beyond the control of Tex-
as, it would be discrimination just the
same to hold an election in which
750,000 persons have been required to
pay a poll tax of \$1.75 in order to
exercise the suffrage franchise, while
it is possible for a million more
without the payment of an equal
amount."

CHARGE AT GALVESTON WILL BE RECOMMENDED

AUSTIN, Sept. 15.—That some change
be made in the Galveston martial
situation is expected to be included in
the governor's recommendations to the
legislature, called to meet September
21, according to a dispatch from Austin
in the military news is citing the
state about \$35,000 a month, according

impeachment.

Charges were made that some fed-
eral judges had "nodded bootleggers
and moonshiners" and that prohibition
laws were being made "a farce" in
some sections by the light punishment.
The committee was named by the
Rev. F. A. Baker, general superintend-
ent of the league, after speakers at the
conference had vigorously criticized
Federal judges for alleged leniency
toward bootleggers. A resolution con-
victed of violation of the prohibition
amendment and enforcement laws.

BOARD OF DIRECTORS OF LONDON HERALD REFUSE TO ACCEPT SOVIET FUND

LONDON, Sept. 15.—The board of
directors of the Daily Herald will not
accept the Russian soviet government's
offer of a £25,000 fund for the paper,
adopted today declares that the direc-
tors had no knowledge that the money
had been offered.

OREGON DECLARES NATIONAL FINANCES BIGGEST PROBLEM

PRESIDENT-ELECT OF MEXICO DISCUSSES CONDITIONS OF COUNTRY.

DANGER OF REVOLUTION DISCOUNTED BY LEADER

Expresses Hope That Americans Will Become More Interested in Her Industries

By RALPH H. TULLY, United Press Staff Correspondent.

MEXICO CITY, Sept. 14.—President-elect Alvaro Obregon of Mexico in his first interview since his election, today declared national finances would be his big problem.

Obregon said he hoped to reach an agreement with American and other foreign bankers whereby Mexico could pay her good debts by beginning payments on her national debt of \$400,000,000.

The president-elect entered Mexico City for the first time since his election, returning from his campaign in southern Mexico. He was in good spirits, laughing over rumors that his life might be endangered. He expressed satisfaction over the temporary government of General Huerta.

"Mexico must adjust her finances so as to discontinue spending what does not belong to us," Obregon said. "I hope to reach an agreement with foreign bankers, basing it on notes rather than bonds. It would be impossible for Mexico to discharge all her obligations immediately, but she can show her good faith."

He may depart in minor details from General Huerta's administration," Obregon said. "But his work in the main will serve as the basis for my own. The Huerta government could well be handled, considering that it covered a period of transition. The fundamental problem was pacification and that has been accomplished."

Obregon said he hoped more Americans would visit Mexico, interesting themselves in her industry and commerce. He believed, he said, that the labor situation would reach normal shortly. He had little fear, he said, that the labor situation would be tinged with bolshevism.

"However," he remarked, "foreign agitators who attempt to undermine our system of government will be dealt with summarily."

Obregon said he would support the international regulations regarding foreign holders of property but he would apply interpretive measures which "will not injure vested interests" more than necessary. He referred to the development of oil fields by foreign capital.

A commission to study the oil problem will be appointed before he takes office in December. His will not be a one man government, he asserted, announcing that he intends to appoint cabinet members capable of running their own departments.

"There are no matters affecting the United States and Mexico which cannot be adjusted amicably," Obregon said.

Danger of a revolution by Carrancistas was discounted by Obregon, who said there would be no excuse for it unless the government were to violate its own laws.

MEXICO CITY, Sept. 14.—Investigation of reports that a plot against the lives of General Alvaro Obregon, president-elect, General P. This action was taken after many telegrams had been received from Mexican consuls in the United States, who said the plotters were at present in San Antonio.

Makes Refrigerator That Will Hold Ice Eight or Ten Days

A refrigerator that would hold ice and refrigerate food for eight or 10 days would work almost a revolution in household economics. W. K. Knutson, general contractor and mill work manufacturer of this city, claims to have produced such a refrigerator and those who have seen the model he has built at his plant on Burnett street south of the Wichita Mill and Elevator Company believe that his claims are substantiated.

Mr. Knutson has applied the vacuum principle to the household refrigerator together with a new system of air circulation that he produced wonderful results. He has applied for patents upon his refrigerator and has obtained a permit for their manufacture.

He has built a model at his mill that is now giving a practical demonstration of his system. In outside appearance his refrigerator is the same as the ordinary household refrigerator. The ice is placed in an upper chamber on the left hand side and below it and at the side are food chambers. Each chamber is a separate unit. The ice chamber and each of the other chambers are surrounded by an air space enclosed by vacuum chambers. The air circulates about the ice chamber which cools it and the cool air in turn cools the food chambers. The food, in effect, is sealed in each chamber.

The vacuum system, as far as known, has been successfully applied to hot and cold water bottles, but so far as has been ascertained has not been applied to household refrigerators. Mr. Knutson's system of air circulation is also an added improvement.

Necessity has again proved the mother of invention in the case of Mr. Knutson's device. Several years ago Mr. Knutson worked at a place where there were a number of children and where it was impossible to secure regular deliveries of ice. He made a vacuum to keep and elevator in the intervening years has worked out the circulating system which is of most importance in his refrigerator.

Mr. Knutson plans to engage in the manufacture of refrigerators here provided he can interest the necessary capital.

CAMERAMEN TAKE MANY RISKS IN FILMING SCENES

The ambitious movie fan who envies the studio cameraman and his intimate association with all degrees of production, may be perfectly willing to admit "Let George do it" after viewing "The Trip Through the World's Greatest Motion Picture Studios" which will be presented at the Olympic as an added attraction September 21.

As many of the scenes so excitingly indicate, the work of a feature-drama cameraman is "one continuous grid of grief," as they term their troubles at the studios. Risks of all descriptions must be encountered and overcome by those who turn the crank, and the "positions" assumed in many instances would do credit to a regulation "human fit."

In photographing an exterior scene between Lloyd Hughes and Gladys George, two new Thomas H. Ince "discovery" cameraman Henry Sharp and his assistants were required to lie flat on their stomachs on a small platform built between the limbs of a towering tree. This position was necessary to effect just the right angle desired by Director John G. Wray.

In "shooting" Douglas MacLean burning the forest at sixty miles per hour with a traffic cop hot in pursuit, Cameraman Paul Eagler stood on the hood of his second machine running about fifty-five miles per hour, with the camera mounted on a platform adjusted to the front axle of the studio car.

Cameraman Sharp, to secure a panorama shot of the Ince "top," scored another ten-strike by placing his camera on the edge of the roof of one of the studio's tallest buildings. It was a perilous and extremely dizzy height, but then—the busy motion picture photographer hasn't time to think of danger and its allies.

NEGOTIATIONS WILL BE UNDER DIRECTION OF THE GOVERNMENT

ITALIAN WORKMEN AND MANUFACTURERS RESUME THEIR CONFERENCE

OWNERS ARE FAVORING PROFIT SHARING SYSTEM

Newspaper Correspondents Predict Acute Phase Of Industrial Crisis Is Past.

By CAMILO CIANFARRO, Staff Correspondent.

MILAN, Sept. 15.—Negotiations between workers and manufacturers to bring about a settlement of the industrial problem will be resumed under government direction, according to advices today from Milan.

Owners are favoring a profit sharing system as a solution. Indications here they will insist upon the workers evacuating the plants they have seized before agreeing to any settlement.

Reports here today indicated a few additional seizures of factories. At Verona, Deputy Scialoja, a socialist, led a group of car men, which occupied a tool factory and evicted the owner and his family from their residence. Employees of the Dibennetti hosiery factory at Turin were reported to have killed the proprietor. The local chamber of labor in Brescia called a general strike there because troops occupied all power houses to insure a supply for industrial plants.

Foreign newspaper correspondents in Milan predicted the acute phase of the industrial crisis is past. They expressed the belief the government will enact legislation recognizing the right of operatives to control factories.

Workers who seized the Fiat automobile factory in Turin refused to recognize the General Confederation of Labor's resolution demanding an economic rather than a political solution of the present conflict. They declared flatly they would not evacuate the plant.

The Co-operative Alliance loaned the strikers 500,000 lire to pay wages. This sum is sufficient for only a brief period.

PLAN LAW PROVIDING FOR A COLLABORATION

MILAN, Sept. 14.—Plans for a law providing for the collaboration of workers in the management of industrial plants, which will be presented at the next session of the Italian parliament, have been placed in the hands of a commission appointed by socialist members of the house of deputies. Leaders of the workers insist that the agreement with employers must admit the men to the management of technical departments, finance and offices for the engagement and dismissal of men. They assert such powers should be exercised by organizations appointed by labor unions. Leaders declare that occupation of plants throughout the country will continue until employers' privileges are suppressed and the new rights of labor acknowledged.

While a majority of employers strongly resist the workmen's scheme for assisting in the work of management, there is an important section which supports a suggestion that the men's scheme be accepted on general lines in order that the conflict going on at present may be ended. This element would reserve discussion of details, which would be submitted to a committee composed of representatives of employers and workers.

BURKBURNETT, Sept. 15.—After having for several years enjoyed the reputation of being the only town in Texas, and perhaps in the whole of America, that was free from the mosquito pest, this city is now literally alive with these insects, and the sanitary department is waging determined war upon the invaders by eliminating their breeding places.

The streets being unpaved, the ditches along the sides have been injured and dammed by automobiles passing to and from the various residence lots, so that numerous pools and puddles line the streets, while the roads and oil properties adjacent to the city, but outside of its jurisdiction, are in even worse condition.

The sanitary department has men worked with shovels on the street-ditches and has already cleared the blocks of these annoying puddles, and the work is being pushed as rapidly as possible.

Sanitary Officer J. T. Bentley states that the pools along the Katy railway track and on the nearby oil properties will be reported to the county health officer and he is hopeful that the nuisances will be abated in the near future, by draining and oiling. In the case of a particularly dangerous pool on the property of an oil company near the city limits, Mr. Bentley offered to supply some damaged tiles which he had on hand, if the oil company would drain the pool with it, and the nuisance was thus abated to the satisfaction of all concerned.

The Martin Hospital, which was opened three weeks ago, is already comfortably filled, and this shows how great is the need of such institutions in a congested oil region.

The building, which is situated on West Third street, is one story in height and is of the military type. Dr. Martin, its founder, having been a surgeon in the army during the war, it is what, in army parlance, is known as an evacuation hospital. There is a fully equipped operating room, also masculine and feminine wards, and graduated nurses. The sewage system is modeled upon the plans approved by the state board of health for such institutions.







Nicholson, wealthy mine owner of Leadville, by 2,928 votes today when 511 precincts out of 1,223 in Colorado, including Denver, had been counted in the contest for the republican nomination for United States senator, Lieutenant Colonel Rite W. Messner of Denver, was running far behind.

ALBANY, N. Y., Sept. 15.—Republican and democratic organization candidates swept New York state in the primary yesterday, according to virtually complete returns today. Judge Nathan I. Miller, received the republican gubernatorial nomination, defeating Senator George P. Thompson by more than 25,000 votes. James W. Worth, Jr., was renominated republican candidate for United States senator.

Gov. Alfred E. Smith, who was unopposed, received the democratic nomination to succeed himself. The democratic candidate for United States senator is Lieut. Gov. Harry C. Walker, who defeated George R. Latta, anti-Tammany aspirant, about 5 to 1.

NEWS FROM THE COURTS STARTLING TESTIMONY RULES RECOMMENDED IN AUTOMOBILE CASE FOR TRIAL OF CASES

Woman Charges That She Was Coerced Into Signing Bill Of Sale For Car.

Testimony on the witness stand that she signed a bill of sale for an automobile under duress, Miss Gien, in the county court, today, secured quite a sensation Wednesday.

She testified that a man in the oil fields had given her money to purchase a car and that she had signed a bill of sale for the car. She testified that she was placed under duress by an officer and placed in the jail at Newtonville.

Her statements were to effect that the officer came to her after she was in jail and told her that he had the evidence to convict her on and that the best thing she could do was to give the bill of sale for the car so that she would stop action against her.

Alleged Threats. The witness told that the officer further said that if she would not consent to do as he said he would bring her to the county jail at Wichita Falls and that she would be sent to the penitentiary because he had all the evidence that was needed to convict her.

She then told under examination by her counsel and under cross-examination that she thought that this was the only method she could take advantage of to get out and see a counsel and therefore she said that the officer took her to the county jail at Newtonville and over to Pio Kirella and advised by the officer that she should go with the woman to Burkburnett and fix up a bill of sale for the automobile.

It was further brought out in examination of the witness that she complied with the officer's alleged instructions and signed the bill of sale which was introduced in evidence. The suit in the trial of which this testimony was brought out is that of Rose Gien vs. Pio Kirella for possession of an automobile.

The case is continued. The counsel for the defense argued before the court that he will give time until Friday morning at which time he will present evidence and especially the officer involved. He argued before the court that the officer should be given an opportunity to answer or deny the charges which the witness made against him and further stated that should it be found that the witness was correct in her charges, the officer should be held liable for the charges.

Judge Guy Rogers continued the case until Friday morning at which time he will further examine witnesses to be brought in by the counsel for the defense.

DAMAGE SUIT INVOLVES LOCAL THEATER COMPANY

Seeking damages to the extent of \$3,461.66 and court costs on alleged breach of contract, the Wichita Theatre company has brought suit against the Jefferson Theatre company of Dallas, Texas, in the eighty-ninth district court in this county.

The plaintiff sets forth in his complaint that on November 20, 1919, the plaintiff entered into an oral contract with the defendant and the plaintiff agreed to assign and transfer a certain contract entered into by the plaintiff and the Southwestern Vaudeville association to the defendant.

It is further recited in the complaint that in consideration of the sum of \$1,000 the defendant agreed to pay the plaintiff a proportion of the cost of the plaintiff's showing other acts in Wichita Falls in the city of the defendant. The plaintiff states that the defendant refuses to pay even though they fulfilled their part of the alleged oral agreement by delivering to the defendant the contract made by and between the plaintiff and the Southwestern Vaudeville association.

JUDGMENT IS RENDERED IN FAVOR OF PLAINTIFF

Judgment was rendered in favor of the plaintiff in the case of J. F. Campbell vs. The Port Worth & Denver and the I. & G. N. railroad companies by Judge Guy Rogers in the district court of law. The suit was for judgment for alleged damages in the shipment of a carload of household furniture and boxes and covers over the defendant's roads.

All motions filed are to be entered on the motion docket which shall be called by the court for disposition at the earliest opportunity. At this time all motions are to be disposed of or good reason given for postponement. The filing of a motion shall be deemed an admission that there are no legal objections in the rules that are now in existence and it is the belief that should these recommended rules be adopted that it will save much time and expense in the filing of motions. PLAN FOR A HOME FOR WORKING GIRLS

County Advisory Board Salvation Army Votes To Open Campaign October 4

The county advisory board of the Salvation Army, meeting in this city Tuesday, voted to open a campaign here October 4 to obtain \$50,000 for the erection of a home for working girls. If the plans outlined by Eldridge Steward, architect from E. Stanley Field's office, are accepted, the proposed home will care for 50 girls, providing board and rooms for approximately \$5 a week and with every facility for convalescence and comfort that accompanies the construction of a modern apartment house.

"Pa" and "Ma" Burdick, who attended the meeting, declared that it is the Army's purpose to make the home self-sustaining, and at the same time provide a means for girls in the humbler walks of life to save money and to enjoy many of the comforts now denied to them. The Army has similar homes in Dallas and Oklahoma City, and it is the hope of the board that the home in Wichita Falls will be a finer institution than either of these.

The matter was brought to the attention of the advisory board by B. F. Johnson, chairman, who explained that the Army already owns a home site on Eighth street across from Bellevue park. Steward explained the proposed architectural plans, which call for a two-story and basement building, with dining rooms, a gymnasium, a library and modern electrical laundry facilities, the total cost to approximate \$75,000.

Johnson stated that Wichita county's Salvation Army budget for the year is \$2,000 and it was his suggestion that a total of \$50,000 be raised in a campaign here and the \$43,000 be applied to the building of the home. The home would be bonded, the bonds sold outside of Wichita Falls by the Army and retired over a period of years by means of the annual budget.

Johnson, referring to last week's meeting of the state advisory board, briefly sketched the history of the Salvation Army and its record of 35 years of service in this country. Every man on the board declared himself in favor of the proposed home, and it was unanimously voted to tackle the proposition in a big way and to erect a home in this city that will be recognized as one of the finest institutions of its kind in the southwest.

The campaign drive will last from October 4 to October 13.

Will Ship 150,000 Head Texas Cattle to German Market

SAN ANTONIO, TEX., Sept. 15.—One hundred and fifty thousand head of Texas cattle, representing an expenditure of more than \$10,000,000 are to be shipped to Austria and Germany during the next six months according to an announcement by the Catholic Central Society in session here.

The first eight hundred of these cattle which will be used for the rehabilitation of dairy herds in the two central European countries, will be shipped from Galveston within ten days, it was said. The rest of the cattle will be shipped as soon as ships can be obtained.

Financing this plan will be by the national Catholic society, the cattle merely loaned to the European countries. This arrangement, it is said, will prevent the cattle from being sold by the Allied countries as partial payments of the war debts of two countries.
