Definite information could not be obtained from the latter, who is lying in a local hospital with only an even chance for recovery and the only clue on which the police have to work is a statement made by Graham shortly after he was shot.

### Rob Bank at Brazos West of Ft. Worth

FORT WORTH, Dec. 7.—One of the banks at Brazos, about fifty miles west of Fort Worth, on the Texas and Pacific, was held up at noon today by three bandits, who locked the cashier in the vault. They escaped in an automobile.

WASHINGTON, Dec. 7.—Secretary Baker was asked today by the house military committee to appear before it Friday to explain why the war department has recruited an army of more than 150,000 men.

### LIABILITIES OF PONZI FAR EXCEED HIS ASSETS

BOSTON, Dec. 7.—Liabilities of Chas. Ponzi are estimated at \$5,296,000 and his assets at \$7,390,324 by the appointees who agree to investigate the estate. Ponzi recently was sentenced to five years imprisonment for using the mails to defraud.

### FOUR UNIDENTIFIED MEN BRIBED PERSONAL PAPERS

CHICAGO, Dec. 7.—Four unidentified men forced an entrance last night into the apartment building here where the widow of the late Jake Hamon lives. The men seized a quantity of personal papers and seventy-five letters received for Mrs. Hamon during her absence at Ardmore, Okla., where her husband was mysteriously shot to death. The intruders took nothing else.

### NOBEL PEACE PRIZE TO BE CONFERRED ON PRESIDENT WILSON

COPENHAGEN, Dec. 7.—Announcement today that the Nobel peace prize will be conferred on President Wilson of the United States on December 10.

### INCREASE IS GRANTED TO EMPLOYEES OF THE PACKING INDUSTRIES

CHICAGO, Dec. 5.—A five per cent wage increase for the period between Monday, July 5, 1920, and Sunday, December 1, 1920, was granted employees of the packing and allied industries in a decision handed down today by Federal Judge Samuel Alschuler, arbitrator in packing house wage disputes.

### REQUEST FOR A BLANKET INCREASE NOT GRANTED

CHICAGO, Dec. 7.—Requests for a blanket increase in wages of from \$1 to \$3 per day by employees of packing companies were denied today by Judge Samuel Alschuler, arbitrator in the disputes between packing companies and employees. Judge Alschuler, however, granted some temporary increases to certain classes of workers which will amount to a bonus of about \$25,000 employees in Chicago, Omaha, Kansas City, Oklahoma City, East St. Louis and Sioux City.

### GOOD RAIN CONDITIONS REPORTED IN THE WEST

FORT WORTH, Dec. 7.—Good range conditions, little if any rain, and light shipments sum up the Texas livestock conditions for the week ending today, according to the reports of the range inspectors to the Texas Cattle Raisers' association.

### CONSTANTINE RECEIVES 98 PER CENT VOTE

PARIS, Dec. 7.—Ex-King Constantine received 98 per cent of the votes cast in Sunday's plebiscite on the question of his return to the Greek throne. It is announced in an Athens dispatch received by the Greek legation here today.

### SEARCH FOR CLARA SMITH HAMON CENTERS AT SAN ANTONIO

ARDMORE, OKLA., Dec. 7.—The search for Clara Smith, wanted in connection with the fatal shooting here of Jake L. Hamon, republican national committeeman from Oklahoma, early today centered at San Antonio, Texas, after Russell R. Brown, county attorney, had received information that Henry M. Ross, San Antonio newspaper man, had stated he had conferred with Miss Smith near San Antonio last night.

### STATE OF WAR OVER FIUME SETTLEMENT WILL NOT CONTINUE

TRIESTE, Dec. 7.—The "state of war" between the regents of Quarnaro and Fiume and Italy will not proceed, said an official statement given out by the headquarters of Gabriele D'Annunzio today. It declared this decision had been reached because D'Annunzio had received a note from the Italian ministry of war stating that General Cavaglia's orders, which brought about the manufacture of dynamite and related chemicals, laws controlling cold storage and requiring federal licenses for all corporations engaged in interstate commerce as a means of reducing the cost of living.

### BILL TO SUSPEND IMMIGRATION HAS TO WAIT TWO DAYS

WASHINGTON, Dec. 7.—The proposed suspension of immigration for five years will wait up for consideration in the house Thursday. Plans to bring it up today were halted by Representative New York, who demanded two days to file a minority report.

### WHOLESALE PRICES OF MEATS CONTINUE A DOWNWARD TREND

WASHINGTON, Dec. 7.—Wholesale prices of meats continued their downward trend last night, said a statement issued here last night by the Institute of American Meat Packers. Fresh pork showed declines of from 10 to 25 per cent; the statement said, although it was less marked near the packing centers than in the east.

### RETAIL PRICES OF BREAD IS REDUCED AT DALLAS

DALLAS, Dec. 7.—Retail prices of sixteen ounce loaves of bread were reduced here today from 12 to 10 cents, and twenty-four ounce loaves from 18 to 15 cents. The reduction was announced by a number of the larger bakeries.

### OUTSTANDING FEATURES OF PRESIDENT'S MESSAGE.

WASHINGTON, Dec. 7.—President Wilson's concrete recommendations to congress in his annual message today were: Revision of the tax laws with simplification of the income and profits taxes.

Independence for the Philippines. A loan to Armenia. Economy in government appropriations and expenditures and creation of a "workable budget system." Cold storage and other laws affecting the cost of living, and the federal licensing of corporations as recommended in previous messages. Rehabilitation and training of disabled soldiers and sailors. The president did not indicate a bonus.

### SENATE RECEIVES ITS FIRST BILLS AND REPORTS

WASHINGTON, Dec. 7.—Sitting in separate session, the house and senate received the president's annual message today and the house adjourned immediately afterwards. The senate continued in session for some time, however, receiving its first bills and reports.

### WAGES OF WORKMEN ARE REDUCED FIFTY CENTS A DAY

HELENA, MONT., Dec. 7.—Wages of all workmen at the American Smelting & Refining Company's East Helena plant were reduced fifty cents per day, effective yesterday. The price of lead was stated as the cause for the reduction.

### FIRST STATE BANK AT CALERA, OKLA., IS LOOTED BY BANDIT

DENISON, TEXAS, Dec. 7.—The lone bandit who, after locking Mrs. C. R. Elliott out of the First State Bank at Calera, Okla., late Monday afternoon, escaped with \$457.75, a telephone message from Calera reported. Six suspects were apprehended there, but all were released after establishing alibis.

### COMPLETE HORSEBACK RIDING COVERAGE ABOUT 400 MILES

SAN FRANCISCO, Dec. 7.—Miss Billy Campbell, 21 years old, arrived here late yesterday from St. Albans, Vermont, having ridden to horseback the entire distance, estimated at 3,700 miles. Miss Campbell started June 30 last.

In closing his message to congress today the president wrote a paragraph which might be regarded as a salutory saying: "I have not so much laid before you a series of recommendations as sought to utter a confession of faith, of the faith to stand by until my lasting fighting day. I believe this to be the faith of America, the faith of the future, and of all the victories that await national action in the days to come, whether in America or elsewhere."

The president's message was not read immediately in the senate, which waited until it had disposed of routine business.

In his final regular message to congress, which was sent to the two houses today by messenger, the president said there are two ways in which the United States can lead in establishing the doctrine of "right makes might" in the world. These ways, he said, are: "By offering the example within her own borders of the will and power of democracy to make and enforce laws which are unquestionably just and which are equal in their administration." "By standing for right and justice as toward individual nations."

The president declared that the "display of an immediate disposition on the part of congress to remedy injustices, to evict the evil influences that threaten themselves in our national life will afford the most effective effect to the forces of chaos and tyranny which are playing so disastrously a part in the fortunes of free peoples in more than one part of the world."

Washington until he comes to assume the presidency. Harding wished to see as many of the leading members of congress as possible. Harding said today that he will not come back here this winter. Because of the large number of persons who went to see Harding and whom he has not time to see, he will work in a secluded office to which he will invite those with whom he wishes to confer.

Harding's conferences began yesterday following his appearance in the senate. In a talk with congressmen later, Harding said he did not want to do anything upon which the impression would be based that he was participating too much by beginning now to discuss plans for his administration. He made it clear that he does not intend, however, to waste any time in getting members of congress thinking now about the problems which will ask their cooperation in solving after March 4, when he intends to begin at once building up the government and co-operating between the two branches of the government for which he pleaded in his speech to the senate.

WASHINGTON, Dec. 7.—Proposed policies of the Harding administration were discussed today at conferences held at the capitol between the president-elect and congressional leaders.

Immediate passage of the budget bill. 2. Strictest economy in government expenditures. 3. Adequate revision of tax laws. 4. Adequate provision for disabled soldiers and sailors. 5. A government loan to Armenia. 6. Granting of independence to the Philippines.

In addition, the president repeated recommendations he made in previous messages urging encouragement for the manufacture of dyestuffs and related chemicals; laws controlling cold storage and requiring federal licenses for all corporations engaged in interstate commerce as a means of reducing the cost of living.

### Text of President's Message to Congress

WASHINGTON, Dec. 7.—The text of President Wilson's message follows:

When I addressed myself to performing the duty laid upon the president by the constitution to present to you an annual report on the state of the union, I found myself dominated by an immortal sentence of Abraham Lincoln, "Let us have faith that right makes might, and in that faith let us dare to do our duty as we understand it," a sentence immortal because it embodies in a form of utter simplicity and purity the essential states of the nation, the faith in which it was conceived and the faith in which it has grown to glory and power. With that faith and the birth of a nation founded upon it came the hope into the world that a new order would prevail throughout the affairs of mankind, an order in which reason and right would take precedence of covetousness and force, and I believe that I express the wish and purpose of every thoughtful American when I say that this sentence marks for us in the plainest manner the part we should play alike in the arrangements of our domestic affairs and in our exercise of influence upon the affairs of the world. By this faith and by this faith alone, can the world be lifted out of its present confusion and despair. It was this faith which prevailed over the wicked face of Germany. You will remember that the beginning of the end of this war came when the German people found themselves face to face with the conscience of the world and realized that right was everywhere arrayed against the wrong that their government was attempting to perpetuate. I think, therefore, that it is true to say that this was the faith which won the war. Certainly this is the faith with which our gallant men went into the field and out upon the sea to make sure of victory.

**Mission of Democracy.**

This is the mission upon which democracy came into the world. Democracy is an assertion of the right of the individuals to live and to be treated justly as against any attempts on the part of any combination of individuals to make laws which will overburden him or which will destroy his equality among his fellows in the matter of right or privilege, and I think we all are sure that the day has come when democracy is being put upon its final test. The old world is just now suffering from a wanton rejection of the principle of democracy and a substitution of the principle of autocracy as asserted in the name, but without the authority and sanction of the multitude. This is the time of all others when democracy should prove its purity and its spiritual power to prevail. It is surely the manifest destiny of the United States to lead in the attempt to make this spirit prevail.

**Two Ways Suggested.**

There are two ways in which the United States can assist to accomplish this great object. First, by offering the example within her own borders of the will and power of democracy to make and enforce laws which are unquestionably just and which are equal in their administration—laws which secure its full right to labor and yet at the same time safeguard the integrity of property and particularly of that property which is devoted to the development of industry and the increase of the necessary wealth of the world. Second, by standing for right and justice as toward individual nations. The law of democracy is for the protection of the weak and the influence of every democracy in the world should be for the protection of the weak nation, the nation which is struggling towards its right and towards its proper recognition and privilege in the family of nations. The United States can not refuse this role of championship without putting the stigma of rejection upon the great and devoted men who brought its government into existence and established

it in the face of almost universal opposition and intrigue, even in the face of wanton force, as, for example, against the order of Council of Great Britain and the arbitrary Napoleonic decrees which involved us in what we know as the war of 1812. I urge you to consider that the display of an immediate disposition on the part of congress to remedy any injustices or evils that may have shown themselves in our own national life, will afford the most effectual offset to the forces of chaos and tyranny which are playing so disastrous a part in the fortunes of the free peoples of more than one part of the world. The United States is of necessity the sample democracy of the world and the triumph of democracy depends upon its success.

**Recovery Expediently Shown.**

Recovery from the disturbing and sometimes disastrous effects of the late war has been exceedingly slow on the other side of the water and has given promise, I venture to say, of early completion only in our own fortunate country, but even with us the recovery has not been as rapid as we would desire and is impeded at times and there are immediate, sensible acts of legislation which it seems to me we ought to attempt, to assist that recovery and improve the industrial recuperation of a great government of the people. One of these is to provide that a great democracy can keep house as successfully and in as businesslike a fashion as any other government. It seems to me that the first step toward proving this is to supply ourselves with a systematic method of handling our estimates and expendi-

tures and bringing them to the point where they will not be an unnecessary drain upon our income or necessitate unreasonable taxation. In other words, a workable budget system, and I respectfully suggest that two elements are essential to such a system, namely, not only that the proposal of appropriations should be in the hands of a single body such as a single appropriations committee in each house of congress, but that this body should be brought into such co-operation with the departments of the government and with the treasury of the United States as would enable it to act upon a complete conspectus of the needs of the government and the resources from which it must draw its income. I reluctantly vetoed the budget bill passed by the last session of the congress because of a constitutional objection. The house of representatives subsequently modified the bill in order to meet this objection. In the revised form I believe that the bill coupled with action already taken by the congress to revise its rules and procedure furnishes the foundation for an effective national budget system. I earnestly hope, therefore, that one of the first steps taken by the present session of the congress will be to pass the budget bill.

**Improvement in Finances.**

The nation's finances have shown marked improvement during the past year. The total ordinary receipts of \$5,824,900,000 for the fiscal year 1920 exceeds those for 1919 by \$1,522,000,000 while the total net ordinary expenditures decreased from \$3,514,000,000 to \$2,492,900,000.

The gross public debt, which reached its highest point on August 31, 1919, when it was \$26,596,000,000, had dropped on November 30, 1920, to \$24,176,900,000. There has also been a

marked decrease in holdings of government war securities by the banking institutions of the country as well as in the amount of bills held by the federal reserve banks secured by government war obligations. This fortunate result has relieved the banks and left them free to finance the needs of agriculture, industry and commerce. It has been due in large part to the reduction of the public debt, especially of the floating debt, but more particularly to the improved distribution of government securities among permanent investors. The cessation of the government's borrowings, except through short time certificates of indebtedness has been a matter of great consequence to the people of the country at large, as well as to the holders of Liberty bonds and Victory notes, and has had an apparent bearing of effective credit control. The year has been characterized by the progressive withdrawal of the treasury from the domestic credit market and from a position of dominant influence in that market. The future course will necessarily depend upon the extent to which economies are practiced and upon the burdens placed upon the treasury as well as upon industrial development and the maintenance of tax receipts at a sufficiently high level.

**War Indebtedness Matured.**

The fundamental fact which at present dominates the government's financial situation is that seven and a half billions of its war indebtedness mature within the next two and a half years. Of this amount two and a half billions are floating debt and five billions Victory notes and war savings certificates. The fiscal program of the government must be determined with reference to these maturities. Sound policy demands that govern-

ment expenditures be reduced to the lowest amount which will permit the various services to operate efficiently, and that government receipts from taxes and salvage be maintained sufficiently high to provide for current requirements, including interest and sinking fund charges on the public debt and at the same time retire the floating debt and part of the Victory loan before maturity. With rigid economy, vigorous salvage operations and adequate revenues from taxation, a surplus of current receipts over

current expenditures can be realized and should be applied to the floating debt. All branches of the government should co-operate to see that this program is realized.

Necessity is necessary. I cannot over emphasize the necessity of economy in government appropriations and expenditures and the avoidance by the congress of practices which take money from the treasury by indefinite or revolving fund appropriations. The estimates for the present year show that over a billion dollars of expenditures were authorized by the last congress in addition to the months shown in the usual completed statement of appropriations. This strikingly illustrates the importance of making direct and specific appropriations. The relation between the current receipts and current expenditures of the government during the present fiscal year, as well as during the last half of the last fiscal year, has been disturbed by the extraordinary burdens thrown upon the treasury by the transportation act, in connection with the return of the railroads to private control. Over \$600,000,000 has already been paid to the railroads under this act—\$355,000,000 during the present fiscal year, and it is estimated that payments aggregating possibly \$550,000,000 must still be made to the railroads during the current year. It is obvious these large payments have already seriously limited the government's progress in retiring the floating debt.

Revision of Tax Laws. Closely connected with this, it seems to me, is the necessity for an immediate consideration of the revision of our tax laws. Simplification of the income and profits taxes has become an immediate necessity. These taxes performed an indispensable service during the war. The need for their simplification, however, is very great in order to save the tax payer inconvenience and expense and in order to make his liability more certain and definite. Other and more detailed recommendations with regard to taxes will no doubt be laid before you by the secretary of the treasury and the commissioner of internal revenue.

It is my privilege to draw to the attention of congress for very sympathetic consideration the problem of providing adequate facilities for the care and treatment of former members of the military and naval forces who are sick or disabled as the result of their participation in the war. These heroic men can never be paid in money for the service they patriotically rendered the nation. Their reward will lie rather in realization of the fact that they vindicated the rights of their country and aided in safeguarding civilization. The nation's gratitude must be effectively revealed to them by the most ample provision for their medical care and treatment as well as their vocational training and placement. The time has come when a more complete program can be formulated and more satisfactorily administered for their treatment and training and I earnestly urge that congress give the matter its early consideration. The secretary of the treasury and the board of vocational education will outline in their annual reports proposals covering medical care and rehabilitation which I am sure will engage your earnest study and command your most generous support.

Renews Recommendation. Permit me to emphasize once more the need for action upon certain matters upon which I dwell at some length in my message to the second session of the Sixty-sixth congress: the necessity, for example, of encouraging the manufacture of dyestuffs and related chemicals; the importance of doing everything possible to promote agricultural production along economic lines to improve agricultural marketing and to make rural life more attractive and healthful; the need for a law restricting cold storage in such way as to limit the time during which goods must be kept in storage, prescribing the method of disposing of them if kept beyond the permitted period and requiring goods released from storage in all cases to bear the date of their receipt in which it would be of more service if it were provided that all goods released from cold storage

age for interstate shipments have plainly marked upon each package the selling or market price at which they went into storage, in order that the purchaser might be able to learn what profits stood between him and the producer or the wholesaler. Indeed, it would be very serviceable to the public if all goods destined for interstate commerce were made to carry upon every packing case whose form made it possible, a plain statement of the price at which they left the hands of the producer. I respectfully call your attention also to the recommendations of the message referred to with regard to a federal license for all corporations engaged in interstate commerce.

Philippine Independence. In brief, the immediate legislative need of the time is the removal of all obstacles to the realization of the best ambitions of our people in their several classes of employment and the strengthening of all instrumentalities by which difficulties are to be met and removed and justice dealt out, whether by law or by some form of mediation and conciliation. I do not feel it to be my privilege at present to suggest the detailed and particular methods by which these objects may be attained, but I have faith that the inquiries of your several committees will discover the way and the method.

Allow me to call your attention to the fact that the people of the Philippines have succeeded in maintaining a stable government since the last action of the congress in their behalf, and have thus fulfilled the condition set by the congress as precedent to a consideration of granting independence to the islands. I respectfully submit that this condition precedent having been fulfilled, it is now our liberty and our duty to keep our promise to the people of those islands by granting them the independence which they so honorably covet. I have not so much laid before you a series of recommendations, gentlemen, as sought to utter a confession of faith, of the faith in which I was bred and which is my solemn purpose to stand by until my last fighting day. I believe this to be the faith of America, the faith of the future and of all the victories which await national action in the days to come, whether in America or elsewhere.

### SAYS A REDUCTION OF FIFTY PER CENT IN COTTON IS DUE

MEMPHIS, TENN., Dec. 7.—A reduction of at least fifty per cent in the cotton acreage in 1921 and a crop of not more than 4,000,000 bales was predicted by W. B. Thompson, former president of the New Orleans cotton exchange in an address today before the cotton conference here, called to inaugurate a campaign for a material cotton acreage reduction and crop diversification during the coming planting season.

"The south is determined to reduce the cotton acreage in 1921 to at least one-half of that of last year," Colonel Thompson said. "That will mean that the coming crop will be reduced to six million bales or less. The convention here is called for the purpose of solidifying this determination and serving notice on the world that the cotton producing south will no longer permit its chief agricultural asset to be slaughtered and its producers impoverished by any combination of circumstances or interests whatsoever."

**Says Reduction Necessary.**  
After outlining the course of the market in recent months, Colonel Thompson declared the reduction movement was made necessary by the appalling decline in prices, due, as he said, by apologetics for the ruthless deflation campaign to over-production.

"In spite of the fact that in the spring the farmers were urged and encouraged by financial authorities at Washington to produce all the cotton possible," Colonel Thompson continued, "we are, after the price has declined to figures which represent less than one-half actual cost of production, told that we have produced too much and must stand the consequences of such over-production."

"The answer to this is, that we will hold tight to every bale of the so-called surplus and that we will reduce the next crop to proportions which will stagger those who would reduce the cotton producer to a condition of destitution."

"The bankers, merchants and farmers of this section understand the situation and its remedy perfectly. Even if the farmers were able and willing to plant a full acreage, the bankers and merchants will not supply the necessary means. This is not a matter of mere resolution by farmers to reduce acreage, but an issue of vital necessity for which the whole financial south is taking up its arms."

### DECLARES LEADERS MUST BE ARRESTED OR SURRENDER ARMS

LONDON, Dec. 7.—Sir Hamar Greenwood, chief secretary for Ireland, declared emphatically amidst cheers in the house of commons today that he was convinced there can be no truce or successful advocacy of a truce in Ireland until the extreme leaders of the Irish republican army either surrender and deliver their arms, or are arrested.

### TWO REASONS ARE ASSIGNED FOR THE SHORTAGE OF COAL

#### TRANSPORTATION DIFFICULTIES AND STRIKES BLAMED BY OPERATOR.

#### DISCOURAGES LAWS TO REGULATE THE INDUSTRY

#### Declares There Can Be No Successful Combination Among Operators.

Editor's Note: In this, the fifth of a series of articles and interviews by leaders in business, labor and industry on legislation which congress should enact, J. D. A. Morrow, vice-president of the National Coal association, tells the views of the coal men. He believes that congress should not pass more laws to regulate the industry.

WASHINGTON, Dec. 7.—I notice some talk of need of legislation for the regulation of the coal industry. This is surprising and proceeds, I am sure, from failure to understand what legislation is now available for the protection of the public against interference with the sufficiency of coal supply for the nation.

There are some ten thousand soft coal mines open and shipping coal. These mines are fully equipped with underground haulage ways, ventilating systems, mechanical equipment and employes, so that they can produce some 700,000,000 tons yearly of bituminous coal. This is 50 per cent

more coal than the country usually needs. With 7,000 producers operating ten thousand mines in 25 different states, it is nonsense to talk about combinations among bituminous coal producers to resist production or put up prices. There are thousands of acres of coal deposits adjacent to railroads, which can be opened at any time that the open market offers opportunity for profit. During the past year on one railroad more than one thousand new mines were opened.

There can be no successful combination among operators for the restriction of production under such circumstances any more than the farmers can successfully combine to put up the price of wheat, corn, cotton or other agricultural commodities. You ask them, what causes these periodical shortages of coal. Just two things: Deficiency of Transportation.

Some deficiency of transportation which for a period makes it impossible to ship from the mines the tonnage of coal needed to meet current demands. This is a matter, it may be argued, against which the public should be safeguarded and protected. I agree, what is not generally understood, however, is that this has already been done, and that the public now through simple legislation is protected against that kind of emergency. I refer to the Esch-Cummings bill, the new transportation act. On June 1 of this year the United States was shorter of bituminous coal than it had ever been on June 1 in any year of which we have a record. We were far worse off than on June 1, 1917. We faced a very grave situation, because the railroads, disorganized by government control and the switchmen's strike, were unable to ship more than about 5,000,000 tons of

bituminous coal per week, when the country needed 12,000,000 tons per week. However, under the newly enacted Esch-Cummings law, the interstate commerce commission, in cooperation with the National Coal association and the American Railway association, put into effect some practical service orders which applied enough transportation to the business of handling coal to fill up deficit to give consumers the reserve supplies they needed for this winter and to restore conditions to normal. Through the advantage afforded by the Esch-Cummings law, the country today, instead of facing a national disaster, as it did in the beginning of the winter of 1917-1918, is back to normal conditions of bituminous coal supply. Thus the Esch-Cummings law and the interstate commerce commission have been subjected to the severest possible tests of their sufficiency in the face of a grave transportation emergency and they have more than made good. Clearly, then, no more legislation is needed to protect the public against that kind of interruption in its coal supply.

Strikes Are Blamed. Now the only other serious interruption to coal supply arises from strikes. This may come from strikes not in the coal industry at all, but among railway employes, dock men, truck drivers, etc., as well as among coal miners. So far there is no protection to the public against that kind of interruption of its coal supply.

The National Coal association, by charter limitation, has nothing to do with labor matters of wage scale negotiations in the coal industry and therefore as an officer of that association, I shall make no comment upon that phase of the situation. I merely want to point out, as an individual

consumer of coal, that my own supply for my house and for any business in which I might be interested, is subject to every vital interruption in coal supply on account of strikes.

Let me say, therefore, that with the legislation now on the statute books it is clear no further law is needed for the control and regulation of the production and distribution of coal. If any legislation is needed, as I have pointed out, it is legislation which will protect the public against the interruptions which come from strikes, whether at the mines, on the railroads or wherever they may be.

COTTON PICKING MACHINE DEMONSTRATION POSTPONED

The demonstration of the Thurman vacuum cotton picker, announced to take place Wednesday on the J. A. Kemp farm, has been postponed for a few days on account of the inclement weather. Another date will be announced in a few days and the demonstration will likely take place during the coming week.

The announcement of the coming demonstration has excited much interest among those interested in cotton growing and there is a widespread desire to see the new invention in operation.

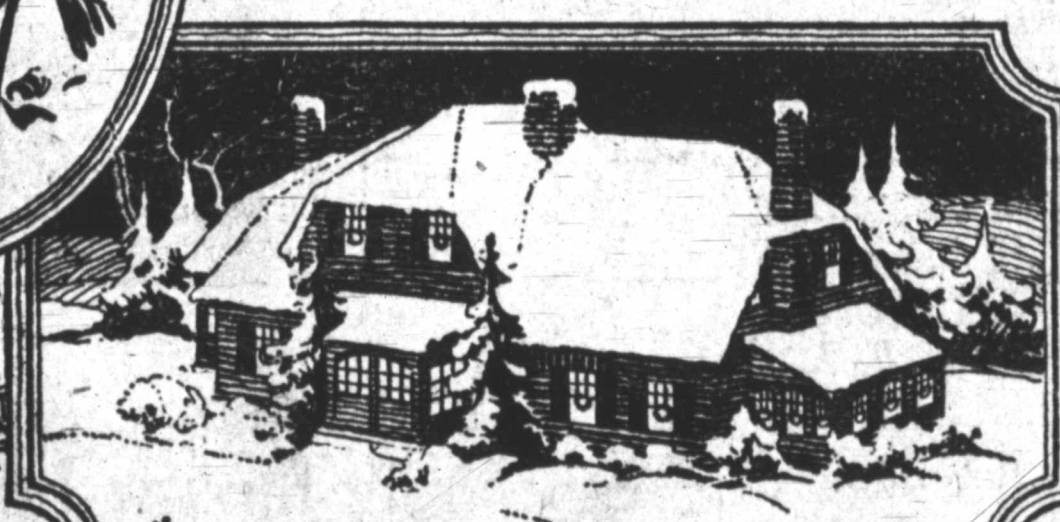

RECORD TAKES EXCEPTION.

The Fort Worth Record takes exception to the statement of J. S. Bahe, New York financier, who declared that "it took twelve years of intensive propaganda, led by the most adroit of our legislators and aided by the weight of the support of practically our entire banking community to enact a federal reserve bank into being."

"Did the representatives of the so-called financial interests of Wall street favor its enactment? Root, Frazier, Knox, Lodge and the republican statesmen or leaders who obeyed their wishes fought the enactment of the federal reserve act. Here in the south, many of the great bankers regarded the federal reserve act as a dangerous innovation."

It probably is true now that the overwhelming majority of the bankers of the country approve the federal reserve act. Many of those who doubted its efficacy—bankers, in the very nature of things, are conservative about innovations in anything pertaining to the financial system of the country.

But in the big money centers of the country there not only remains strong opposition to the present reserve bank system, but it is formidable enough to believe that by some sort of hocus-fucus, it can emanate the law of those features which are of the greatest benefit to the country at large, but which they consider inimical to their own interests.

DIFFER AS TO CABINET. Nine republican governors, attending the governors' conference the other day, discussed cabinet probabilities in the next administration. There was wide divergence of opinion among them as to the best choices President-elect Harding could make, but all nine of them agreed on several points, upon most of which most of us would be willing to join them.

Argentina's withdrawal from the league of nations assembly—whether or not the withdrawal is also from the league itself has not at this writing appeared—seems to have been founded on the Argentine delegation's predilections for all central powers and its demand that all nations be admitted to equal footing in the league, which as regards Germany the entente powers are not yet willing to concede.

### LEAGUE ASSEMBLY DISCUSSES ARMENIA AND RUSSIAN STATES

#### PLAN FOR CO-OPERATION ON TECHNICAL ORGANIZATIONS OF LEAGUE.

#### LAYING OUT A WORKING BASIS FOR ASSEMBLY

#### Find Problems Which Seem For The Moment At Least Beyond Solution.

GENEVA, Dec. 7.—Plans for co-operation on technical organizations of the League of Nations by representatives of Armenia and former Russian states, though these states are not admitted to full membership in the league, were discussed by the assembly of the league here today. This was the principal item on the agenda, having been brought into prominence by the decision yesterday of the committee on the admission of new states.

The assembly also continued the work of laying a working basis for the league which would enable it to function as efficiently as possible, pending the time necessary to effect a clear interpretation of various matters and note the practical effects of the intricate system by which the assembly and council dovetail into each other.

The most enthusiastic supporters of the league now admit there are problems in the covenant, which seem, for the moment at least, beyond solution, since it is impossible to tell how present arrangements are going to work out. The general policy adopted seems to be to let time work out a solution of some problems.

Decision was reached by the committee on relations between the assembly and council last night to apply this policy to the contested point as to whether the word "exclusive" should be eliminated from the second of the four general principles enumerated by the committee as a working basis for the league. This sentence reads at present: "The assembly has now power to modify decisions coming within the exclusive competence of the council."

The committee decided to recommend that the whole paragraph be dropped from the report rather than prolong a discussion which might be fruitless.

Work on the typhus campaign now going on in Poland and plans looking to the welfare of children in Europe were also discussed today.

GENEVA, Dec. 4.—Argentina's delegation to the League of Nations assembly wound up its affairs today. The members, headed by Honorio Pueyrredon, will leave for home the latter part of the week.

The assembly meanwhile proceeded with its task as if nothing had occurred. There were few regrets expressed yesterday. The organization showed its determination to reject Argentina's amendments for the time being by referring them to a committee to be reported on at the next session. The only amendments to the cove-

nant to receive attention at this session were in the form of a set of principles determining relations between the council and assembly. These give the assembly power to examine the decisions of the council and provide for a report from the council to the assembly.

"Any interpretation of my efforts for the admission of all states to the league as intended primarily in behalf of Germany, is entirely false," Pueyrredon told the United Press today. "Pueyrredon will go to Paris tonight. Other delegates and their assistants will remain here until Thursday."

### DELEGATES DEMAND PROTECTIVE TARIFF FOR FARM PRODUCTS

#### INDIANAPOLIS, IND., Dec. 7.—Demands for protective tariffs covering farm products from peasants to whom were demanded by delegates to the convention of the American Farm Bureau Federation, in session here today.

President J. R. Howard declared sentiment from all sections of the country was solidifying behind a tariff program, though in the past the farmer has been regarded as a "free trader."

"Our tariff demands are not radical," Howard said. "All that we want is equality in tariff legislation as it pertains to industrial and agricultural products."

The proposed duty on foreign peanuts is not intended to make the bags at the farm smaller, but merely to afford protection for southern growers, who turn much of their product into oil. They are now facing serious competition from foreign imports of vegetable oil.

Delegates from Michigan and California, the largest bean producing states, are clamoring for a duty on Japanese beans.

Canadian shipments of potatoes are worrying American farmers. Canadian farmers can place potatoes on the Detroit market cheaper because of the freight rates than can the American producers in that city, Howard.

Sheep producers are vigorously opposing shipments duty free of wool from Australia and meats from Argentina, claiming the sheep industry in the United States is endangered by this competition.

### Protest Against Recent Speeches By the Germans

BERLIN, Dec. 7.—A joint British, French and Belgian note has been handed to the German government protesting against speeches recently made in the occupied territories by members of the German government, as calculated to cause trouble and bring the execution of the Versailles treaty into question. The note offers a grave warning that such speeches by responsible persons must be avoided in the future.

### ARTHUR HENDERSON BEARS TRUCE FLAG FROM 'SINN FEIN'

#### OTHER IMPORTANT INTERMEDIARIES HASTEN BACK AND FORTH WITH PEACE MESSAGES.

#### LABOR LEADER EXPECTS TO SEE LLOYD GEORGE TODAY

#### Home Rule Bill Last Night Passed The Committee In The House Of Lords.

By WEDDIE MILLER, United Press Staff Correspondent.

LONDON, Dec. 7.—Arthur Henderson, bearer of a truce flag, was to present since-felt peace proposals to the British government today, Henderson, British labor leader, came direct from Ireland, where he talked with Sinn Fein leaders. Other important intermediaries hastened back and forth with peace messages. No flat declaration that a truce impends was made by authorities on either side but the atmosphere was clearer than in months.

At the same time there were indications that fighting will continue to the hour of the armistice, if it comes. The government continued to raid and arrest. Sinn Fein terrorists continued their campaign of ambush.

Last night a lorry load of police nearsighted Henderson was attacked in the darkness. The police hastily took cover, apparently without injuries. They were rescued shortly afterward by soldiers.

The government pursued its policy of tracking down Sinn Fein leaders by surprising the Dublin corporation in the city hall and arresting six members. One of these was a member of parliament elected by the Sinn Fein. The prisoners were taken to one of the internment camps nearby.

Henderson expected to see Lloyd George today and it was believed the premier would arrange a meeting. The premier in common last night reiterated his cautious assertion that he was willing to discuss with any authorized and responsible persons any question that would bring peace to Ireland. He said he was trying to learn whether Father Michael O'Flanagan, vice-president of the Sinn Fein, who asked him what the first step toward peace should be, was "the man on the bridge."

The home rule bill last night passed the committee in the house of lords, when it was voted to eliminate the clause under which Ireland would be governed as a crown colony in case an insufficient number of Irish legislators refused the oath of allegiance.

#### GOVERNMENT IS DEFEATED IN THE HOUSE OF LORDS

LONDON, Dec. 6.—The government was again defeated in the house of lords tonight when an amendment proposing a new clause in the home rule bill, offered by the Marquis of Salisbury, was carried by a vote of 31

to 55. This amendment provided that neither the northern nor the southern parliaments should be established under the king's authority and the protection of the rights and liberties of all persons in both northern and southern Ireland were fully assured, and that otherwise the appointed day for putting the act in force should be fixed by resolution of the imperial parliament.

### WILL PRESENT FOUR BILLS DEALING WITH COTTON MARKETING

WACO, TEXAS, Dec. 7.—Newt B. Williams, representative in the state legislature from McLennan county, will introduce four bills in the coming session of the legislature designed to regulate the marketing of cotton. They will provide for bonding cotton buyers who must stand examination as classifiers, districts for taxing to build warehouses, for compresses to be attached to warehouses, and prohibiting compresses from charging a fee for storage on cotton received by them from warehouses.

### Says No Home is Complete Without A Boy and a Girl

EVANSTON, ILL., Dec. 7.—No home is complete without a girl and a boy. It takes more brains to run a home than to be a stenographer. A housewife has to have just as good a head on her as a business woman.

Rev. James Madison Stifter, pastor of the First Baptist church here, told this to the United Press today, without explaining his reasons for starting the school.

"I am not advocating that every home should have fourteen children," said Mr. Stifter. "But I do believe that every home should have a boy and a girl."

Stifter said he founded the school not because he believes there is anything wrong with the American home, but because he wants more of them.

"There isn't more importance in this crisis of American life than that the spiritual value of a home should be increased," he said.

"I am an American and believe in the American home. I don't believe the American home equaled anywhere in the world. But I believe we ought to have more of them."

"Everybody ought to have a home. It should be a home that would keep husband and wife at home instead of out seeking a good time."

"To keep them home there should be a boy and a girl. It is not a home until they have two children."

Stifter said that instead of girls going to work in the business world they should stay at home and help their mothers. Stifter launched his school for newly weds a week ago. Twenty couples attend the first class.

### MEASURE PLANS TO PERMIT A LIBERAL CREDIT TO FARMERS

#### WASHINGTON, Dec. 7.—Immediate consideration by the senate farmer relief legislation was considered probable today with the report of a joint resolution by the agricultural committee receiving the war finance corporation and directing the federal reserve board to permit extension of "liberal" credits to farmers.

Senator Gronna, chairman of the committee, announced he would urge immediate action on the resolution and members of the committee expressed confidence that sufficient votes were in sight to insure its adoption.

The war finance corporation, which the resolution would revive with a view to securing greater sales of surplus farm products abroad, had made total advances of \$35,961,464 up to May 10 last, when its loan activities were suspended by the secretary, according to the annual report of the corporation made public today. Repayments of \$23,234,439 up to November 26, had left a balance outstanding of \$12,727,025, the report showed.

During the past year advances made by the corporation have been principally to aid in financing exports. It was said, the total of such loans amounting to \$46,347,654, of which \$4,274,912 has been repaid, leaving outstanding a balance of \$42,072,742. Summarizing its export advances the corporation showed that \$12,229,099 was loaned to send flour, grain and foodstuffs to Belgium.

During the past year the report declared the corporation had made every effort to liquidate its outstanding cattle loans without entailing undue hardship upon borrowers. At the beginning of the year, the amount of these loans outstanding was \$1,452,714, which was reduced through repayments to \$792,096, while the total advanced on these loans was \$7,827,274.

### ARGENTINE PRESS IS DIVIDED ON COMMENT AS TO WITHDRAWAL

#### BUENOS AIRES, Dec. 6.—News papers here are divided on their comment on the withdrawal of the Argentine delegation from the assembly of the League of Nations.

Some complain that the government had not taken the people into its confidence as to its position before the departure of the delegation for Geneva. Others assert Argentina has put itself in the position of being an advocate of Germany.

La Nacion says the position of the Argentine delegation is impossible. "The delegation was sent with a mysterious mission whose object was to disaste the world," it asserts, "declaring itself thereby the champion of the German disaster." It only succeeded, as was logical, in making its participants of this disaster. Thus, like the defeated countries, we remain outside the league.

"But while for them the situation is a tragic result, and while for the United States it is a complication of the treaty of Versailles, which it is able to accept or not as a conquering power, and while for Rumania it is a question of principle diametrically opposed for us it constitutes a fact. It is worse than collapse; it is ridiculous."

#### AUTHORISED AGREEMENT FOR AN EXTENSION OF PAYMENT

WASHINGTON, Dec. 7.—The interstate commerce commission today authorized the Trans-Mississippi Terminal Railroad company and the Texas Pacific Railway company to enter into an agreement with the Missouri Pacific Railway company for the extension of the payment of \$2,437,500 worth of six per cent three-year gold notes.

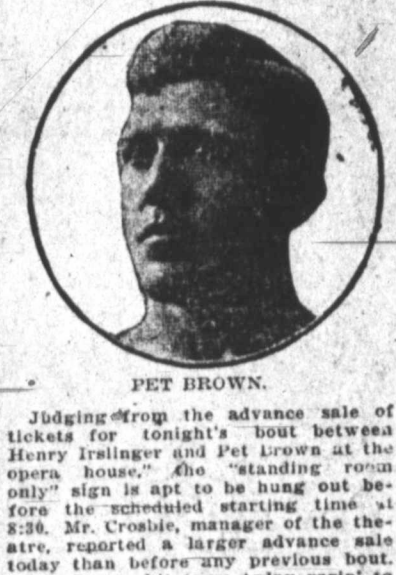

MCGRAW WOULD PERMIT IRLINGERS TO DRY BALL RATHER THAN WET IT

John McGraw, in a New York interview, gives the impression that he is not so much concerned as to whether the spit-batters get a reprieve or not, but he does think there should be some modification of the rule that would permit the pitchers to dry the ball, rather than wet it. Says McGraw: "In my opinion the cause of the tremendous hitting of the season is the rule which prevents the pitchers from custom of putting rosin on their fingers in order to take the gloss off the ball. The strict enforcement of this rule has handicapped all of the pitchers. 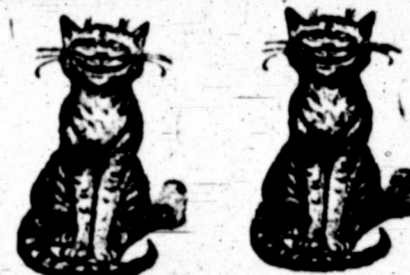

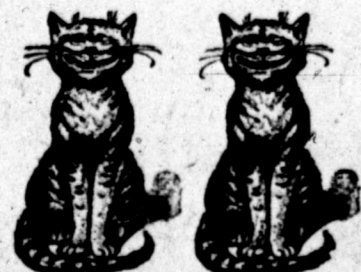

Formal Opening of Halton & Friedly  
In Their New Store At Eighth  
And Indiana.

Between 4 o'clock yesterday afternoon and 10 last night thousands of Wichitans braved the stormy weather to attend the opening of Halton & Friedly's new store. Exclamations of delight and admiration were heard on every hand and the proprietors were busy receiving the congratulations of their friends.

In the planning and furnishing of the establishment no pains nor expense have been spared and the result is an atmosphere of unostentatious elegance that is suggestive to the Chicagoans of the mercantile house of Marshall Field and company in that city. In fact this latest acquisition of Wichita Falls would not be out of place among the best mercantile houses of any city in the world, not excepting Paris itself.

**Furnishings Solid Mahogany.**  
The furnishings are of solid mahogany and were especially made for this store. Before the heavily braced-trimmed street door stands a U-shaped counter and show case for the display of such jewelry as brooches, pins, chains and charms, and this case is lighted by electric globe which throw their rays upon its interior but which are not visible to the eye of the passer.

Beneath the plate glass top of the silverware counter are to be seen glittering specimens of such small articles as spoons, forks and napkin rings, and here the shopper may sit and make selections at leisure. The main stock represented by these samples being stored beneath in receptacles which are accessible from the rear of the counter. Behind this stands a wall case for the display of larger articles of silver, as platters and cake stands. The doors of this and the other wall cases consist of unframed sheets of plate glass which move upon roller bearings.

**Private Rooms Provided.**  
Behind the wall cases on the Eighth street side are two tiny rooms where the purchaser of diamonds may make selection at leisure and in privacy. Each one of these rooms is equipped with a little table measuring about 12 by 24 inches.

The show case in which diamonds are displayed is lighted by a specially constructed fixture that has multiple reflectors which catch the light rays and concentrate them upon the object held below.

The cut glass room is entirely devoid of mirrors or other camouflage which is usually found in such places. Each piece of glassware, standing upon a plain shelf of plate glass, has for

From the account of Wolf's difficulties it appears that he did not carry automobile liability insurance when his car caused a serious accident, with the result that the costs of the suit instituted against him, together with the judgment secured by the injured person, forced him into bankruptcy.
