MOTION IN ACUFF CASE PASSED OVER FOR SEVERAL DAYS

BRIEFS ARE SUBMITTED BY STATE AND DEFENDANT ON LAW IN CASE.

DEFENDANT ALLEGES 300 MEMBERS IN KLAN

Attorneys He Has Right to File Motion to Quash Given Under Constitution.

Arguments in the B. W. Acuff motion to quash the indictment were not heard Monday by Judge Ed Miller and Judge P. A. Martin. The hearing was passed over for the time until several criminal cases in which announcements of ready were received, are tried. It is possible that it will be heard the latter part of the week.

Both the state and the defendant have filed their briefs citing the law and decision which they contend are applicable in the case. The defendant's brief is a lengthy one containing over 40 paragraphs.

The defendant alleges in his brief that there are at least 300 members of the Ku Klux Klan in Wichita county and that the grand jury commission selected grand jurors from this number when in fact there were from five to six thousand qualified grand jurors in the county.

Another paragraph in the brief contends that the grand jury commission corruptly declined and refused to select the members of the grand jury from the citizenship of different portions of the county, but instead selected members of the K. K. K. for this service.

The state relies to have the motion dismissed on the ground that the defendant is not showing any injury and that his motion to quash is nothing more than a challenge to the array of the grand jury. It contends that the time for the filing of motion has passed, alleging that it should have been done before the grand jury was impaneled and stating that the defendant was at that time under arrest and in fact was well aware of the fact that the grand jury was being impaneled and that his case would be under investigation.

The defendant contends that under article 14 of the 14th amendment to the constitution of the United States that he has a right at any time to declare his rights to a fair and impartial trial and to a fair and impartial investigation of the offense with which he stands charged.

Other Speakers Heard

C. I. Francis, attorney, declared that the remedy lay with the district judge and the district attorney who, he said, "must be more nervous and brains and understanding of their business."

Further criticism of the legal profession came from B. F. Johnson, who asserted that an attorney man with money could hire attorneys to block and delay and clutter up with technicalities the efforts to punish him.

P. B. Cox, attorney, replying to Mr. Johnson, sought to place the responsibility on the public. That portion of the public that attended the meeting manifested its resentment of his remarks by crying "sit down," but up, although there were some shouts of "tell it to 'em" as well.

Mr. Cox held the floor and declared the public was to blame for the situation. He stated that he was so low that the right sort of men could not hold office, and second, for laxness and indifference in the law enforcement.

The meeting then proceeded to perfect its organization.

TEXT OF RESOLUTIONS

Work of Grand Jury. Where, as our jury commission and grand jury commission was composed of the best men in this country, men who have the interest of our community upon their hearts, men who are for the moral uplift of our citizenship, and

Whereas, it has spent six weeks laboriously in its effort to apprehend and punish the law-breakers as a great personal sacrifice to each member, now

Resolved: That we endorse the grand jury in its good work and hereby pledge our efforts in the law enforcement which the grand jury has started.

Quicker Trials Urged. Be it Resolved by the citizens of Wichita county, Texas, in mass meeting assembled:

That the district and county judges having jurisdiction in Wichita county, Texas, are hereby respectfully requested by all means in their power to expedite the trial of all criminal cases, to the end that persons charged with crime may be tried promptly and convicted or acquitted as the law and facts may require.

We respectfully request that all the judges trying cases in this county shall, so far as practicable, give the trial of criminal cases preference over civil cases, except those civil cases where an immediate trial is necessary to protect the rights of the parties.

District Attorneyship. Be it Resolved: That the executive committee of this association is hereby authorized in the name of the association to recommend to the governor of this state a proper person for appointment to the office of district attorney of the 33rd judicial district, which office is now judicially vacant, and to make such recommendation to be made not later than Tuesday next.

Conduct of Attorneys. Be it Resolved: That whereas, it is currently reported that it is the practice of certain lawyers engaged in the practice of law in Wichita Falls, Texas, and who represent defendants charged with violation of the criminal law, to use what is commonly designated as professional bondsmen, or persons who habitually act on bonds of persons who are represented by such lawyers, and

Organizations. We respectfully request that the authorities shall investigate such practices and if they are shown to exist, that proper steps be taken to prevent the same and to take such other action as may be necessary, in the premises.

Be it Resolved by the citizens of Wichita county, Texas, in mass meeting assembled on this the 26th day of February, 1922:

That an organization be created to be known as the "Wichita County Citizens' Association."


That the general purpose of this association shall be to, by all proper and legal means, assist the courts and all officers charged with the enforcement of the criminal laws in the prosecution and punishment of all crimes of the grade of felony, and to accomplish these ends by inducing the following method of organization and action is adopted.

First—Every man and woman residing in Wichita county who shall declare himself or herself in sympathy with this movement, is eligible to membership in this organization, and a nominal fee for membership of (\$1.00) dollar shall be collected, to be expended under the direction of the executive committee, hereinafter expressed.

Second—The managing officers of this association shall consist of an executive committee of 25 members, to be selected from all portions of Wichita county. The executive committee shall consist of five members each from Burkburnett, Electra and Iowa Park, and their vicinities, and of 10 members from the city of Wichita Falls and vicinity, each community to select its members.

Third—The said committee shall have control of the management of the business of this association, and it shall be its duty to take such steps as it sees proper to carry into effect the purposes for which this association is created, and to that end direct the members of the association at such times and places as they see proper. And it shall be their duty to give the officers charged with the administration of the criminal laws, assisting as in their judgment may be necessary or desirable, and shall have a right at any time to call upon any member of this association for any assistance which in the judgment of the committee ought to be rendered by such member. The said committee shall further have the power and it shall be their duty to keep informed as to the progress of the association, and to advise the members of the association of any violations of their duties by such officers, and the said committee shall, if satisfactory evidence is obtained that any peace officer or other officers charged with the enforcement of the criminal laws, has willfully failed to perform his duty, take such steps as may be necessary to secure the removal of such officer from office, and shall have a right to call upon any member of this association for such assistance.

EXPECT THOUSANDS AT FAT STOCK SHOW

Low Rates Announced for Exhibition at Fort Worth March 11 to 18.

FORT WORTH, TEXAS, Feb. 27.—With special round trip railroad rates of a fare and a fifth having been granted for the Southwestern Exposition and Fat Stock Show March 11 to 18, exposition officials are arranging to take care of thousands of out-of-town visitors.

When the gates of the annual show are thrown open for the 1922 presentation the public will witness a greatly enlarged exhibition which under its program of expansion has built up the old departments and created several new departments.

For these new divisions of the show the exhibition has taken over several large concrete buildings located adjoining the exposition coliseum. These structures are being remodeled and brilliantly illuminated, attractively decorated and converted into spacious exhibition halls.

In each of these buildings, day and night, will be several forms of free entertainment aside from the exhibition itself. Five thousand dollars is being spent for these attractions, Hawaiian quintets, vocal quartets, jazz bands, singers and dancers and several brass bands will make up a part of the free entertainment that will carry out the exposition's plan for "something doing every minute—day and night."

An automobile show that is expected to set a new standard for such events in brilliancy and quality is being arranged. Henry H. Marks of Chicago, known as the wizard of motor car shows and exhibitions, who has staged such attractions in a number of states, is directing the motor car show program as well as plans for the other added departments. The automobile show uses a part of the added 200,000 square feet of floor space which will be used this year for the first time.

Entries from many sections of the state are expected in the new agricultural division. Many counties and individuals have written the exhibition management asking for information on the agricultural exhibits.

West Texas counties have started a concerted drive under the direction of the west Texas chamber of commerce to have west Texas and panhandle counties well represented in the agricultural as well as livestock shows.

Latest in spring styles will be portrayed by beautiful girl models. The style show will be given at the exhibition matinee and night of the exhibition. There also will be gentlemen and children models.

Fashions also will be displayed in the commercial exhibits. Local manufacturers, jobbers and bankers have taken space for exhibits.

Probably the largest pet stock show ever seen in Texas will be presented this year. Large cash prizes as well as trophies have been offered to attract entries in the rabbit, dog, poultry and pigeon shows.

The exposition will be opened on the night of March 11 with a mammoth pageant directed on the most elaborate scale ever attempted in this state. An attractive castle with numerous electrical and waterfalls effects is being constructed under the leadership of experts for the setting of the coronation of the "Queen of the South." The identity of the queen will not be revealed until she appears before the coliseum crowd.

A huge lamp shade, the largest ever built in the south, which will be sixty feet in diameter, will hang from the center of the coliseum over hundreds of electric lights. Underneath the shade will hang a large ball made out of 1,200 mirrors upon which spotlights will play.

The ladies' fashion display automobile parade will be held on society night, March 12. Each matinee and night thereafter the program in the coliseum will consist of every ranch in the United States on which is a cowboy or cowgirl who has won honors in western contests will be represented in the rodeo, according to Manager Ray McKinley. Horse show features will be held in connection with the rodeo.

Secretary Manager M. Sansom Jr. is receiving many live-stock entries which give indication that the exposition will present a million dollar livestock exhibition. He has started a campaign to bring Mexican buyers here for the exposition to stimulate interest in the sales feature of the show.

MEMBER OF U. S. RELIEF WORK IN MOSCOW IS SHOT

MOSCOW, Feb. 27.—J. B. Murray of Woburn, Mass., connected with the American relief administration, suffered a slight flesh wound when fired upon in the street early yesterday. He was accompanied by a Mr. Callahan of Fall River, Mass.

Whether the shot was fired by a highwayman or by street patrols who misinterpreted the actions of the Americans, has not been determined.

Murray and Callahan were driving home when they saw a sleigh ahead of them, several shots were fired at them, one hitting Murray, who, however, was able to continue running and reached a nearby house.

Neither one understands Russian, but they succeeded in making the patrols, who quickly arrived, understand that they were Americans, and were assisted home.

American relief administration employees familiar with Moscow are inclined to the theory that street patrols had halted the sleigh ahead of the Americans and fired on the Americans to stop them for investigation.

ACCIDENTAL SHOT WOUNDS WATCHMAN. IS STRUCK IN KNEE

J. R. Scarborough, night watchman at the Goodhue Wholesale Grocery at 10th and Commercial, was struck Saturday night suffering from a bullet wound sustained when his revolver was accidentally discharged. The shot hit Scarborough in the right knee and although painful is not serious.

The accident took place about 1 o'clock Saturday night and came as a result of an investigation started by Mr. Scarborough when he heard a noise in the building. He was in the warehouse. His revolver was resting in the pocket of a rain coat.

Mr. Scarborough was wearing and carrying the coat when the shot was fired. He was discharged. The injured man remained at work for some time and finally summoned a doctor. He was taken to the hospital where an examination disclosed the wound to be of superficial character.

LOCOMOTIVE SHOPS OF THE 'KATY' AT DENISON WILL RESUME MARCH 6

DENISON, TEXAS, Feb. 27.—The locomotive shops of the Katy railroad of this city which have been closed since January 19, will resume operations March 6 with a full force, it was announced today from the office of F. K. Tait, mechanical superintendent. About 450 men are affected by the order.

All locomotive shops on the system, including the one at Parsons, Kan., will be reopened at the same time the superintendent's office further stated.

MORE JURORS NEED SUMMON THIS WEEK THAN EVER BEFORE

Despite the unfavorable weather conditions more jurors reported for service Monday morning than ever before, according to those who have been connected with the courts in the impaneling of the jury for the week.

Over 100 men who were called for special duty, nearly 50 reported for this number probably 15 were excused, leaving a total of 45 men to be interchanged among the courts now in session.

Those who are interested in the organization of the law enforcement officers found gathering in their own quarters on Sunday, stating that the citizens of the county have awakened to the realization that it is their duty that devolves upon them to respond to jury service.

Fourth—The executive committee shall further have the right and authority to examine the qualifications of all persons who shall offer themselves as candidates for any office connected with the enforcement of the criminal laws, and to call meetings of the membership at large at any time they see proper for the purpose of selecting and recommending suitable persons for such offices, and the members agree to seriously consider such recommendations and unless in their judgment better candidates are offered, to accept same.

Fifth—The executive committee shall meet promptly upon the call of the president or secretary and two vice-presidents and a secretary and treasurer of the association, which officers shall perform the duties usually performed by such officers in organizations of this character.

Sixth—The members of the executive committee above named from each of the several vicinities referred to in this resolution, shall meet and assist in the organization of the criminal law enforcement officers in their vicinities.

Seventh—The executive committee shall have the right to make such by-laws and other regulations as they may see proper in order to carry out the purposes for which this organization is created.

Eighth—On amendment from the floor—Should any of the communities mentioned herein fail to form a part of this organization, the organization will nevertheless function in those communities which are organized.

DOUKHOBOURS LEADER SENDS APOLOGIES AND MAKES AN EXPLANATION

NELSON, R. C., Feb. 27.—The Doukhobours of Canada, otherwise known as the "Christian Community of Universal Brotherhood," merely expressed a theoretical advocacy of massacre of their children and aged, according to the explanation now offered by Peter Verigin, president of the band, in a letter to the Daily News here. In his letter he expresses some alarm at the apparent indignation of Canadians over the announcement of the sect some days ago, that the members were contemplating migration to escape taxation, in which event it might be found necessary to kill off children and aged persons who impeded the progress of the wanderers.

After apologizing to the Canadian public, particularly the women, the Doukhobour chief explains that the children of the colony are deprived of milk through the forced sale of cows in 1920 for the payment of taxes.

The letter concludes with a plea for official inquiry as to the end that the Doukhobours be reimbursed for the losses they have incurred and ask for \$50,000 loan to be spent in irrigation.

MANY IDLE STEEL MEN SENT BACK TO WORK IN YOUNGSTOWN DISTRICT

YOUNGSTOWN, OHIO, Feb. 27.—Several hundred of the thousands of idle steel workers have went back to work today with increased operations in the steel mills of this district. Open hearth steel production today reached more than two-thirds of capacity with the Carnegie Steel company. Fabricating plants also reported better operations. There is no change in the blast furnace production.

RESUME OPERATION ON THE WEST VERNON WELL

VERNON, TEXAS, Feb. 27.—Operations have been resumed in earnest on the West Vernon well, and drilling is in progress. Under the terms of an agreement with fee owners, actual work was resumed on the fifteenth, but most of the time since then has been spent in tuning up machinery. It is proposed making the West Vernon well the first deep test in Witharage county.

"Being the oldest policeman in the world is a big honor," he said, "and I'm glad to have it." "All you have to do is to shoo the kids off the grassy beds here in the park in the summer, and to see that none of them young fellows gets too fresh with the girls that parade the streets in these new short skirts."

Sam was listed on the police roster here for so long that even officials themselves can't remember when he started.

Sam was born in 1824 in the ancient fishing village of Barnegat, N. J. With him, being a policeman is an avocation. He started as a plain clothes man in the government secret service at the time of the St. Louis whiskey ring before the civil war.

Sam, pointing to his remarkable eyes, said to emphasize his remarks, says: "In 1861 I was Lincoln's personal bodyguard on the way from Illinois to Washington for the inauguration."

Daring to have that statement questioned and have it pointed out that if all such claims were true, Lincoln must have had 5,000 bodyguards, Sam assumes an air of injured dignity.

"I was a champion sprinter in my time, too," he adds. "Lincoln once said to me: 'Well, Sam, you can run faster than I can, but I can split more rails than you.' But I don't suppose you believe that, either."

Sam says he went into the north-west first in 1858 to watch for poaching Canadian trappers. Now he has switched to watching for mashers.

"See those numbers on my badge?" He displayed it proudly. "Twenty-three." "That don't mean anything special for me, for I'm going to live a long time yet. But it means 'git' for them young mashers fellows."

MORSE INDICTED WITH THREE SONS AND SEVEN OTHERS

CHARGE CONSPIRACY TO DEFRAUD IN ONE INDICTMENT

CONSPIRE TO COMMIT OFFENSE IN SECOND

Involves War-Time Transactions Of Morse and Associates.

WASHINGTON, Feb. 27.—Indictments against Charles W. Morse, New York shipbuilder, his three sons, Benjamin, Harry and Ervin; Colin H. Livingstons of Washington, president of Florida Shipbuilding corporation, and seven others were returned today by the federal grand jury which has been investigating the war-time transactions of Morse and some of his associates with the shipping board.

Others named in the indictments are presented to the strict of Columbia supreme court included: R. O. White of New York, former president of the International Transportation company; George M. Burdette of New York; W. Scott, Washington, attorney; L. A. Christie of Alexandria, Va.; Nehemiah Campbell of New York and Phillip Rhinehart of Baltimore, former government auditor at the Virginia Shipbuilding plant.

Two indictments were returned one charging conspiracy to defraud the government and the other charging conspiracy to commit offenses against the government.

The conspiracy as charged by the government against the defendants making false statements as to the value of their plant and assets and thereby obtaining loans from the shipping board.

Those indicted either were or still are connected with the Groten Iron Works, Groten, Tenn., the Virginia Shipbuilding corporation, Alexandria, Va., or the United States Transportation company, Inc., which concerns are known as the Morse concern.

Morse in a statement issued through his attorneys after the indictment against him was returned declared the proceedings against him were the result of "animus" on the part of Attorney General Daugherty.

REPORT ON EXPENSE OF PRISON SYSTEM

Board Outlines Cost Involved For Maintenance During Seven Years.

By Associated Press. HUNTSVILLE, TEXAS, Feb. 27.—A report on the cost of the penitentiary system of Texas is in need of money for maintenance and support and efforts are being made by Governor Hogg to secure the necessary funds without calling a special session of the legislature.

A statement of the board of penitentiaries for the year 1922 is in the amount of money expended in the support and maintenance of the system since 1915.

From 1915 to 1920, inclusive, a period of six years, \$6,566,201.06 was expended for the maintenance and operating expenses of the penitentiary system.

The Texas state penitentiary was established in June of 1849 under Governor Bell's administration.

Early in that year, ten acres were bought by the state at Huntsville, a wooden building and corral erected as a nucleus to what in all probability is the largest penitentiary system in the United States.

Payette county is given credit for the first commitment in July, 1851, a white man was received for a term of three years for cattle theft.

The same man was pardoned in September of 1851, it is charged that records show this pardon was the first ever issued to a convict in the state of Texas.

On September 28, 1851, the first attempt to escape was made. This man was killed, which is also the first in the history of the penitentiary.

As the years went by, the population of the penitentiary began to increase. Up to 1876, 1,139 commitments were received. In that year the branch penitentiary at Rusk was opened. On July 5, 1878, the records show that 4,231 convicts were carried on the rolls, of which 1,411 were new men received during that year.

The year 1921 brought to the penitentiary the largest amount of newly received men since it was established, according to Mr. Herring, 1,641 men and women having been committed. The population of the penitentiary on December 28, 1921, was 5,153.

SENIATOR CRITICAL OF NEW PRIVATE LOANS TO EUROPE

WOULD LIKE ASSURANCE THAT MONEY WILL GO INTO INDUSTRIES.

FOREIGN DEBT PROBLEM WORRYING THE LEADERS

Seen As Involving Question of Huge European Military Establishments.

WASHINGTON, Feb. 27.—Doubtless the American newspapers are reading pretty carefully and fully by foreign ambassadors resident in Washington from the countries that want us to go to Europe.

Mr. Hoover is a member of the new commission to handle these foreign debts. He is also one of the members of the cabinet who would have much to say on the point of whether we are to loan or not.

Mr. Hoover in his recent speech did not mention Genoa and did not allude to the Greek debt. He did allude to the economic practices of some of the governments of Europe.

In Great Britain and some other states, Mr. Hoover said, "reasonable hopes of economic stability are being attained. Yet their progress is threatened by the steady degeneration of governmental finance in some of the states on the continent."

The armies being maintained at great expense by some of these countries were mentioned by Mr. Hoover in his speech. He said that if the United States were to have an army of 1,500,000 men and reserves of 2,000,000, so long as these countries continue to spend money on the maintenance of their armies, there is little hope of economic progress.

Mr. Hoover continued, "there is little hope of economic progress. The economic loss in the decrease of national savings is one of the great difficulties of Europe."

Against Big Armies. For the foreign governments concerned, the chief thing in Mr. Hoover's further statement that "we have a desire to help. But before we do so we must be sure that we are not creating a situation of alarm and threats of political action and its possibilities of war."

Aside from this utterance of Mr. Hoover's, some senators have recently made a point of stating that the United States should not be asked to subsidize the military establishments of European governments that already owe the United States government huge sums long overdue. If this money were used for other productive purposes, if it were used to revive and stimulate industry the senators would find no objection; but if it is used to subsidize the military establishments of European governments, they are already being too long unbalanced.

It is quite possible that we shall reach a time when our government will want to look into new loans requested by our debtor governments from American bankers making reports from the central markets of the department here.

With the announcement that plans to install agricultural markets and warehouse in the department here had been completed at a conference between the state department of agriculture, markets and warehouse department, University of Texas and federal bureau of crop estimates and markets, plans for the co-operation of the chambers of commerce were revealed.

Negotiations are said to be under way in the Indian state of commerce at Dallas to enlist the aid of members of that organization.

FAIR ASSOCIATION WORKERS ARE BUSY DESPITE WEATHER

START MONDAY MORNING TO COMPLETE SUBSCRIPTION LIST OF \$200,000.

HOPE TO FINISH FUND WITHIN SHORT TIME

One-Fourth of Amount Required Has Already Been Pledged, \$150,000 to Be Raised.

About two score workers, appointed at Friday night's meeting, have this task in hand, and it is hoped to complete the subscription within a few days. About \$50,000 was raised at Friday night's meeting, leaving a total of \$150,000 to be secured this week.

Just as soon as it is seen that the subscriptions will reach the mark set, arrangements for the purchase of the land, and for the construction of the stadium will be perfected. It is hoped to have the grandstand completed in time for the May fair.

DECLARES YOUTH MUST BE TAUGHT LAW OBSERVANCE

Dr. T. S. Pittenger of the First M. E. church Sunday evening brought a forceful message to his hearers upon the subject of "How shall I implant his law upon the minds and hearts of His people," declaring that it is with the boys and girls, in the period of their innocence, that parents must start the period of training that will enable them to become law-abiding citizens and God-fearing people.

The scripture for the evening was taken from the 19th Psalm and the text from the book of Hebrews. The pastor declared that he has been watching some boys at play upon the church lawn, and that then they would come over to the court house yard, that no one cared for these boys, seemingly, yet these were the citizens of tomorrow and were the ones that would have to answer for crimes that had been committed, because they had not been taught to do right, or would be the men that would stand for law enforcement," he said.

"Nobody seems to care for some boys, yet Christ came into the world and gave His life for them and made them strong men and God-fearing men.

"We had a great mass meeting this afternoon and a committee of 25 was formed to help with the suppression of crime and that is fine, but back of all this there must be the law written into the minds and hearts of the boys and girls. There is no redeeming force to correct law breaking unless the basic laws of God are imprinted upon the mind of the child. When that destructive idea is written upon the mind of the boy it will make a criminal out of him unless something stronger is imprinted to crowd out the evil idea. There is a difference between the boy that has had the law of God written into his heart when a child and the one that has had nothing written upon his mind and into his heart, yet many boys are growing up without anyone's taking enough interest in their wrong way.

"There are many boys not over 10 years old now that know more, that they ought to know, than their fathers knew at 10, and why? Because someone has taken the trouble to tell them that which they ought not to know and no one else has taken the pains to tell them the things that ought to be told to them. It is the business of the parent, the teacher and the church to see that the proper impression is given the youth. We have had 100 boys using our gymnasium all winter, and I have been here every night looking after them because I figure a preacher can do no bigger business than to help the boys of his community.

"God has said that he will write His statutes into our hearts. He sent Christ into the world in order that he might grip our hearts and cause us to love to do the thing that is holy and true. The thing that is worth while is gripping the boys so they can be taught to let alone the things that are not right and to get hold of those things that will make strong men and women out of them, and men that are not afraid to stand for the upholding of righteousness. Livingston's purpose to do the will of God was so written upon his mind that he was willing to do what God wanted him to do and go where God wanted him to go, and that is the way that Stanley was led to follow him. Christ was sent into the world to implant the love of God, His service and His law into our minds and hearts so that we shall be fulfilled men and women, and shall have the impulse and desire to write these same things into the minds and hearts of the boys and girls in our community today. May God help us to do no less than this."

COLONNA TOGGERY IS SCENE OF WHOLESALE ROBBERY SATURDAY NIGHT.

SECOND CASE OF KIND WITHIN RECENT WEEKS

Store Is Looted in Systematic Manner—Entrance Effected Through Rear.

Working methodically and apparently knowing perfectly well what they wanted and where it could be found, thieves Saturday night looted the Colonna Toggery shop, 707 Indiana avenue, of wearing apparel valued at approximately \$2,000. The theft was the second large one reported to police by local merchants within a month.

According to City Detective Jack Miller, the robbers gained entrance to the Colonna store by leaving away from the roof of a small building located on an alley at the rear of the building and then forcing open a door giving access to the main rooms.

From the appearance of things Sunday, the robbers were in a hurry to get out. They took their time in going through the stock. Boxes and crates had been opened, expensive goods and dresses hanging in the store were making an appearance of the loss Monday and estimated the value of the robbers' loot at \$2,000 or possibly more.

ONLY FIFTEEN DAYS IN WHICH TO FILE YOUR TAX RETURNS

Taxpayers have 15 days, not including Sunday, in which to file their income tax returns for the calendar year 1921. To avoid penalty, the return, accompanied by at least one-quarter of the tax, must be in the hands of the collector of internal revenue or a deputy collector on or before midnight of March 15.

Returns may be mailed or filed in person at the office of the collector, Dallas, Texas, and the following branch offices: Fort Worth, Tyler, Abilene and Wichita Falls, Texas. Payment may be made by check, money order or in cash. If made at a branch office, payment should be by money order or check, to avoid danger of loss in transmission to the office of the collector.


Where in exceptional cases such as illness or absence, a taxpayer is unable to make a return within the time prescribed, an extension of not to exceed 30 days may be obtained upon application to the collector. Such an extension will be granted only when in the judgment of the collector, further time is actually required for the making of an accurate return. Application for such extension must be made prior to March 15.

The absence or illness of one or more officers of a corporation will not be accepted as a reasonable cause for failure to file the return within the prescribed time, unless it is satisfactorily shown that there were no other principal officers available and sufficiently informed as to the affairs of the corporation to make and verify the return.

As a condition of granting an extension of time for filing a return, the collector may require the submission of a tentative return. Tentative returns will not be accepted unless permission is obtained previously to filing. A copy of the authority for filing the tentative return must be attached thereto when filed. When a taxpayer files a tentative return and fails to file a complete return within the period of extension requested by him, the complete return when filed is subject to penalties prescribed for delinquency.

If before the end of a 30-day extension granted by the collector, an accurate return cannot be made, an appeal for a further extension must be made to the commissioner of Internal Revenue, Washington, D. C., with a full recital of the causes for delay. The commissioner will not grant an additional extension without a clear showing that a complete return cannot be made at the end

of the 30-day period. For failure to file a return on time, the taxpayer becomes liable to a penalty of not more than \$1,000 and a further penalty of 25 per cent of the amount of tax due, unless he later files a return and it is satisfactorily shown that the delinquency was due to a reasonable cause and not to willful neglect.
