ARMOUR DOES NOT APPEAR TO TESTIFY AT PACKER HEARING

ATTORNEY ANNOUNCES HE WILL BE ON HAND WEDNESDAY.

GOVERNMENT CHARGES MONOPOLISTIC PRACTICE

Hearing Held Before Commissioner of Department of Agriculture.

KANSAS CITY, MO., March 27.—J. Ogden Armour, president of the packing company that bears his name, did not arrive here this morning to testify as a witness in the department of agriculture, hearing of charges against the packing company. Attorney for Armour company announced that Mr. Armour would be on hand Wednesday to testify.

In opposing the motions John S. Boid of counsel for the plaintiffs said: "We shall show that this is the most monstrous scheme the packers ever attempted to put over."

Charges of monopolistic practices in the conduct of the Mistletoe yards here, tending to depress the price of hogs and to bring about an open and competitive market were brought against the Armour company, January 23, 1922, by J. P. Fanning and Frank W. Hainner, livestock commission men, acting for the Kansas City livestock exchange.

Violation of the federal packers' stockyards control act, 1918, is charged. Under the provisions of that act the hearing is being held before a commissioner of the department of agriculture, J. T. Hainner.

Thirty-nine associations of livestock producers and farmers have filed a separate motion in the charges against the Armour company.

They assert Mistletoe yards privately has given exclusive rights to selected shippers who deal with the Mistletoe yards, extending all cooperative associations. The price of hogs is fixed arbitrarily at the Mistletoe yards, that there are no competitive bids, and that the system is designed to keep hogs from reaching market prices, causing heavy losses to all producers.

The Armour company, in a reply to the charges filed with the department of agriculture, has asserted its right to operate private yards and has denied that the intent or effect of such operation has been to depress hog prices.

The federal law provides that the funds can be administered only by state highway engineers while the Texas constitution makes county commissioners court only administrator of road money. RENEW EFFORTS TO AVERT COAL STRIKE

Sub-Committee Resumes Negotiation With Mine Operators in New York.

By Associated Press. NEW YORK, March 27.—Labor members of the anthracite wage scale subcommittee returned from Cleveland today to renew negotiations with the operators in effort to avert the strike called for next Saturday night. Both operators and miners expressed a desire to end the general discussions and to confine future sessions to consideration of the 19 demands of the workers.

Demanding a 29 per cent increase in wages the miners say they propose to demonstrate that wages in the mines failed to keep pace with wages in other industries during the war; that the total increase has been only 45 per cent since 1914; that the mine operator is making an excessive profit and that the mines could continue to show a reasonable profit to the operator after granting both an increase and a reduction of prices.

The operators indicated that today they would make known the percentage of wage cuts they advocate in counter proposal to the 19 demands of the miners. FARRINGTON WILL MEET OPERATORS ON WEDNESDAY. SPRINGFIELD, ILL., March 27.—Acting upon his promise to coal operators, President Frank Farrington of the Illinois union miners this morning wired presidents of three coal operators associations of Illinois that would meet them in conference at 10:00 o'clock Wednesday morning in Chicago. When asked if this conference might result in a separate wage scale for Illinois miners, Mr. Farrington said: "Not at this time, I believe."

That the Illinois miners will not break with the international union was reiterated by President Farrington, who stated he had given notice at the Cleveland conference last Friday he would enter separate negotiations with the Illinois operators, "so long as the international union has forbidden district organizations to make."

Radio Amateur and Novice

By FRANK ROBERT.

(Checked and approved by Radio Section, U. S. Bureau of Standards.) In no other country in the world is the amateur radio operator as free from restraint as in the United States. The only restrictions placed on his activities are with regard to wave lengths and licensing. This is to prevent confusion in the air lanes.

The amateur operator is not necessarily a small boy. Many amateurs are men, and some who possess most efficient radio stations. The term "amateur" operator as distinguished from "commercial" operator is used simply to designate operators who are in radio merely for love of the art.

The radio "novice" is one who has only received a license for the purpose of "listening in." Of amateurs there are more than 13,000; of novices, 600,000.

Amateur's Work. To the amateur operators is due much of the credit for the position the United States occupies in the world. The rapidity of the practical development of long distance radio communication has been largely the result of tests and experiments conducted by amateurs in determining the efficiency or inefficiency of equipment.

Fully 90 per cent of the radio operators in the American military or naval services during the war were recruited from the ranks of amateur operators.

The amateurs have also been of valuable assistance to the department of commerce in its limited inspection force in helping to administer the radio laws. They have served as radio policemen in holding the radio laws in their hands and in preventing the encroachment of amateur work on commercial activities.

Development of the radio-phones should accelerate rather than restrict further expansion of the radio-phones. In the towns that have been devastated by fire, storm or flood, the radio amateur has frequently provided the only means of communication. The development of this kind will always be needed.

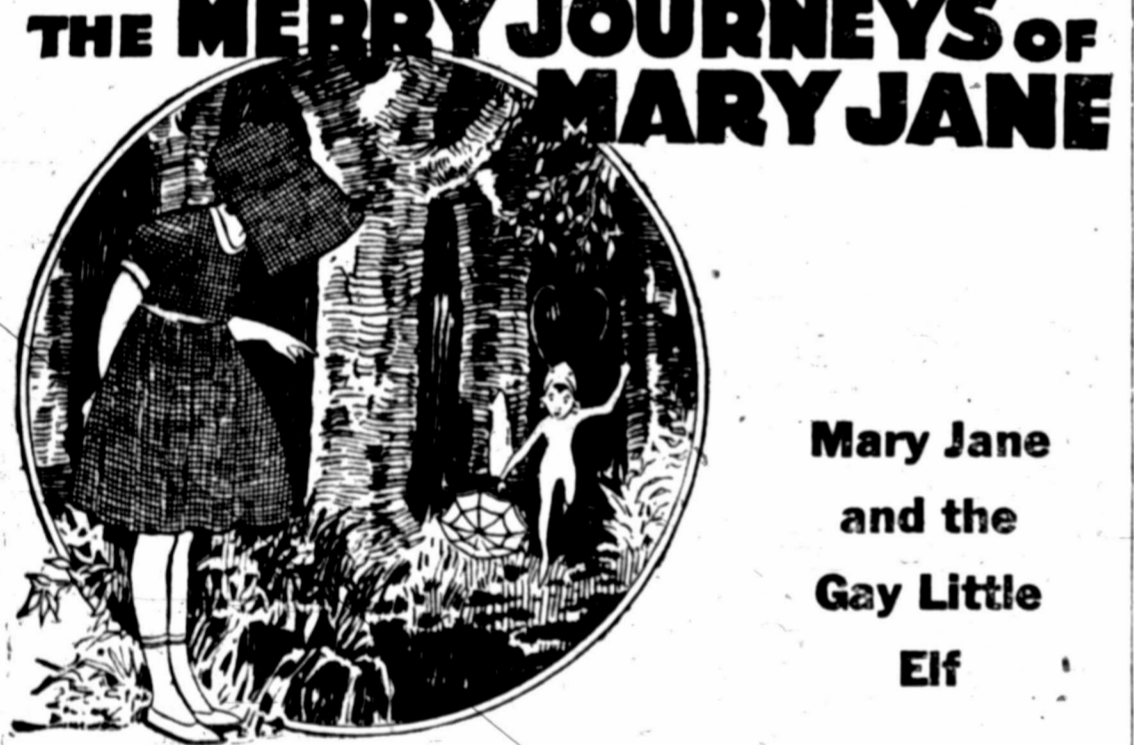
