By Associated Press.

PEKING, Aug. 21.—Grave alarmis felt by British subjects throughout Manchuria over the threat Chang Tso-Lin, governor, to with-hold his protection of British lives and property in reprisal for what he calls British contempt of his authority. Chang declares the Manchu-rians contemplate a boycott of British business,

On August 12, it was said, Chang invited several American and Brit-ish merchants to his chadquarters n Mukden. There he attacked the Britons bitterly.

He declared that in the war be-

tween himself and Wu Pel Fu, the northern military leader who de-feated Chang and revived the old republican parliament, Manchurian soldiers were killed with bombs hurled from British airplanes. 

Prof. Bell will give an explanatory lecture with this marvelous exhibition."

There's a curious coincidence between "vocal and instrumental music and conversation" over the telephone wire in 1877, and similar service by radio in 1922.

The telephone, considered a marvel, swept popular fancy overnight. Then it had a slump. People began to call it "a scientific toy." Many of them predicted that the telephone craze would die out quickly, just as similar predictions are being made now about radio.

But the telephone hasn't died out. Neither will radio. It is as much in its infancy as Bell's phone was in 1877. And its future is as promising.

EUROPE DRIFTING TOWARD ANOTHER WAR.

Herbert Houston in an editorial in the World Today last month said that in Europe there was a growing "will to peace." He quoted the statesmen of all the leading countries of Europe in support of this statement and said that where there was such a will there would come peace.


